BAGI STATISTIK EKSPORT IMPORT MENGIKUT NEGERI MEI 2022

SELANGOR, PULAU PINANG DAN SABAH ADALAH PENGIMPORT UTAMA GANDUM PADA MEI 2022

PUTRAJAYA, 28 Jun 2022 – Jumlah dagangan Malaysia pada bulan Mei 2022 bernilai RM228.4 bilion (peningkatan 33.6% tahun ke tahun) dengan nilai eksport RM120.5 bilion (peningkatan 30.5% tahun ke tahun) dan import bernilai RM107.9 bilion (peningkatan 37.3% tahun ke tahun). Beralih kepada nilai import gandum belum dikilang ke Malaysia pada Mei 2022, import meningkat 98.5 peratus tahun ke tahun kepada RM227.5 juta. Di peringkat negeri, Selangor mencatatkan import tertinggi bagi gandum belum dikilang bernilai RM101.0 juta (44.4%), diikuti Pulau Pinang (RM74.2 juta, 32.6%) dan Sabah (RM19.0 juta, 8.3%) seperti yang dilaporkan hari ini dalam **STATISTIK EKSPORT IMPORT MENGIKUT NEGERI MEI 2022**.

Dalam satu kenyataan pada hari ini, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia berkata, “Import pada bulan Mei 2022 meningkat RM29.3 bilion (+37.3%) berbanding bulan yang sama tahun sebelumnya. Peningkatan import dicatatkan di Pulau Pinang (+RM10.7 bilion), Johor (+RM5.2 bilion), Selangor (+RM3.8 bilion), W.P. Kuala Lumpur (+RM3.4 bilion), Kedah (+RM1.8 bilion), Negeri Sembilan (+RM1.2 bilion), Pahang (+RM837.4 juta), Perak (+RM739.9 juta), Sarawak (+RM573.2 juta), Terengganu (+RM258.5 juta) dan Sabah (+RM215.4 juta). Walau bagaimanapun, import menurun di Melaka (-RM137.0 juta), Perlis (-RM14.3 juta), Kelantan (-RM8.5 juta) dan W.P. Labuan (-RM1.2 juta).”


Beralih kepada prestasi eksport mengikut negeri, Ketua Perangkawan memaklumkan, “Eksport juga meningkat sebanyak RM28.2 bilion (+30.5%) berbanding bulan yang sama tahun sebelumnya. Eksport lebih tinggi direkodkan bagi kebanyakan negeri iaitu Pulau Pinang (+RM13.3 bilion), Johor (+RM5.2 bilion), Sarawak (+RM3.6 bilion), W.P. Kuala Lumpur (+RM2.9 bilion), Selangor (+RM2.2 bilion), W.P. Labuan (+RM1.1 bilion), Kedah (+RM1.1 bilion), Sabah (+RM903.5 juta), Pahang (+RM56.1 juta) dan Perlis (+RM30.1 juta). Walau bagaimanapun, eksport menyusut di Melaka (-RM951.0 juta), Perak (-RM443.8 juta), Terengganu (-RM375.1 juta), Negeri Sembilan (-RM193.9 juta) dan Kelantan (-RM25.0 juta).”

Dato' Sri Dr. Mohd Uzir Mahidin seterusnya memaklumkan “Antara lima negeri pengimpor utama, Pulau Pinang menjadi penyumbang utama dengan 26.3 peratus, diikuti oleh Selangor (24.1%), Johor (19.1%), W.P. Kuala Lumpur (8.8%) dan Kedah (5.8%). Sementara itu, bagi eksport, Pulau Pinang kekal sebagai pengeksport utama dengan sumbangan 31.0 peratus, diikuti oleh Johor (21.0%), Selangor (16.8%), Sarawak (8.8%) dan W.P. Kuala Lumpur (4.5%).”


**Carta 1: Data Siri Masa Eksport dan Import bagi negeri Johor, Pulau Pinang dan Selangor,

Paparan 1: Infografik Statistik Eksport Import Mengikut Negeri, Mei 2022





**SELANGOR, PULAU PINANG AND SABAH ARE THE TOP IMPORTERS
OF WHEAT IN MAY 2022**

PUTRAJAYA, 28 June 2022 – Malaysia's total trade for May 2022 amounted to RM228.4 billion, increased 33.6 per cent year-on-year (y-o-y), with exports of RM120.5 billion (+30.5% y-o-y) and imports worth RM107.9 billion (+37.3% y-o-y). Looking at the import value of wheat, unmilled to Malaysia in May 2022, imports increased by 98.5 per cent y-o-y to RM227.5 million. At the state level, Selangor recorded the highest imports of wheat, unmilled worth RM101.0 million (44.4%), followed by Pulau Pinang (RM74.2 million, 32.6%) and Sabah (RM19.0 million, 8.3%) as reported today in **EXPORT IMPORT STATISTICS BY STATE MAY 2022**.

In a statement today, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia said, "Imports in May 2022 increased RM29.3 billion (+37.3%) in May 2022 compared to the same month of the previous year. Higher imports were mainly from Pulau Pinang (+RM10.7 billion), Johor (+RM5.2 billion), Selangor (+RM3.8 billion), W.P. Kuala Lumpur (+RM3.4 billion), Kedah (+RM1.8 billion), Negeri Sembilan (+RM1.2 billion), Pahang (+RM837.4 million), Perak (+RM739.9 million), Sarawak (+RM573.2 million), Terengganu (+RM258.5 million) and Sabah (+RM215.4 million). However, imports decreased in Melaka (-RM137.0 million), Perlis (-RM14.3 million), Kelantan (-RM8.5 million) and W.P. Labuan (-RM1.2 million)."

Looking at the performance of exports by state, the Chief Statistician informed, “Exports also increased RM28.2 billion (+30.5%) compared to the same month of the previous year. Higher exports were recorded in most states such as Pulau Pinang (+RM13.3 billion), Johor (+RM5.2 billion), Sarawak (+RM3.6 billion), W.P. Kuala Lumpur (+RM2.9 billion), Selangor (+RM2.2 billion), W.P. Labuan (+RM1.1 billion), Kedah (+RM1.1 billion), Sabah (+RM903.5 million), Pahang (+RM56.1 million) and Perlis (+RM30.1 million). However, exports decreased in Melaka (-RM951.0 million), Perak (-RM443.8 million), Terengganu (-RM375.1 million), Negeri Sembilan (-RM193.9 million) and Kelantan (-RM25.0 million).”

Dato' Sri Dr. Mohd Uzir Mahidin also informed, “Among the top five major importing states, Pulau Pinang became the largest contributor with a share of 26.3 per cent, followed by Selangor (24.1%), Johor (19.1%), W.P. Kuala Lumpur (8.8%) and Kedah (5.8%). Meanwhile, as for exports, Pulau Pinang remained as the top exporter with a share of 31.0 per cent, followed by Johor (21.0%), Selangor (16.8%), Sarawak (8.8%) and W.P. Kuala Lumpur (4.5%).”

May 2021 – May 2022 (RM Billion)**






Exhibit 1: Infographic on Export Import Statistics by State May 2022
