KENYATAAN MEDIA BAGI STATISTIK EKSPORT IMPORT MENGIKUT NEGERI, JANUARI 2022

PULAU PINANG MENCATATKAN EKSPORT TERTINGGI BAGI BARANGAN ELEKTRIK DAN ELEKTRONIK SEBANYAK RM26.2 BILION PADA JANUARI 2022

PUTRAJAYA, 14 Mac 2022 – Jumlah dagangan Malaysia pada bulan Januari 2022 bernilai RM203.0 bilion (peningkatan 24.8 peratus tahun ke tahun) dengan nilai eksport RM110.7 bilion (peningkatan 23.5 peratus tahun ke tahun) dan import bernilai RM92.3 bilion (peningkatan 26.4 peratus tahun ke tahun). Eksport barangan elektrik dan elektronik bernilai RM44.8 bilion (40.4 peratus daripada jumlah eksport) pada Januari 2022. Di peringkat negeri, Pulau Pinang mencatatkan eksport tertinggi bagi barangan elektrik dan elektronik bernilai RM26.2 bilion (58.5%), diikuti Selangor (RM6.0 bilion, 13.3%) dan Johor (RM4.8 bilion, 10.7%) seperti yang dilaporkan hari ini dalam **STATISTIK EKSPORT IMPORT MENGIKUT NEGERI, JANUARI 2022**.

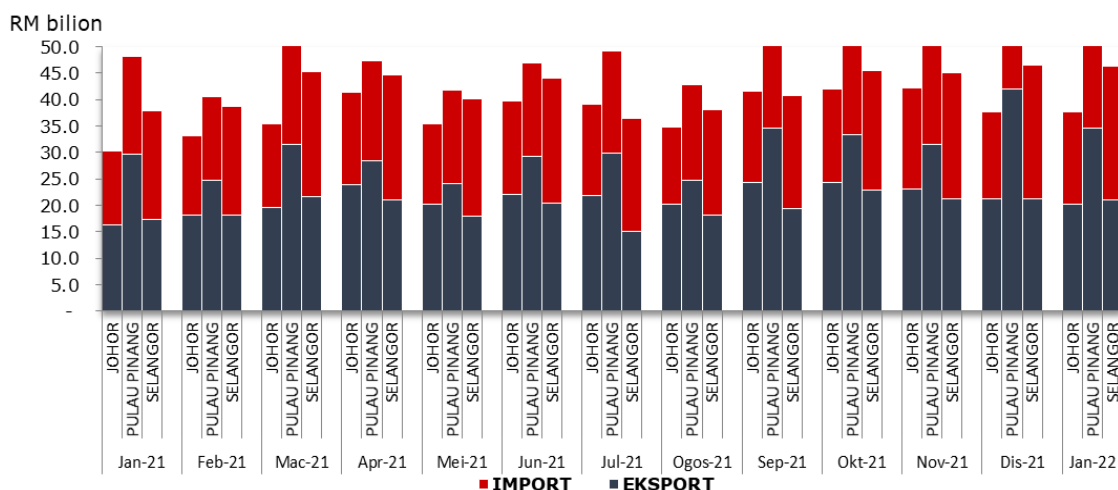
Dalam satu kenyataan pada hari ini, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia berkata, "Eksport pada bulan Januari 2022 meningkat sebanyak RM21.1 bilion (+23.5%) berbanding bulan yang sama tahun sebelumnya. Eksport lebih tinggi direkodkan bagi kebanyakan negeri iaitu Pulau Pinang (+RM5.0 bilion), Johor (+RM4.0 bilion), Sarawak (+RM3.7 bilion), Selangor (+RM3.6 bilion), Kedah (+RM1.8 bilion), Sabah (+RM1.4 bilion), Pahang (+RM732.3 juta), W.P. Labuan (+RM713.8 juta), Terengganu (+RM511.0 juta), W.P. Kuala Lumpur (+RM278.9 juta), Kelantan (+RM66.2 juta) dan Perlis (+RM33.1 juta). Walau bagaimanapun, eksport menyusut di Perak (-RM610.2 juta), Melaka (-RM197.9 juta) dan Negeri Sembilan (-RM68.9 juta)."

Beralih kepada prestasi import mengikut negeri, Ketua Perangkawan memaklumkan, “Import juga meningkat RM19.3 bilion (+26.4%) pada Januari 2022 berbanding bulan yang sama tahun sebelumnya. Peningkatan import dicatatkan di Selangor (+RM4.7 bilion), Pulau Pinang (+RM4.0 bilion), Johor (+RM3.4 bilion), Kedah (+RM2.4 bilion), W.P. Kuala Lumpur (+RM1.6 bilion), Sarawak (+RM1.2 bilion), Negeri Sembilan (+RM673.0 juta), Pahang (+RM525.5 juta), Melaka (+RM151.9 juta), Perak (+RM143.0 juta), Terengganu (+RM115.1 juta), Sabah (+RM98.2 juta) dan Perlis (+RM22.5 juta). Walau bagaimanapun, import menurun di Kelantan (-RM162.8 juta) dan W.P. Labuan (-RM37.9 juta).”

Dato' Sri Dr. Mohd Uzir Mahidin seterusnya memaklumkan “Antara lima negeri pengeksporth utama, Pulau Pinang kekal sebagai pengeksporth utama dengan sumbangan 31.3 peratus, diikuti oleh Selangor (19.0%), Johor (18.3%), Sarawak (7.8%) dan Kedah (4.1%). Sementara itu, bagi import, Selangor kekal sebagai penyumbang utama dengan 27.3 peratus, diikuti oleh Pulau Pinang (24.4%), Johor (18.9%), W.P. Kuala Lumpur (7.0%) dan Kedah (6.6%).”

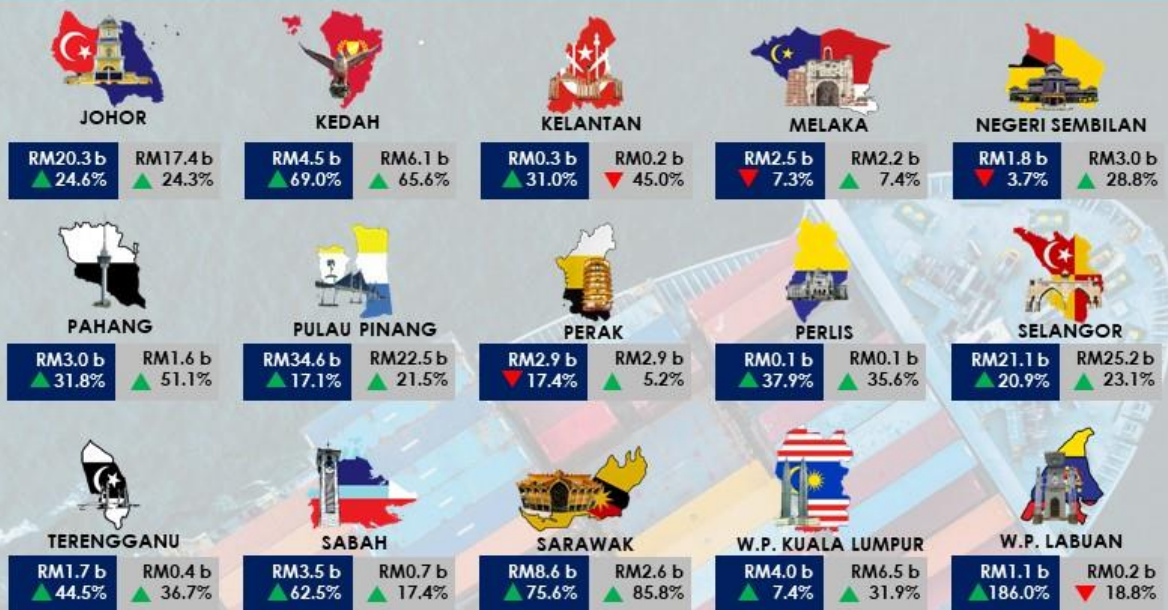

FOR EXPORT IMPORT STATISTICS BY STATE, JANUARY 2022

PULAU PINANG RECORDED THE HIGHEST EXPORTS OF ELECTRICAL AND ELECTRONIC PRODUCTS WORTH RM26.2 BILLION IN JANUARY 2022

PUTRAJAYA, 14 March 2022 – Malaysia's total trade for January 2022 amounted to RM203.0 billion, increased 24.8% year-on-year (y-o-y), with exports of RM110.7 billion (+23.5% y-o-y) and imports worth RM92.3 billion (+26.4% y-o-y). Exports of electrical and electronic (E&E) products amounted to RM44.8 billion (40.4 per cent of total exports) in January 2022. At the state level, Pulau Pinang recorded the highest exports of E&E products worth RM26.2 billion (58.5%), followed by Selangor (RM6.0 billion, 13.3%) and Johor (RM4.8 billion, 10.7%) as reported today in **EXPORT IMPORT STATISTICS BY STATE, JANUARY 2022**.

In a statement today, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia said, "Exports in January 2022 increased RM21.1 billion (+23.5%) compared to the same month of the previous year. Higher exports were recorded in most states such as Pulau Pinang (+RM5.0 billion), Johor (+RM4.0 billion), Sarawak (+RM3.7 billion), Selangor (+RM3.6 billion), Kedah (+RM1.8 billion), Sabah (+RM1.4 billion), Pahang (+RM732.3 million), W.P. Labuan (+RM713.8 million), Terengganu (+RM511.0 million), W.P. Kuala Lumpur (+RM278.9 million), Kelantan (+RM66.2 million) and Perlis (+RM33.1 million). However, exports decreased in Perak (-RM610.2 million), Melaka (-RM197.9 million) and Negeri Sembilan (-RM68.9 million)."

Looking at the performance of imports by state, the Chief Statistician informed, “Imports also increased RM19.3 billion (+26.4%) in January 2022 compared to the same month of the previous year. Higher imports were mainly from Selangor (+RM4.7 billion), Pulau Pinang (+RM4.0 billion), Johor (+RM3.4 billion), Kedah (+RM2.4 billion), W.P. Kuala Lumpur (+RM1.6 billion), Sarawak (+RM1.2 billion), Negeri Sembilan (+RM673.0 million), Pahang (+RM525.5 million), Melaka (+RM151.9 million), Perak (+RM143.0 million), Terengganu (+RM115.1 million), Sabah (+RM98.2 million) and Perlis (+RM22.5 million). However, imports decreased in Kelantan (-RM162.8 million) and W.P. Labuan (-RM37.9 million).”

Dato' Sri Dr. Mohd Uzir Mahidin also informed, “Among the top five major exporting states, Pulau Pinang remained as the top exporter with a share of 31.3 per cent, followed by Selangor (19.0%), Johor (18.3%), Sarawak (7.8%) and Kedah (4.1%). Meanwhile, as for imports, Selangor remained as the largest contributor with a share of 27.3 per cent, followed by Pulau Pinang (24.4%), Johor (18.9%), W.P. Kuala Lumpur (7.0%) and Kedah (6.6%).”

Chart 1: Time Series Data on Exports and Imports in Johor, Pulau Pinang and Selangor, January 2021 – January 2022 (RM Billion)

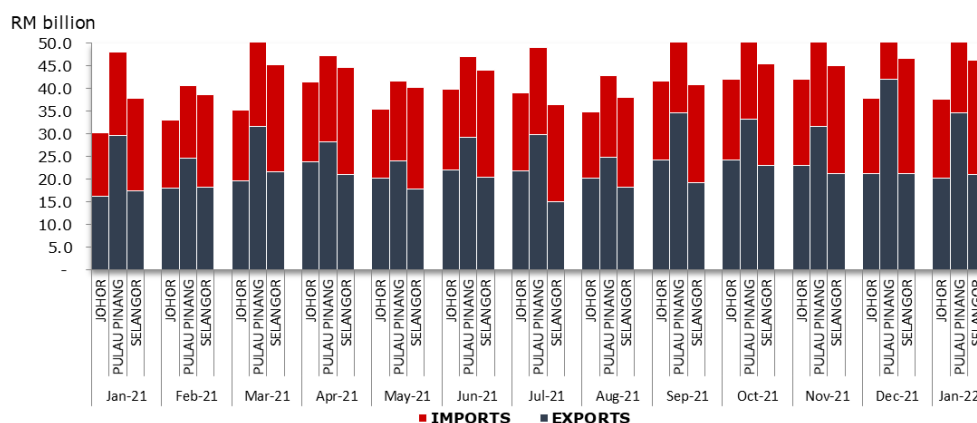
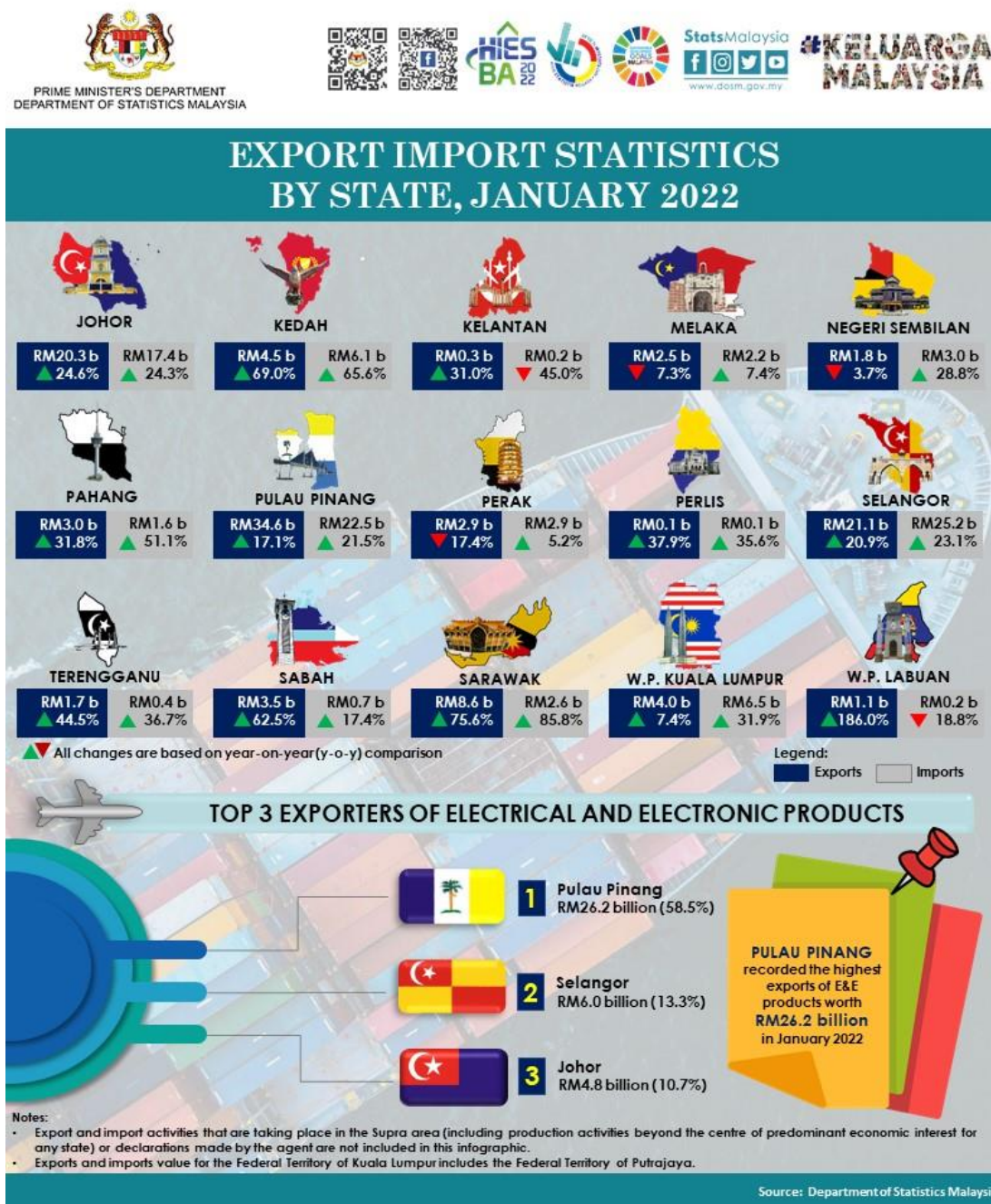


Exhibit 1: Infographic on Export Import Statistics by State, January 2022
