**Indeks nilai seunit eksport & import Malaysia merekodkan pertumbuhan positif 0.2 peratus pada Disember 2021**

**PUTRAJAYA, 4 FEBRUARI 2022** – Indeks nilai seunit eksport dan import bulanan Malaysia kekal positif, kedua-duanya meningkat 0.2 peratus pada Disember 2021, sebagai mana dipaparkan oleh laporan **INDEKS PERDAGANGAN LUAR NEGERI (2010=100), DISEMBER 2021** pada hari ini. Penerbitan ini memaparkan statistik indeks nilai seunit dan indeks volum mengikut seksyen bagi eksport dan import barang.

Jumlah perdagangan Malaysia merekodkan prestasi menaik, meningkat 5.5 peratus pada Disember 2021 berbanding bulan sebelumnya. Nilai eksport meningkat 10.4 peratus kepada RM123.8 bilion berbanding November 2021, disumbangkan oleh kenaikan eksport alat jentera & kelengkapan pengangkutan (+22.4%), minyak & lemak binatang & sayur-sayuran (+13.2%) dan pelbagai barang keluaran kilang (+7.8%). Sementara itu, nilai import menyusut 0.4 peratus bulan ke bulan pada Disember 2021, dengan nilai RM92.9 bilion, disumbangkan oleh kejatuhan import minyak galian (-25.9%), minyak & lemak binatang & sayur-sayuran (-20.7%) dan bahan mentah tidak boleh dimakan (-2.4%). Nilai perdagangan pula meningkat 63.6 peratus bulan ke bulan, dengan nilai RM31.0 bilion.

Menurut Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin, "Indeks nilai seunit eksport meningkat 0.2 peratus pada Disember 2021 berbanding bulan sebelumnya, disumbangkan oleh kenaikan indeks minyak & lemak binatang & sayur-sayuran (+3.4%), alat jentera & kelengkapan pengangkutan (+0.8%) dan bahan kimia (+0.8%). Indeks volum eksport turut meningkat 10.1 peratus pada bulan yang sama, disumbangkan oleh kenaikan indeks alat jentera & kelengkapan pengangkutan (+21.5%), bahan kimia (+9.3%) dan pelbagai barang keluaran kilang (+7.7%). Indeks volum eksport pelarasan bermusim bertumbuh 6.0 peratus daripada 162.2 mata kepada 172.0 mata. Berdasarkan perbandingan tahunan, kedua-dua indeks nilai seunit dan volum eksport masing-masing meningkat 15.8 peratus dan 11.6 peratus."

Dato' Sri Dr. Mohd Uzir Mahidin berkata "Indeks nilai seunit import turut meningkat 0.2 peratus pada Disember 2021 berbanding bulan sebelumnya, disumbangkan oleh kenaikan indeks minyak & lemak binatang & sayur-sayuran (+7.0%), alat jentera & kelengkapan pengangkutan (+0.5%) dan barang-barang keluaran kilang (+0.5%). Sementara itu, indeks volum import menyusut 0.6 peratus pada Disember 2021 berbanding bulan sebelumnya, disumbangkan oleh kejatuhan indeks minyak & lemak binatang & sayur-sayuran (-25.9%), minyak galian (-23.9%) dan bahan mentah tidak boleh dimakan (-2.2%). Indeks volum import pelarasan bermusim pada Disember 2021 menurun 1.0 peratus daripada 168.7 mata kepada 166.8 mata. Perbandingan tahun ke tahun menunjukkan kedua-dua indeks nilai seunit dan volum import masing-masing berkembang 8.4 peratus dan 14.1 peratus."

Jabatan Perangkaan Malaysia (DOSM) turut melaporkan terma perdagangan Malaysia mencatatkan pertumbuhan 0.04 peratus bulan ke bulan kepada 107.1 mata pada Disember 2021. Prestasi terma perdagangan Malaysia kekal positif 6.9 peratus daripada 100.2 mata pada Disember tahun lalu.

Jabatan Perangkaan Malaysia sedang menjalankan Survei Pendapatan, Perbelanjaan Isi Rumah dan Kemudahan Asas (HIES/BA) 2022 bermula dari 1 Januari 2022 sehingga 31 Disember 2022. ***Malaysia's export & import unit value indices recorded positive growths of 0.2 per cent in December 2021***

**PUTRAJAYA, FEBRUARY 4, 2022** – Malaysia's monthly export and import unit value indices remained positive, both increased by 0.2 per cent in December 2021, as reported today in **EXTERNAL TRADE INDICES (2010=100), DECEMBER 2021**. This publication presents the unit value and volume index by sections for both exports and imports of goods.


Malaysia's total trade recorded an upward trend, grew 5.5 per cent in December 2021 compared to the previous month. Export value rose by 10.4 per cent to RM123.8 billion as against November 2021, reflected by the increment in exports of machinery & transport equipment (+22.4%), animal & vegetable oils & fats (+13.2%) and miscellaneous manufactured articles (+7.8%). On the other hand, imports declined by 0.4 per cent month-on-month (m-o-m) in December 2021 amounted at RM92.9 billion, reflected by the deterioration in imports of mineral fuels (-25.9%), animal & vegetable oils & fats (-20.7%) and inedible crude materials (-2.4%). Meanwhile, trade value soared by 63.6 per cent m-o-m, amounted to RM31.0 billion.

*According to the Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin, "The export unit value index grew 0.2 per cent in December 2021 as compared with the previous month, contributed by the increases in index of animal & vegetable oils & fats (+3.4%), machinery & transport equipment (+0.8%) and chemicals (+0.8%). Likewise, the export volume index grew 10.1 per cent in the same month, reflected by the increases in index of machinery & transport equipment (+21.5%), chemicals (+9.3%) and miscellaneous manufactured articles (+7.7%). The seasonally adjusted export volume index rose 6.0 per cent from 162.2 points to 172.0 points. On annual comparison, both export unit value and volume index grew 15.8 per cent and 11.6 per cent, respectively."*

*Dato' Sri Dr. Mohd Uzir Mahidin commented, "The import unit value index also grew 0.2 per cent in December 2021 as compared with the previous month, attributed to the increases in index of animal & vegetable oils & fats (+7.0%), machinery & transport equipment (+0.5%) and manufactured goods (+0.5%). On the other hand, the import volume index dropped by 0.6 per cent in December 2021 as compared to the preceding month, attributed by the deterioration in index of animal & vegetable oils & fats (-25.9%), mineral fuels (-23.9%) and inedible crude materials (-2.2%). The seasonally adjusted import volume index in December 2021 decreased by 1.0 per cent from 168.7 points to 166.8 points. On a year-on-year basis, both the import unit value and volume indices expanded 8.4 per cent and 14.1 per cent, respectively."*

*Department of Statistics Malaysia (DOSM) also reported that Malaysia's terms of trade increased by 0.04 per cent m-o-m to 107.1 points in December 2021. Malaysia's terms of trade performance sustained positive growth at 6.9 per cent from 100.2 points in December of previous year.*
