KENYATAAN MEDIA BAGI STATISTIK EKSPORT IMPORT MENGIKUT NEGERI, NOVEMBER 2021

PENINGKATAN EKSPORT TERTINGGI DICATATKAN DI SELANGOR MANAKALA IMPORT DI PULAU PINANG

PUTRAJAYA, 13 Januari 2022 – Jumlah dagangan Malaysia pada bulan November 2021 bernilai RM205.5 bilion, meningkat 34.9% tahun ke tahun, dengan nilai eksport RM112.2 bilion (+32.4% tahun ke tahun) dan import bernilai RM93.3 bilion (+38.0% tahun ke tahun). Peningkatan eksport tertinggi dicatatkan di Selangor manakala import di Pulau Pinang seperti yang dilaporkan hari ini dalam **STATISTIK EKSPORT IMPORT MENGIKUT NEGERI, NOVEMBER 2021**.

Dalam satu kenyataan pada hari ini, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia berkata, “Eksport pada bulan November 2021 meningkat sebanyak RM27.5 bilion (+32.4%) berbanding tahun sebelumnya. Eksport lebih tinggi direkodkan bagi kebanyakan negeri iaitu Selangor (+RM6.3 bilion), Johor (+RM5.3 bilion), Pulau Pinang (+RM4.4 bilion), Sarawak (+RM3.1 bilion), Kedah (+RM2.1 bilion), Sabah (+RM1.8 bilion), Pahang (+RM1.6 bilion), W.P. Kuala Lumpur (+RM1.2 bilion), Melaka (+RM904.8 juta), W.P. Labuan (+RM692.5 juta), Perak (+RM254.0 juta), Negeri Sembilan (+RM245.8 juta) dan Perlis (+RM11.2 juta). Walau bagaimanapun, eksport menurun di Terengganu (-RM346.6 juta) dan Kelantan (-RM42.5 juta).”


Beralih kepada prestasi import mengikut negeri, Ketua Perangkawan memaklumkan, “Import meningkat RM25.7 bilion (+38.0%) berbanding tahun sebelumnya. Import meningkat di Pulau Pinang (+RM6.0 bilion), Johor (+RM5.6 bilion), Selangor (+RM4.7 bilion), Kedah (+RM2.7 bilion), W.P. Kuala Lumpur (+RM2.2 bilion), Negeri Sembilan (+RM1.8 bilion), Sarawak (+RM749.8 juta), Perak (+RM533.7 juta), Pahang (+RM305.5 juta),

Sabah (+RM260.5 juta), W.P. Labuan (+RM151.6 juta), Terengganu (+RM105.1 juta) dan Perlis (+RM22.4 juta). Walau bagaimanapun, import menurun di Melaka (-RM34.9 juta) dan Kelantan (-RM5.7 juta)."

Dato' Sri Dr. Mohd Uzir Mahidin seterusnya memaklumkan "Lima negeri mendominasi eksport Malaysia adalah Pulau Pinang (28.2%), Johor (20.6%), Selangor (19.0%), Sarawak (7.6%) dan Kedah (4.0%). Eksport bagi lima negeri ini menyumbang sebanyak 79.4 peratus daripada jumlah eksport Malaysia. Sementara itu, bagi import, Selangor kekal sebagai penyumbang utama dengan 25.6 peratus, diikuti oleh Pulau Pinang (23.3%), Johor (20.3%), W.P. Kuala Lumpur (7.5%) dan Kedah (7.1%)."

FOR EXPORT IMPORT STATISTICS BY STATE, NOVEMBER 2021

THE HIGHEST INCREASE OF EXPORTS WAS RECORDED IN SELANGOR MEANWHILE FOR IMPORTS IN PULAU PINANG

PUTRAJAYA, 13 January 2022 – Malaysia's total trade for November 2021 amounted to RM205.5 billion, increased 34.9% year-on-year (y-o-y), with exports of RM112.2 billion (+32.4% y-o-y) and imports worth RM93.3 billion (+38.0% y-o-y). The highest increase of exports was recorded in Selangor meanwhile for imports in Pulau Pinang as reported today in **EXPORT IMPORT STATISTICS BY STATE, NOVEMBER 2021**.

In a statement today, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia said, "Exports in November 2021 increased RM27.5 billion (+32.4%) over the year. Higher exports were recorded in most states such as Selangor (+RM6.3 billion), Johor (+RM5.3 billion), Pulau Pinang (+RM4.4 billion), Sarawak (+RM3.1 billion), Kedah (+RM2.1 billion), Sabah (+RM1.8 billion), Pahang (+RM1.6 billion), W.P. Kuala Lumpur (+RM1.2 billion), Melaka (+RM904.8 million), W.P. Labuan (+RM692.5 million), Perak (+RM254.0 million), Negeri Sembilan (+RM245.8 million) and Perlis (+RM11.2 million). However, exports decreased in Terengganu (-RM346.6 million) and Kelantan (-RM42.5 million)."

Looking at the performance of imports by state, the Chief Statistician informed, "Imports increased RM25.7 billion (+38.0%) over the year. Higher imports were mainly from Pulau Pinang (+RM6.0 billion), Johor (+RM5.6 billion), Selangor (+RM4.7 billion), Kedah (+RM2.7 billion), W.P. Kuala Lumpur (+RM2.2 billion), Negeri Sembilan (+RM1.8 billion),

Sarawak (+RM749.8 million), Perak (+RM533.7 million), Pahang (+RM305.5 million), Sabah (+RM260.5 million), W.P. Labuan (+RM151.6 million), Terengganu (+RM105.1 million) and Perlis (+RM22.4 million). However, imports decreased in Melaka (-RM34.9 million) and Kelantan (-RM5.7 million)."

Dato' Sri Dr. Mohd Uzir Mahidin also informed, "Five states that dominated Malaysia's export were Pulau Pinang (28.2%), Johor (20.6%), Selangor (19.0%), Sarawak (7.6%) and Kedah (4.0%). The contribution of these five states accounted for 79.4 per cent of Malaysia's total exports. Meanwhile, as for imports, Selangor remained as the largest contributor with a share of 25.6 per cent, followed by Pulau Pinang (23.3%), Johor (20.3%), W.P. Kuala Lumpur (7.5%) and Kedah (7.1%)."

Chart 1: Time Series Data on Exports and Imports in Johor, Pulau Pinang and Selangor, November 2020 – November 2021 (RM Billion)


