**Eksport Mencecah Nilai Tertinggi Baharu, RM110.8 bilion,
Berkembang 24.7 peratus pada September 2021**

PUTRAJAYA, 28 Oktober 2021 – Prestasi dagangan Malaysia kekal stabil untuk mencatatkan pertumbuhan kukuh dua-digit pada bulan September 2021, meningkat 25.5 peratus kepada RM195.5 bilion. Eksport mencapai nilai tertinggi baharu, RM110.8 bilion, meningkat 24.7 peratus berbanding tahun sebelumnya. Melengkap kepada prestasi yang kukuh, import juga mencatat kenaikan 26.5 peratus kepada RM84.7 bilion, tahun ke tahun sebagai mana dilaporkan dalam **BULETIN PERANGKAAN PERDAGANGAN LUAR NEGERI MALAYSIA, SEPTEMBER 2021** hari ini. Laporan ini turut memaparkan prestasi import dan eksport mengikut produk dan rakan dagangan.

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin berkata "Eksport mencatatkan nilai bulanan tertinggi RM110.8 bilion, meningkat 24.7 peratus disokong oleh eksport domestik dan eksport semula. Ini adalah peningkatan tahun ke tahun ketiga belas bulan berturut-turut sejak September 2020. Eksport domestik berjumlah RM87.7 bilion dan menyumbang 79.1 peratus kepada jumlah eksport, meningkat 22.4 peratus. Di samping itu, eksport semula dengan nilai RM23.2 bilion, naik 34.1 peratus tahun ke tahun. Import Malaysia pada September 2021 berjumlah RM84.7 bilion, terus mencatatkan pertumbuhan 26.5 peratus atau RM17.7 bilion berbanding bulan yang sama 2020. Lebihan dagangan berkembang 19.1 peratus kepada RM26.1 bilion. Seiring dengan pemulihan aktiviti ekonomi domestik kesan daripada pelaksanaan Pelan Pemulihian Negara (PPN), prestasi bulan ke bulan bagi eksport, import, jumlah dagangan dan lebihan dagangan juga menunjukkan pertumbuhan kukuh, masing-masing 16.0 peratus, 14.2 peratus, 15.2 peratus dan 22.2 peratus.

Selaras dengan pertumbuhan tahunan, 168 daripada 254 kumpulan barang untuk eksport menunjukkan peningkatan berbanding tempoh yang sama tahun sebelumnya. Bagi import, 147 daripada 260 kumpulan merekodkan pertumbuhan positif."

Jabatan Perangkaan Malaysia juga melaporkan bahawa peningkatan eksport disumbangkan terutamanya oleh eksport yang lebih tinggi ke Singapura (+RM4.0 bilion), diikuti China (+RM3.0 bilion), Amerika Syarikat (+RM2.0 bilion), Indonesia (+RM1.7 bilion), India (+RM1.4 bilion), Hong Kong (+RM1.1 bilion), dan Jepun (+RM879.4 juta). Sementara itu, China terus menjadi penyumbang utama kenaikan import (+RM4.6 bilion), diikuti oleh Singapura (+RM2.1 bilion), Kesatuan Eropah (+RM1.9 bilion), Indonesia (+RM1.6 bilion), Taiwan (+RM1.5 bilion), Amerika Syarikat (+RM1.0 bilion) dan Republik Korea (+RM930.7 juta).


Peningkatan eksport didorong oleh keluaran petroleum (+RM5.6 bilion); barang perkilangan logam (+RM3.6 bilion); minyak kelapa sawit & keluaran pertanian berasaskan minyak kelapa sawit (+RM2.8 bilion); barang elektrik & elektronik (+RM2.2 bilion); kimia & bahan kimia (+RM1.7 bilion); barang perkilangan berasaskan minyak kelapa sawit (+RM1.2 bilion); barang besi & keluli (+RM1.1 bilion) dan gas asli cecair (+RM1.1 bilion). Sementara itu, kenaikan import dicatatkan bagi barang elektrik & elektronik (+RM6.4 bilion); keluaran petroleum (+RM4.0 bilion); kimia & bahan kimia (+RM2.1 bilion) dan petroleum mentah (+RM755.1 juta).

Bagi tempoh yang sama, pertumbuhan import bagi Penggunaan Akhir disokong oleh kenaikan permintaan bagi barang perantaraan, barang modal dan barang penggunaan. Import barang perantaraan (51.0% daripada jumlah import) berjumlah RM43.2 bilion, meningkat RM9.9 bilion atau 29.7 peratus. Barang modal (10.8% daripada jumlah import) mencatatkan kenaikan 20.3 peratus daripada RM7.6 bilion pada tahun sebelumnya kepada RM9.2 bilion. Import barang penggunaan yang berjumlah RM6.9 bilion, meningkat 3.7 peratus berbanding September 2020, dan merangkumi 8.1 peratus daripada jumlah import.


Banci Penduduk dan Perumahan Malaysia 2020 (Banci Malaysia 2020) masih dilaksanakan di seluruh Negara sehingga 31 Oktober 2021 secara bersemuka dengan pematuhan Prosedur Operasi Standard (SOP) yang telah ditetapkan oleh Majlis Keselamatan Negara (MKN). Aktiviti Semakan Kualiti (QC) dan Penyiasatan Liputan Banci (PES) akan dilaksanakan pada November dan Disember 2021. Semua penduduk Malaysia diseru untuk memberikan kerjasama dalam menjayakan Banci Malaysia 2020 bagi memastikan tiada yang ketinggalan kerana "Data Anda Masa Depan Kita". 
**Carta 1: Perangkaan Perdagangan Luar Negeri, Jan 2019 – Sep 2021

**Exports Reached a New High, RM110.8 billion, Expanded by
24.7 per cent in September 2021**

PUTRAJAYA, October 28, 2021 – Malaysia’s trade performance remained steady to record a strong double-digit growth in September 2021, growing by 25.5 per cent to RM195.5 billion. Exports reached a new high, RM110.8 billion, expanded by 24.7 per cent as compared to the previous year. Adding to these remarkable performances, imports also registered an increase of 26.5 per cent to RM84.7 billion year-on-year (y-o-y) as reported today in **MALAYSIA EXTERNAL TRADE STATISTICS BULLETIN, SEPTEMBER 2021**. This report also presents the performance of imports and exports by product and trading partner.

Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin said “Exports recorded the highest monthly value of RM110.8 billion, an increase of 24.7 per cent supported by both domestic exports and re-exports. This was the thirteenth consecutive month of y-o-y expansion since September 2020. Domestic exports amounted to RM87.7 billion and contributed 79.1 per cent to total exports, expanded by 22.4 per cent. On the same note, re-exports with a value of RM23.2 billion, grew by 34.1 per cent, y-o-y. Imports in September 2021 totaled RM84.7 billion, continued to register a growth of 26.5 per cent or RM17.7 billion as compared with same month in 2020. Trade surplus expanded by 19.1 per cent to RM26.1 billion. Along with the recovery in domestic economic activity due to the implementation of National Recovery Plan (NRP) in June 2021, the month-on-month performance of exports, imports, total trade and trade surplus were also showing sturdy growth of 16.0 per cent, 14.2 per cent, 15.2 per cent and 22.2 per cent, respectively.

In conjunction to the annual growth, 168 out of 254 commodity groups for exports showed increases as compared to the same period of previous year. As for imports, 147 of 260 groups posted positive growths.”

The Department of Statistics Malaysia also reported that the rise in exports was attributable mainly to the higher exports to Singapore (+RM4.0 billion) followed by China (+RM3.0 billion), the United States (+RM2.0 billion), Indonesia (+RM1.7 billion), India (+RM1.4 billion), Hong Kong (+RM1.1 billion), and Japan (+RM879.4 million). Meanwhile, China continued to be the major contributor to the increase in imports (+RM4.6 billion), followed by Singapore (+RM2.1 billion), the European Union (+RM1.9 billion), Indonesia (+RM1.6 billion), Taiwan (+RM1.5 billion), the United States (+RM1.0 billion) and Republic of Korea (+RM930.7 million).


The expansion in exports was driven by petroleum products (+RM5.6 billion); manufacture of metal (+RM3.6 billion); palm oil & palm oil-based agriculture products (+RM2.8 billion); electrical & electronic products (+RM2.2 billion); chemical & chemical products (+RM1.7 billion); palm oil-based manufactured products (+RM1.2 billion); iron & steel products (+RM1.1 billion) and liquefied natural gas (+RM1.1 billion). Meanwhile, the rise in imports were noted for electrical & electronic products (+RM6.4 billion); petroleum products (+RM4.0 billion); chemical & chemical products (+RM2.1 billion) and crude petroleum (+RM755.1 million).

On the same note, expansion in imports by End Use sustained by higher demand for intermediate goods, capital goods and consumption goods. Imports of intermediate goods (51.0% of the total imports) totaled RM43.2 billion, increased by RM9.9 billion or 29.7 per cent. Capital goods (10.8% of total imports) registered an increase of 20.3 per cent from RM7.6 billion in the preceding year to RM9.2 billion. Imports of consumption goods which amounted to RM6.9 billion, rose by 3.7 per cent as compared to September 2020, and comprised of 8.1 per cent of total imports.




*Chart 1: External Trade Statistics, Jan 2019 – Sep 2021
