***Six states registered an increase in total trade despite COVID-19 pandemic***

**PUTRAJAYA, 8 June 2020** – Department of Statistics, Malaysia has released the report on Malaysia Trade Statistics by State 2021. Commenting on the report, Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin highlighted, “2020 has been a challenging year for the economy due to the COVID-19 pandemic and has also impacted trade activities around the world. Malaysia's trade in 2020 recorded RM1,777.2 billion, a decrease of 3.6 percent compared to RM1,844.5 in 2019. However, six states recorded an increase in total trade despite the COVID-19 outbreak namely Pulau Pinang (+RM38.6 billion), Sabah (+RM4.5 billion), Pahang (+RM3.5 billion), Kedah (+RM3.0 billion), Kelantan (+RM969.7 million) and Perak (+RM294.8 million)”.

*Malaysia's exports in 2020 valued at RM981.0 billion in 2020, weighed down 1.4 per cent as compared to RM995.1 billion in 2019. Imports also recorded a decrease of 6.3 per cent to RM796.2 billion in 2020 as against RM849.4 billion in the previous year.*

*The decline in exports was due to the lower exports mainly by Sarawak (-RM15.5 billion), Selangor (-RM11.3 billion), Johor (-RM5.3 billion), Sabah (-RM4.2 billion), W.P. Kuala Lumpur (-RM3.4 billion), Terengganu (-RM2.8 billion), Negeri Sembilan (-RM2.3 billion), W.P. Labuan (-RM2.1 billion), Kedah (-RM0.4 billion) and Perlis (-RM0.1 billion). However, the value of exports increased in Pulau Pinang by*

*RM28.4 billion, Pahang (+RM3.4 billion), Perak (+RM2.0 billion), Melaka (+RM0.5 billion) and Kelantan (+RM0.1 billion).*

*At the same time, the decline in imports was induced by a lower imports from Selangor (-RM23.7 billion), Johor (-RM19.7 billion), W.P. Kuala Lumpur (-RM10.2 billion), Melaka (-RM9.7 billion), Negeri Sembilan (-RM6.1 billion), Terengganu (-RM1.8 billion), Perak (-RM1.7 billion), Sarawak (-RM1.2 billion), Perlis (-RM0.5 billion) and W.P. Labuan (-RM0.2 billion). On the contrary, Pulau Pinang recorded higher imports of RM10.2 billion, followed by Sabah (+RM8.6 billion), Kedah (+RM3.4 billion), Kelantan (+RM0.9 billion) and Pahang (+RM0.1 billion).*

*This publication contains statistics of Malaysia's External Trade (merchandise) on imports and exports at the state level with the rest of the world from 2015 to 2020. In addition, this publication provides detailed statistics for each state according to major / selected commodities, country of origin and destination from 2018 to 2020.*

*Malaysia External Trade Statistics by State 2021 aims to provide detailed statistics at the state level to the stakeholders. These comprehensive statistics are generated from the Trade Enterprise Characteristics (TEC) module which is one of the Department's initiatives under the Statistics Big Data Analytics (STATSBDA). TEC integrates two different statistics domains: the international merchandise trade database and Malaysia Statistical Business Register (MSBR). These statistics provide imperative information to policymakers to formulate strategic planning for states involved in international trade.*

*Dato' Sri Dr. Mohd Uzir Mahidin added, "Five states that dominated Malaysia's export were Pulau Pinang (31.8%), Johor (20.0%), Selangor (18.9%), Sarawak (6.7%) and Perak (3.2%). The contribution of these five states accounted for 80.5 per cent of Malaysia's total exports.*

*In 2020, overall Malaysia's trade registered net exports of RM184.8 billion, an increase of 26.8 per cent from previous year. This was contributed by high net exports especially in Pulau Pinang (+RM124.4 billion), Sarawak (+RM47.2 billion), Johor (+RM39.7 billion) and Pahang (+RM15.1 billion). High net exports recorded in Pulau Pinang were*



*contributed by electrical & electronic products. High net exports recorded in Johor were contributed by electrical & electronics and palm oil products & palm oil-based products. While liquefied natural gas (LNG) and palm oil were the main contributors of net exports in Sarawak. Iron rods and steel were the main contributors in Pahang”.*

#### **Enam negeri mencatatkan peningkatan jumlah perdagangan walaupun berlaku wabak COVID-19**

**PUTRAJAYA, 8 Jun 2021** – Jabatan Perangkaan Malaysia (DOSM) telah mengeluarkan laporan Statistik Perdagangan Malaysia Mengikut Negeri 2021 bagi tahun rujukan 2020. Mengulas berkaitan laporan tersebut, Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin menyatakan, “Tahun 2020 merupakan tahun yang mencabar kepada ekonomi disebabkan pandemik COVID-19 dan turut memberi kesan kepada aktiviti perdagangan di seluruh dunia. Perdagangan Malaysia pada tahun 2020 merekodkan RM1,777.2 bilion, penurunan 3.6 peratus berbanding RM1,844.5 pada tahun 2019. Walau bagaimanapun, enam negeri mencatatkan peningkatan jumlah perdagangan walaupun berlaku wabak COVID-19 iaitu negeri Pulau Pinang (+RM38.6 bilion), Sabah (+RM4.5 bilion), Pahang (+RM3.5 bilion), Kedah (+RM3.0 bilion), Kelantan (+RM969.7 juta) dan Perak (+RM294.8 juta)”.

Eksport Malaysia pada 2020 bernilai RM981.0 bilion pada tahun 2020, turun 1.4 peratus berbanding RM995.1 bilion pada tahun 2019. Import juga mencatatkan penurunan 6.3 peratus kepada RM796.2 bilion pada 2020 berbanding RM849.4 bilion pada tahun sebelumnya.

Penurunan eksport dipengaruhi oleh eksport yang lebih rendah terutamanya oleh Sarawak (-RM15.5 bilion), Selangor (-RM11.3 bilion), Johor (-RM5.3 bilion), Sabah (-RM4.2 bilion), W.P. Kuala Lumpur (-RM3.4 bilion), Terengganu (-RM2.8 bilion), Negeri Sembilan (-RM2.3 bilion), W.P. Labuan (-RM2.1 bilion), Kedah (-RM0.4 bilion) dan Perlis (-RM0.1 bilion). 


Manakala gas asli cecair (LNG) dan minyak kelapa sawit penyumbang utama eksport bersih di Sarawak. Batang besi dan keluli penyumbang utama di Pahang”.
