Inflasi Malaysia terus mereda kepada 2.8 peratus pada Mei 2023

PUTRAJAYA, 23 Jun 2023 – Inflasi Malaysia terus mereda kepada 2.8 peratus pada Mei 2023 dengan mata indeks mencatatkan 130.2 berbanding 126.6 pada bulan yang sama tahun sebelumnya. Jabatan Perangkaan Malaysia (DOSM) melaporkan hari ini mengenai keluaran **INDEKS HARGA PENGGUNA (IHP), MEI 2023**.

Menurut Jabatan Perangkaan Malaysia, kenaikan inflasi di Malaysia masih kekal didorong oleh kenaikan lebih tinggi Restoran & Hotel (6.7%) berbanding April 2023 (6.6%). Namun begitu, peningkatan perlana berbanding bulan sebelumnya bagi beberapa kumpulan seperti Makanan & Minuman Bukan Alkohol, 5.9 peratus (April 2023: 6.3%); Pengangkutan, 1.0 peratus (April 2023: 2.3%) dan Hiasan, Perkakasan & Penyelenggaraan Isi Rumah, 2.7 peratus (April 2023: 3.0%), sedikit sebanyak telah mengimbangi inflasi Malaysia daripada terus meningkat lebih tinggi. Wajaran bagi kumpulan Makanan & Minuman Bukan Alkohol (29.5%), Pengangkutan (14.6%) dan Restoran & Hotel (2.9%) yang meliputi 47.0 peratus daripada wajaran keseluruhan IHP turut memberi impak ketara kepada kadar inflasi dan kos sara hidup.

Selain itu, kenaikan inflasi di Malaysia pada Mei 2023 turut didorong oleh peningkatan bagi kumpulan Pelbagai Barang & Perkhidmatan (2.9%); Hiasan, Perkakasan & Penyelenggaraan Isi Rumah (2.7%); Kesihatan (1.9%) dan Pendidikan (1.9%). Perumahan, Air, Elektrik, Gas & Bahan Api Lain dan Perkhidmatan Rekreasi & Kebudayaan pula masing-masing meningkat 1.8 peratus. Ini dikuti oleh, Minuman Alkohol & Tembakau (0.7%) dan Pakaian & Kasut (0.4%).

Kumpulan Makanan & Minuman Bukan Alkohol menyumbang 29.5 peratus daripada keseluruhan wajaran IHP telah merekodkan peningkatan sederhana iaitu 5.9 peratus (April 2023: 6.3%). Komponen Makanan di rumah meningkat perlahaan kepada 4.3 peratus pada Mei 2023 berbanding 5.0 peratus yang direkodkan bulan sebelumnya. Namun bagi komponen Makanan di luar rumah mencatatkan kenaikan 8.1 peratus, berkadar sama seperti yang rekodkan pada April 2023. Kenaikan komponen Makan di rumah adalah didorong terutamanya oleh kenaikan subkumpulan Daging (7.8%); Susu, keju & telur (6.5%); Beras, roti & bijirin lain (6.0%) dan Gula, jem, madu, coklat & manisan (3.7%). Buah-buahan meningkat sebanyak 3.6 peratus dan Ikan & makanan laut meningkat 2.7 peratus. Manakala, kedua-dua subkumpulan Sayur-sayuran dan Minyak & lemak masing-masing menurun negatif 1.1 peratus dan negatif 0.4 peratus. Beberapa item bagi komponen Makanan di luar rumah yang mencatat peningkatan pada bulan ini iaitu Burger (16.6%) (April 2023: 9.5%) dan Ayam goreng (11.0%) (April 2023: 9.2%).

Subkumpulan Daging yang merangkumi Daging ayam, Daging lembu, Daging babi, Daging kambing, Daging kerbau dan Daging itik telah mencatatkan peningkatan lebih perlahaan kepada 7.8 peratus berbanding 9.2 peratus yang dicatatkan pada April 2023. Ayam yang merupakan komponen terbesar dalam subkumpulan ini (46.1%) telah meningkat 6.7 peratus berbanding 8.8 peratus pada bulan April 2023. Purata harga Ayam standard di Semenanjung Malaysia meningkat kepada RM9.92 sekilogram pada bulan Mei 2023 berbanding RM9.23 sekilogram pada Mei 2022 (April 2023: RM9.91), melebihi paras harga kawalan yang ditetapkan oleh Kerajaan iaitu RM9.40 sekilogram. Sementara itu, purata harga Ayam standard Malaysia meningkat kepada RM10.45 sekilogram berbanding RM9.70 sekilogram pada bulan Mei 2022 (April 2023: RM10.45). Selain itu, peningkatan pada subkumpulan ini turut didorong oleh peningkatan Daging babi (28.1%) dan Daging Itik (7.4%). Bagi perbandingan bulan ke bulan, kelas perbelanjaan Daging segar meningkat kepada 0.6 peratus (April 2023: 0.4%). Kenaikan ini disumbangkan oleh daging babi iaitu 1.8 peratus (April 2023: 0.7%) dan daging lembu kepada 0.5 peratus pada Mei 2023 (April 2023: 0.2%).

Selain itu, subkumpulan Susu, keju & telur menunjukkan peningkatan yang lebih rendah iaitu 6.5 peratus pada Mei 2023 berbanding 7.0 peratus pada bulan April 2023. Telur ayam yang menyumbang 22.8 peratus kepada subkumpulan tersebut meningkat lebih rendah 4.0 peratus pada Mei 2023 (April 2023: 4.1%). Sementara itu, kedua-dua Susu sejat dan Susu krimer manis masing-masing mereda kepada 13.4 peratus dan 11.7 peratus berbanding 14.4 peratus dan 12.1 peratus pada bulan April 2023. Subkumpulan Beras, roti & bijirin lain juga terus meningkat pada kadar lebih perlahan iaitu 6.0 peratus pada Mei 2023 (April 2023: 6.4%). Namun, Tepung gandum masih merekodkan peningkatan dua digit iaitu 15.3 peratus (April 2023: 20.2%). Antara produk makanan berasaskan tepung yang telah mencatatkan peningkatan yang lebih rendah adalah Mi basah dan Kuih muih tempatan.

Inflasi bagi subkumpulan Sayur-sayuran merekodkan penurunan ketara kepada negatif 1.1 peratus berbanding 0.7 peratus pada bulan April 2023. Namun begitu, perbandingan secara bulan ke bulan subkumpulan ini merekodkan peningkatan sebanyak 0.7 peratus berbanding negatif 3.5 peratus pada April 2023. Monsun Barat Daya yang bermula pada Mei 2023 dijangka berterusan sehingga September 2023 dan telah menyebabkan kebanyakan tempat di seluruh negara mengalami bilangan hari tanpa hujan yang lebih banyak. Ianya telah menjasakan bekalan beberapa jenis sayur-sayuran di pasaran dan secara langsung memberi tekanan harga kepada pengguna. Antara sayur-sayuran pilihan rakyat Malaysia yang mencatatkan peningkatan bulan ke bulan adalah Sawi (11.5%) (April 2023: -9.0%), Cili padi (9.2%) (April 2023: -1.7%), Salad (7.8%) (April 2023: -8.0%) dan Timun (1.6%) (April 2023: -11.7%).

Inflasi Pengangkutan meningkat lebih perlahan kepada 1.0 peratus pada Mei 2023 berbanding April 2023 (2.3%). Antara faktor yang menyumbang kepada kenaikan perlahan ini ialah penetapan harga Petrol tanpa plumbum RON97 yang lebih rendah (Mei 2023: RM3.35 seliter) berbanding RM4.26 seliter pada bulan Mei tahun lalu (April 2023: RM3.35). Walau bagaimanapun, kelas perbelanjaan bagi Pembaikan & penyelenggaraan untuk pengangkutan persendirian merekodkan peningkatan 9.6 peratus pada bulan Mei 2023 berbanding 10.6 peratus pada bulan April 2023. Kenaikan ini disumbangkan oleh Penyelenggaraan kereta dan motosikal yang meningkat kepada 10.8 peratus (April 2023: 12.5%).

Bagi inflasi di peringkat negeri, sembilan negeri merekodkan peningkatan di bawah paras nasional 2.8 peratus dengan Wilayah Persekutuan Labuan merekodkan peningkatan paling rendah sebanyak 1.2 peratus pada Mei 2023. Walau bagaimanapun, tujuh negeri merekodkan peningkatan melebihi paras inflasi nasional iaitu Sarawak (3.5%), Selangor (3.3%), Perak (3.2%), Wilayah Persekutuan Putrajaya (3.1%), Pahang (3.1%), Melaka (3.1%) dan Sabah (3.0%). Kesemua negeri mencatatkan peningkatan inflasi Makanan & Minuman Bukan Alkohol. Peningkatan tertinggi dicatatkan oleh Sarawak (7.6%), diikuti oleh Selangor (7.3%), Wilayah Persekutuan Putrajaya (7.1%), Melaka (6.1%) dan Pahang (6.0%). Sementara itu, negeri-negeri lain menunjukkan peningkatan di bawah paras inflasi Makanan & Minuman Bukan Alkohol nasional iaitu 5.9 peratus pada Mei 2023.

Inflasi keseluruhan secara bulanan pada Mei 2023 meningkat kepada 0.2 peratus berbanding April 2023 (0.1%). Ini disumbangkan terutamanya oleh Restoran & Hotel (0.6%), Makanan & Minuman Bukan Alkohol (0.5%) dan Perumahan, Air, Elektrik, Gas & Bahan Api Lain (0.5%). Inflasi teras mengukur perubahan harga barang dan perkhidmatan yang tidak termasuk item makanan segar yang tidak menentu dari segi harga serta barang dan perkhidmatan yang tertakluk dengan kawalan harga dari kerajaan meningkat lebih perlahan kepada 3.5 peratus (April 2023: 3.6%). Kenaikan ini didorong terutamanya oleh peningkatan perlahaan kumpulan Makanan & Minuman Bukan Alkohol yang mencatatkan kenaikan 7.1 peratus (April 2023: 7.2%) dan Restoran & Hotel (6.7%) (April 2023: 6.6%). Sementara itu, inflasi bagi kumpulan pendapatan bawah RM3,000, meningkat 3.1 peratus (April 2023: 3.4%). Peningkatan ini disumbangkan oleh kumpulan Makanan & Minuman Bukan Alkohol sebanyak 5.1 peratus dan terutamanya direkodkan oleh subkumpulan Daging (8.3%), diikuti oleh Susu, keju & telur (5.8%) dan Beras, roti & bijirin lain (5.5%).

Sementara itu, bagi perbandingan dengan inflasi negara lain, inflasi Zon Euro meningkat perlahan kepada 6.1 peratus pada Mei 2023 berbanding 7.0 peratus pada bulan sebelumnya, manakala inflasi di Amerika Syarikat mereda kepada 4.0 peratus pada Mei 2023 berbanding April 2023 (4.9%). Bagi perbandingan dengan negara-negara terpilih di rantau Asia Pasifik, kadar inflasi di Malaysia (2.8%) adalah lebih rendah berbanding inflasi di Republik Korea, Indonesia dan Filipina.




Inflasi Keseluruhan Malaysia, Januari 2011 – Mei 2023



Nota: *Purata inflasi bagi tempoh Januari 2011 hingga Mei 2023




Inflasi bagi Kumpulan Pendapatan Bawah RM3,000, Mei 2020 – Mei 2023




Taburan Inflasi Makanan dan Bukan Makanan yang Meningkat ≤10%, April 2023 & Mei 2023








Inflasi bagi Makanan & Minuman Bukan Alkohol, Mei 2020 – Mei 2023



Malaysia's inflation eased further to 2.8 per cent in May 2023

PUTRAJAYA, 23 June 2023 – Malaysia's inflation eased further to 2.8 per cent in May 2023 with the index points recorded at 130.2 as against 126.6 in the same month of the previous year. The Department of Statistics Malaysia (DOSM) reported today on the release of **CONSUMER PRICE INDEX (CPI), MAY 2023**.

According to the Department of Statistics Malaysia, the increase in Malaysia's inflation was still driven by the higher increase in Restaurants & Hotels (6.7%) as compared to April 2023 (6.6%). Nevertheless, the slower increase in some groups as compared to the previous month such as Food & Non-Alcoholic Beverages, 5.9 per cent (April 2023: 6.3%); Transport, 1.0 per cent (April 2023: 2.3%) and Furnishings, Household Equipment & Routine Household Maintenance, 2.7 per cent (April 2023: 3.0%), to a certain extent offset Malaysia's inflation from continuing to rise higher. The weight for the Food & Non-Alcoholic Beverages group (29.5%), Transport (14.6%) and Restaurants & Hotels (2.9%) comprise 47.0 per cent of the total weight for CPI which have a significant impact on the inflation rate and the cost of living.

Apart from that, the increase in Malaysia's inflation for May 2023 also contributed by the rise in Miscellaneous Goods & Services (2.9%); Furnishings, Household Equipment & Routine Household Maintenance group (2.7%); Health (1.9%) and Education (1.9%). Housing, Water, Electricity, Gas & Other Fuels and Recreation Services & Culture recorded an increase of 1.8 per cent respectively. This was followed by, Alcoholic Beverages & Tobacco (0.7%) and Clothing & Footwear (0.4%).

Food & Non-Alcoholic Beverages group which contributes 29.5 per cent of total CPI weight recorded a moderate increase of 5.9 per cent (April 2023: 6.3%). The component of Food at home increased slower to 4.3 per cent in May 2023 as compared to 5.0 per cent recorded in the previous month. However, the component of Food away from home recorded an increase of 8.1 per cent, the same rate as recorded in April 2023. The increase in the component of Food at home was mainly driven by the increase in the subgroup of Meat (7.8%); Milk, cheese & eggs (6.5%); Rice, bread & other cereals (6.0%) and Sugar, jam, honey, chocolate & confectionery (3.7%). Fruits increased 3.6 per cent and Fish & seafood increased 2.7 per cent. Meanwhile, both subgroup of Vegetables and Oils & fats decreased by negative 1.1 per cent and negative 0.4 per cent respectively. Some items in the component of Food away from home that recorded an increase in this month were Burger (16.6%) (April 2023: 9.5%) and Fried chicken (11.0%) (April 2023: 9.2%).

The subgroup of Meat which consists of Chicken, Beef, Pork, Lamb, Buffalo and Duck registered a slower increase of 7.8 per cent as compared to 9.2 per cent in April 2023. Chicken as the largest component in the subgroup (46.1%) increased by 6.7 per cent as against 8.8 per cent in April 2023. The average price of Standard chicken in Peninsular Malaysia increased to RM9.92 per kilogramme in May 2023 as compared to RM9.23 per kilogramme in May 2022 (April 2023: RM9.91), exceeding the control price set by the Government at RM9.40 per kilogramme. Meanwhile, the average price of Standard chicken in Malaysia increased to RM10.45 per kilogramme as compared to RM9.70 per kilogramme in May 2022 (April 2023: RM10.45). In addition, the increase in this subgroup was also driven by the increase in Pork (28.1%) and Duck (7.4%). On a monthly basis, expenditure class of Fresh meat increased at 0.6 per cent (April 2023: 0.4%). The increase was contributed by Pork 1.8 per cent (April 2023: 0.7%) and Beef 0.5 per cent in May 2023 (April 2023: 0.2%).

Other than that, the subgroup of Milk, cheese & eggs showed a slower increase of 6.5 per cent in May 2023 as against 7.0 per cent in April 2023. Chicken eggs which contribute 22.8 per cent weight to this subgroup, increased lower to 4.0 per cent in May 2023 (April 2023: 4.1%). Meanwhile, both Evaporated milk and Sweetened condensed milk eased at 13.4 per cent and 11.7 per cent as compared to 14.4 per cent and 12.1 per cent in April 2023 respectively. The subgroup of Rice, bread

& cereals inclined at a slower rate of 6.0 per cent in May 2023 (April 2023: 6.4%). However, Wheat flour recorded double-digit increase at 15.3 per cent (April 2023: 20.2%). Among the flour-based food products that have recorded a lower increase are Wet noodles and Local cakes.

Inflation for the Vegetables subgroup recorded a significant decrease to negative 1.1 per cent as compared to 0.7 per cent in April 2023. However, month-on-month the subgroup recorded an incline of 0.7 per cent as compared to negative 3.5 per cent in April 2023. The Southwest Monsoon which started in May 2023 is expected to continue until September 2023 and has caused several places to experience more dry days. It has affected the supply of some types of vegetables in the market and directly assert price pressure on consumers. Among the vegetables preferred by Malaysians that recorded a month-on-month increase were Choy sum (11.5%) (April 2023: -9.0%), Bird's eye chilli (9.2%) (April 2023: -1.7%), Lettuce (7.8%) (April 2023: -8.0%) and Cucumber (1.6%) (April 2023: -11.7%).

Inflation of Transport showed a slower increase of 1.0 per cent in May 2023 as compared to April 2023 (2.3%). Among the factor that contributed to the slower increase was the lower price of Unleaded Petrol RON97 (May 2023: RM3.35 per litre) as compared to RM4.26 per litre in May last year (April 2023: RM3.35). However, the expenditure class of Repair & maintenance for personal transport recorded increases in May 2023 at 9.6 per cent as compared to 10.6 per cent in April 2023. This increase was contributed by Car and motorcycle maintenance which increased to 10.8 per cent (April 2023: 12.5%).

For inflation at the state level, nine states recorded increases below the national inflation level of 2.8 per cent with Wilayah Persekutuan Labuan recorded the lowest increase of 1.2 per cent in May 2023. However, seven states recorded increases above the national inflation level namely Sarawak (3.5%), Selangor (3.3%), Perak (3.2%), Wilayah Persekutuan Putrajaya (3.1%), Pahang (3.1%), Melaka (3.1%) and Sabah (3.0%). All states registered an increase in the inflation of Food & Non-Alcoholic Beverages. The highest increase was recorded by Sarawak (7.6%), followed by Selangor (7.3%), Wilayah Persekutuan Putrajaya (7.1%), Melaka (6.1%)

and Pahang (6.0%). Meanwhile, other states showed an increase below the national inflation of Food & Non-Alcoholic Beverages of 5.9 per cent in May 2023.

The monthly headline inflation in May 2023 increased at 0.2 per cent as against April 2023 (0.1%). This was mainly contributed by Restaurants & Hotels (0.6%), Food & Non-Alcoholic Beverages (0.5%) and Housing, Water, Electricity, Gas & Other Fuels (0.5%). Core inflation which measures changes in the prices of all goods and services, excluding volatile prices of fresh food as well as administered prices of goods by the government increased slower at 3.5 per cent (April 2023: 3.6%). The increase was mainly due to a slower increase in Food & Non-Alcoholic Beverages group which recorded 7.1 per cent (April 2023: 7.2%) and Restaurants & Hotels (6.7%) (April 2023: 6.6%). Meanwhile, the inflation for the income group below RM3,000, increased by 3.1 per cent (April 2023: 3.4%). The increase was attributed by Food & Non-Alcoholic Beverages group at 5.1 per cent and was mainly recorded for the subgroup of Meat (8.3%), followed by Milk, cheese & eggs (5.8%) and Rice, bread & other cereals (5.5%).

Meanwhile, in comparison to inflation of other countries, the Eurozone inflation increased slower to 6.1 per cent in May 2023 as compared to 7.0 per cent in the previous month, while the inflation rate in the United States of America eased to 4.0 per cent in May 2023 as against April 2023 (4.9%). In comparison to selected countries in the Asia Pacific region, the inflation rate in Malaysia (2.8%) was lower than the inflation in Republic of Korea, Indonesia and Philippines.



Malaysia Headline Inflation, Core Inflation and Inflation without Fuel, May 2022 – May 2023



Inflation for Income Group Below RM3,000, May 2020 – May 2023



Inflation by Quadrant, April 2023 & May 2023



Distribution of Inflation for Food and Non-Food that Increased $\leq 10\%$, April 2023 & May 2023



Inflation of Selected Food for Income Group Below RM3,000, May 2021 – May 2023



Average Price of Unleaded Petrol RON95, Unleaded Petrol RON97 and Diesel, May 2022 – May 2023



Inflation for Food & Non-Alcoholic Beverages, May 2020 – May 2023



Inflation by State, April 2023 & May 2023



Inflation of Selected Countries, May 2021 – May 2023



