INDEKS HARGA PENGELOUAR PERKHIDMATAN, MALAYSIA
SUKU TAHUN KETIGA 2023**

Indeks Harga Pengeluar Perkhidmatan meningkat 1.4 peratus pada Suku Tahun Ketiga 2023

PUTRAJAYA, 6 November 2023 – Satu laporan **INDEKS HARGA PENGELOUAR PERKHIDMATAN (IHPRP), SUKU TAHUN KETIGA 2023** yang mengukur perubahan harga pengeluar bagi sektor perkhidmatan tempatan di Malaysia telah diterbitkan oleh Jabatan Perangkaan Malaysia pada hari ini. IHPRP mencatatkan 115.4 mata pada suku tahun ketiga 2023, peningkatan 1.4 peratus berbanding 113.8 pada suku yang sama tahun sebelumnya.

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin menjelaskan dalam kenyataannya, “Semua subsektor merekodkan peningkatan pada suku ini kecuali indeks Maklumat & Komunikasi yang kekal tidak berubah. Penginapan dan Aktiviti Perkhidmatan Makanan & Minuman meningkat 4.6 peratus (ST2 2023: 6.3%) disebabkan oleh peningkatan dalam Restoran & Aktiviti Perkhidmatan Makanan Bergerak (5.2%) dan Pengangkutan merekodkan peningkatan marginal 0.7 peratus (ST2 2023: 4.8%) disebabkan oleh Pengangkutan Udara (1.5%). Pada masa yang sama, subsektor lain yang merekodkan kenaikan adalah Pendidikan (1.0%), Kesenian, Hiburan & Rekreasi (0.8%) dan Profesional (0.4%). Sementara itu, indeks Aktiviti Hartanah dan Kesihatan masing-masing mencatatkan peningkatan sebanyak 0.2 peratus.”

Beliau mengulas lanjut, “Perbandingan Suku tahun ke suku tahun menunjukkan IHPRP meningkat 0.4 peratus berbanding 0.2 peratus yang dilaporkan pada suku tahun sebelumnya. Ini disebabkan oleh kenaikan terutamanya dalam indeks Kesenian, Hiburan & Rekreasi (3.0%), Penginapan dan Aktiviti Perkhidmatan Makanan & Minuman (0.9%),

Pendidikan (0.3%) dan Aktiviti Hartanah (0.2%). Manakala indeks Pengangkutan, Profesional, Kesihatan dan Maklumat & Komunikasi kekal tidak berubah.”



SERVICES PRODUCER PRICE INDEX, MALAYSIA
THIRD QUARTER 2023**

***The Services Producer Price Index increased by 1.4 per cent
in the Third Quarter of 2023***

PUTRAJAYA, November 6th, 2023 – A report on the **SERVICES PRODUCER PRICE INDEX (SPPI), THIRD QUARTER 2023**, which measures changes in producer prices for Malaysia's domestic services sector, was released today by the Department of Statistics Malaysia. The SPPI averaged 115.4 points in the third quarter of 2023, an increase of 1.4 per cent as compared to 113.8 in the same quarter of the preceding year.

The Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin explained in the statement that, “All subsectors recorded an increase in this quarter except the index of Information & Communication which remained unchanged. The Accommodation and Food & Beverage Service Activities rose by 4.6 per cent (Q2 2023: 6.3%) attributed to the increase in Restaurants & Mobile Food Service Activities (5.2%) and Transportation recorded a marginal increase of 0.7 per cent (Q2 2023: 4.8%) due to the Air Transport (1.5%). In the meantime, the other subsectors that recorded an increase were Education (1.0%), Arts, Entertainment & Recreation (0.8%) and Professional (0.4%). Meanwhile, the index of Real Estate Activities and Health both increased by 0.2 per cent, respectively.”

He further elaborated that, “On a quarter-on-quarter basis comparison shows that SPPI increased by 0.4 per cent as compared to 0.2 per cent recorded in the previous quarter. This was due to the increase particularly in Arts, Entertainment & Recreation (3.0%), Accommodation and Food & Beverage Service Activities (0.9%), Education (0.3%) and Real

Estate Activities (0.2%) subsectors. Meanwhile, the index of Transportation, Professional, Health and Information & Communication remained unchanged."


