**Jualan Perdagangan Borong & Runcit meningkat 6.5 peratus kepada
RM142.3 bilion pada Oktober 2023**

PUTRAJAYA, 11 DISEMBER 2023 – Perdagangan Borong & Runcit Malaysia mencatatkan nilai jualan berjumlah RM142.3 bilion, meningkat 6.5 peratus tahun ke tahun pada Oktober 2023. Walau bagaimanapun, nilai jualan jatuh marginal -0.3 peratus berbanding September 2023. Ini dilaporkan oleh Jabatan Perangkaan Malaysia (DOSM) hari ini dalam siaran **PRESTASI PERDAGANGAN BORONG & RUNCIT, OKTOBER 2023**. Laporan ini juga memaparkan statistik nilai jualan dan indeks volum bagi Perdagangan Borong & Runcit mengikut subsektor serta indeks jualan runcit melalui internet.

Dalam satu kenyataan hari ini, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia berkata, "Peningkatan sebanyak 6.5 peratus tahun ke tahun bagi Perdagangan Borong & Runcit pada Oktober 2023 disumbangkan oleh subsektor Perdagangan Borong yang meningkat 5.7 peratus atau RM3.4 bilion kepada RM63.3 bilion. Perdagangan Runcit juga berkembang dengan mencatatkan 3.9 peratus atau RM2.3 bilion kepada RM60.6 bilion, diikuti oleh

Kenderaan Bermotor dengan pertumbuhan dua digit 19.1 peratus atau RM3.0 bilion untuk berada pada RM18.4 bilion.”

Sementara itu, penurunan marginal -0.3 peratus berbanding bulan sebelumnya adalah disebabkan oleh Perdagangan Borong yang menguncup -1.4 peratus, diikuti oleh Perdagangan Runcit dengan -0.8 peratus. Sebaliknya, Kenderaan Bermotor kembali mencatatkan pertumbuhan positif 5.2 peratus.

Melihat kepada prestasi mengikut subsektor, Ketua Perangkawan memaklumkan, “Pertumbuhan 5.7 peratus tahun ke tahun bagi Perdagangan Borong disumbangkan oleh Lain-lain Pengkhususan Jualan Borong yang meningkat RM1.7 bilion atau 7.5 peratus kepada RM24.4 bilion. Ini diikuti oleh Jualan Borong Barangan Isi Rumah (4.7%), Jual Borong Bahan Mentah Pertanian & Haiwan Hidup (8.9%), Jualan Borong Makanan, Minuman & Tembakau (3.3%), Jualan Borong Jentera, Peralatan & Bekalan (3.4%), Perdagangan Borong Tanpa Pengkhususan (5.7%) dan Jual Borong Berdasarkan Kontrak atau Yuran (4.2%). Walau bagaimanapun, bagi perbandingan bulanan, Perdagangan Borong jatuh -1.4 peratus, terutamanya disebabkan oleh Lain-lain Pengkhususan Jualan Borong (-2.8%), Jualan Borong Makanan, Minuman & Tembakau (-2.5%) dan Jual Borong Bahan Mentah Pertanian & Haiwan Hidup (-3.5%).”

Mengulas lanjut mengenai subsektor Perdagangan Runcit, kenaikan 3.9 peratus tahun ke tahun pada bulan ini disokong oleh Jualan Runcit di Kedai Bukan Pengkhususan yang tumbuh 6.1 peratus atau RM1.3 bilion kepada RM22.9 bilion. Kumpulan lain dalam subsektor ini turut merekodkan pertumbuhan positif iaitu Jualan Runcit Makanan, Minuman & Tembakau (10.8%), Jualan Runcit di Kedai Pengkhususan (2.2%), Jualan Runcit Bahan Api Kenderaan (4.8%), Jualan Runcit Barangan Isi Rumah (2.0%), Jualan Runcit Barangan Kesenian & Rekreasi (1.5%), Jualan Runcit di Gerai & Pasar (5.2%) dan Jualan Runcit Bukan di Kedai, Gerai atau Pasar (0.2%). Sebaliknya, bagi perbandingan bulan ke bulan, jualan

subsektor ini turun -0.8 peratus, didorong oleh Jualan Runcit di Kedai Bukan Pengkhususan (-1.2%), Jualan Runcit di Kedai Pengkhususan (-1.1%), Jualan Runcit Kelengkapan Informasi & Komunikasi (-1.4%) dan Jualan Runcit Makanan, Minuman & Tembakau (-1.3%).

Dato' Sri Dr. Mohd Uzir Mahidin turut menerangkan, “Pertumbuhan tahun ke tahun sebanyak 19.1 peratus bagi subsektor Kenderaan Bermotor pada bulan ini dipacu oleh Jualan Kenderaan Bermotor yang melonjak 24.6 peratus atau RM2.0 bilion untuk merekodkan RM10.3 bilion. Ini diikuti oleh Jualan Komponen & Aksesori Kenderaan Bermotor (16.1%) dan Penyelenggaraan & Pembaikan Kenderaan Bermotor (17.7%). Bagi perbandingan bulanan, subsektor ini tumbuh 5.2 peratus, disokong oleh Jualan Kenderaan Bermotor (8.6%), Jualan, Penyelenggaraan & Pembaikan Motosikal (7.0%), Jualan Komponen & Aksesori Kenderaan Bermotor (0.4%) dan Penyelenggaraan & Pembaikan Kenderaan Bermotor (0.5%).”

Bagi indeks jualan runcit melalui internet, indeks ini jatuh -0.3 peratus tahun ke tahun pada Oktober 2023 berbanding 2.0 peratus pada September 2023. Bagi nilai pelarasan musim, indeks ini merosot -1.5 peratus berbanding bulan sebelum.

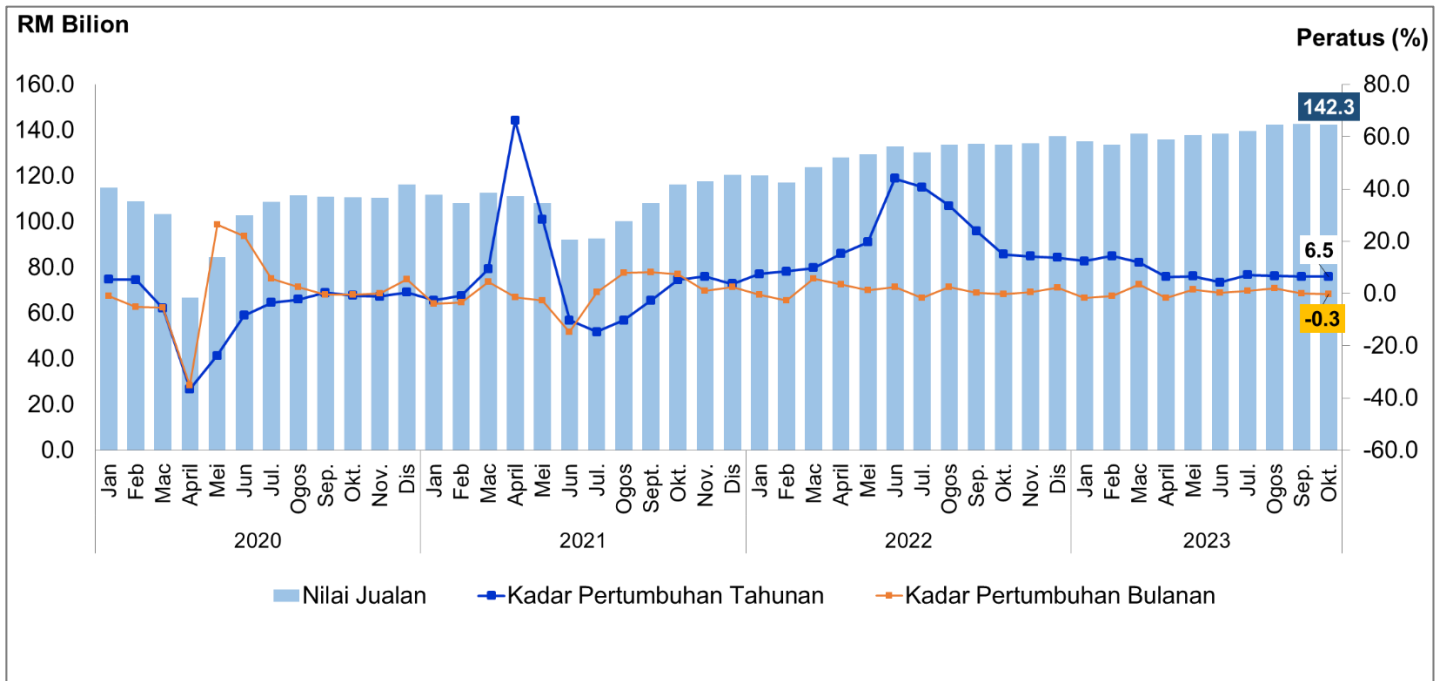
Beralih kepada indeks volum, Perdagangan Borong & Runcit pada Oktober 2023 mencatatkan pertumbuhan tahun ke tahun sebanyak 4.5 peratus. Pengembangan ini disumbangkan oleh semua subsektor iaitu Kenderaan Bermotor (15.8%), Perdagangan Borong (4.7%) dan Perdagangan Runcit (2.3%). Sebaliknya, bagi indeks volum pelarasan musim, ia menurun -2.2 peratus bulan ke bulan.

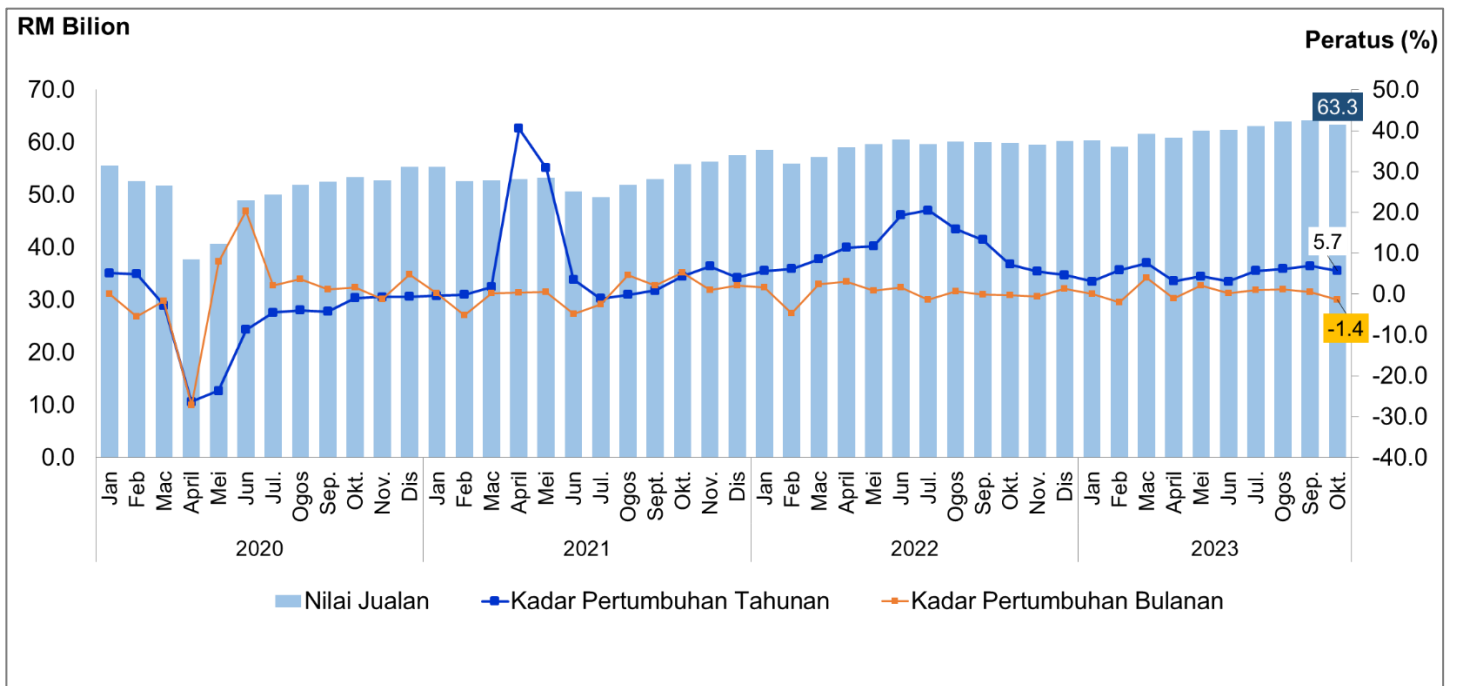

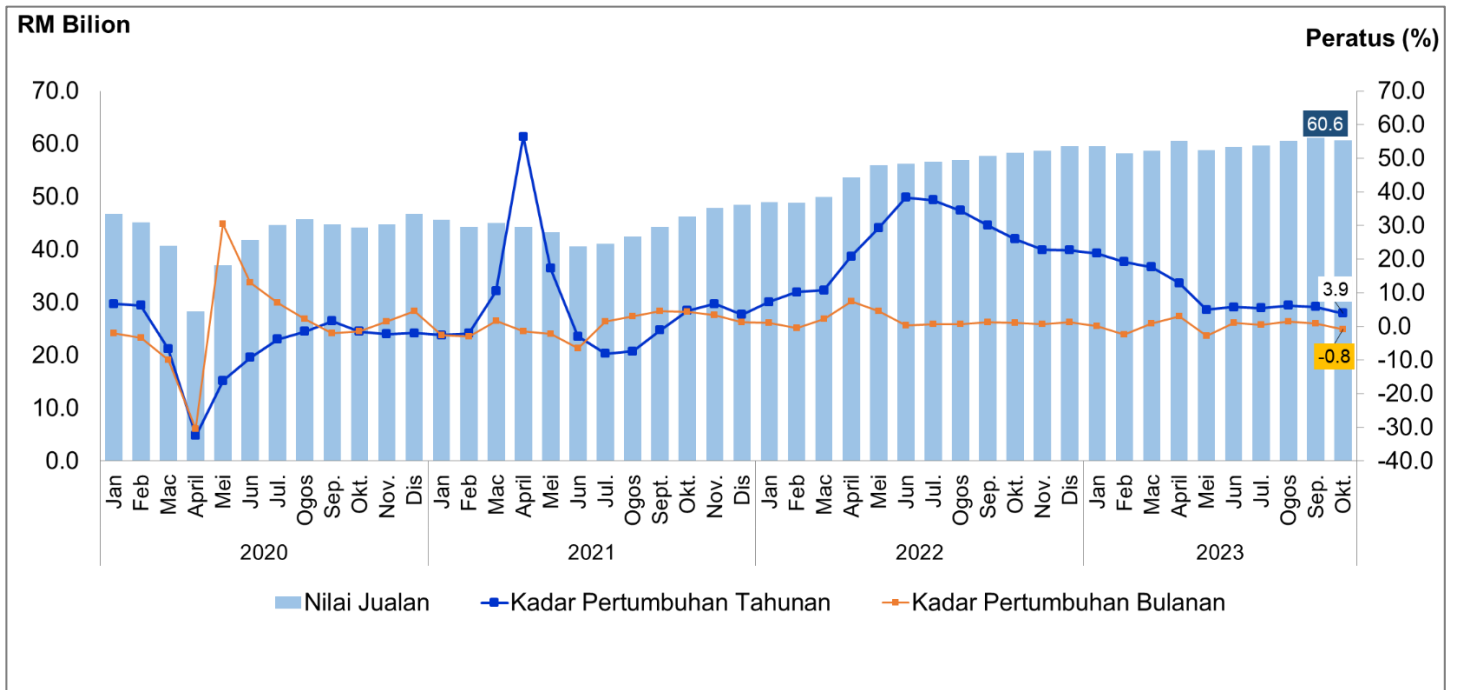
Carta 1: Nilai Jualan Perdagangan Borong & Runcit



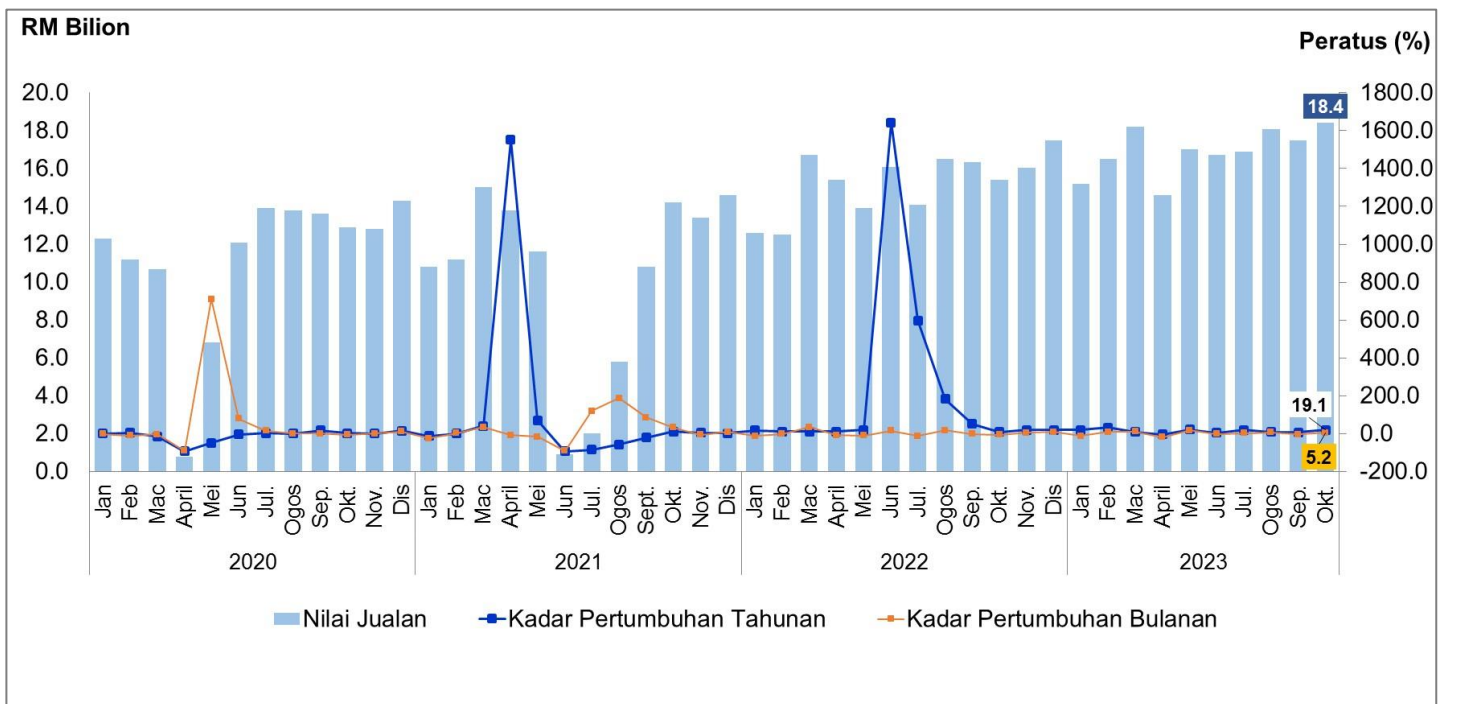
Carta 2: Nilai Jualan Perdagangan Borong



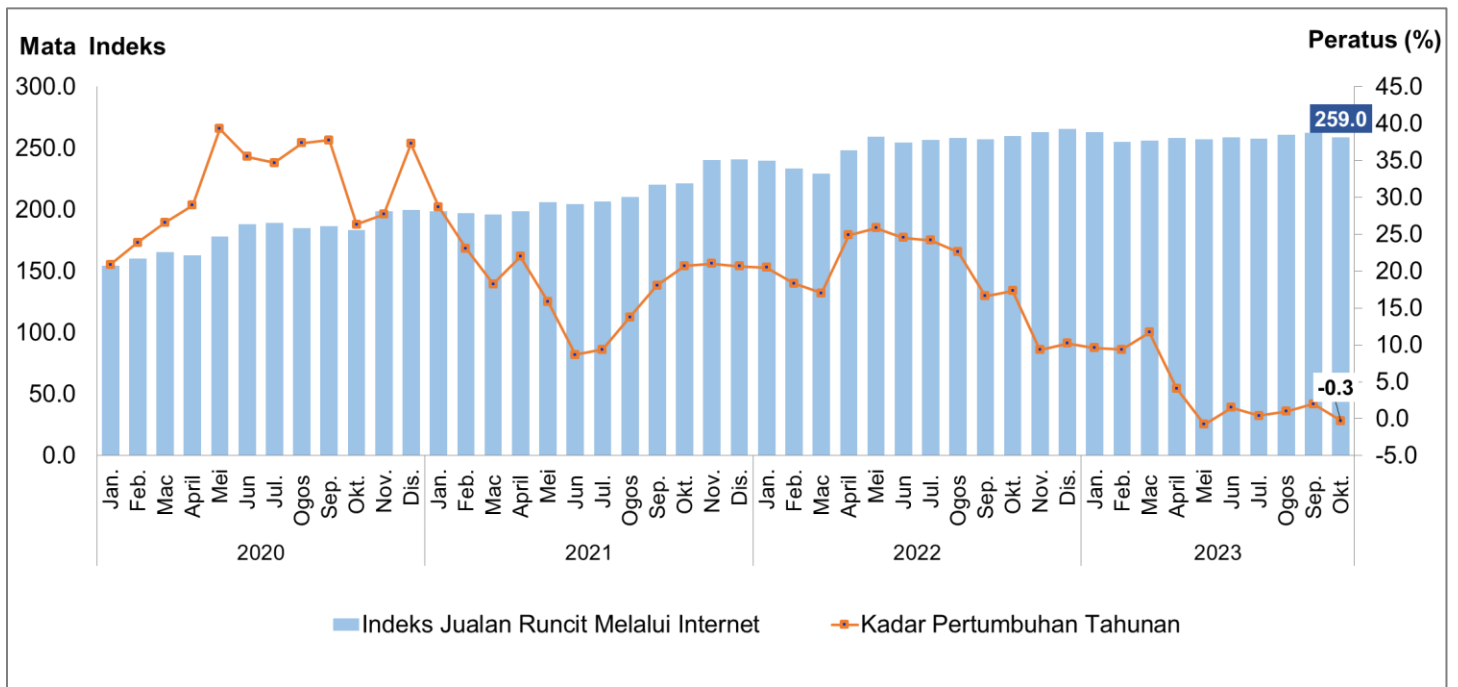
Carta 3: Nilai Jualan Perdagangan Runcit

***Wholesale & Retail Trade sales up 6.5 per cent to RM142.3 billion in
October 2023***

PUTRAJAYA, DECEMBER 11, 2023 – Malaysia's Wholesale & Retail Trade recorded sales value of RM142.3 billion, increased 6.5 per cent year-on-year in October 2023. However, sales value fell marginally -0.3 per cent as compared to September 2023. This is reported by Department of Statistics Malaysia (DOSM) in today's release of **PERFORMANCE OF WHOLESALE & RETAIL TRADE, OCTOBER 2023**. The report also presents statistics on sales value and volume index of Wholesale & Retail Trade by sub-sector as well as index of retail sales over the internet.

In a statement today, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia said, "The increase of 6.5 per cent year-on-year for Wholesale & Retail Trade in October 2023 was driven by Wholesale Trade sub-sector, which rose 5.7 per cent or RM3.4 billion to register RM63.3 billion. Retail Trade also expanded by registering 3.9 per cent or RM2.3 billion to RM60.6 billion, followed by Motor

Vehicles with a double-digit growth of 19.1 per cent or RM3.0 billion to settle at RM18.4 billion.”

Meanwhile, the marginal decrease of -0.3 per cent from the previous month was attributed to Wholesale Trade which contracted -1.4 per cent, followed by Retail Trade with -0.8 per cent. On the other hand, Motor Vehicles rebounded 5.2 per cent.

Looking at the performance across sub-sectors, the Chief Statistician informed, “The growth of 5.7 per cent year-on-year in Wholesale Trade was contributed by Other Specialised Wholesale which rose RM1.7 billion or 7.5 per cent to RM24.4 billion. This was followed by Wholesale of Household Goods (4.7%), Wholesale of Agricultural Raw Materials & Live Animals (8.9%), Wholesale of Food, Beverages & Tobacco (3.3%), Wholesale of Machinery, Equipment & Supplies (3.4%), Non-specialised Wholesale Trade (5.7%), and Wholesale on a Fee or Contract Basis (4.2%). However, for monthly comparison, Wholesale Trade decreased -1.4 per cent, mainly due to Other Specialised Wholesale (-2.8%), Wholesale of Food, Beverages & Tobacco (-2.5%), and Wholesale of Agricultural Raw Materials & Live Animals (-3.5%).”

Commenting further on Retail Trade sub-sector, the increase of 3.9 per cent year-on-year in this month was supported by Retail Sales in Non-specialised Stores which grew 6.1 per cent or RM1.3 billion to RM22.9 billion. Other groups in this sub-sector also recorded positive growth namely Retail Sales of Food, Beverages & Tobacco (10.8%), Retail Sales in Specialised Stores (2.2%), Retail Sales of Automotive Fuel (4.8%), Retail Sales of Household Goods (2.0%), Retail Sales of Cultural & Recreation Goods (1.5%), Retail Sales in Stalls & Market (5.2%), and Retail Sales Not in Stores, Stalls or Market (0.2%). Conversely, for month-on-month comparison, sales of this sub-sector edged down -0.8 per cent, pulled down by Retail Sales in Non-specialised Stores (-1.2%), Retail Sales in

Specialised Stores (-1.1%), Retail Sales of Information & Communication Equipment (-1.4%), and Retail Sales of Food, Beverages & Tobacco (-1.3%).

Dato' Sri Dr. Mohd Uzir Mahidin also informed, "The year-on-year growth of 19.1 per cent for Motor Vehicles sub-sector in this month was fueled by Sales of Motor Vehicles which accelerated 24.6 per cent or RM2.0 billion to record RM10.3 billion. This was followed by Sales of Motor Vehicles Parts & Accessories (16.1%) and Maintenance & Repair of Motor Vehicles (17.7%). For monthly comparison, this sub-sector grew 5.2 per cent, supported by Sales of Motor Vehicles (8.6%), Sales, Maintenance & Repair of Motorcycles (7.0%), Sales of Motor Vehicles Parts & Accessories (0.4%), and Maintenance & Repair of Motor Vehicles (0.5%)."

For index of retail sale over the internet, the index went down -0.3 per cent year-on-year in October 2023 as compared to 2.0 per cent in September 2023. For seasonally adjusted value, the index declined -1.5 per cent as against the previous month.

In terms of volume index, Wholesale & Retail Trade for October 2023 registered a year-on-year growth of 4.5 per cent. The expansion was attributed to all sub-sectors namely Motor Vehicles (15.8%), Wholesale Trade (4.7%), and Retail Trade (2.3%). However, for seasonally adjusted volume index, it decreased -2.2 per cent month-on-month.

Chart 1: Sales Value of Wholesale & Retail Trade

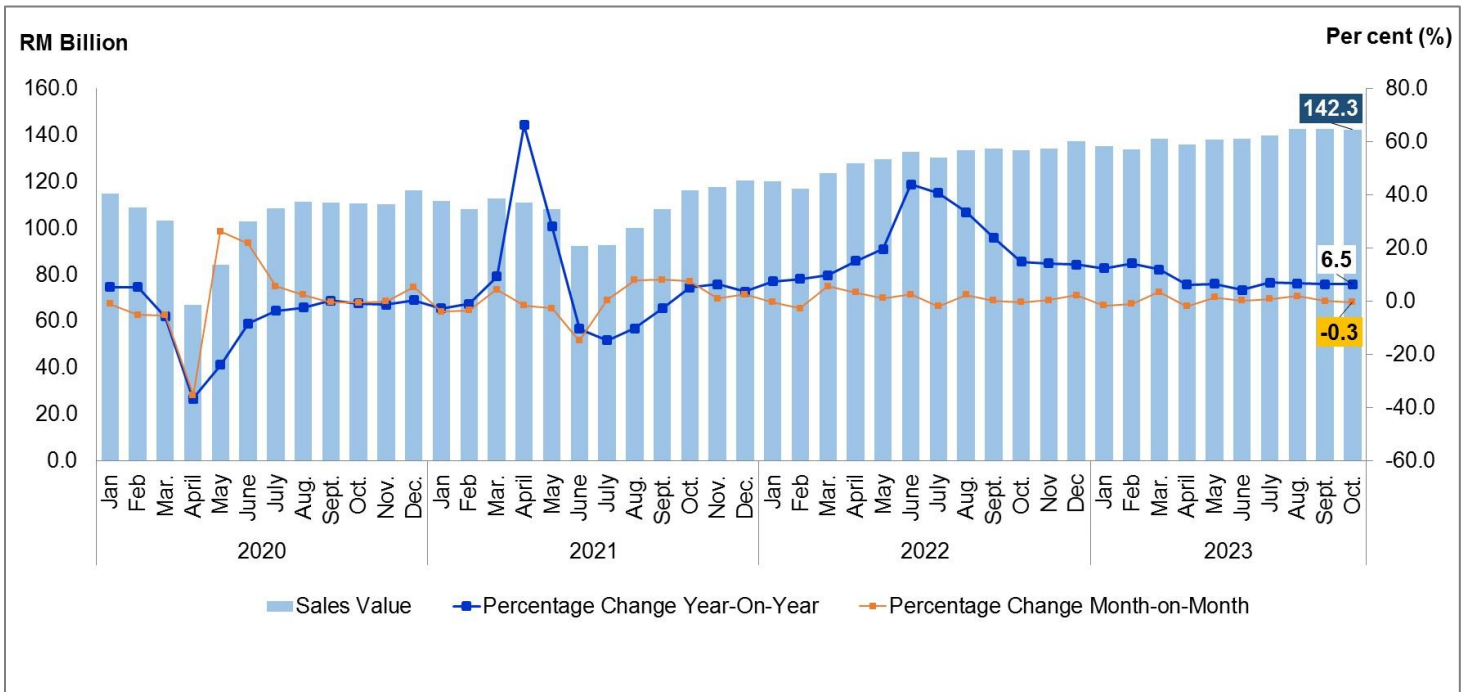


Chart 2: Sales Value of Wholesale Trade

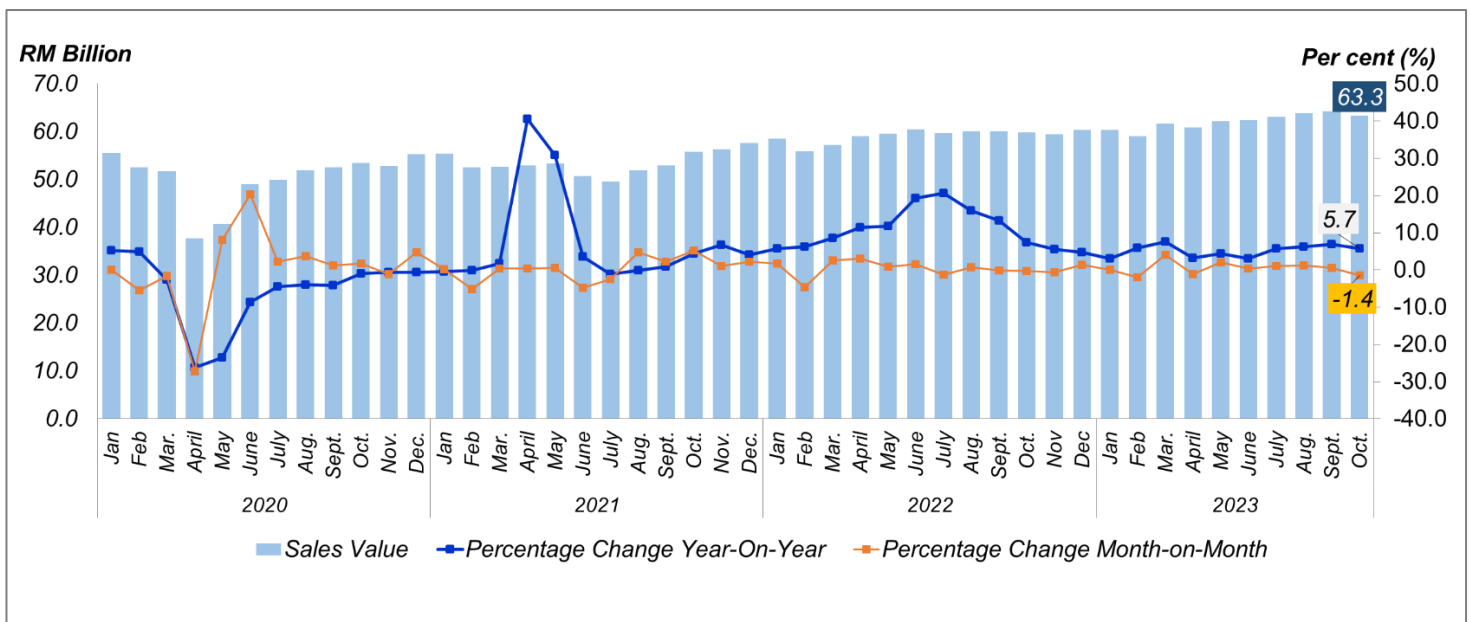


Chart 3: Sales Value of Retail Trade

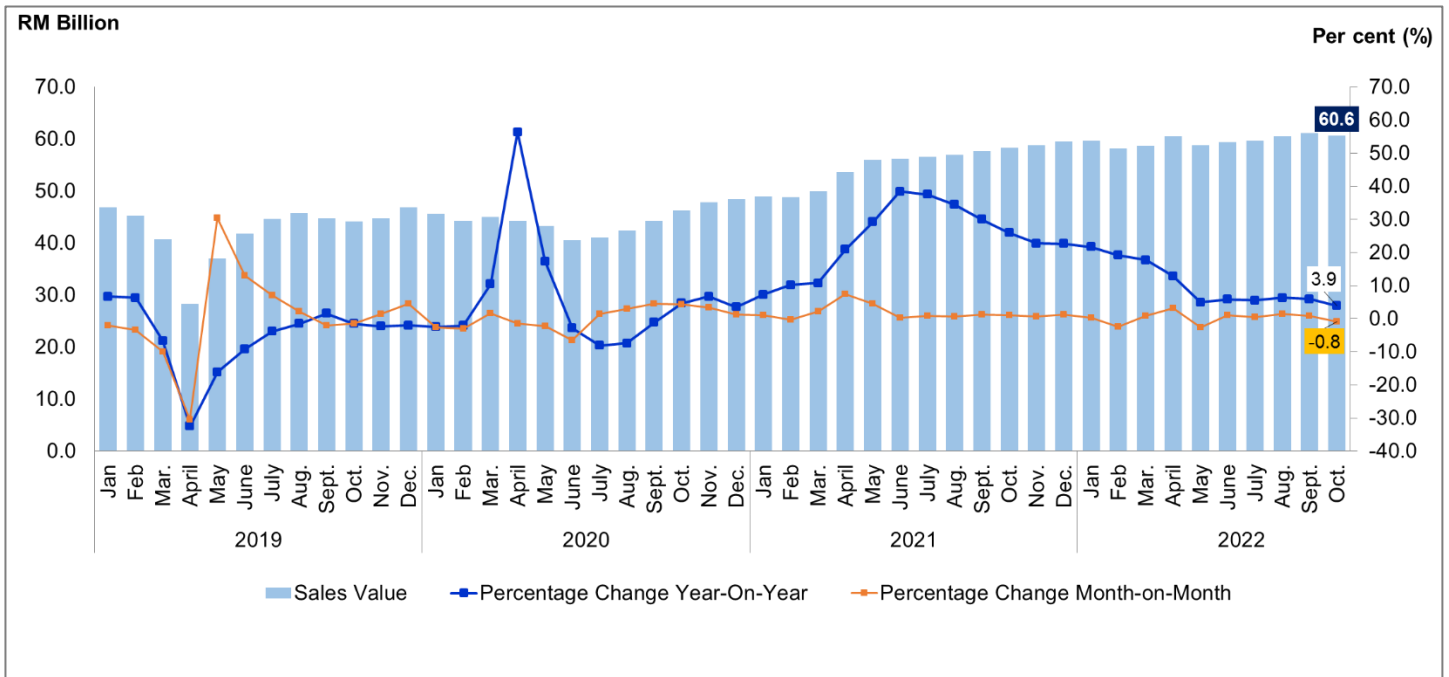


Chart 4: Sales Value of Motor Vehicles

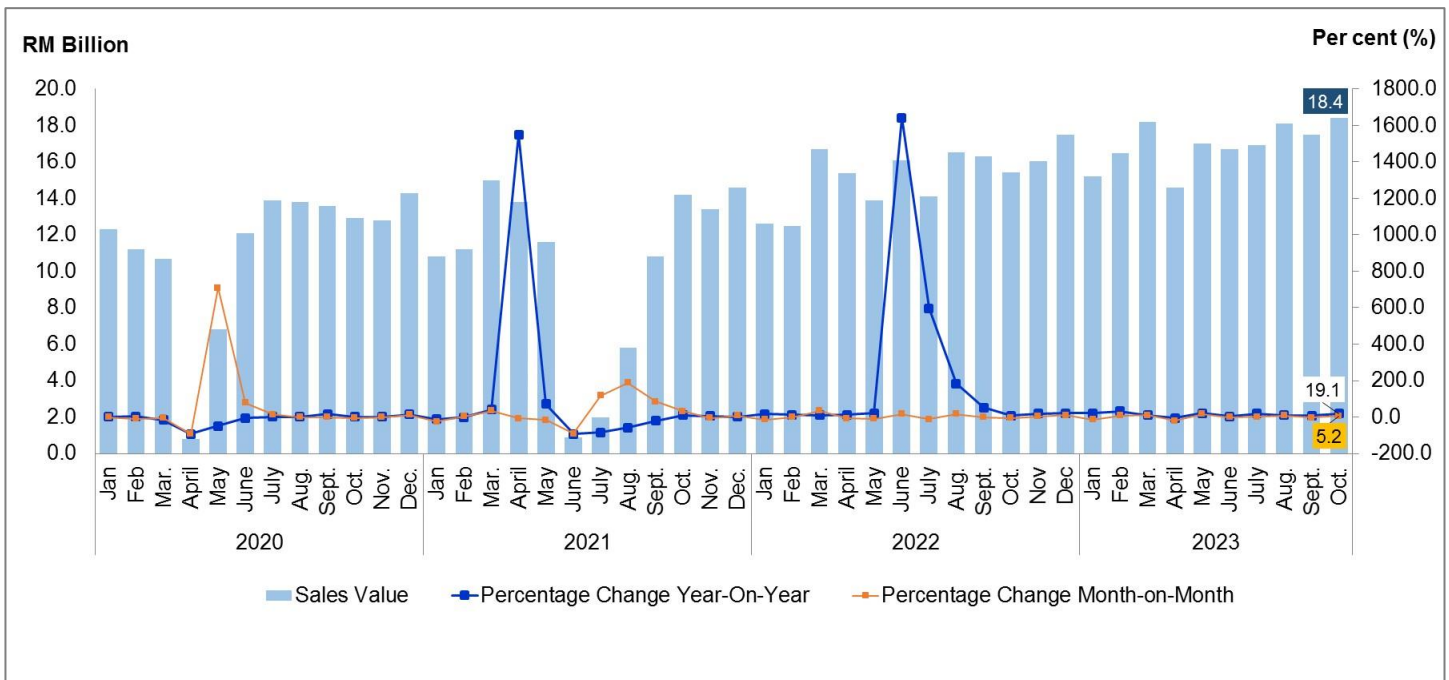
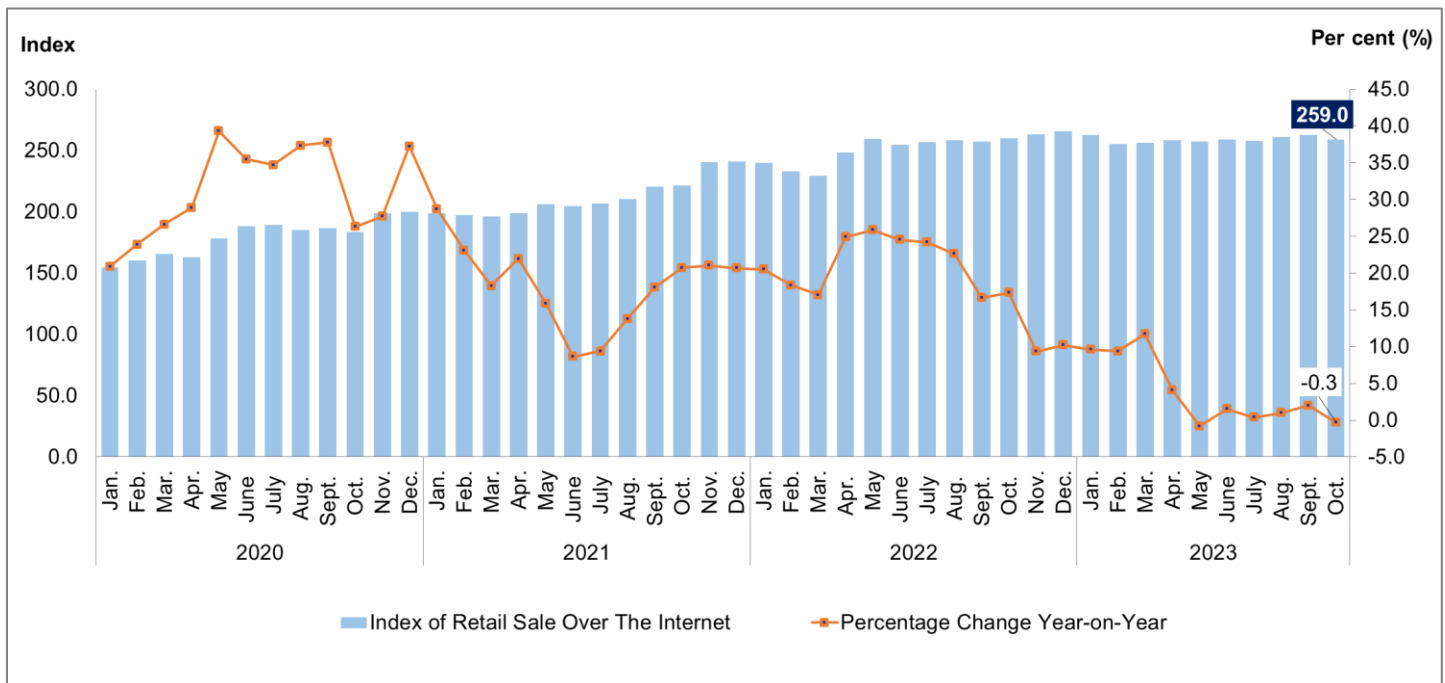


Chart 5: Index of Retail Sale Over the Internet
