BAGI INDEKS VOLUM PERDAGANGAN BORONG & RUNCIT, MALAYSIA, SUKE TAHUN KEEMPAT 2023

Indeks Volum Perdagangan Borong & Runcit meningkat 4.2 peratus pada suku tahun keempat 2023

PUTRAJAYA, 8 FEBRUARI 2024 – Indeks volum Perdagangan Borong & Runcit Malaysia merekodkan pertumbuhan 4.2 peratus tahun ke tahun pada suku tahun keempat 2023 untuk mencapai 153.1 mata, menjadikan prestasi keseluruhan tahun 2023 kepada 5.6 peratus berbanding 2022. Ini dilaporkan oleh Jabatan Perangkaan Malaysia (DOSM) pada hari ini dalam siaran **INDEKS VOLUM PERDAGANGAN BORONG & RUNCIT (2015=100), SUKE TAHUN KEEMPAT 2023**. Laporan ini juga membentangkan statistik mengenai indeks volum Perdagangan Borong & Runcit mengikut subsektor.

Mengulas laporan tersebut, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia dalam satu kenyataan hari ini berkata, “Peningkatan 4.2 peratus tahun ke tahun disumbangkan oleh subsektor Kenderaan Bermotor yang melonjak 9.8 peratus, diikuti oleh Perdagangan Borong dan Perdagangan Runcit yang meningkat masing-masing 4.6 peratus dan 2.9 peratus. Bagi perbandingan suku tahun ke suku tahun, indeks volum naik 0.8 peratus, disokong oleh Kenderaan Bermotor yang bertumbuh 3.7 peratus.”

Beralih kepada prestasi mengikut subsektor, Dato' Sri Dr. Mohd Uzir Mahidin memaklumkan, "Pertumbuhan positif 9.8 peratus bagi indeks volum subsektor Kenderaan Bermotor disokong oleh Jualan Kenderaan Bermotor dengan 13.1 peratus, diikuti oleh Jualan Komponen & Aksesori Kenderaan Bermotor dan Penyelenggaraan & Pembaikan Kenderaan Bermotor masing-masing dengan 12.1 peratus dan 10.3 peratus. Bagi perbandingan suku tahun ke suku tahun, indeks volum Kenderaan Bermotor meningkat 3.7 peratus."

Mengulas lanjut prestasi indeks volum Perdagangan Borong, beliau seterusnya memaklumkan peningkatan sebanyak 4.6 peratus bagi subsektor ini disumbangkan oleh Jualan Borong Bahan Mentah Pertanian & Haiwan Hidup dengan 8.4 peratus. Ini diikuti Lain-lain Pengkhususan Jualan Borong (7.7%), Jualan Borong Barang Isi Rumah (3.3%), Perdagangan Borong Tanpa Pengkhususan (2.7%), Jualan Borong Jentera, Peralatan & Bekalan (2.4%), Jual Borong Berdasarkan Kontrak atau Yuran (2.2%) dan Jualan Borong Makanan, Minuman & Tembakau (1.5%). Sebaliknya, bagi perbandingan suku tahunan, indeks volum Perdagangan Borong jatuh -0.8 peratus.

Dato' Sri Dr. Mohd Uzir Mahidin turut memaklumkan, "Indeks volum subsektor Perdagangan Runcit merekodkan pertumbuhan positif 2.9 peratus disumbangkan oleh Jualan Runcit Makanan, Minuman & Tembakau dengan 8.4 peratus. Ini diikuti oleh Jualan Runcit di Kedai Bukan Pengkhususan (5.0%), Jualan Runcit Bahan Api Kenderaan (4.4%), Jualan Runcit di Gerai & Pasar (4.2%) dan Jualan Runcit Peralatan Isi Rumah (3.6%). Bagi perbandingan suku tahun, indeks volum Perdagangan Runcit naik 1.5 peratus berbanding suku tahun lepas."

"Bagi indeks volum pelarasan musim, Perdagangan Borong & Runcit merosot -2.6 peratus berbanding suku tahun ketiga 2023, dipengaruhi oleh pertumbuhan negatif bagi semua subsektor iaitu Kenderaan Bermotor (-8.2%), Perdagangan Borong (-3.6%) dan Perdagangan Runcit (-1.4%)," jelas beliau.



FOR VOLUME INDEX OF WHOLESALE & RETAIL TRADE, MALAYSIA, FOURTH QUARTER 2023

***Wholesale & Retail Trade Volume Index rose 4.2 per cent
in fourth quarter 2023***

PUTRAJAYA, FEBRUARY 8, 2024 – Volume index of Wholesale & Retail Trade Malaysia registered a growth of 4.2 per cent year-on-year in fourth quarter of 2023 to reach 153.1 points, bringing the overall performance for 2023 to 5.6 per cent as compared to 2022. This is reported by Department of Statistics Malaysia (DOSM) in today's release of **VOLUME INDEX OF WHOLESALE & RETAIL TRADE (2015=100), FOURTH QUARTER 2023**. This report also presents statistics on volume index of Wholesale & Retail Trade by sub-sector.

Commenting on the report, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia in a statement today said, "The year-on-year increase of 4.2 per cent was attributed to Motor Vehicles sub-sector which soared 9.8 per cent, followed by Wholesale Trade and Retail Trade which increased 4.6 per cent and 2.9 per cent, respectively. For quarter-on-quarter comparison, volume index edged up 0.8 per cent, supported by Motor Vehicles which grew 3.7 per cent."

Moving on to performance across sub-sectors, Dato' Sri Dr. Mohd Uzir Mahidin added to note that, "The positive growth of 9.8 per cent in volume index of Motor Vehicles was supported by Sales of Motor Vehicles with 13.1 per cent, followed by Sales of Motor Vehicles Parts & Accessories and Maintenance & Repair of Motor Vehicles with 12.1 per cent and 10.3 per cent, respectively. For quarter-on-quarter comparison, volume index of Motor Vehicles increased 3.7 per cent."

Commenting further on the performance of volume index of Wholesale Trade, he pointed out that the increase of 4.6 per cent in this sub-sector was contributed by Wholesale of Agricultural Raw Materials & Live Animals with 8.4 per cent. This was followed by Other Specialised Wholesale (7.7%), Wholesale of Household Goods (3.3%), Non-specialized Wholesale Trade (2.7%), Wholesale of Machinery, Equipment & Supplies (2.4%), Wholesale on a Fee or Contract Basis (2.2%), and Wholesale of Food, Beverages & Tobacco (1.5%). Conversely, for quarterly comparison, volume index of Wholesale Trade went down -0.8 per cent.

Dato' Sri Dr. Mohd Uzir Mahidin added to note that, "Volume index of Retail Trade recorded a positive growth of 2.9 per cent, contributed by Retail Sales of Food, Beverages & Tobacco with 8.4 per cent. This was followed by Retail Sales in Non-Specialised Stores (5.0%), Retail Sales of Automotive Fuel (4.4%), Retail Sales via Stalls & Markets (4.2%), and Retail Sales of Household Goods (3.6%). For quarterly comparison, volume index of Retail Trade increased 1.5 per cent as compared to the previous quarter."

"As for seasonally adjusted volume index, Wholesale & Retail Trade declined -2.6 per cent as against the third quarter of 2023 due to the negative growth in all sub-sectors namely, Motor Vehicles (-8.2%), Wholesale Trade (-3.6%), and Retail Trade (-1.4%)," he explained.
