BAGI PRESTASI PERDAGANGAN BORONG & RUNCIT, MALAYSIA, MEI 2024

**Jualan Perdagangan Borong & Runcit pada Mei 2024 melonjak
7.1 peratus, mencapai jumlah keseluruhan sebanyak RM147.9 bilion**

PUTRAJAYA, 11 JULAI 2024 – Perdagangan Borong & Runcit Malaysia mencatatkan nilai jualan bulanan berjumlah RM147.9 bilion, berkembang 7.1 peratus tahun ke tahun pada Mei 2024. Ini dilaporkan oleh Jabatan Perangkaan Malaysia (DOSM) hari ini dalam siaran **PRESTASI PERDAGANGAN BORONG & RUNCIT, MEI 2024**. Laporan ini juga memaparkan statistik nilai jualan dan indeks volum bagi Perdagangan Borong & Runcit mengikut subsektor serta indeks jualan runcit melalui internet.

Dalam satu kenyataan hari ini, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia berkata, "Peningkatan sebanyak 7.1 peratus tahun ke tahun bagi Perdagangan Borong & Runcit pada Mei 2024 dipacu oleh subsektor Perdagangan Runcit yang meningkat 8.7 peratus atau RM5.1 bilion kepada RM64.0 bilion. Perdagangan Borong juga bertumbuh 4.7 peratus atau RM2.9 bilion kepada RM65.1 bilion, diikuti oleh Kenderaan Bermotor dengan peningkatan 10.5 peratus atau RM1.8 bilion untuk mencapai RM18.8 bilion."

Bagi perbandingan bulanan, Perdagangan Borong & Runcit naik 2.0 peratus berbanding bulan sebelumnya, disokong oleh Kenderaan Bermotor dan Perdagangan Borong masing-masing dengan 8.8 peratus dan 2.0 peratus.

Beralih kepada prestasi mengikut subsektor, Ketua Perangkawan memaklumkan, “Pertumbuhan 8.7 peratus tahun ke tahun bagi Perdagangan Runcit disumbangkan oleh Jualan Runcit di Kedai Bukan Pengkhususan yang tumbuh 10.7 peratus atau RM2.4 bilion kepada RM24.9 bilion. Kumpulan lain dalam subsektor ini turut merekodkan pertumbuhan positif iaitu Jualan Runcit di Kedai Pengkhususan (12.8%), Jualan Runcit Bahan Api Kenderaan (8.1%), Jualan Runcit Barangan Isi Rumah (5.3%), Jualan Runcit Makanan, Minuman & Tembakau (9.6%), Jualan Runcit Barangan Kesenian & Rekreasi (3.4%), Jualan Runcit Bukan di Kedai, Gerai atau Pasar (8.0%) dan Jualan Runcit di Gerai & Pasar (5.9%). Bagi perbandingan bulan ke bulan, jualan subsektor ini menokok 0.3 peratus, disokong oleh Jualan Runcit di Kedai Bukan Pengkhususan (0.9%), Jualan Runcit Bahan Api Kenderaan (0.6%) dan Jualan Runcit Barangan Kesenian & Rekreasi (1.1%).”

Mengulas lanjut mengenai subsektor Perdagangan Borong, kenaikan 4.7 peratus tahun ke tahun pada bulan ini disokong oleh Lain-lain Pengkhususan Jualan Borong yang meningkat RM0.9 bilion atau 4.0 peratus kepada RM24.1 bilion. Ini diikuti oleh Jualan Borong Barangan Isi Rumah (6.5%), Jualan Borong Makanan, Minuman & Tembakau (6.2%), Jual Borong Bahan Mentah Pertanian & Haiwan Hidup (3.9%), Jualan Borong Jentera, Peralatan & Bekalan (1.8%), Perdagangan Borong Tanpa Pengkhususan (4.3%) dan Jual Borong Berdasarkan Kontrak atau Yuran (2.2%). Bagi perbandingan bulanan, Perdagangan Borong naik 2.0 peratus, terutamanya disumbangkan oleh Jualan Borong Barangan Isi Rumah (2.9%), Jual Borong Bahan Mentah Pertanian & Haiwan Hidup (4.7%) dan Lain-lain Pengkhususan Jualan Borong (0.9%).

Dato' Sri Dr. Mohd Uzir Mahidin turut menerangkan, “Pertumbuhan tahun ke tahun sebanyak 10.5 peratus bagi subsektor Kenderaan Bermotor pada Mei dipacu oleh Jualan Kenderaan Bermotor yang melonjak 11.1 peratus atau RM1.0 bilion untuk merekodkan RM9.9 bilion. Ini diikuti oleh Jualan Komponen & Aksesori Kenderaan Bermotor (11.9%) dan Penyelenggaraan & Pembaikan Kenderaan Bermotor (12.8%). Bagi perbandingan bulanan, subsektor ini kembali positif dengan 8.8 peratus, didorong oleh Jualan Kenderaan Bermotor (14.9%) dan Jualan, Penyelenggaraan & Pembaikan Motosikal (17.2%).”

Bagi indeks jualan runcit melalui internet, indeks ini berkembang 5.2 peratus tahun ke tahun pada Mei 2024 berbanding 4.3 peratus pada April 2024. Bagi nilai pelarasan musim, indeks ini menyusut -4.7 peratus berbanding bulan sebelum.

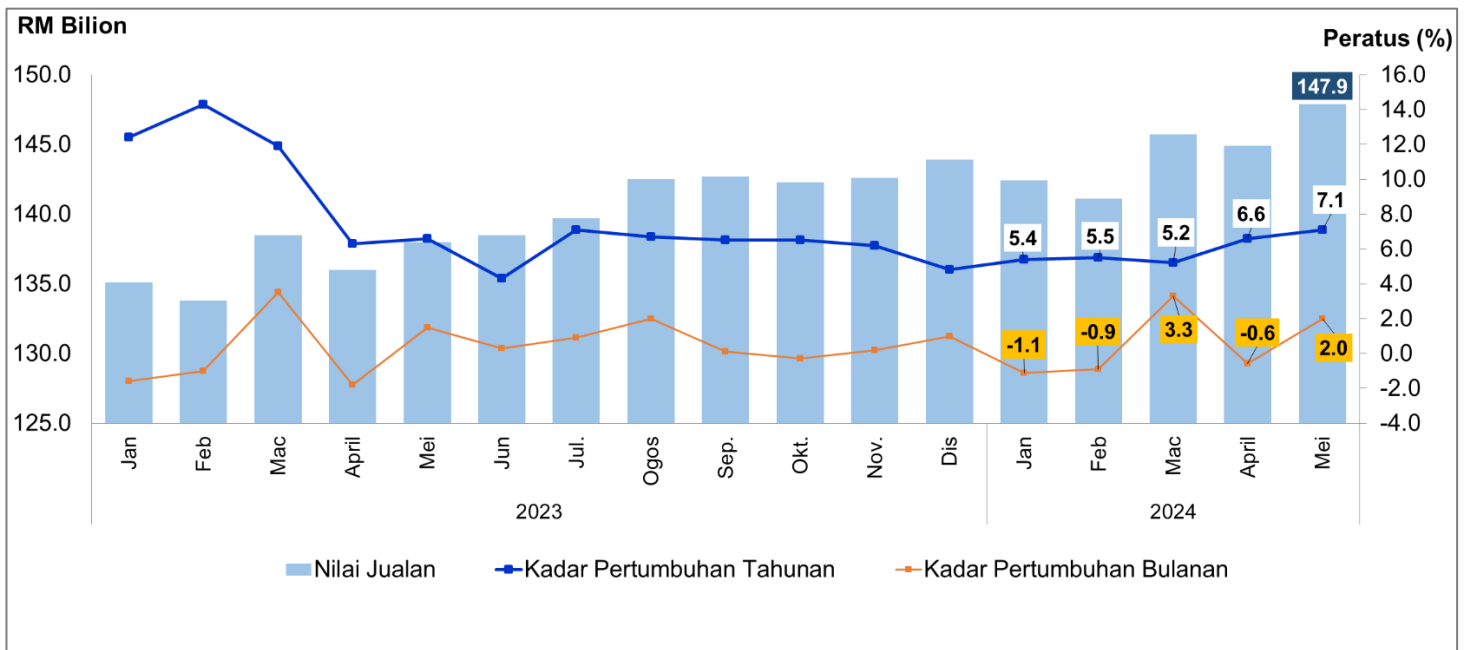
Dari segi indeks volum, Perdagangan Borong & Runcit pada Mei 2024 mencatatkan pertumbuhan tahun ke tahun sebanyak 5.7 peratus. Pengembangan ini disumbangkan oleh semua subsektor iaitu Kenderaan Bermotor (9.6%), Perdagangan Runcit (6.8%) dan Perdagangan Borong (3.4%). Sebaliknya, bagi indeks volum pelarasan musim, ia jatuh -0.9 peratus bulan ke bulan.

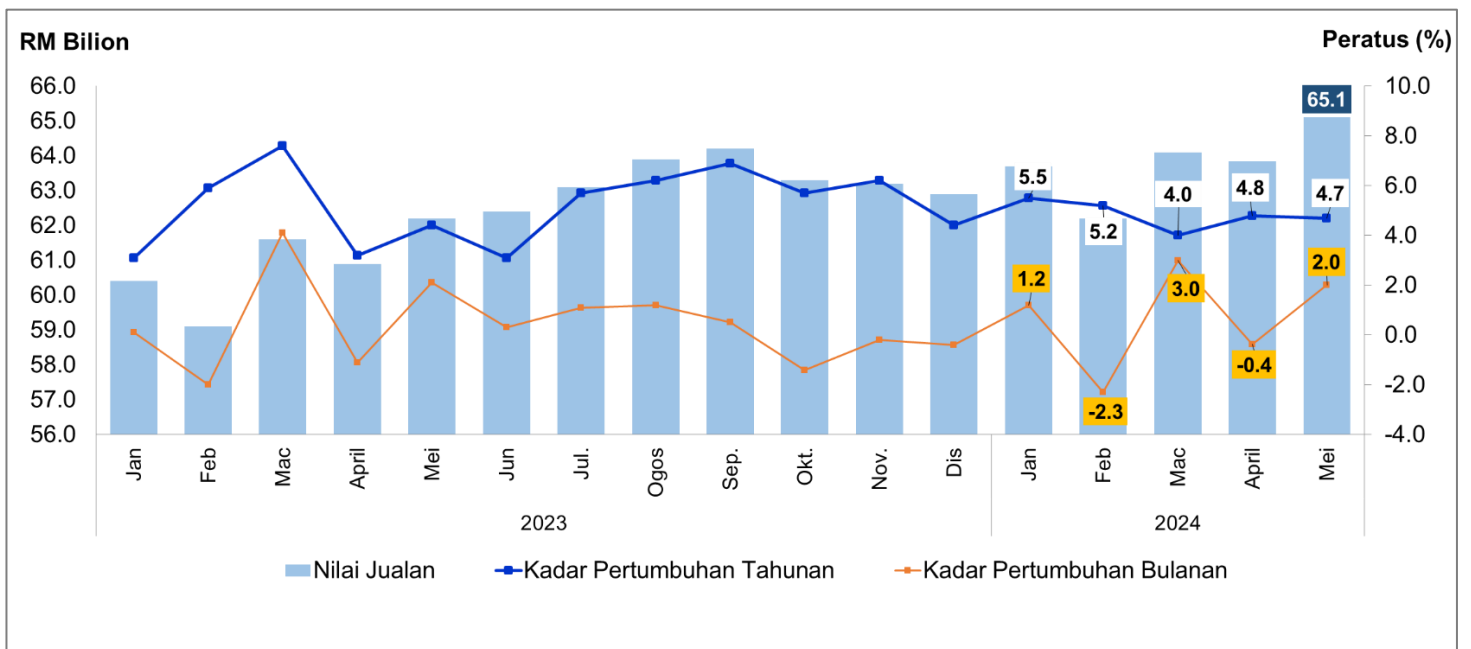

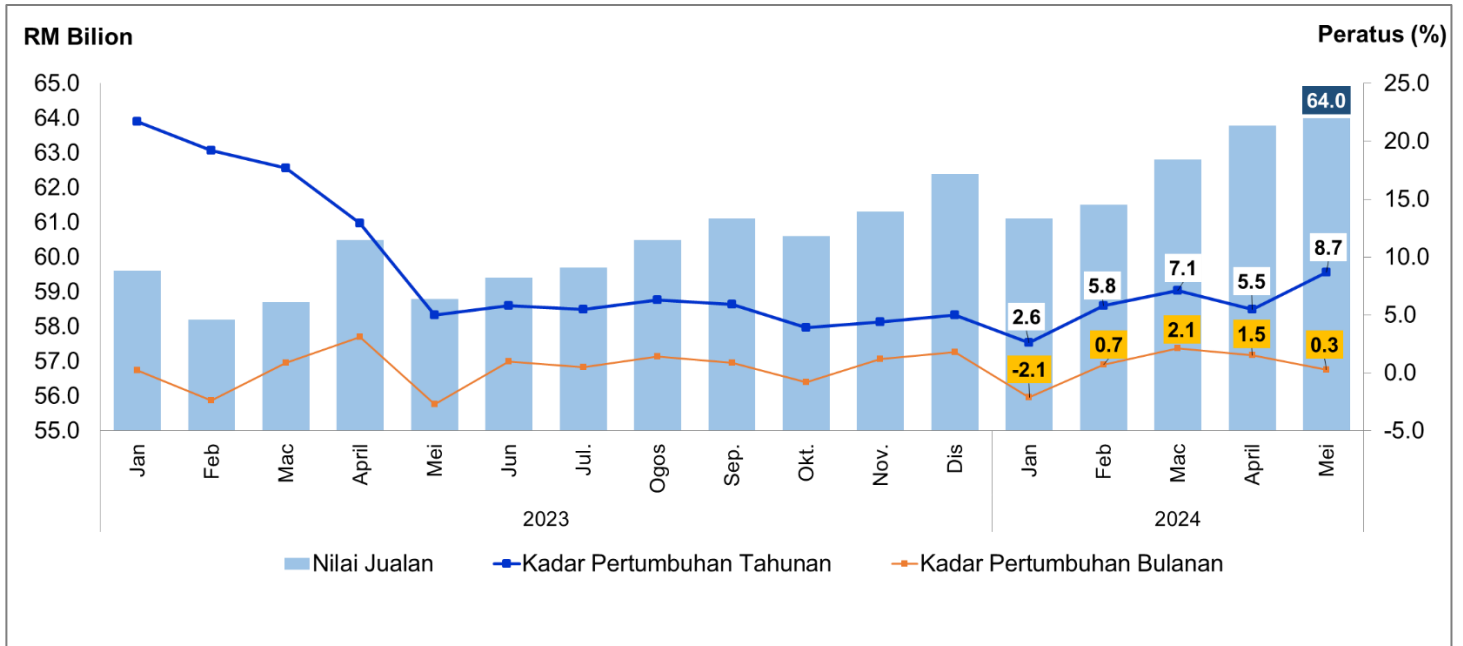
Carta 1: Nilai Jualan Perdagangan Borong & Runcit



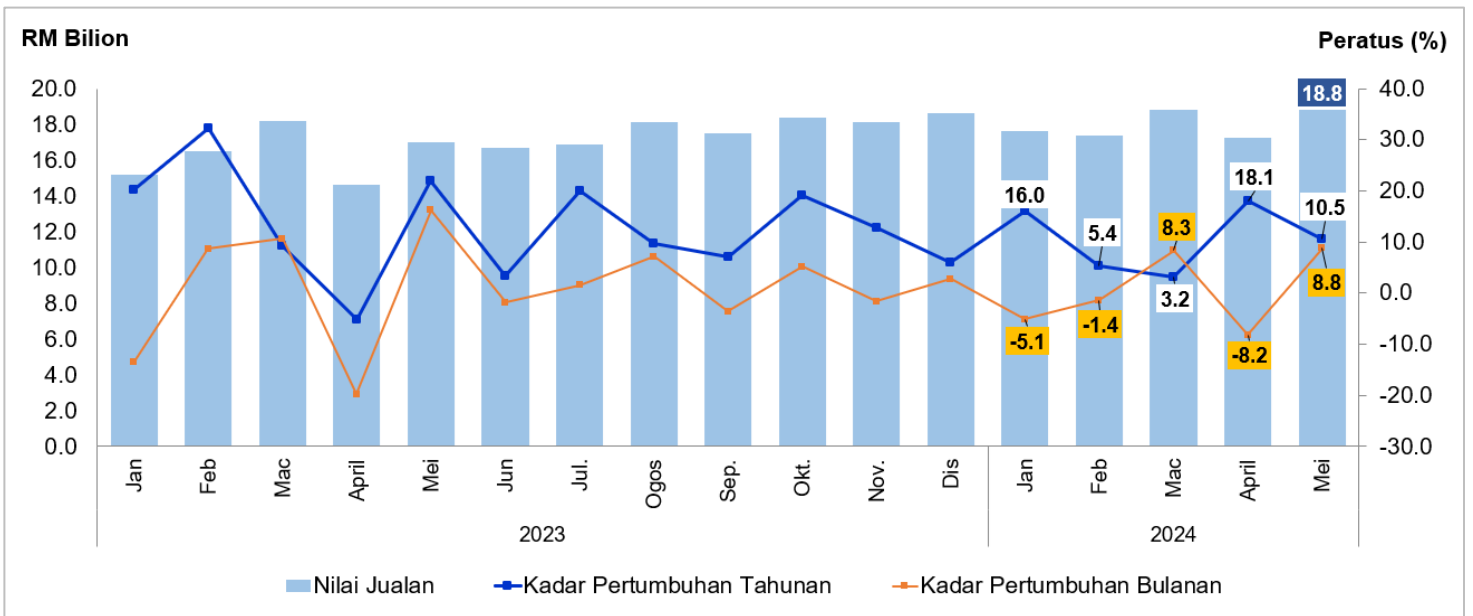
Carta 2: Nilai Jualan Perdagangan Borong



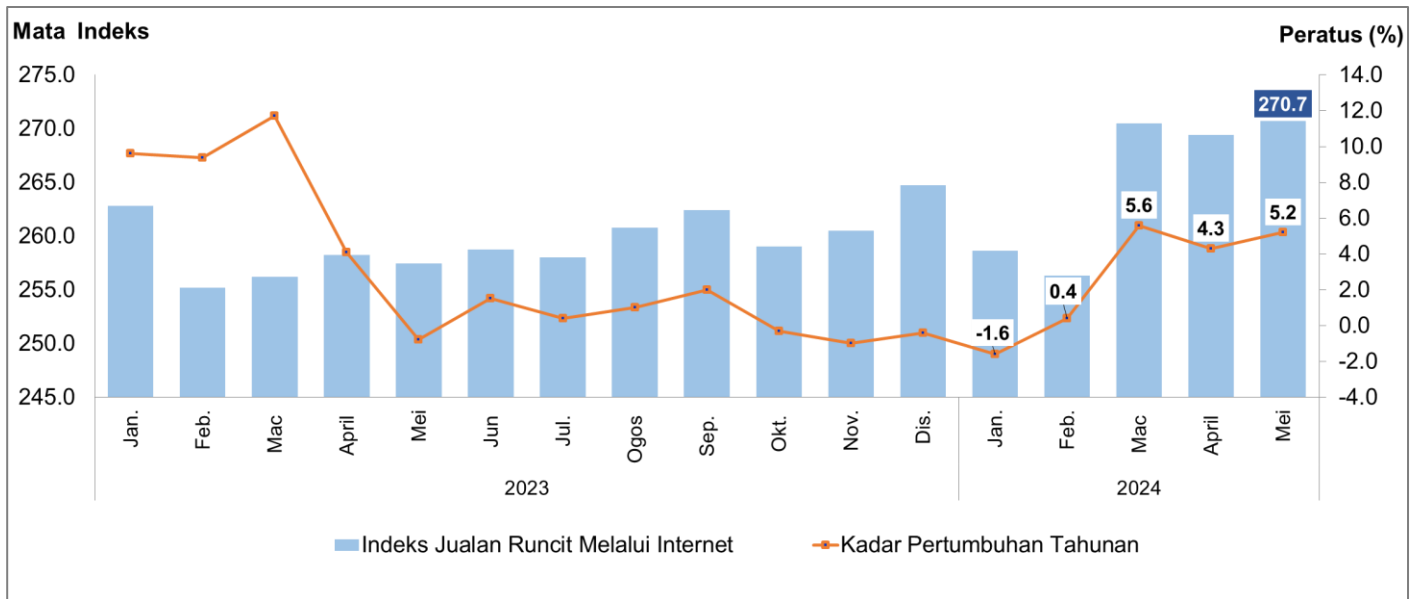
Carta 3: Nilai Jualan Perdagangan Runcit

***Wholesale & Retail Trade sales in May 2024 soared by 7.1 per cent,
reaching a total of RM147.9 billion***

PUTRAJAYA, JULY 11, 2024 – Malaysia’s Wholesale & Retail Trade registered monthly sales value of RM147.9 billion, expanded 7.1 per cent year-on-year in May 2024. This is reported by Department of Statistics Malaysia (DOSM) in today’s release of **PERFORMANCE OF WHOLESALE & RETAIL TRADE, MAY 2024**. The report also presents statistics on sales value and volume index of Wholesale & Retail Trade by sub-sector as well as index of retail sales over the internet.

In a statement today, Dato’ Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia said, “The increase of 7.1 per cent year-on-year for Wholesale & Retail Trade in May 2024 was driven by Retail Trade sub-sector, which rose 8.7 per cent or RM5.1 billion to register RM64.0 billion. Wholesale Trade also grew by registering 4.7 per cent or RM2.9 billion to RM65.1 billion, followed by Motor Vehicles with an increase of 10.5 per cent or RM1.8 billion to settle at RM18.8 billion.”

For monthly comparison, Wholesale & Retail Trade went up 2.0 per cent from the previous month, supported by Motor Vehicles and Wholesale Trade with 8.8 per cent and 2.0 per cent, respectively.

Looking at the performance across sub-sectors, the Chief Statistician informed, “The growth of 8.7 per cent year-on-year in Retail Trade was contributed by Retail Sales in Non-specialised Stores which grew 10.7 per cent or RM2.4 billion to RM24.9 billion. Other groups in this sub-sector also recorded positive growth namely Retail Sales in Specialised Stores (12.8%), Retail Sales of Automotive Fuel (8.1%), Retail Sales of Household Goods (5.3%), Retail Sales of Food, Beverages & Tobacco (9.6%), Retail Sales of Cultural & Recreation Goods (3.4%), Retail Sales Not in Stores, Stalls or Markets (8.0%), and Retail Sales in Stalls & Markets (5.9%). For month-on-month comparison, sales of this sub-sector inched up 0.3 per cent, supported by Retail Sales in Non-specialised Stores (0.9%), Retail Sales of Automotive Fuel (0.6%), and Retail Sales of Cultural & Recreation Goods (1.1%).”

Commenting further on Wholesale Trade sub-sector, the increase of 4.7 per cent year-on-year in this month was supported by Other Specialised Wholesale which rose RM0.9 billion or 4.0 per cent to RM24.1 billion. This was followed by Wholesale of Household Goods (6.5%), Wholesale of Food, Beverages & Tobacco (6.2%), Wholesale of Agricultural Raw Materials & Live Animals (3.9%), Wholesale of Machinery, Equipment & Supplies (1.8%), Non-specialised Wholesale Trade (4.3%), and Wholesale on a Fee or Contract Basis (2.2%). For monthly comparison, Wholesale Trade rose 2.0 per cent, mainly contributed by Wholesale of Household Goods (2.9%), Wholesale of Agricultural Raw Materials & Live Animals (4.7%), and Other Specialised Wholesale (0.9%).

Dato’ Sri Dr. Mohd Uzir Mahidin also informed, “The year-on-year growth of 10.5 per cent for Motor Vehicles sub-sector in May was fueled by Sales of Motor

Vehicles which soared 11.1 per cent or RM1.0 billion to record RM9.9 billion. This was followed by Sales of Motor Vehicle Parts & Accessories (11.9%) and Maintenance & Repair of Motor Vehicles (12.8%). For monthly comparison, this sub-sector rebounded 8.8 per cent, spearheaded by Sales of Motor Vehicles (14.9%) and Sales, Maintenance & Repair of Motorcycles (17.2%).”

For index of retail sale over the internet, the index expanded 5.2 per cent year-on-year in May 2024 as compared to 4.3 per cent in April 2024. For seasonally adjusted value, the index slipped -4.7 per cent as against the previous month.

In terms of volume index, Wholesale & Retail Trade for May 2024 registered a year-on-year growth of 5.7 per cent. The expansion was attributed to all sub-sectors namely Motor Vehicles (9.6%), Retail Trade (6.8%), and Wholesale Trade (3.4%). Conversely, for seasonally adjusted volume index, it went down -0.9 per cent month-on-month.

Chart 1: Sales Value of Wholesale & Retail Trade

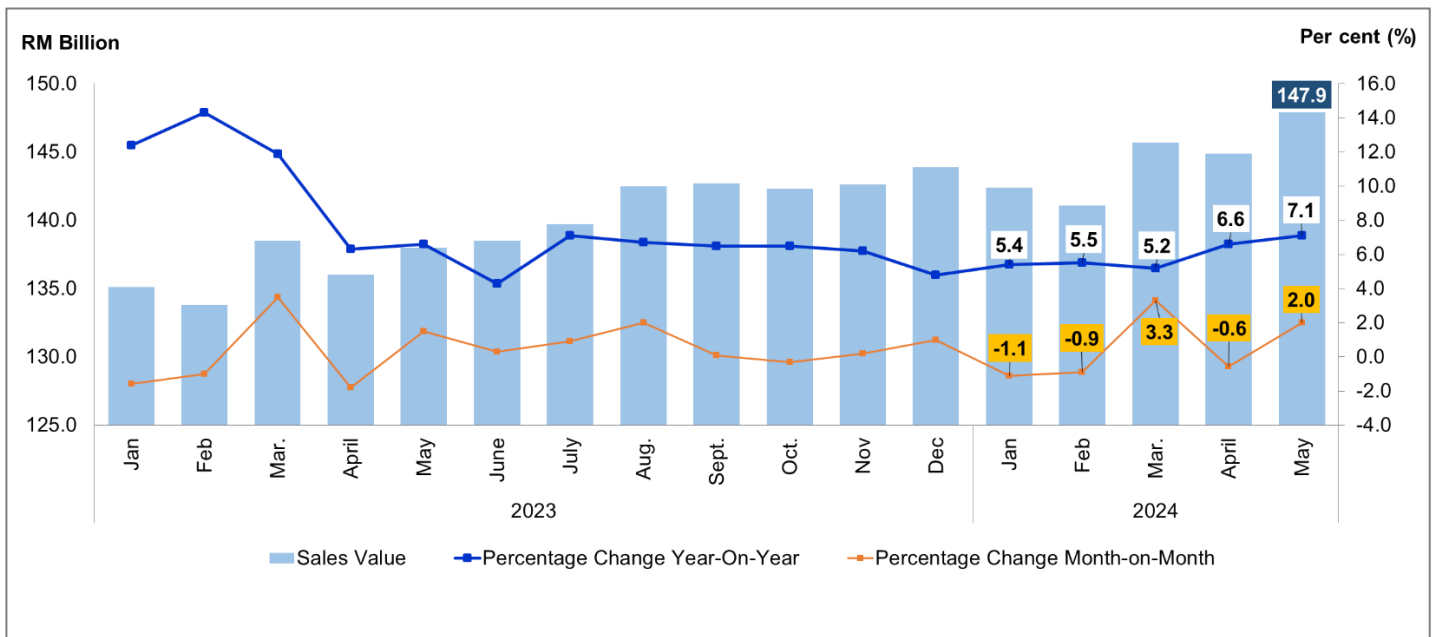


Chart 2: Sales Value of Wholesale Trade

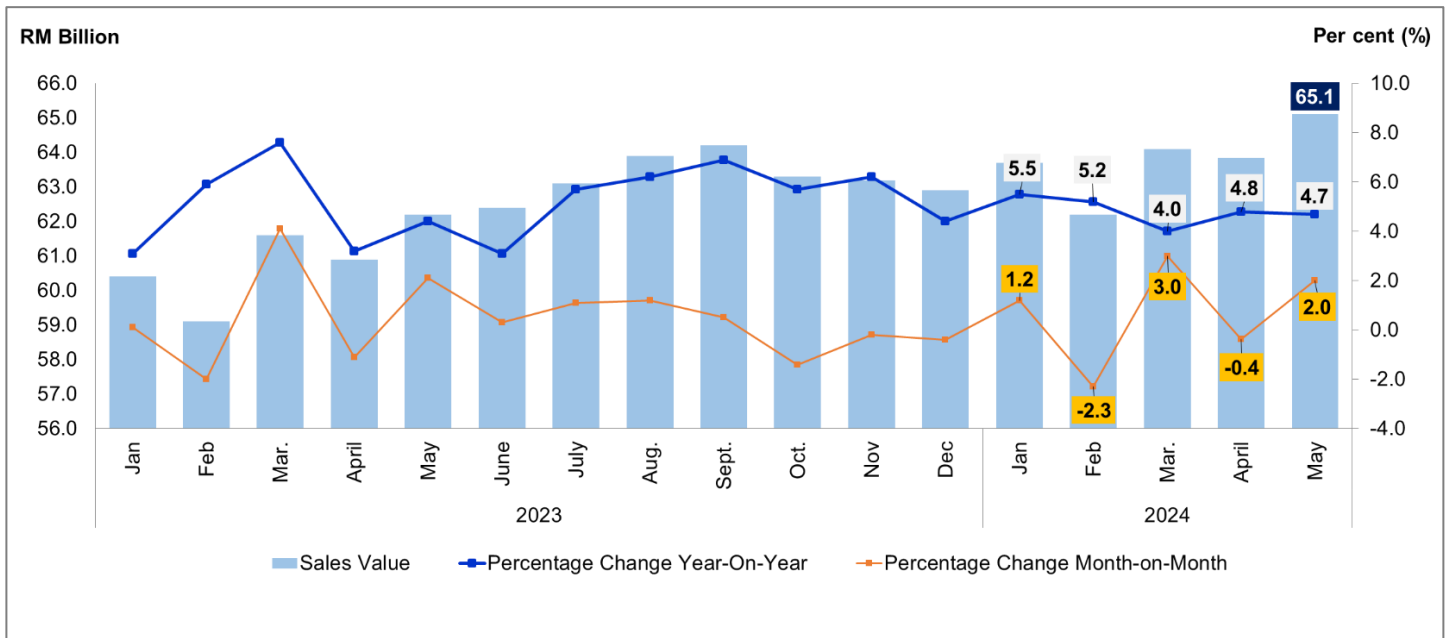


Chart 3: Sales Value of Retail Trade

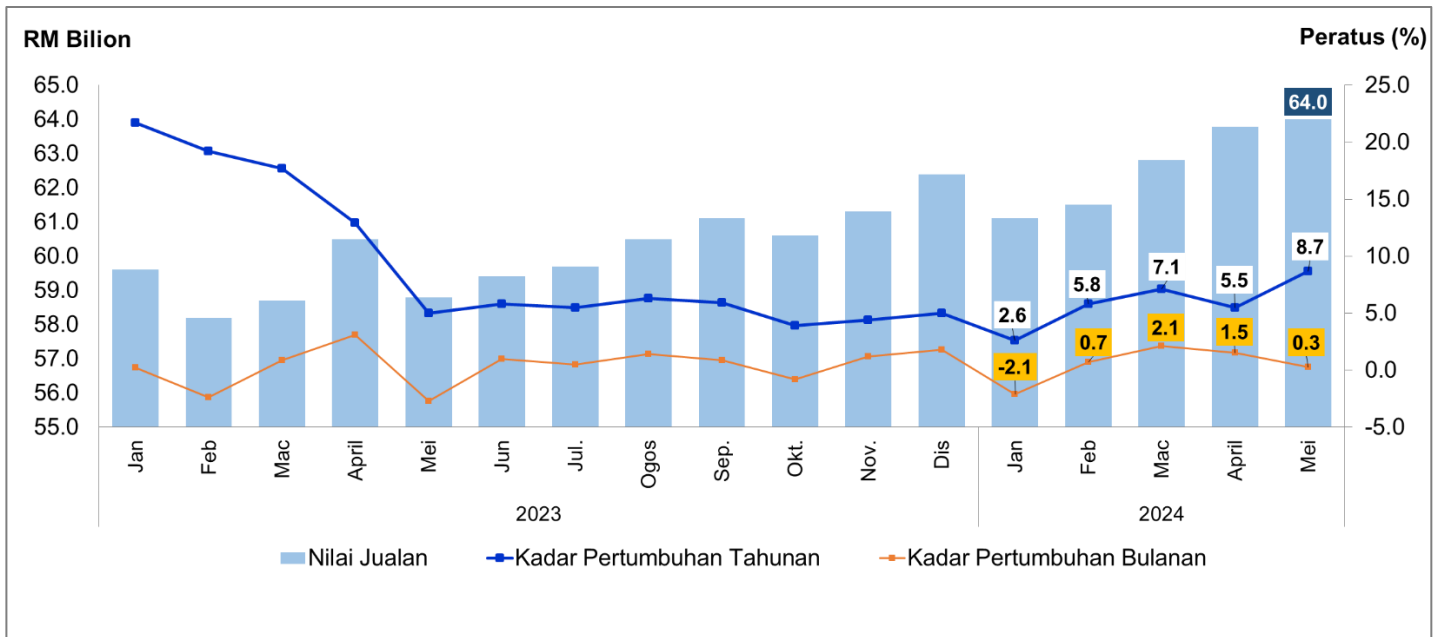


Chart 4: Sales Value of Motor Vehicles

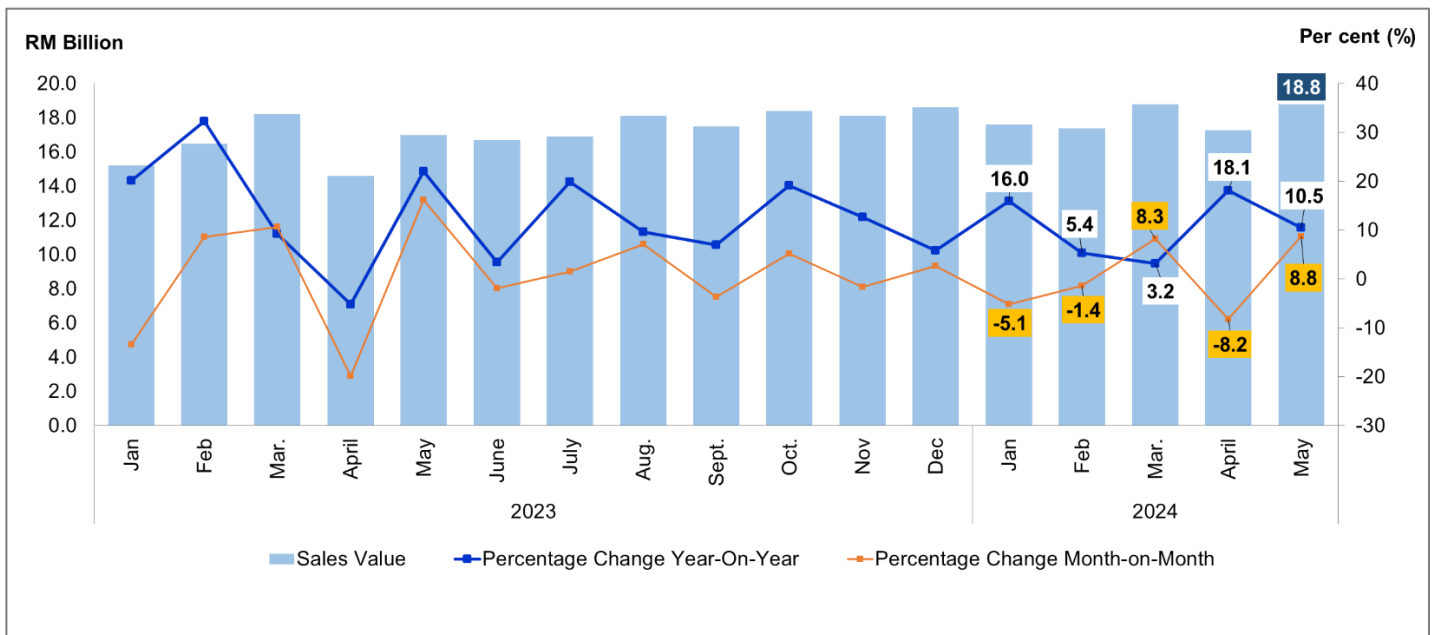
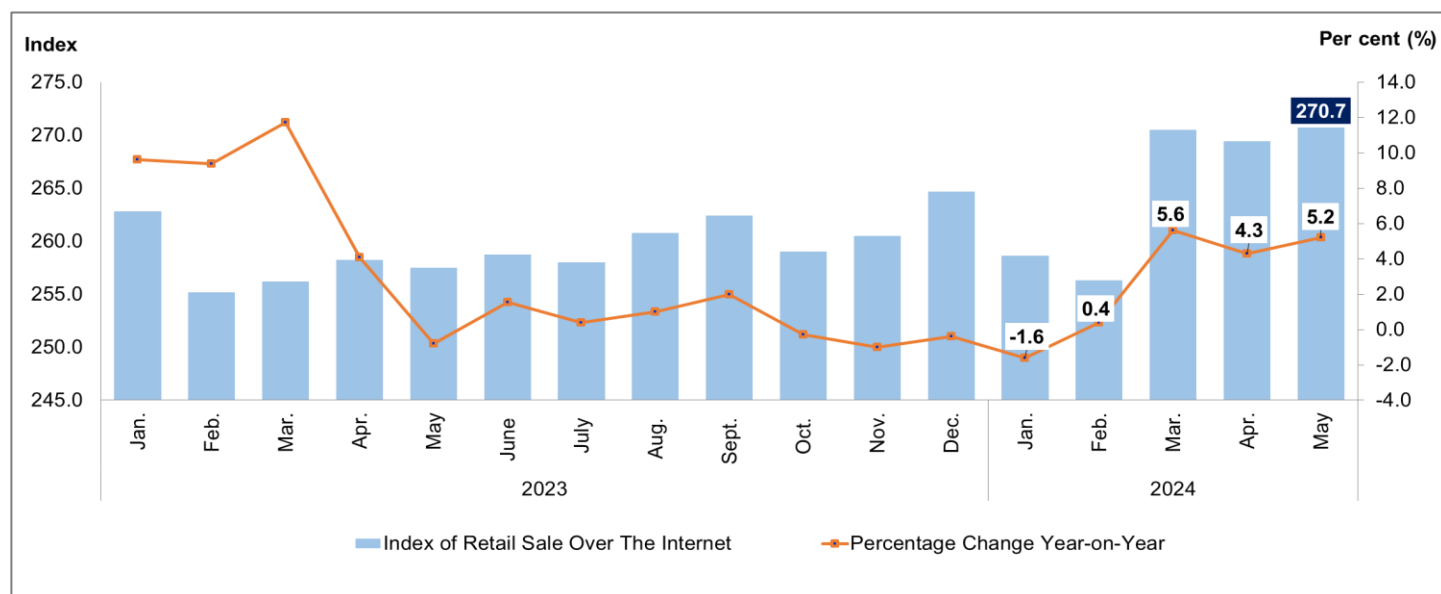


Chart 5: Index of Retail Sale Over the Internet
