## INDEKS HARGA PENGELOUAR PERKHIDMATAN, MALAYSIA SUKU TAHUN KETIGA 2024

### **Indeks Harga Pengeluar Perkhidmatan meningkat 0.3 peratus pada Suku Tahun Ketiga 2024**

**PUTRAJAYA, 6 November 2024** – Satu laporan **INDEKS HARGA PENGELOUAR PERKHIDMATAN (IHPRP), SUKU TAHUN KETIGA 2024**, yang mengukur perubahan harga pengeluar bagi sektor perkhidmatan tempatan di Malaysia telah diterbitkan oleh Jabatan Perangkaan Malaysia pada hari ini. Indeks Harga Pengeluar Perkhidmatan (IHPRP) meningkat perlahan 0.3 peratus pada suku tahun ketiga 2024 berbanding 0.7 peratus pada suku tahun sebelumnya.

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin menjelaskan dalam kenyataannya, “Indeks Kesenian, Hiburan & Rekreasi meningkat 5.4 peratus berbanding 7.7 peratus pada suku tahun kedua 2024, disumbangkan oleh Aktiviti Hiburan & Rekreasi Lain (0.9%). Indeks Penginapan dan Aktiviti Perkhidmatan Makanan & Minuman kekal meningkat 2.4 peratus (ST2 2024: 2.4%) disebabkan oleh Aktiviti Perkhidmatan Minuman (3.7%) dan Restoran dan Aktiviti Perkhidmatan Makanan Bergerak (2.5%). Sementara itu, indeks Pendidikan meningkat 0.8 peratus, disumbangkan oleh Pendidikan Menengah (1.7%). Pada masa sama, indeks Kesihatan meningkat 0.3 peratus, manakala Profesional dan Aktiviti Hartanah masing-masing meningkat sebanyak 0.2 peratus dan 0.1 peratus.”

Beliau turut menambah, “Sebaliknya, indeks Pengangkutan menurun 2.0 peratus (ST2 2024: -1.4%), disebabkan terutamanya oleh indeks Pengangkutan Penumpang Udara (-8.1%). Selain itu, indeks Maklumat & Komunikasi terus turun 0.1 peratus (ST2 2024: -0.1%) disebabkan oleh indeks Aktiviti Telekomunikasi Tanpa Wayar (-0.2%).”

Beliau mengulas lanjut, “Perbandingan suku tahunan, IHPRP meningkat kepada 0.1 peratus berbanding penurunan 0.1 peratus pada suku tahun kedua 2024. Peningkatan ini disebabkan terutamanya oleh indeks Penginapan dan Aktiviti Perkhidmatan Makanan & Minuman dan Kesenian, Hiburan & Rekreasi, di mana kedua-dua indeks mencatatkan peningkatan 0.9 peratus. Selain itu, indeks Pendidikan juga meningkat 0.2 peratus. Sementara itu, indeks Kesihatan, Profesional dan Maklumat & Komunikasi kekal tidak berubah. Walau bagaimanapun, indeks Pengangkutan dan Aktiviti Hartanah masing-masing turun 0.6 peratus dan 0.5 peratus.”



## SERVICES PRODUCER PRICE INDEX, MALAYSIA THIRD QUARTER 2024

### ***The Services Producer Price Index increased 0.3 per cent in the Third Quarter of 2024***

**PUTRAJAYA, November 6<sup>th</sup>, 2024** – A report on the **SERVICES PRODUCER PRICE INDEX (SPPI), THIRD QUARTER 2024**, which measures changes in producer prices for Malaysia's domestic services sector, was released today by the Department of Statistics Malaysia. The Services Producer Price Index (SPPI) increased marginally by 0.3 per cent in the third quarter of 2024 as compared to 0.7 per cent in the previous quarter.

The Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin explained in the statement that, “The Arts, Entertainment & Recreation index rose 5.4 per cent as against 7.7 per cent in the second quarter of 2024 contributed by the Other Amusement & Recreation Activities (0.9%). The index of Accommodation and Food & Beverage Service Activities continued to increase by 2.4 per cent (Q2 2024: 2.4%) attributed to Beverage Service Activities (3.7%) and Restaurants & Mobile Food Service Activities (2.5%). Meanwhile, the Education index inched up 0.8 per cent, contributed by Secondary Education (1.7%). In the meantime, Health index increased by 0.3 per cent, while Professional and Real Estate Activities indices inclined by 0.2 per cent and 0.1 per cent, respectively.”

He also added that, “Conversely, the Transport index shrank by 2.0 per cent (Q2 2024: -1.4%), particularly due to Passenger Air Transport index (-8.1%). Apart from that, the Information & Communication index continued to decrease by 0.1 per cent (Q2 2024: -0.1%) due to Wireless Telecommunication Activities index (-0.2%).”

*He further elaborated that, “On a quarter-on-quarter basis comparison, SPPI increased by 0.1 per cent after a decrease of 0.1 per cent in the second quarter of 2024. This was mainly due to Accommodation and Food & Beverage Service Activities and Arts, Entertainment & Recreation, where both indices recorded an increase of 0.9 per cent. In addition, the Education index also increased by 0.2 per cent. Meanwhile the index of Health, Professional, Information & Communication remained unchanged. However, Transportation and Real Estate Activities indices declined by 0.6 per cent and 0.5 per cent, respectively.”*


