## PERANGKAAAN PERDAGANGAN LUAR NEGERI MALAYSIA JANUARI 2024

---

**Prestasi perdagangan Malaysia merekodkan peningkatan 3.1 peratus, kekal momentum positif pada Januari 2025**

**PUTRAJAYA, 20 FEBRUARI 2025** – Prestasi perdagangan Malaysia bermula dengan kukuh pada awal tahun 2025, membawa kepada trend perdagangan yang lebih baik, disokong oleh peningkatan eksport dan import yang lebih tinggi. Jumlah dagangan meningkat 3.1 peratus kepada RM241.9 bilion, didorong oleh pertumbuhan eksport (+0.3%) RM122.8 bilion dan import (+6.2%) RM119.2 bilion. Sebaliknya, imbalan dagangan turun 64.3 peratus kepada RM3.6 bilion pada Januari 2025 seperti yang dilaporkan hari ini dalam **BULETIN PERANGKAAAN PERDAGANGAN LUAR NEGERI MALAYSIA, JANUARI 2025**. Buletin ini juga membentangkan prestasi produk untuk eksport dan import serta rakan dagangannya.

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin menjelaskan prestasi eksport Malaysia meningkat selaras dengan kenaikan eksport domestik pada Januari 2025. Eksport domestik (79.4% daripada jumlah eksport), meningkat 2.9 peratus kepada RM97.5 bilion. Sementara itu, eksport semula (20.6% daripada jumlah eksport) turun 8.7 peratus berbanding Januari 2024, bernilai RM25.3 bilion. Selain itu, import bernilai RM119.2 bilion, meningkat 6.2 peratus atau RM6.9 bilion.

Lebihan dagangan menguncup 64.3 peratus kepada RM3.6 bilion, lebihan bulan ke-57 berturut-turut sejak Mei 2020. Berbanding Disember 2024, eksport, import, jumlah dagangan dan imbalan dagangan masing-masing mencatatkan penguncupan 11.3 peratus, 0.2 peratus, 6.2 peratus dan 81.0 peratus.

Melihat dari sudut kumpulan barangan, 123 daripada 259 kumpulan eksport dan 116 daripada 259 kumpulan import menunjukkan peningkatan berbanding bulan yang sama pada tahun sebelumnya.

Ketua Perangkawan Malaysia turut menggariskan bahawa eksport yang lebih tinggi disumbangkan terutamanya ke Amerika Syarikat (+RM3.8 bilion), diikuti Singapura (+RM3.4 bilion), Taiwan (+RM1.2 bilion), Hong Kong (+RM810.4 juta), Kenya (+RM388.5 juta), Kanada (+RM346.6 juta) dan Brunei Darussalam (+RM186.4 juta). Selain itu, import yang lebih tinggi disumbangkan terutamanya dari Taiwan (+RM7.2 bilion), diikuti oleh Amerika Syarikat (+RM2.6 bilion), China (+RM2.4 bilion), Republik Korea (+RM993.9 juta), Iraq (+RM488.5 juta), Ecuador (+RM348.0 juta) dan Mexico (+RM332.0 juta).

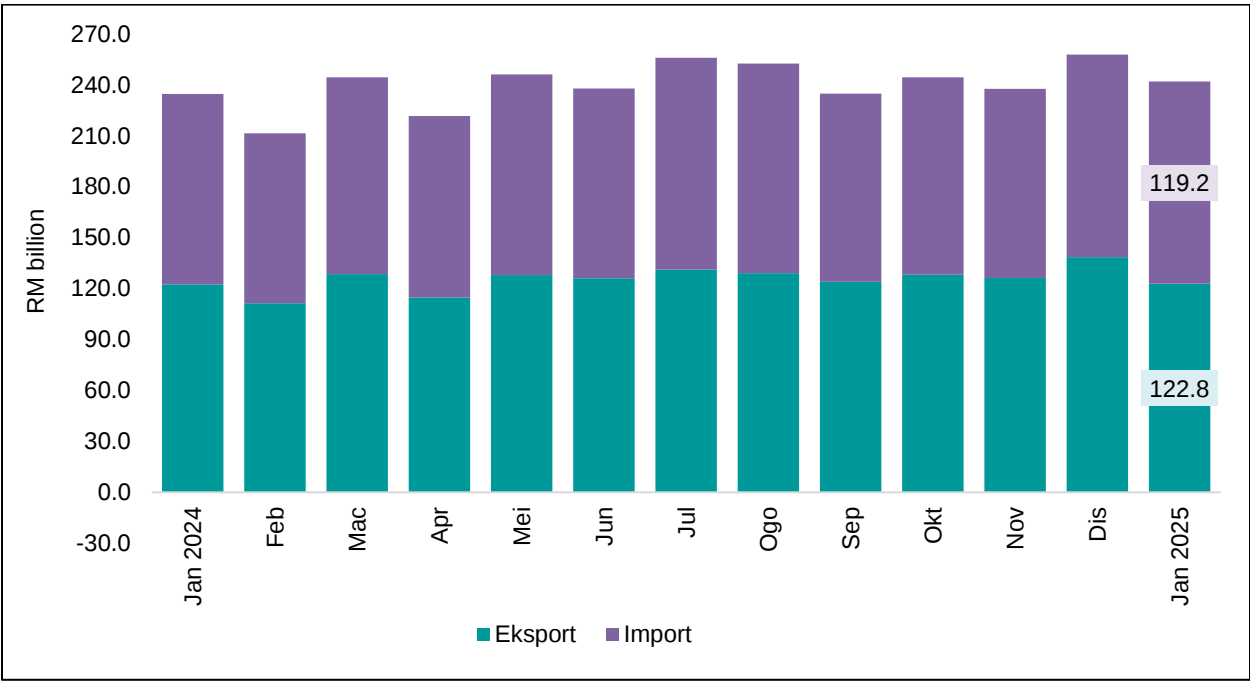
Mengulas lebih lanjut mengenai eksport, kenaikan ini sejajar dengan peningkatan dalam barangan elektrik & elektronik (+RM6.5 bilion); barangan perkilangan lain (+RM665.0 juta); minyak kelapa sawit & keluaran pertanian berasaskan kelapa sawit (+RM537.8 juta); jentera, kelengkapan & peralatan (+RM429.5 juta); barangan perkilangan berasaskan minyak kelapa sawit (+RM409.2 juta); dan keluaran pertanian yang lain (+RM317.3 juta). Di samping itu, peningkatan import dicatatkan bagi barangan elektrik & elektronik (+RM13.4 bilion); jentera, kelengkapan & peralatan (+RM808.3 juta); keluaran pertanian yang lain (+RM636.7 juta); minyak kelapa sawit & keluaran pertanian berasaskan kelapa sawit (+RM421.3 juta); barangan perkilangan berasaskan minyak kelapa sawit (+RM367.2 juta); dan minyak sayuran lain (+RM320.9 juta).

Selanjutnya, Ketua Perangkawan Malaysia juga memaklumkan pertambahan import mengikut Penggunaan Akhir adalah seiring dengan permintaan yang lebih tinggi bagi barangan modal dan barangan perantaraan. Import barangan modal (16.8% daripada jumlah import), meningkat 45.9 peratus atau RM6.3 bilion mencatatkan nilai RM20.0 bilion. Import barangan perantaraan (51.0% daripada jumlah import), bernilai RM60.7 bilion, mencatatkan peningkatan 3.3 peratus atau RM1.9 bilion berbanding Januari 2024. Sementara itu, barangan penggunaan (8.4% daripada jumlah import), susut 2.6 peratus atau RM272.6 juta mencecah RM10.1 bilion.

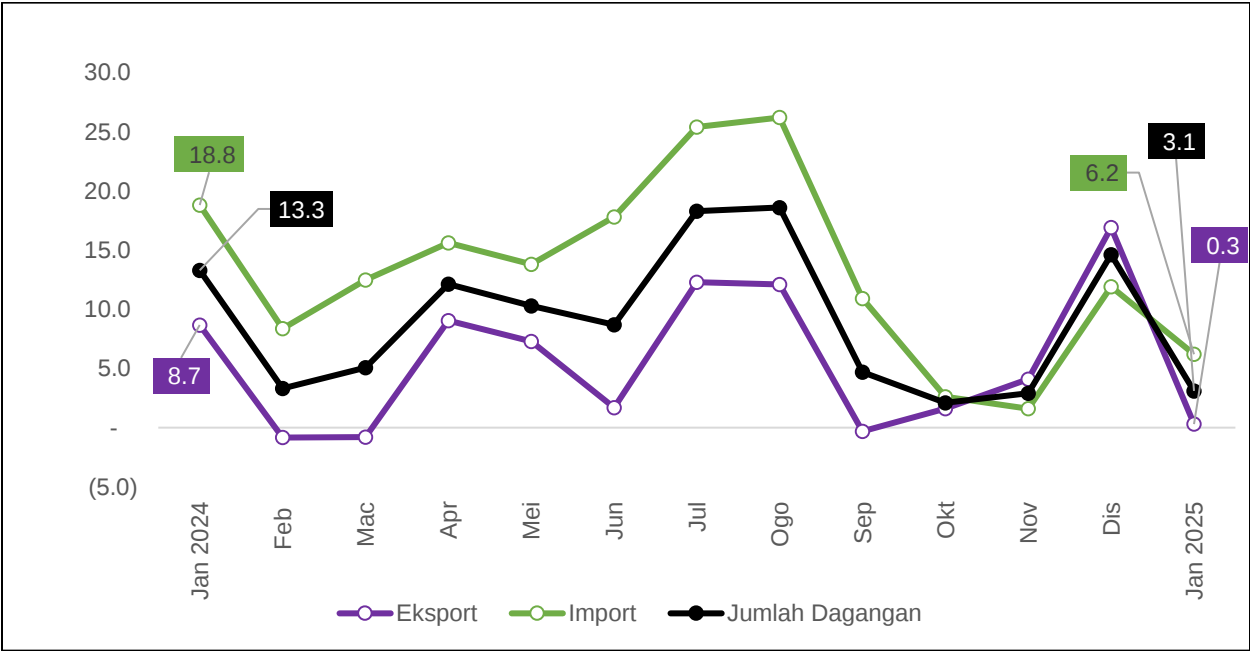

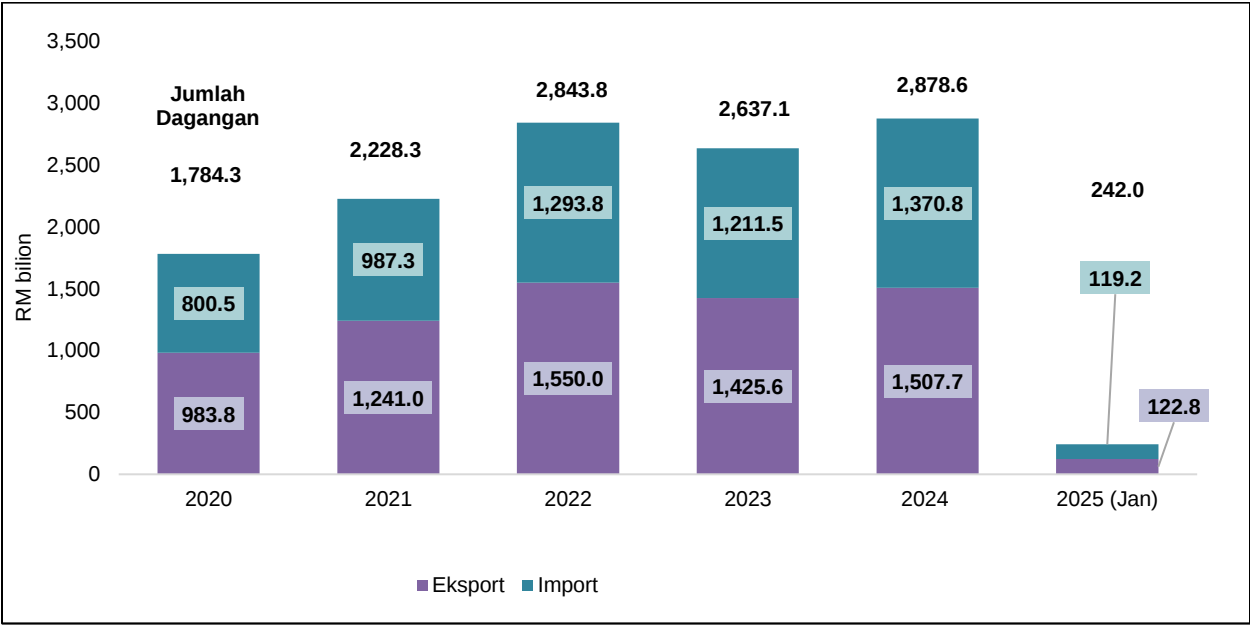
Carta 1: Perangkaan Perdagangan Luar Negeri, Jan 2024 – Jan 2025 (Nilai)



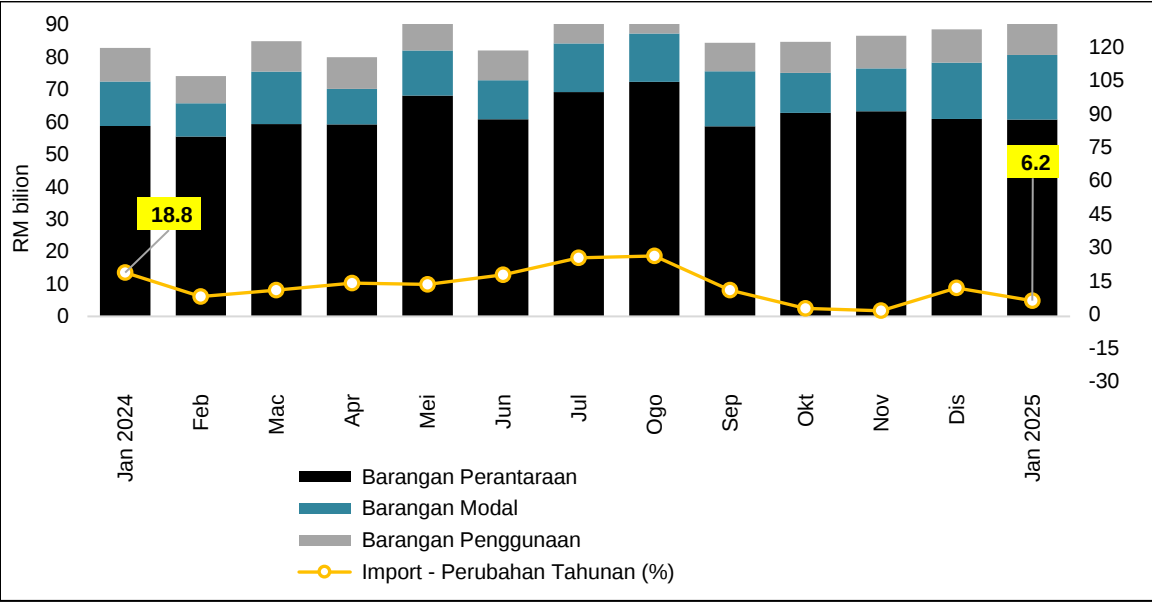
Carta 2: Perangkaan Perdagangan Luar Negeri, Jan 2024 – Jan 2025  
(Peratus Perubahan Tahunan)



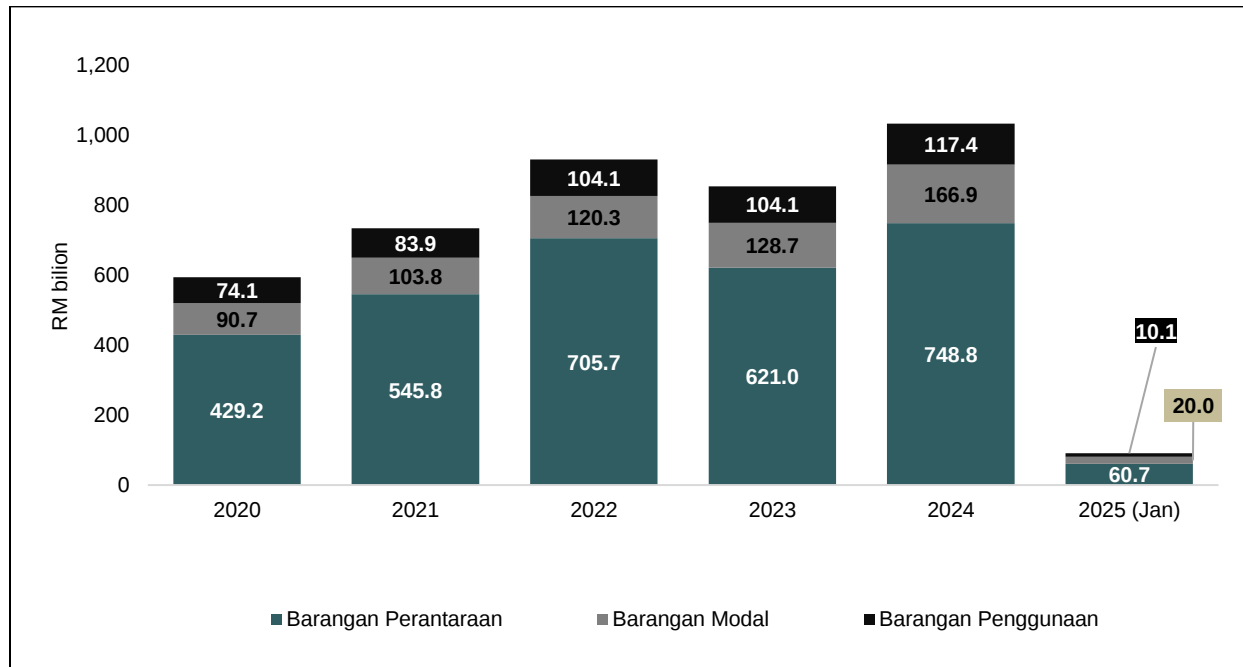
Carta 3: Perangkaan Perdagangan Luar Negeri, 2020 – 2025 (Jan)

## **MALAYSIA EXTERNAL TRADE STATISTICS JANUARY 2025**

---

***Malaysia's trade performance recorded a 3.1 percent increase, maintaining positive momentum in January 2025***

**PUTRAJAYA, 20 FEBRUARY 2025** – Malaysia's trade performance kicked off strongly at the start of 2025, led to better trends of trade, supported by both higher exports and imports. Total trade witnessed an increase by 3.1 per cent to RM241.9 billion, attributable to the growth of exports (+0.3%) of RM122.8 billion and imports (+6.2%) of RM119.2 billion. On the contrary, trade balance fell by 64.3 per cent to RM3.6 billion in January 2025 as reported today in **MALAYSIA EXTERNAL TRADE STATISTICS BULLETIN, JANUARY 2025**. This bulletin also presents the performance of export and import products with its trading partners.

Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin highlighted Malaysia's exports increased in line with the rise in domestic exports in January 2025. Domestic exports (79.4% of total exports), grew by 2.9 per cent to RM97.5 billion. Meanwhile, re-exports (20.6% of total exports) was down by 8.7 per cent as compared to January 2024, worth RM25.3 billion. Moreover, imports worth RM119.2 billion, increased by 6.2 per cent or RM6.9 billion. Trade surplus contracted by 64.3 per cent to reach RM3.6 billion, 57<sup>th</sup> consecutive month of surplus since May 2020. Comparing with December 2024, exports, imports, total

*trade and trade balance recorded a contraction by 11.3 per cent, 0.2 per cent, 6.2 per cent and 81.0 per cent, respectively.*

*From the perspective of the commodity group, 123 out of 259 export groups and 116 out of 259 import groups showed an increase as compared to the same month of the previous year.*

*Chief Statistician Malaysia further explained higher exports was attributable mainly to the United States (+RM3.8 billion), followed by Singapore (+RM3.4 billion), Taiwan (+RM1.2 billion), Hong Kong (+RM810.4 million), Kenya (+RM388.5 million), Canada (+RM346.6 million) and Brunei Darussalam (+RM186.4 million). Moreover, higher imports were mainly contributed from Taiwan (+RM7.2 billion), followed by the United States (+RM2.6 billion), China (+RM2.4 billion), Republic of Korea (+RM993.9 million), Iraq (+RM488.5 million), Ecuador (+RM348.0 million) and Mexico (+RM332.0 million).*

*Commenting further on exports, the increase was in line with the rise in electrical & electronic products (+RM6.5 billion); other manufactures (+RM665.0 million); palm oil & palm-based agriculture products (+RM537.8 million); machinery, equipment & parts (+RM429.5 million); palm oil-based manufactured products (+RM409.2 million); and other agriculture (+RM317.3 million). In addition, the increase in imports was logged for electrical & electronic products (+RM13.4 billion); machinery, equipment & parts (+RM808.3 million); other agriculture (+RM636.7 million); palm oil and palm-based agriculture products (+RM421.3 million); palm oil-based manufactured products (+RM367.2 million); and other vegetables oil (+RM320.9 million).*

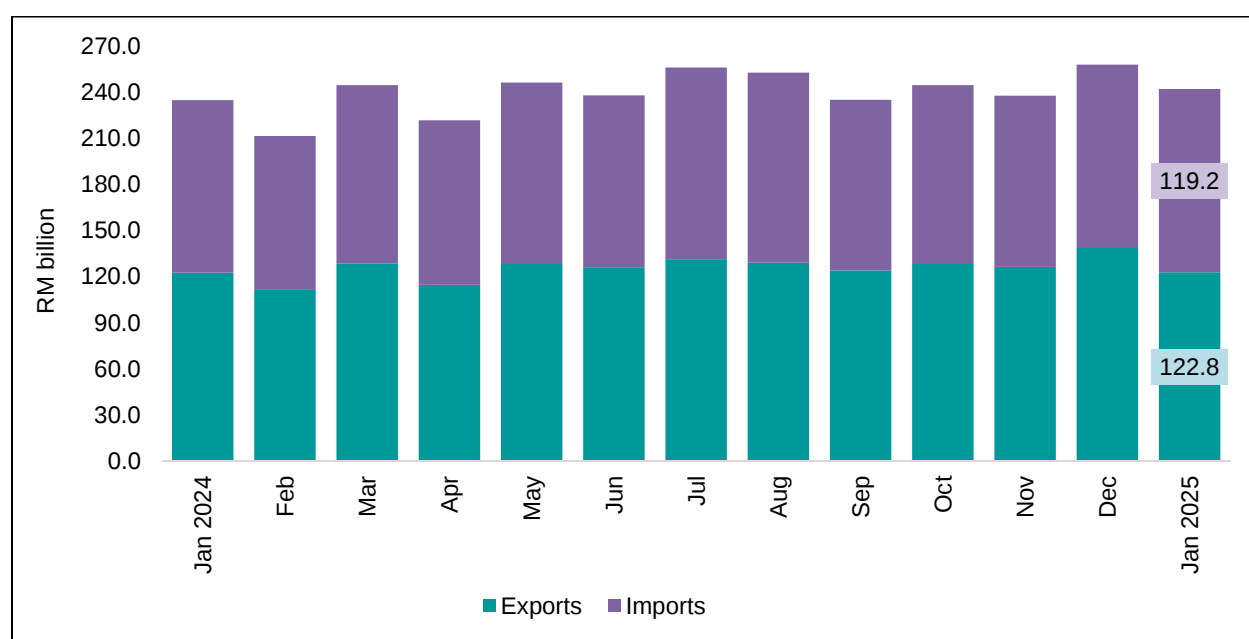
*Adding to this, the Chief Statistician Malaysia also emphasised the upsurge in imports by End Use which was in accordance with higher demand for capital goods*

and intermediate goods. Imports of capital goods (16.8% of total imports), grew by 45.9 per cent or RM6.3 billion to post a value of RM20.0 billion. Imports of intermediate goods (51.0% of total imports), valued at RM60.7 billion, registered an increase of 3.3 per cent or RM1.9 billion as compared to January 2024. Meanwhile, consumption goods (8.4% of total imports), declined by 2.6 per cent or RM272.6 million to reach RM10.1 billion.

The Government of Malaysia has declared National Statistics Day (MyStats Day) on October 20<sup>th</sup>. MyStats Day theme is “Statistics is the Essence of Life”. DOSM commemorates its 75<sup>th</sup> Diamond Jubilee in 2024.

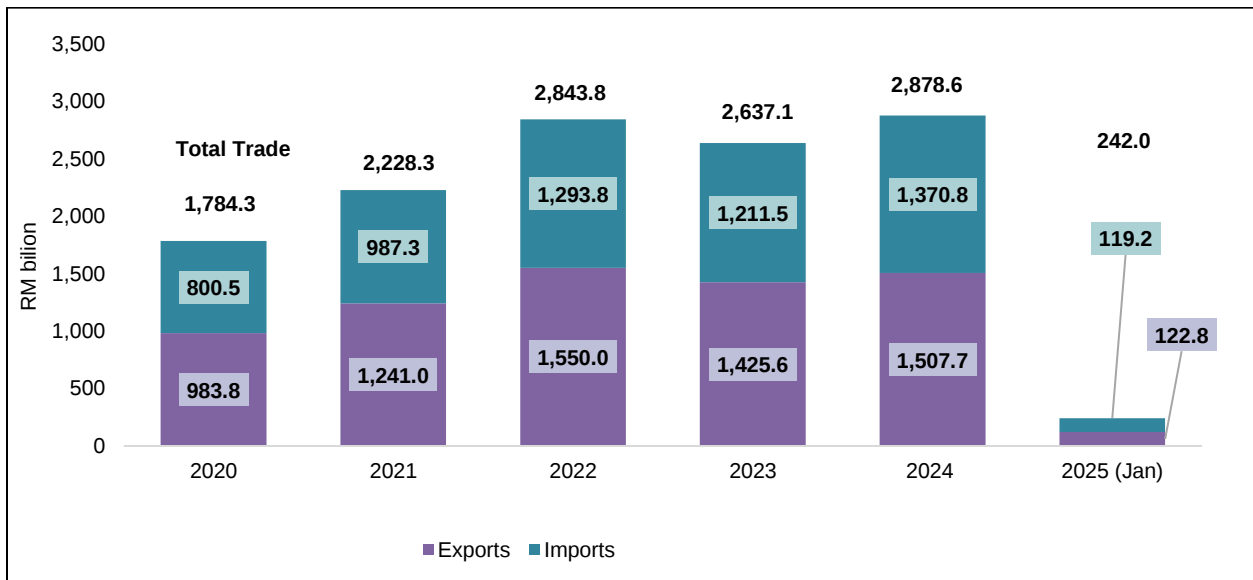
Chart 1: External Trade Statistics, Jan 2024 – Jan 2025 (Value)



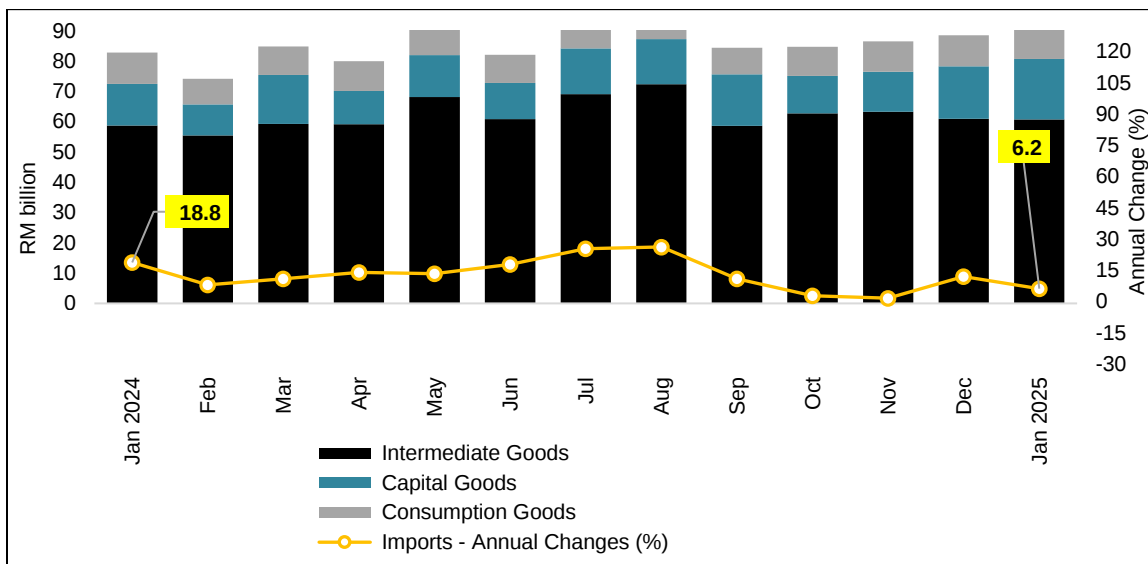
*Chart 2: External Trade Statistics, Jan 2024 – Jan 2025*  
(Annual Percentage Change)



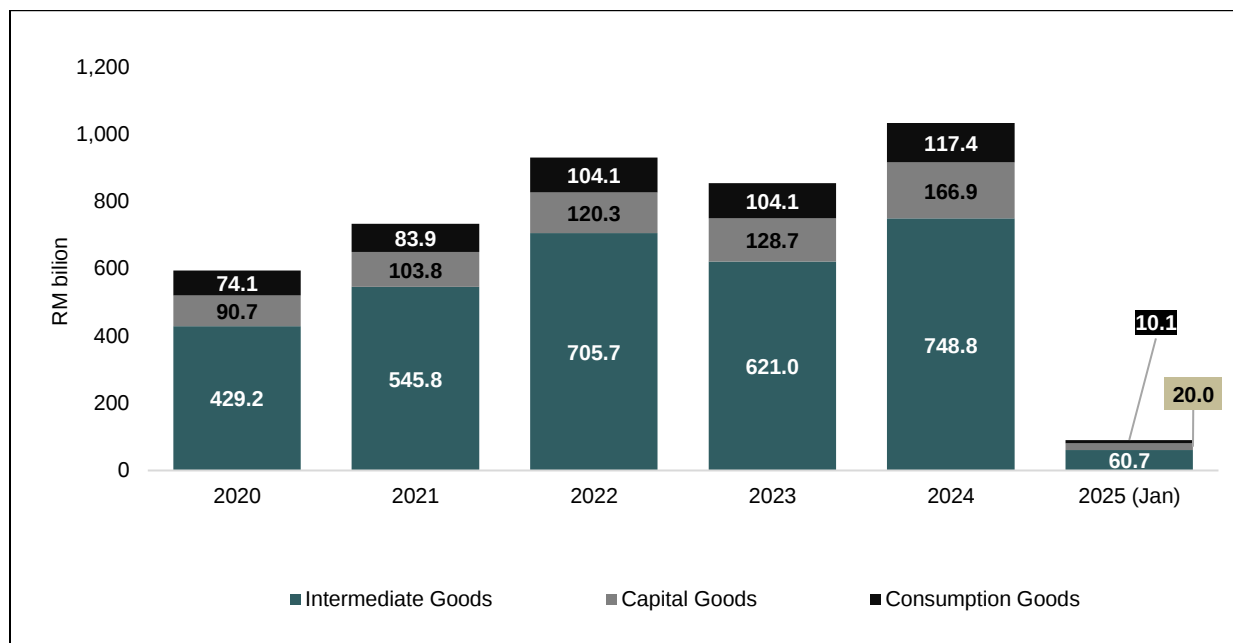
*Chart 3: External Trade Statistics, 2020 – 2025 (Jan)*
