INDEKS HARGA PENGELUAR PERKHIDMATAN, MALAYSIA SUKU TAHUN KEDUA 2025

Indeks Harga Pengeluar Perkhidmatan Malaysia meningkat 1.0 peratus pada Suku Tahun Kedua 2025

PUTRAJAYA, 6 Ogos 2025 – Jabatan Perangkaan Malaysia, pada hari ini menerbitkan satu laporan **INDEKS HARGA PENGELUAR PERKHIDMATAN (IHPRP), SUKU TAHUN KEDUA 2025**, yang memberikan ukuran perubahan harga pengeluar dalam sektor perkhidmatan tempatan di Malaysia. IHPRP mencatatkan peningkatan tahun ke tahun sebanyak 1.0 peratus pada suku kedua 2025, meningkat daripada peningkatan 0.6 peratus pada suku tahun sebelumnya.

Ketua Perangkawan Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin menjelaskan dalam kenyataannya, “Indeks Kesenian, hiburan & rekreasi meningkat 4.5 peratus peningkatan sederhana berbanding peningkatan 6.6 peratus pada suku tahun sebelumnya. Peningkatan ini disumbangkan oleh Aktiviti hiburan & rekreasi lain (1.9%). Indeks Penginapan dan aktiviti perkhidmatan makanan & minuman juga meneruskan trend peningkatannya, meningkat 3.6 peratus, sama seperti suku tahun pertama 2025. Peningkatan ini disokong oleh peningkatan dalam indeks Restoran dan aktiviti perkhidmatan makanan bergerak (4.2%) dan Aktiviti perkhidmatan minuman (2.7%). Indeks lain yang mencatatkan peningkatan adalah Pendidikan (1.3%), Kesihatan (0.6%) dan Profesional (0.5%).”

Dato' Sri Dr. Mohd Uzir Mahidin turut menambah, “Sebaliknya, indeks Pengangkutan merekodkan penurunan 0.8 peratus, penyusutan yang lebih kecil berbanding penurunan 3.1 peratus pada suku tahun sebelumnya. Penurunan ini terutamanya disebabkan oleh penurunan dalam indeks Pengangkutan penumpang udara (-4.8%). Indeks Aktiviti hartanah turut mencatatkan penurunan perlahan 0.1 peratus, selepas mencatatkan peningkatan 0.1 peratus pada bulan sebelumnya dipengaruhi oleh indeks Aktiviti hartanah atas dasar

bayaran kontrak (-0.1%). Sementara itu, indeks Maklumat & komunikasi kekal tidak berubah.”

Ketua Perangkawan Malaysia mengulas lanjut, “Pada asas suku tahunan, IHPRP mencatatkan peningkatan sebanyak 0.3 peratus, mengekalkan kadar yang sama seperti pada suku tahun sebelumnya. Peningkatan ini disumbangkan terutamanya oleh indeks Kesenian, hiburan & rekreasi (2.0%) dan indeks Penginapan dan aktiviti perkhidmatan makanan & minuman (0.6%). Sementara itu, indeks Pengangkutan dan Pendidikan masing-masing mencatatkan peningkatan 0.3 peratus. Indeks lain yang turut menyumbang kepada peningkatan sederhana secara keseluruhan adalah Kesihatan (0.2%) dan Profesional (0.1%). Namun begitu, indeks Maklumat & komunikasi dan Aktiviti hartanah kekal tidak berubah pada suku tahun ini.”

Kepengerusian ASEAN-Malaysia 2025: Jabatan Perangkaan Malaysia (DOSM) akan mempengerusikan Jawatankuasa Sistem Statistik Komuniti ASEAN Ke-15 (ACSS15) yang bertujuan untuk memperkukuh kerjasama statistik ke arah pembangunan serantau yang mampan.

Malaysia buat julung kalinya telah menduduki tangga pertama (1) di peringkat global dalam laporan dwi-tahunan *Open Data Inventory* (ODIN) 2024/25 yang dikeluarkan oleh *Open Data Watch* (ODW), mengatasi 197 negara lain. Pencapaian ini merupakan lonjakan ketara daripada kedudukan ke-67 dalam penilaian ODIN 2022/23.



SERVICES PRODUCER PRICE INDEX, MALAYSIA SECOND QUARTER 2025

Malaysia's Services Producer Price Index increased by 1.0 per cent in the Second Quarter of 2025

PUTRAJAYA, August 6th, 2025 – The Department of Statistics, Malaysia today released a report of the **SERVICES PRODUCER PRICE INDEX (SPPI), SECOND QUARTER 2025**, which providing a measures of producer prices changes within Malaysia's domestic services sector. The SPPI registered a year-on-year increase of 1.0 per cent in the second quarter of 2025, up from a 0.6 per cent rise in the previous quarter.

In a statement, Chief Statistician Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin, stated, "The Arts, entertainment & recreation index increased by 4.5 per cent, moderating from a 6.6 per cent increase in the previous quarter. This was primarily driven by the Other amusement and recreation activities index (1.9%). The Accommodation and food & beverage service activities index also continued its upward trend, rising by 3.6 per cent, similar in the first quarter of 2025. This was supported by increases in Restaurants and mobile food service activities index (4.2%) and Beverage service activities index (2.7%). Other indices that recorded increases were Education (1.3%), Health (0.6%) and Professional (0.5%)."

Dato' Sri Dr. Mohd Uzir Mahidin also added that, "In contrast, the Transportation index declined by 0.8 per cent, albeit a smaller contraction compared to the 3.1 per cent drop in the previous quarter. The decrease was mainly attributed to a decrease in the Passenger air transport index (-4.8%). The Real estate activities index also recorded a marginal decrease of 0.1 per cent, after an increase of 0.1 per cent in the previous month, influenced by Real estate activities on a contract basis index (-0.1%). Meanwhile, the Information & communication index remained unchanged."

Chief Statistician Malaysia further elaborated that, “Quarter-on-quarter basis, SPPI increased by 0.3 per cent, maintaining the same rate as in the previous quarter. The increase was primarily attributed to Arts, entertainment & recreation index (2.0%) and Accommodation and food & beverage service activities (0.6%). Meanwhile, both Transportation and Education indices registered an increase of 0.3 per cent, respectively. Other indices that contributed to the modest overall increase were Health (0.2%) and Professional (0.1%). However, Information & communication and Real estate activities indices remained unchanged in this quarter.”

ASEAN-Malaysia 2025 Chairmanship: The Department of Statistics Malaysia (DOSM) will chair the 15th ASEAN Community Statistical System Committee (ACSS15) which aims to strengthen the statistical cooperation towards sustainable regional development.

Malaysia, for the first time, ranked as number one (1) globally in the biennial Open Data Inventory (ODIN) 2024/25 report released by Open Data Watch (ODW), surpassing 197 other countries. This achievement marks a significant leap from its 67th position in the ODIN 2022/23 assessment.


