A RECAP OF DOSM'S INTERNATIONAL PROGRAMMES



Reflecting on **the journey of DOSM's** international programmes **in 2024**, this recap **highlights key activities, partnerships and accomplishments** around the globe.

In 2024, the Department of Statistics Malaysia (DOSM) made significant strides in expanding its global footprint, solidifying its role as a key player in international collaboration. With a focus on fostering strategic partnerships, sharing expertise and embracing innovative solutions, DOSM's international programmes reached new heights this year. Throughout the year, DOSM had the privilege of hosting numerous study and working visits from international delegations, offering a platform to exchange knowledge, share best practices, and collaborate on strategic management initiatives. These visits allowed DOSM to share its expertise with global partners while also gaining valuable insights from leaders and organizations worldwide.



A notable highlight for DOSM in 2024 was the announcement of **Malaysia's 2025 ASEAN Chairmanship**, which created a significant opportunity for DOSM to lead regional statistical initiatives in the coming year.

In line with this mandate, DOSM was entrusted to lead and chair the Fifteenth Session of the ASEAN Community Statistical System (ACSS15), further reinforcing its role in strengthening statistical cooperation and integration across ASEAN Member States. Throughout the year, DOSM continued to build strategic linkages with renowned organisations across various sectors while supporting global initiatives aimed at advancing statistical development. These efforts underscored DOSM's commitment to promoting robust management practices and contributing to the future of strategic leadership at both regional and international levels.

Overall, DOSM's international endeavours in 2024 not only enhanced its global visibility but also fostered meaningful cross-border collaborations that are helping to shape a more informed and interconnected world.



DOSM: PIONEERING DATA EXCELLENCE SINCE 1949

The Department of Statistics, Malaysia (DOSM) was established in 1949 under the Statistics Ordinance 1949 and initially known as the Bureau of Statistics. At that time, the statistics produced were primarily limited to external trade and estate agriculture. In 1965, the Bureau of Statistics was renamed the Department of Statistics, Malaysia, and began operating under the provisions of the Statistics Act 1965. This transition marked the expansion of the Department's functions and roles, with the collection of data now encompassing broader economic and social areas.

Today, the Department of Statistics Malaysia is a premier government agency entrusted with the vital responsibility of collecting, interpreting, and disseminating up-to-date and real-time statistics. These statistics play a critical role in monitoring national economic performance and social development. DOSM is dedicated to providing accurate data that supports informed decision-making at both the national and international levels.

The Department's headquarters is located in the Federal Government Administrative Center in Putrajaya, with state offices across every state in Malaysia. In addition, operational offices have been set up in several states to further strengthen data collection activities and ensure comprehensive, nationwide statistical coverage.

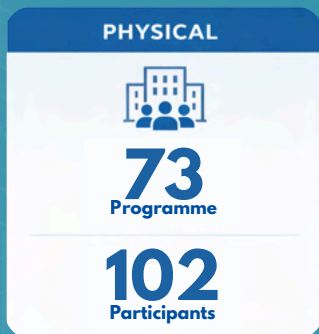

DOSM's PARTICIPATION IN INTERNATIONAL PROGRAMMES

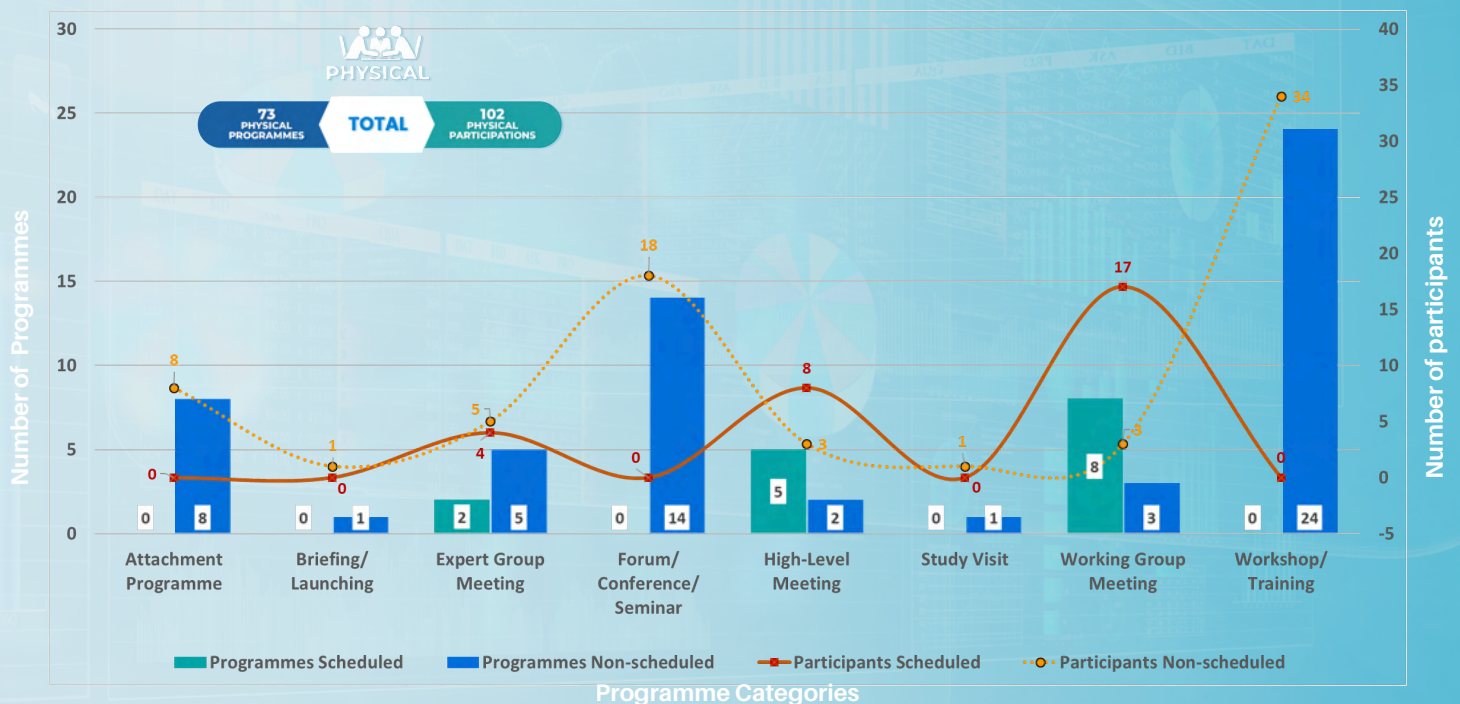


In 2024, the DOSM continued to demonstrate strong engagement with the international statistical community through both physical and virtual participation. A total of **196 international programmes** were attended, **involving 654 DOSM officers** across meetings, workshops, expert groups, seminars and conferences.

Physical participation accounted for 73 programmes (36.9%) with 102 officers (15.5%), reflecting DOSM's commitment to maintaining in-person representation at key regional and global platforms.

Meanwhile, virtual participation made up the majority, with 123 programmes (63.1%) and 552 officers (84.5%), indicating the increasing efficiency and accessibility of remote engagements. Overall, the combined physical and virtual participation underscores DOSM's active role and consistent presence in shaping international statistical development throughout 2024.

Chart 1: International Programmes and Participants by Category and Schedule, 2024



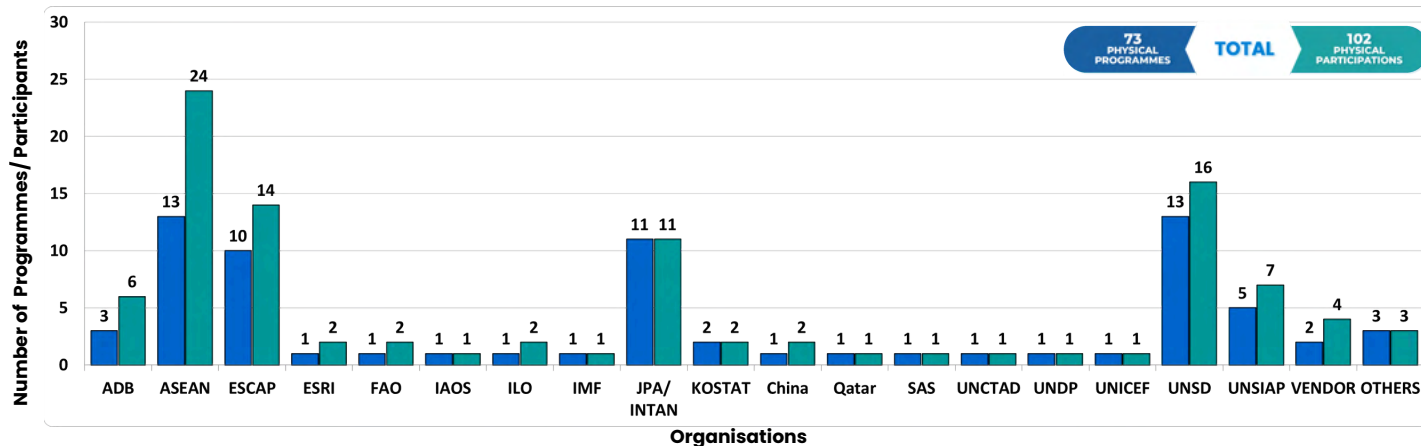
The chart illustrates the number of international programmes attended by category, distinguishing between scheduled and non-scheduled (invitation-based) engagements, as well as the corresponding number of participants. Overall, participation was largely driven by non-scheduled programmes, particularly in workshops/training and forums/conferences/seminars, which also recorded the highest number of participants. Scheduled engagements were more prominent in Working Group Meetings and High-Level Meetings/Commissions, reflecting structured and recurring international commitments. This distribution highlights DOSM's proactive engagement in both planned programmes and responsive participation in invitation-based international activities.

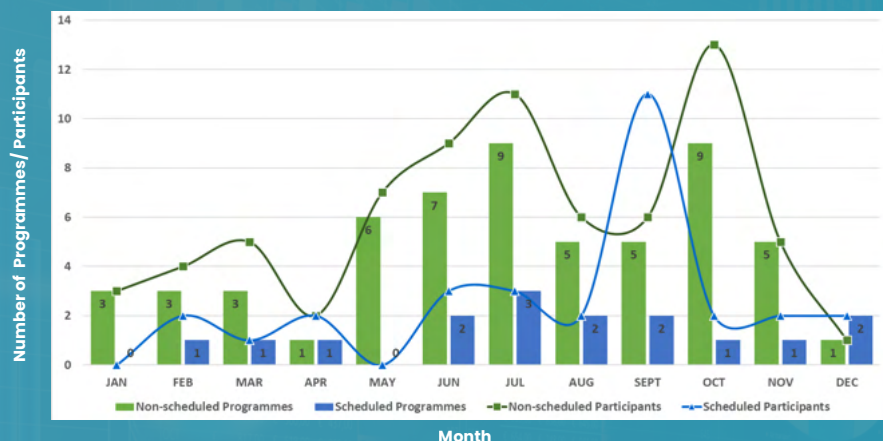

Chart 2: Invitations and DOSM Participation by Organiser, 2024 - Physical



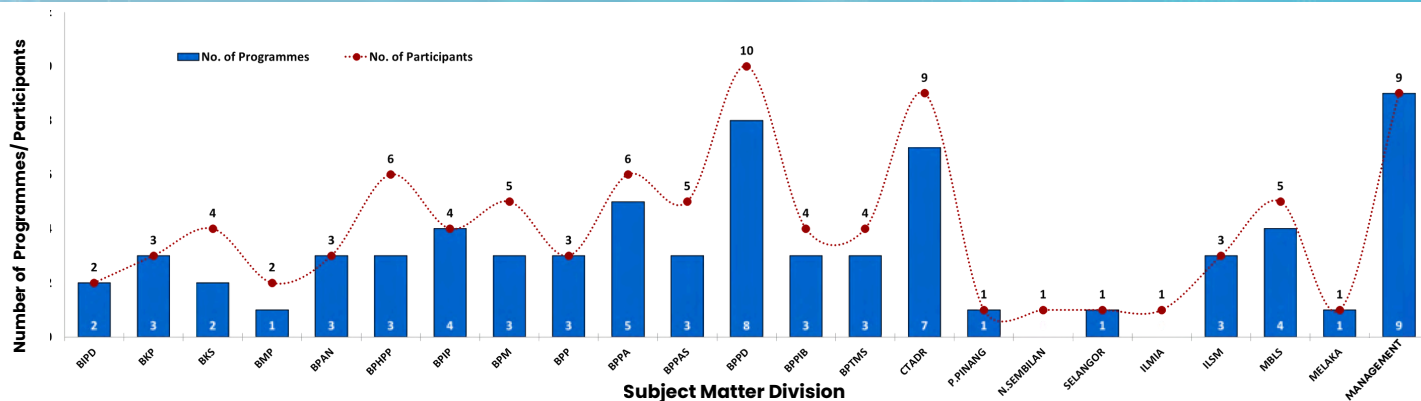
The chart shows the number of international programmes DOSM was invited to in 2024 and the officers involved. ASEAN, ESCAP, UNSD and UNSIAP extended the highest number of invitations. These organisations also recorded the largest officer participation. This highlights DOSM's strong engagement in regional and global statistical initiatives.

Chart 3: Monthly Distribution by Programmes (Scheduled vs Non-scheduled) 2024 - Physical



The chart shows DOSM's monthly participation in international programmes by scheduled and non-scheduled activities. Participation peaked in July, September and October, largely driven by an increase in non-scheduled (ad hoc) invitations, which accounted for the majority of additional officer involvement during these months. In contrast, scheduled programmes remained relatively consistent throughout the year, reflecting stable planned international engagements.

The chart shows the number of international programmes DOSM was invited to in 2024 and the officers involved. ASEAN, ESCAP, UNSD and UNSIAP extended the highest number of invitations. Chart 5 : Estimated and Actual Programme Expenditure by Organisation (RM '000)

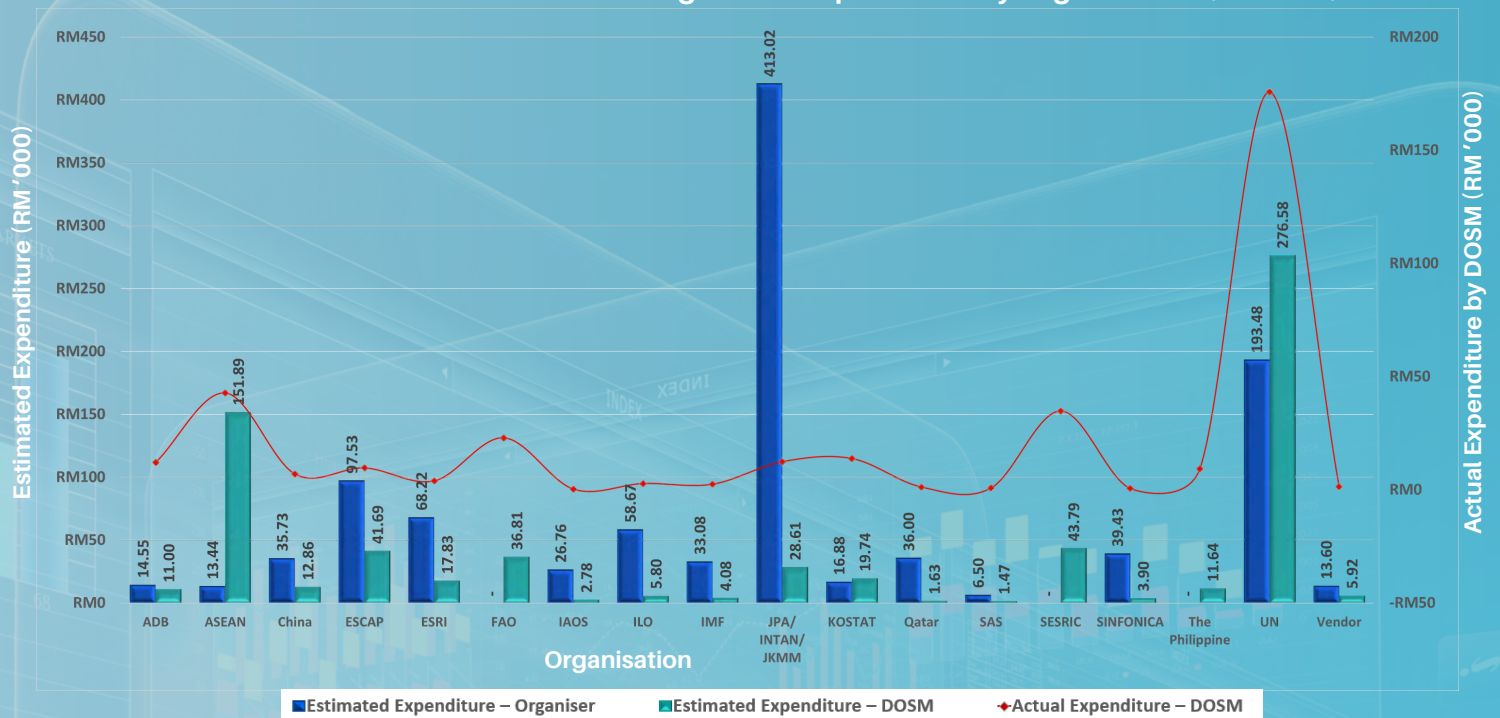
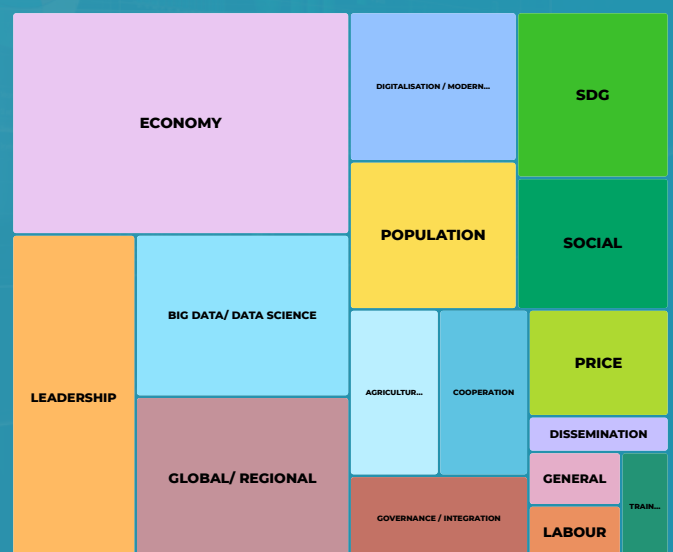


Chart 5 presents a comparison of estimated and actual programme expenditure by organisation, distinguishing between costs borne by the organising institutions and costs covered by DOSM. Estimated expenditure reflects projected costs borne by organisers as well as estimated costs to be covered by DOSM, while actual expenditure represents the realised costs incurred by DOSM. The highest programme expenditures were recorded for JPA/INTAN/JKMM, the United Nations (UN) and ASEAN. JPA/INTAN/JKMM registered the largest estimated organiser expenditure at approximately RM413.0 thousand. The UN recorded the highest estimated and actual DOSM expenditure, at about RM276.6 thousand and RM193.5 thousand respectively, while ASEAN showed the next highest estimated DOSM expenditure at around RM151.9 thousand.

Chart 6: Key Thematic Areas of DOSM's International Engagements, 2024

The bubble chart highlights the key themes of international programmes that DOSM was invited to in 2024, covering expert group meetings, working groups, workshops, seminars and conferences. The largest invitations were centred on Economy, followed by Leadership, SDG, Social, Price, Population, Big Data/Data Science, and Digitalisation. This shows that DOSM's international engagements largely focus on core statistical domains while also expanding into emerging areas such as digital transformation and data governance. DOSM's wide thematic involvement reflects its strong recognition and active role in global and regional statistical development.

NUMBER OF PROGRAMMES ATTENDED BY DOSM IN OTHER COUNTRIES

International programmes attended by DOSM officers were largely hosted in the ASEAN region, with Thailand (12 programmes) and Indonesia (9 programmes) recording the highest number of engagements, reflecting their roles as hosts of the ESCAP Headquarters and the ASEAN Secretariat, respectively. Participation also extended to Japan and the United States (5 programmes each) and selected countries in Europe, the Middle East and Asia, underscoring DOSM's active involvement in regional and global statistical cooperation.



Chart 7: Participation by Grade, 2024

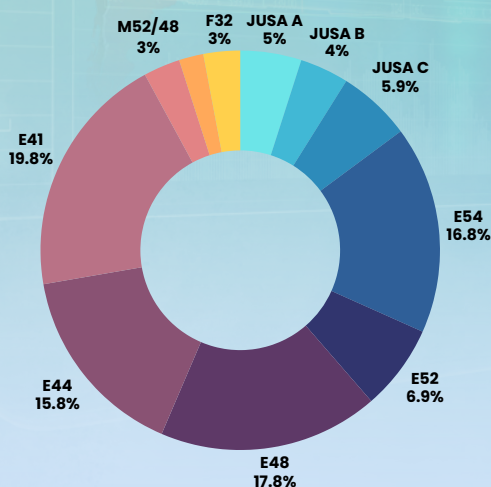
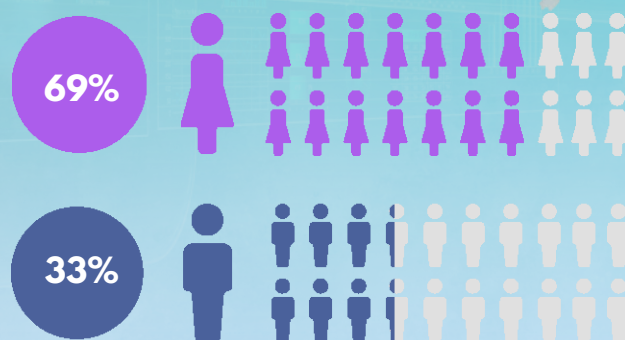


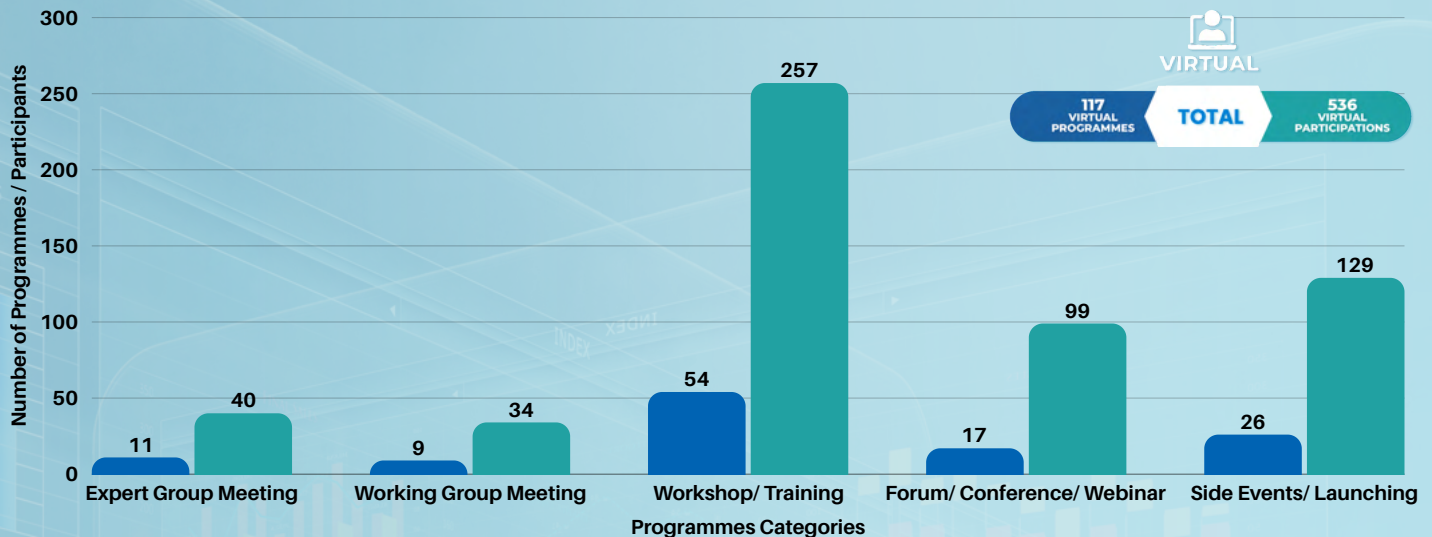
Chart 8: Participation by Gender, 2024

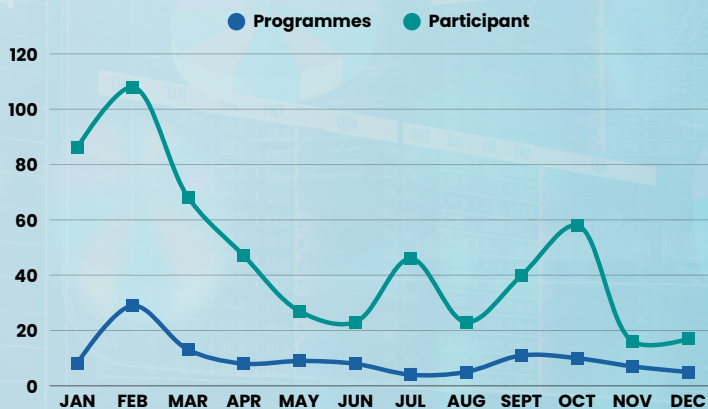

Virtual international engagements in 2024 were dominated by workshops and training programmes, while forums, conferences and webinars recorded moderate participation. Expert group and working group meetings involved fewer, more specialised engagements.

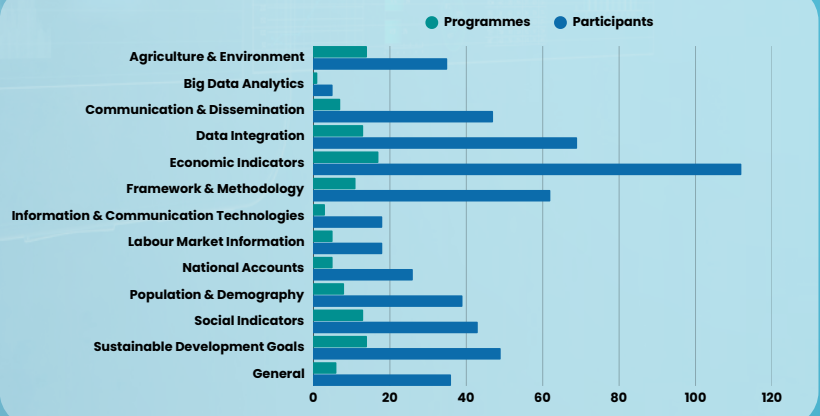
Chart 10: Monthly Participation in Virtual International Programmes, 2024



DOSM's virtual participation fluctuated throughout the year, peaking in February with more than 100 participants, largely driven by side events held in conjunction with the 56th United Nations Statistical Commission (UNSC56). Participation declined during the mid-year period before increasing again in September and October, with October recording nearly 60 participants. Overall, participant trends closely mirrored programme activity across the year.

Chart 11: Participation by Key Statistical Domains (Virtual), 2024

Virtual participation was highest in economic statistics-related domains, recording the largest share of programmes and participants. This was followed by data integration and frameworks and methodology. Other domains such as communication and dissemination, big data analytics and governance-related statistics also showed notable participation, highlighting DOSM's broad expertise across core and emerging statistical areas.

DOSM PARTICIPATION AS INVITED SPEAKERS AND RESOURCE PERSONS IN INTERNATIONAL PROGRAMMES, 2024

In 2024, DOSM officers actively participated in international programmes as presenters, panellists and guest speakers through both physical and virtual platforms. A total of 31 programmes were recorded, comprising 18 physical and 13 virtual engagements, involving 66 DOSM presenters. Study visits and learning visits accounted for the highest number of physical presenters, while virtual participation was most prominent in courses and training programmes. This reflects DOSM's strong demand as a technical resource institution across multiple international platforms.

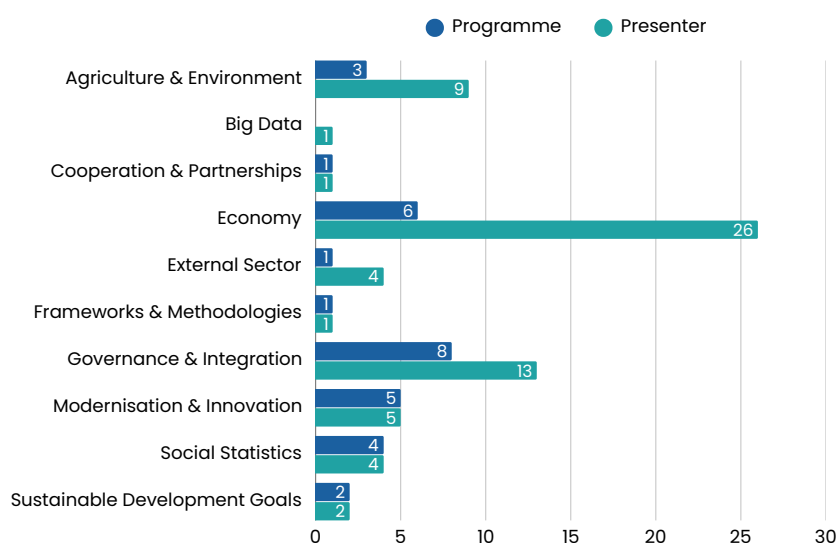


Chart 12: Areas of Expertise Contributed by DOSM in International Programmes, 2024

DOSM's expertise was most frequently invited in the areas of Economy, Governance and Integration and Agriculture & Environment. Economic statistics recorded the highest level of engagement, particularly in presenter roles, indicating strong international demand for DOSM's technical knowledge in macroeconomic and sectoral analysis. Other key areas included modernisation and innovation, social statistics, and sustainable development goals, reflecting DOSM's broad and diversified expertise in supporting international statistical discourse.

In 2024, the Department of Statistics Malaysia (DOSM) participated in 36 international programmes conducted in Malaysia, involving a total of 143 participations. Capacity-building activities, encompassing courses, workshops and training programmes, constituted the largest segment, accounting for 18 programmes and 93 participations. This was followed by seminars, forums and conferences, with 6 programmes and 19 participations. Internal coordination meetings comprised 9 programmes with 22 participations, while briefings, launchings and meetings or commissions represented a smaller share of overall engagements.

RESPONDING TO INTERNATIONAL REQUESTS FOR STATISTICAL DEVELOPMENT

In 2024, the Department of Statistics Malaysia (DOSM) provided a total of 99 responses to requests from international statistical organisations. These responses covered various formats, including data and statistical submissions, surveys, technical write-ups, and contributions to international frameworks and guidelines. The distribution across quarters reflects DOSM's consistent engagement and its ongoing commitment to supporting global statistical development.

New York, 26 February 2024 - In a momentous step forward in international collaboration, Malaysia and Uzbekistan formalised a Memorandum of Understanding (MoU), marking a pivotal milestone in strengthening bilateral cooperation in official statistics. The agreement signifies a significant elevation in the partnership between both countries, aimed at fortifying statistical practices, enhancing capacity-building and advancing shared aspirations in modernising National Statistics Systems. With a focus on knowledge exchange and technical expertise, the MoU charts a five-year cooperation framework that reinforces the commitment of both Malaysia and Uzbekistan to evidence-based decision-making and sustainable development. This milestone further reflects the collective effort to strengthen the global statistical community.



The MoU was signed by **YBhg. Dato' Sri Dr. Mohd Uzir Mahidin**, Chief Statistician Malaysia, representing the Government of Malaysia and Mr. Bakhodir Begalov, Director of the Statistics Agency under the President of the Republic of Uzbekistan (Statistics Agency), representing the Government of Uzbekistan.



The ceremony was witnessed by His Excellency Dato' Dr. Ahmad Faisal Bin Muhamad, Ambassador and Permanent Representative of Malaysia to the United Nations (UN), along with His Excellency Mr. Ulugbek Lapasov, Ambassador and Permanent Representative of the Republic of Uzbekistan to the United Nations.



Held at the Permanent Mission of Malaysia to the United Nations, the signing coincided with the 55th Session of the United Nations Statistical Commission (UN55SC), convened from 27 February to 1 March 2024.





55TH UNITED NATIONS STATISTICAL COMMISSION (#UN55SC)



The **United Nations Statistical Commission (UNSC)** is a crucial platform for chief statisticians and leaders of national statistical systems (NSSs) globally. This year's event saw a remarkable turnout, with over 550 participants from 108 countries representing 52 agencies and non-governmental organizations. The agenda was diverse, featuring 350 written statements, 65 in-person side events, and 33 virtual side events, all dedicated to exploring the paramount importance and standardisation of statistics in our rapidly evolving world. The overarching theme of the event was **'Better Data, Better Lives'**, highlighting the indispensable role of high-quality statistics in advancing global well-being.

27 February - 3 March 2024 - At the 55th United Nations Statistical Commission (UNSC) in New York, the Department of Statistics Malaysia showcased Malaysia's leadership in global statistical development and contributed to discussions that advanced international standards across economic, social and environmental domains.

Malaysia's participation extended beyond the formal sessions, with DOSM engaging in **high-level seminars and bilateral meetings** beginning 23 February. Through these engagements, Malaysia exchanged best practices with leading National Statistical Offices (NSOs) and reinforced its standing as an active and respected member of the global statistical community.

* Driving Change with Written Statements

DOSM submitted **33 Written Statements** supporting global efforts to improve statistical guidelines, ensuring alignment with global standards to produce reliable data and empowering nations to generate timely statistics for sustainable development.

* Voicing Malaysia's Vision

DOSM delivered **11 oral statements** that highlighted Malaysia's perspectives, advancing global statistical agendas and reinforcing the nation's role in global decision-making.

* Leading the Digital Trade Revolution

As a **guest speaker** at the side event **"Measuring Digital Trade"**, DOSM shared Malaysia's best practices in e-commerce measurement, encouraging global innovation in digital trade tracking.

* Building Bridges Through Collaboration

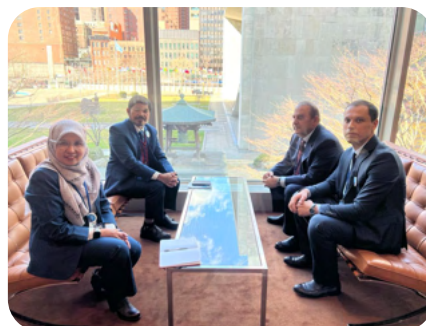

9-13 December 2024 — The Department of Statistics Malaysia attended the Asia-Pacific Statistics Week 2024 in Bangkok, Thailand. This annual event, organised by the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) and the Statistical Institute for Asia and the Pacific (SIAP), was conducted under the theme **"The Power of Data"**. The event brought together heads of national statistical offices and international statistical experts to strengthen cooperation and strategies for agile and inclusive statistical development.



Representing Malaysia were Ms. Norhayati Jantan, Senior Director, National Accounts Statistics Division, and Mr. Mohd Sofi bin Ali, Director of the Malaysia Statistical Training Institute. The delegation participated in policy dialogues, technical sessions, and leadership discussions, sharing Malaysia's perspectives and best practices to strengthen regional statistical capacity.



The programme was comprehensive, featuring policy dialogues, technical discussions, and specialised side events that addressed key priorities, including modernising statistical systems, strengthening data governance, enhancing population and social statistics, expanding the use of administrative and big data, and reinforcing partnerships for capacity development.

The 2024 session demonstrated exceptional regional engagement, bringing together over 170 participants from national statistical offices (NSOs) and 37 representatives from international organisations, UN agencies, intergovernmental bodies, and development partners, amounting to a total of 209 participants.



As part of the programme, CST-9 took place from 11 to 13 December, marking a critical moment for regional statistical governance. Delegates reviewed progress under the region-wide **"Declaration on Navigating Policy with Data to Leave No One Behind,"** reinforcing the commitment of member States to build data-driven, inclusive and modern statistical systems.

Through active participation, Malaysia contributed to shaping the regional statistical agenda. The delegation shared experiences and best practices in areas including modern data infrastructure, capacity-building, and statistical harmonisation. Discussions underscored the need for agile statistical systems capable of responding to emerging data demands, particularly in big data, machine learning and artificial intelligence, aligning closely with regional efforts to modernise national statistical systems and improve data quality and accessibility.

As a member of the SIAP Governing Council, Malaysia contributed directly to discussions shaping the SIAP Strategic Plan 2025-2029, the SIAP Finance Plan, and the SIAP Work Programme for 2025, with a focus on AI, big data, and climate-related statistics.

13TH SESSION OF THE OIC-STATISTICAL COMMISSION (OIC-STATCOM)

15 -16 October 2024 - The Statistical, Economic and Social Research and Training Centre for Islamic Countries (SESRIC), in its capacity as the Secretariat of the OIC Statistical Commission (OIC-StatCom), **organised the 13th Session of the OIC-StatCom** in a hybrid format at its Headquarters in Ankara, Republic of Türkiye, in collaboration with the Islamic Development Bank (IsDB) Group. It was attended by a total of **68 participants from the National Statistical Offices (NSOs) of 38 OIC member countries, along with representatives from nine international and regional organisations**, namely the Statistical Centre for the Cooperation Council for the Arab Countries of the Gulf (GCC-Stat), Organization for Economic Cooperation and Development (OECD) Istanbul Centre, PARIS21, United Nations Economic Commission for Europe (UNECE), United Nations Economic Commission for Western Asia (UNESCWA), United Nations Population Fund (UNFPA), United Nations Statistics Division (UNSD), United Nations Technology Bank for the Least Developed Countries and the World Bank.

The working sessions of the 13th Session of the OIC-StatCom focused on key areas of vital to the statistical development of OIC member countries. As the Commission's Secretariat, **SESRIC delivered two presentations on: (1) the implementation of the Resolutions of the 12th Session of the OIC-StatCom, and (2) the implementation of the OIC-StatCom Programme of Action for 2021-2025.** These were followed by discussions on a range of technical topics, including **Inclusive Data Collection in Social Protection, Ethics for New Data Sources and Technologies, Sustainable Development Goals: Monitoring and Reporting SDG 2 (Zero Hunger) Indicators, Embracing Machine Learning and Artificial Intelligence in Official Statistics, 2020 Round of the World Population and Housing Census Programme: Lessons Learnt and The Way Forward.**

Representing Malaysia were Mr. Mohd Sofi Ali, Director of the Malaysia Statistical Training Institute (ILSM) and Mr. Mohd Sawal Shakimon, Director of the DOSM State Office of Negeri Sembilan. They demonstrated their full commitment by **sharing their experiences and best practices**, particularly in **Machine Learning and Artificial Intelligence**, as well as the **2020 Round of the World Population and Housing Census**.





14TH SESSION OF THE ASEAN COMMUNITY STATISTICAL SYSTEM (ACSS14) COMMITTEE

26 - 28 November 2024 - Since its inception in 2011, the ACSS has remained dedicated to fulfilling its mandate by continuously providing high-quality, timely, and comparable statistics to support ASEAN integration efforts and informed policymaking across the region, particularly by supporting ASEAN integration monitoring and evidence-based policy and decision-making. The ACSS has also been consistently strengthening its cooperation to enhance the statistical capacities of ASEAN Member States (AMS) and the ASEAN Secretariat.

This commitment was prominently reflected at the Fourteenth Session of the ASEAN Community Statistical System Committee (ACSS14), hosted by the Lao Statistics Bureau from 26 to 28 November 2024. The session was chaired by Ms. Phonesaly Souksavath, Head of the Lao Statistics Bureau, with YBhg. Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia, serving as Co-Chairperson.

Malaysia, represented by the Department of Statistics Malaysia (DOSM), played an influential role in advancing the regional statistical agenda. YBhg. Dato' Sri Dr. Mohd Uzir was accompanied by Ms. Ezatul Nisha Abdul Rahman, Director of the Change Management Office and Member of the ACSS Sub-Committee on Planning and Coordination (ACSS-SCPC). Together, they contributed Malaysia's perspectives and shared best practices across several priority areas.

Key topics highlighted by the Malaysian delegation included the presentation of the Handbook for Mirror Analysis on Merchandise Trade Statistics; progress updates on data harmonisation initiatives under Malaysia's leadership of the Working Group on the System of National Accounts (WGSNA) from 2021-2024; and insights into national developments in data governance, data stewardship and data integration. The delegation also briefed the Committee on Malaysia's preparations for ACSS15, as the country assumes the ACSS Chairmanship in 2025 under its broader ASEAN Chairmanship mandate.

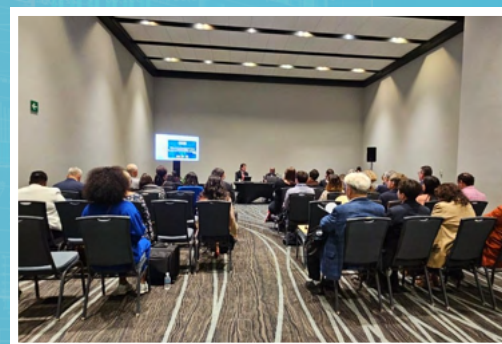

MARCH

6 March 2024 - The **Webinar on Measuring Digital Trade** was part of SIAP's webinar series on Macroeconomic Statistics Frameworks. Ms Norazlin Muharam, Principal Assistant Director of the Services Statistics Division, acted as the trainer, sharing Malaysia's experience and best practices in developing international e-commerce. Her presentation, titled "Malaysia's Experience and Practice: Measuring Digital Trade," emphasised current e-commerce statistics, related digital economy data, and key initiatives underway to improve the measurement of digital trade for future development.



APRIL

24 - 25 April 2024 - The Virtual Training Course on Sustainable Development Goal 4 (SDG 4) on the topic **"Quality Education"** was conducted. Dr. Nor Hisham bin Ismail, Principal Assistant Director at the Ministry of Education Malaysia, and Ms. Norul Anisa Abu Safran, Assistant Director at the Manpower and Social Statistics Division, served as trainers. 15 -17 May 2024 - **The IAOS-ISI RSC 2024 Mexico Conference**, held in Mexico City and organised by Mexico's National Institute of Statistics and Geography (INEGI), the International Association of Official Statistics (IAOS), and the International Statistical Institute (ISI), featured the theme "Building A National Data Infrastructure for Malaysia's Future: A Focus on Data Production & Innovation." The conference highlighted the vital role of National Statistical Offices (NSOs) in partnering with citizens and stakeholders to address challenges in data production and governance. The training featured Mr. Mohd Syahidi Alfee, Senior Assistant Director of Core Team Big Data, and Ms. Wan Aznie Fatimah, Assistant Director of Core Team Big Data Analytics. The training aimed to discuss the relation between international trade statistics and business statistics to enrich economic analysis, particularly on production, employment and enterprises' performance.

MAY

Ultimately, the workshop sought to formulate agreed actions and outline the next steps for these initiatives.

31 May 2024 - **The Compiling of Unit Value Index - Export and Import Price Index Workshop** was organised by DOSM in collaboration with the National Account Unit, Ministry of Planning and Economic Development, Egypt. Presentations were delivered by Ms. Wan Siti Saleha Wan Zakaria, Deputy Director of the International Trade Statistics Division; Mr. Muhammad Nazri Adam, Assistant Director; as well as Mr. Nelson Jimbun and Ms. Nur Atiqah Zulkifli, Assistant Statistical Officers from the same division. The workshop aimed to enhance participants' understanding of the computational procedures for the Unit Value Index, with particular emphasis on calculating weights and deriving both value and volume indices.



JUNE



4 June 2024 - a webinar entitled **"Developing a Data Strategy: Connecting User Needs with Effective Data Governance and Stewardship"** was organised by the United Nations Network of Economic Statisticians. The session was delivered by Mr Mohd Yazid Kasim, Senior Director of the Change Management Office. Asian Development Bank (ADB)

In 2 May 2024, a delegation from the Asian Development Bank (ADB), led by Ms. Elaine Tan, visited the Department of Statistics Malaysia for a courtesy call to discuss a collaborative effort on the Green City Action Plans (GCAP). United Nations Children's Fund (UNICEF)

From Statistics Agency under the Republic of Uzbekistan



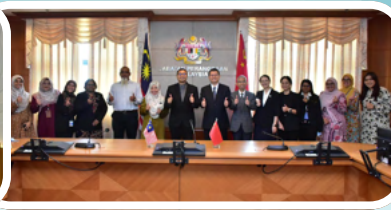

With this shared knowledge and understanding, both countries aim to enhance their statistical capabilities and improve data quality, ultimately contributing to more accurate and transparent national statistics.



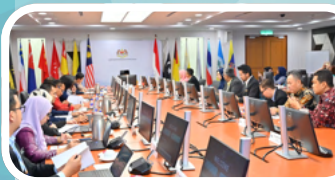
WORKING VISIT TO DOSM

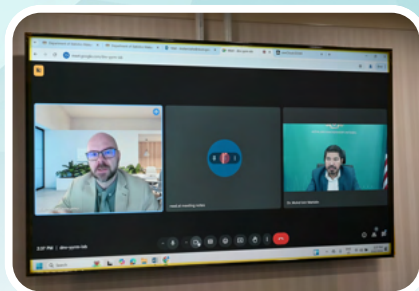
INTERVIEW SESSION

The successful convening of WGSNA-8 further reinforces Malaysia's commitment to leading efforts that strengthen a harmonised, competitive and forward-looking ASEAN System of National Accounts in support of the region's sustainable development agenda.



Regional Workshop on Compiling Tourism Statistics in Asia and the Pacific

PUTRAJAYA, 28th NOVEMBER 2024 – Malaysia has officially reassumed the Chairmanship of the ASEAN Community Statistical System (ACSS) for 2025 after a decade, following its previous leadership in 2015. This milestone marks a significant step in strengthening regional statistical collaboration. The announcement was made during the 14th Session of the ACSS Committee (ACSS14), held from 28th to 29th November 2024 in Vientiane, Lao PDR, hosted by the Lao Statistics Bureau. The session was chaired by Mr. Phommavanh Soukhanth, Chief Statistician of Lao PDR and co-chaired by Dr. Mohd Uzi Mahidin, Chief Statistician of Malaysia. As the Chair of ACSS for 2025, Malaysia will focus on leading the strategic agenda of ACSS, particularly in strengthening ASEAN's statistical capacity, supporting data-driven decision-making and sharing initiatives towards more sustainable and inclusive regional integration.

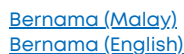

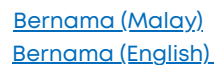
