## KATA PENGANTAR

Penerbitan Perusahaan Mikro, Kecil dan Sederhana (PMKS) membentangkan statistik yang meliputi Keluaran Dalam Negeri Kasar (KDNK), Eksport, Guna Tenaga dan Produktiviti dari tahun 2015 hingga 2023. Penyusunan ini menggunakan konsep yang disarankan oleh Sistem Akaun Negara 2008.

Penerbitan ini dibahagikan kepada empat bahagian. Bahagian pertama memaparkan sorotan utama keseluruhan statistik PMKS, diikuti bahagian kedua, mengandungi ringkasan penemuan bagi keseluruhan statistik PMKS. 






## PENGENALAN

Penerbitan ini memaparkan prestasi Perusahaan Mikro, Kecil dan Sederhana (PMKS) meliputi KDNK, Eksport dan Guna Tenaga bagi tahun 2023. Statistik ini disusun berdasarkan definisi PMKS yang digariskan oleh Majlis Pembangunan Usahawan dan PMKS Kebangsaan (MPUPK).

### PRESTASI KDNK PMKS 2023

KDNK PMKS Malaysia bertumbuh 5.0 peratus pada tahun 2023 berbanding 12.3 peratus pada tahun 2022. Prestasi ini melebihi KDNK Malaysia dan KDNK Bukan PMKS yang masing-masing mencatatkan 3.6 peratus dan 2.7 peratus (**Carta 1**).



Sumbangan PMKS kepada KDNK meningkat kepada 39.1 peratus pada tahun 2023 dengan nilai ditambah sebanyak RM613.1 bilion, berbanding 38.6 peratus (nilai ditambah: RM584.1 bilion) pada tahun sebelumnya, seperti yang ditunjukkan dalam **Carta 2**. Prestasi ini dipacu oleh sektor Perkhidmatan dan Pembuatan yang menyumbang 84.8 peratus daripada jumlah KDNK PMKS. Dari segi nominal, KDNK PMKS mencatatkan RM707.6 bilion pada tahun 2023 (2022: RM672.9 bilion).


## Nilai Ditambah dan Peratus Sumbangan KDNK PMKS kepada KDNK Malaysia bagi 2016-2023



Nilai ditambah PMKS dalam sektor **Perkhidmatan** berkembang sebanyak 6.5 peratus pada tahun 2023 berbanding 17.2 peratus pada tahun sebelumnya, seperti yang ditunjukkan dalam **Paparan 1**. Prestasi ini disokong oleh pertumbuhan positif dalam semua subsektor, iaitu Perdagangan borong & runcit, makanan & minuman dan penginapan pada 5.7 peratus (2022: 16.3%), Kewangan, insurans, hartanah dan perkhidmatan perniagaan sebanyak 6.3 peratus (2022: 17.0%), Pengangkutan & penyimpanan dan maklumat & komunikasi pada 10.6 peratus (2022: 19.5%) dan Perkhidmatan lain pada 9.1 peratus (2022: 23.4%).

Sementara itu, nilai ditambah PMKS bagi sektor **Pembuatan** bertumbuh pada kadar yang lebih perlahan iaitu 1.5 peratus (2022: 6.0%) pada tahun 2023. Pertumbuhan sederhana ini dipengaruhi oleh pertumbuhan positif dalam subsektor Makanan, minuman dan tembakau yang meningkat sebanyak 5.0 peratus (2022: 4.8%). Selain itu, Produk mineral bukan logam, logam asas dan produk logam yang direka berkembang kepada 5.3 peratus berbanding 7.8 peratus pada tahun sebelumnya.


Nilai ditambah PMKS dalam sektor **Pertanian** pada tahun 2023 meningkat 1.3 peratus, lebih tinggi berbanding pertumbuhan 0.9 peratus pada tahun sebelumnya. Prestasi ini disokong oleh subsektor Getah, kelapa sawit, ternakan dan pertanian lain (1.8%) dan Perikanan (0.5%).

Di samping itu, nilai ditambah PMKS bagi sektor **Pembinaan** dan **Perlombongan & pengkuarian** masing-masing meningkat kepada 5.8 peratus dan 4.9 peratus.

## KOMPOSISI KDNK PMKS MENGIKUT JENIS AKTIVITI EKONOMI

Sektor Perkhidmatan kekal sebagai penyumbang utama kepada aktiviti PMKS dengan sumbangan 64.6 peratus, diikuti oleh sektor Pembuatan dengan 20.2 peratus (**Paparan 2**). Sementara itu, sektor Pertanian pula menyumbang sebanyak 9.1 peratus. Sektor Pembinaan dan Perlombongan & pengkuarian masing-masing menyumbang 4.5 peratus dan 0.5 peratus kepada KDNK PMKS.


### Paparan 2: Peratus Sumbangan KDNK Malaysia dan PMKS bagi 2023 pada Harga Malar 2015



## SUMBANGAN KDNK PMKS KEPADA KDNK MALAYSIA MENGIKUT JENIS AKTIVITI EKONOMI

Dari perspektif sumbangan KDNK PMKS mengikut jenis aktiviti ekonomi, semua sektor mencatatkan peningkatan pada tahun 2023 kecuali sektor Pembinaan. KDNK PMKS diterajui oleh sektor Pertanian dengan sumbangan 55.1 peratus (2022: 54.8%) seperti yang ditunjukkan dalam **Paparan 3**. Sumbangan KDNK PMKS bagi Pembinaan pula mencatatkan 48.9 peratus daripada 49.0 peratus pada tahun sebelumnya.


### Paparan 1: Peratus Sumbangan KDNK PMKS kepada KDNK Malaysia bagi 2023 pada Harga Malar 2015



Sumbangan KDNK PMKS dalam sektor Perkhidmatan meningkat kepada 42.7 peratus daripada 42.1 peratus pada tahun sebelumnya. Sektor ini didominasi oleh subsektor Perdagangan borong & runcit, makanan & minuman dan penginapan. Selain itu, sektor Pembuatan menyumbang 33.8 peratus (2022: 33.5%) daripada KDNK PMKS, disokong oleh subsektor Makanan, minuman dan tembakau. KDNK PMKS dalam sektor Perlombongan & pengkuarian mencatatkan sumbangan 3.2 peratus (2022: 3.0%) pada tahun 2023.

## PRESTASI EKSPORT PMKS 2023

Eksport PMKS bernilai RM152.2 billion pada tahun 2023, bertumbuh secara perlahan 4.5 peratus berbanding 17.2 peratus pada tahun sebelumnya. Prestasi tersebut dipengaruhi terutamanya oleh sektor Pembuatan yang menyusut 0.7 peratus berbanding 19.5 peratus pada tahun 2022. Walau bagaimanapun, sektor Perkhidmatan melonjak kepada 24.2 peratus (2022: 8.8%) manakala sektor Pertanian kekal kukuh pada 13.7 peratus (2022: 15.5%) seperti dalam **Carta 3**. Sumbangan eksport PMKS meliputi 12.2 peratus kepada keseluruhan eksport pada tahun 2023, diterajui oleh sektor Pembuatan dengan 9.0 peratus, diikuti sektor Perkhidmatan (2.8%) dan sektor Pertanian (0.3%).



Nilai eksport PMKS bagi sektor **Pembuatan** adalah RM113.1 bilion pada tahun 2023 berbanding RM113.8 bilion pada tahun 2022, merangkumi 74.3 peratus dan kekal mendominasi keseluruhan eksport PMKS. Penyumbang utama sektor ini adalah barang-barang keluaran kilang, pelbagai barang keluaran kilang dan jentera & peralatan pengangkutan. Destinasi utama untuk eksport PMKS bagi sektor Pembuatan adalah Singapura yang meliputi 18.4 peratus, diikuti oleh China (14.2%) dan Amerika Syarikat (11.3%).


Eksport PMKS sektor **Perkhidmatan** bagi tahun 2023 meningkat kepada RM35.4 bilion berbanding RM28.5 bilion pada tahun sebelumnya. Komponen utama yang menyumbang kepada pertumbuhan ini adalah Perkhidmatan perniagaan lain, Perjalanan dan Pengangkutan.

Eksport PMKS bagi sektor **Pertanian** bernilai RM3.7 bilion dengan sumbangan 2.4 peratus daripada jumlah eksport PMKS pada tahun 2023. Sektor ini mencatatkan pertumbuhan 13.7 peratus didorong oleh peningkatan dalam eksport ikan hiasan, ayam/ itik dan perikanan dengan nilai RM1.1 bilion berbanding RM0.8 bilion pada tahun 2022.

## PRESTASI GUNA TENAGA PMKS 2023

Guna tenaga PMKS pada tahun 2023 terus mencatatkan peningkatan tahun ke tahun, walaupun dengan kadar yang lebih perlahan 3.5 peratus berbanding 3.8 peratus pada tahun sebelumnya. Pertumbuhan guna tenaga PMKS adalah lebih tinggi berbanding guna tenaga Malaysia dan guna tenaga Bukan PMKS yang mana masing-masing meningkat 2.8 peratus dan 2.1 peratus. Dari segi bilangan, guna tenaga PMKS bertambah sebanyak 263 ribu untuk merekodkan sejumlah 7.86 juta orang (2022: 7.59 juta orang). Sehubungan itu, guna tenaga PMKS yang merangkumi 48.5 peratus daripada jumlah keseluruhan guna tenaga Malaysia, meningkat 0.3 mata peratus daripada 48.2 peratus pada tahun 2022 (**Carta 4**).

## GUNA TENAGA PMKS MENGIKUT JENIS AKTIVITI EKONOMI 2023

Guna tenaga PMKS dalam sektor **Pertanian** menyumbang 42.5 peratus daripada keseluruhan guna tenaga dalam sektor ini (2022: 42.3%) untuk merekodkan 795 ribu orang pada tahun 2023. Bilangan guna tenaga PMKS dalam sektor Pertanian meningkat kepada 1.0 peratus berbanding negatif 0.4 peratus pada tahun 2022.

Sumbangan guna tenaga PMKS dalam sektor **Perlombongan & pengkuarian** adalah sebanyak 27.5 peratus pada tahun 2023, dengan sejumlah 21 ribu orang pada tahun tersebut. Guna tenaga PMKS dalam sektor ini mencatatkan peningkatan marginal 0.1 peratus berbanding tahun sebelumnya.


Pada masa yang sama, terdapat 1.28 juta guna tenaga dalam PMKS bagi sektor **Pembuatan** pada tahun 2023, merangkumi 45.7 peratus daripada jumlah guna tenaga dalam sektor ini (2022: 45.9%). Walaupun sumbangan guna tenaga PMKS dalam sektor Pembuatan berkurangan, bilangan guna tenaga PMKS meningkat 2.4 peratus dalam tempoh tersebut (2022: 3.0%). Prestasi ini didorong oleh pertumbuhan positif dalam semua subsektor, terutamanya dalam subsektor Makanan, minuman dan tembakau yang meningkat 5.4 peratus (2022: 4.6%).

Di samping itu, guna tenaga PMKS dalam sektor **Pembinaan** menyumbang 48.3 peratus daripada keseluruhan guna tenaga dalam sektor ini (2022: 48.4%). Dari segi bilangan, guna tenaga PMKS bagi sektor Pembinaan bertambah baik dengan 0.9 peratus pada tahun 2023 berbanding pertumbuhan kecil 0.2 peratus pada tahun sebelumnya untuk merekodkan 675 ribu orang.

Bagi sektor **Perkhidmatan**, guna tenaga PMKS mencatatkan sejumlah 5.09 juta orang, menyumbang 50.6 peratus daripada keseluruhan guna tenaga dalam sektor Perkhidmatan (2022: 50.1%). Dari segi perubahan peratusan tahunan, guna tenaga PMKS dalam sektor ini meningkat 4.5 peratus pada tahun 2023 berbanding 5.3 peratus pada tahun lepas. Peningkatan ini sebahagian besarnya disumbangkan oleh dua subsektor iaitu Perdagangan borong & runcit, makanan & minuman dan penginapan (5.2%) dan Pengangkutan & penyimpanan dan maklumat & komunikasi (4.5%).

Guna tenaga PMKS pada tahun 2023 kebanyakannya tertumpu dalam sektor Perkhidmatan dengan sumbangan sebanyak 64.7 peratus, meningkat 0.6 mata peratus daripada 64.1 peratus pada tahun sebelumnya. Guna tenaga PMKS dalam sektor Pembuatan merangkumi 16.3 peratus daripada jumlah guna tenaga PMKS, diikuti oleh sektor Pertanian yang menyumbang sebanyak 10.1 peratus. Di samping itu, sumbangan guna tenaga PMKS dalam sektor Pembinaan adalah sebanyak 8.6 peratus, manakala sektor Perlombongan & pengkuarian menyumbang hanya 0.3 peratus (**Paparan 4**).

#### **Paparan 4: ➤ Guna Tenaga PMKS mengikut Jenis Aktiviti Ekonomi bagi 2022-2023**




#### **PRODUKTIVITI BURUH PMKS 2023**


Produktiviti buruh PMKS yang diukur sebagai nilai ditambah per pekerja meningkat 1.5 peratus pada tahun 2023 untuk mencatatkan nilai produktiviti sebanyak RM78,035 per pekerja (2022: RM76,919 per pekerja). Pada tempoh tersebut, pertumbuhan produktiviti buruh PMKS adalah lebih tinggi daripada pertumbuhan produktiviti buruh Malaysia dan Bukan PMKS yang mana masing-masing mencatatkan peningkatan 0.7 peratus dan 0.5 peratus. Walau bagaimanapun, nilai ditambah per pekerja PMKS adalah lebih rendah daripada produktiviti buruh Malaysia (RM96,780 per pekerja) dan Bukan PMKS (RM114,432 per pekerja) (**Carta 5**).


## INTRODUCTION

This publication presents the performance of Micro, Small, and Medium Enterprises (MSMEs) regarding GDP, Exports, and Employment for the year 2023. MSMEs statistics are compiled based on the MSMEs definition outlined by the National Entrepreneur Development and MSME Council (MPUPK).

## PERFORMANCE OF MSMEs' GDP 2023

GDP of Malaysia's MSMEs grew by 5.0 per cent in 2023 as against 12.3 per cent in 2022. This performance exceeded Malaysia's GDP and Non-MSMEs' GDP which registered 3.6 per cent and 2.7 per cent, respectively (**Chart 1**).




The contribution of MSMEs to GDP increased to 39.1 per cent in 2023 with a value added of RM613.1 billion, as compared to 38.6 per cent (value added: RM584.1 billion) in the previous year, as presented in **Chart 2**. The performance was driven by the Services and Manufacturing sectors, which accounted for 84.8 per cent of the total MSMEs' GDP. In nominal terms, MSMEs' GDP recorded RM707.6 billion in 2023 (2022: RM672.9 billion).

The value added of MSMEs in the **Services** sector expanded by 6.5 per cent in 2023 as compared to 17.2 per cent in the previous year, as shown in **Exhibit 1**. This performance was supported by positive growth in all sub-sectors, namely Wholesale & retail trade, food & beverages and accommodation at 5.7 per cent (2022: 16.3%), Finance, insurance, real estate and business services at 6.3 per cent (2022: 17.0%), Transportation & storage and information & communication at 10.6 per cent (2022: 19.5%) and Other services at 9.1 per cent (2022: 23.4%).

Meanwhile, MSMEs' value added for the **Manufacturing** sector grew at a slower pace of 1.5 per cent (2022: 6.0%) in 2023. The moderate growth was influenced by positive growth in Food, beverage and tobacco sub-sector, which grew by 5.0 per cent (2022: 4.8%). Additionally, the Non-metallic mineral products, basic metal and fabricated metal products expanded by 5.3 per cent as compared to 7.8 per cent in the previous year.


The value added of MSMEs in the **Agriculture** sector in 2023 increased 1.3 per cent, higher than the 0.9 per cent growth in the preceding year. This performance was supported by Rubber, oil palm, livestock and other agriculture (1.8%) and Fishing (0.5%) sub-sectors.

Additionally, MSMEs' value added for the **Construction** and **Mining & quarrying** sectors increased to 5.8 per cent and 4.9 per cent, respectively.

### **COMPOSITION OF MSMEs' GDP BY KIND OF ECONOMIC ACTIVITY**

The Services sector remained the main contributor to MSMEs' activities with a share of 64.6 per cent, followed by the Manufacturing sector with 20.2 per cent (**Exhibit 2**). Meanwhile, the Agriculture sector contributed 9.1 percent. The Construction and Mining & quarrying sectors contributed 4.5 per cent and 0.5 per cent, respectively to MSMEs' GDP.


**Exhibit 2:**  Percentage Share of Malaysia and MSMEs' GDP for 2023 at Constant 2015 Prices



### **CONTRIBUTION OF MSMEs' GDP TO MALAYSIA'S GDP BY KIND OF ECONOMIC ACTIVITY**

From the perspective of MSMEs' GDP contribution by kind of economic activity, all sectors recorded an increase in 2023 except the Construction sector. MSMEs' GDP was led by the Agriculture sector with a share of 55.1 per cent (2022: 54.8%) as portrayed in **Exhibit 3**. The contribution of MSMEs' GDP for Construction posted 48.9 per cent from 49.0 per cent in the preceding year.

**Exhibit 3:**  Percentage Share of MSMEs' GDP to Malaysia's GDP for 2023 at Constant 2015 Prices




The share of MSMEs' GDP in the Services sector augmented to 42.7 per cent from 42.1 per cent in the previous year. The sector was dominated by Wholesale & retail trade, food & beverage, and accommodation sub-sector.

In addition, the Manufacturing sector contributed 33.8 per cent (2022: 33.5%) of MSMEs' GDP, supported by Food, beverages and tobacco sub-sector. MSMEs' GDP in the Mining & quarrying sector recorded a share of 3.2 per cent (2022: 3.0%) in 2023.

## PERFORMANCE OF MSMEs' EXPORTS 2023

Exports of MSMEs recorded a value of RM152.2 billion in 2023, with a slower growth of 4.5 per cent as compared to 17.2 per cent in the preceding year. The performance was mainly influenced by the Manufacturing sector, which fell by 0.7 per cent as compared to 19.5 per cent in 2022. However, the Services sector accelerated to 24.2 per cent (2022: 8.8%), while the Agriculture sector remained vibrant at 13.7 per cent (2022: 15.5%), as shown in Chart 3. Exports of MSMEs represented 12.2 per cent of total exports in 2023, led by the Manufacturing sector with 9.0 per cent, followed by the Services sector (2.8%) and the Agriculture sector (0.3%).

The value of MSMEs' exports in the **Manufacturing** sector amounted to RM113.1 billion in 2023 as compared to RM113.8 billion in 2022, thus constituting 74.3 per cent and continuing to dominate total MSMEs' exports. The main contributors in this sector were manufactured goods, miscellaneous manufactured articles, and machinery & transport equipment. The major destination for MSMEs' exports in the Manufacturing sector was Singapore, which contributed 18.4 per cent, followed by China (14.2%) and the United States of America (11.3%).


MSMEs' exports of **Services** sector rose to RM35.4 billion in 2023 as compared to RM28.5 billion in the previous year. The main components contributing to this growth were Other business services, Travel and Transportation.

MSMEs' exports of **Agriculture** sector were RM3.7 billion with a share of 2.4 per cent of the total MSMEs' exports in 2023. This sector recorded a growth of 13.7 per cent driven by the increase in exports of ornamental fish, poultry and fisheries with a value of RM1.1 billion as compared to RM0.8 billion in 2022.

## PERFORMANCE OF MSMEs' EMPLOYMENT 2023

MSMEs' employment in 2023 continued to register a year-on-year increase, albeit at a slower rate of 3.5 per cent compared to 3.8 per cent in the preceding year. The growth of MSMEs' employment was higher as against to the Malaysia's employment and Non-MSMEs' employment which grew 2.8 per cent and 2.1 per cent, respectively. In terms of numbers, MSMEs' employment went up by 263 thousand to record a total of 7.86 million persons (2022: 7.59 million persons). Therefore, MSMEs' employment comprised 48.5 per cent of total Malaysia's employment, increased 0.3 percentage points from 48.2 per cent in 2022 (**Chart 4**).

### MSMEs' EMPLOYMENT BY KIND OF ECONOMIC ACTIVITY 2023

MSMEs' employment in the **Agriculture** sector contributed 42.5 per cent of overall employment in this sector (2022: 42.3%) to record 795 thousand persons in 2023. The number of MSMEs' employment in the Agriculture sector rebounded by 1.0 per cent as against a negative 0.4 per cent in 2022.

The contribution of MSMEs' employment in the **Mining & quarrying** sector was 27.5 per cent in 2023, with a total of 21 thousand persons during the year. MSMEs' employment in this sector posted a marginal increase of 0.1 per cent as compared to the previous year.


In the meantime, there were 1.28 million workers in the MSMEs' **Manufacturing** sector in 2023, which comprised 45.7 per cent of total employment in this sector (2022: 45.9%). Although the share of MSMEs' employment in the Manufacturing sector declined, the number of MSMEs' employment grew by 2.4 per cent during the period (2022: 3.0%). The performance was driven by positive growth in all sub-sectors, particularly in Food, beverages and tobacco sub-sector, which rose by 1.0 per cent (2022: 4.6%).

Furthermore, MSMEs' employment in the **Construction** sector contributed 48.3 per cent of overall employment in this sector (2022: 48.4%). In terms of numbers, MSMEs' employment in the Construction sector improved further by 0.9 per cent in 2023 compared to a slight growth of 0.2 per cent in the previous year to record 675 thousand persons.

As for the **Services** sector, the employment of MSMEs accounted for a total of 5.09 million persons, contributing 50.6 per cent of overall employment in the Services sector (2022: 50.1%). In terms of annual percentage change, MSMEs' employment in this sector increased by 4.5 per cent in 2023 as compared to 5.3 per cent last year. The increase was contributed mainly by two sub-sectors, namely Wholesale & retail trade, food & beverage and accommodation (5.2%) and Transportation & storage and information & communication (4.5%).

MSMEs' employment in 2023 was mostly concentrated in the Services sector, with a share of 64.7 per cent, which increased by 0.6 percentage points from 64.1 per cent in the preceding year. MSMEs' employment in the Manufacturing sector comprised 16.3 per cent of total MSMEs' employment, followed by the Agriculture sector which accounted for 10.1 per cent. Besides that, the share of MSMEs' employment in the Construction sector was 8.6 per cent, while the Mining & quarrying sector contributed only 0.3 per cent (**Exhibit 4**).


## Exhibit 4: MSMEs' Employment by Kind of Economic Activity for 2022-2023



## MSMEs' LABOUR PRODUCTIVITY 2023

MSMEs' labour productivity as measured by value added per employment rose 1.5 per cent in 2023 to register a productivity value of RM78,035 per person (2022: RM76,919 per person). During the year, MSMEs' labour productivity growth was higher than Malaysia's and Non-MSMEs' productivity, which posted an increase of 0.7 per cent and 0.5 per cent, respectively. However, the value added per employment for MSMEs was lower than Malaysia's (RM96,780 per person) and Non-MSMEs' (RM114,432 per person) labour productivity (Chart 5).

MSMEs' labour productivity by economic sector in 2023 showed that all sectors recorded an increase in productivity except for the Manufacturing sector, which posted a negative growth of 0.9 per cent during the year.

MSMEs' labour productivity in the Agriculture sector registered a slight improvement in productivity with a growth of 0.3 per cent, while the Construction sector increased further by 4.9 per cent in 2023 compared to 4.7 per cent during the preceding year. In the meantime, growth of MSMEs' labour productivity in the Mining & quarrying (4.8%) and Services (1.9%) sectors remained in an upward trend with a slower rate as compared to last year (**Exhibit 5**).

# NOTA TEKNIKAL

## A. PENGENALAN

Penerbitan ini membentangkan data PMKS mengikut jenis aktiviti ekonomi bagi tahun 2015 hingga 2023. Data KDNK PMKS yang telah dinyatakan pada harga semasa dan harga malar 2015 adalah selari dengan pengasasan semula KDNK pada tahun asas 2015. Statistik ini telah disusun berdasarkan konsep yang disarankan oleh Sistem Akaun Negara 2008.

Data PMKS yang dibentangkan dalam penerbitan ini adalah berdasarkan keseluruhan kriteria PMKS tanpa perincian kategori mikro, kecil dan sederhana.

## B. KONSEP DAN DEFINISI

Definisi PMKS yang digunakan dalam penerbitan ini adalah berdasarkan definisi yang digariskan oleh Majlis Pembangunan Usahawan dan PMKS Kebangsaan (MPUPK) yang memberi fokus kepada dua kriteria iaitu bilangan pekerja sepenuh masa atau nilai jualan tahunan. Sesuatu pertubuhan diklasifikasikan sebagai PMKS jika ia memenuhi salah satu kriteria (**Jadual I**). Walau bagaimanapun, definisi ini tidak termasuk:

- Entiti tersenarai awam yang berada di papan utama; dan
- Subsidiari bagi:
  - Syarikat tersenarai awam yang berada di papan utama;
  - Syarikat multinasional (MNCs);
  - Syarikat berkaitan Kerajaan (GLCs);
  - Syarikat Menteri Kewangan Diperbadankan (MKDs); dan

### i. METODOLOGI

KDNK diukur dengan menggunakan tiga kaedah iaitu Pengeluaran, Perbelanjaan dan Pendapatan. Berdasarkan kepada ketersediaan data, Kaedah Pengeluaran adalah kaedah yang paling sesuai untuk menganggar sumbangan PMKS kepada setiap aktiviti ekonomi.

KDNK adalah jumlah nilai barang dan perkhidmatan yang dikeluarkan dalam tempoh tertentu selepas ditolak kos barang dan perkhidmatan yang digunakan dalam proses pengeluaran. Nilai ini merupakan nilai sebelum ditolak nilai peruntukan bagi penggunaan modal tetap iaitu jumlah nilai ditambah pada harga pengeluar bagi pengeluar residen ditambah dengan duti import.

**KDNK boleh dinyatakan seperti berikut:**

$$\text{KDNK} \rightarrow \sum \text{Nilai Ditambah kasar}$$

**yang mana;**

- Jumlah nilai ditambah kasar bersamaan dengan perbezaan antara output kasar bagi semua pengeluar tolak penggunaan perantaraan.

### ii. OUTPUT

Output adalah nilai barang dan perkhidmatan yang dikeluarkan. Ini termasuk pengeluaran untuk pasaran, pengeluaran untuk kegunaan sendiri dan pengeluaran bukan pasaran (perkhidmatan kerajaan dan NPISHs). Pengeluaran barang dan perkhidmatan tidak semestinya untuk dijual atau perolehan oleh pertubuhan.

$$\text{Nilai Ditambah} = \text{Output} - \text{Penggunaan Perantaraan}$$

### iii. PENGGUNAAN PERANTARAAN

Penggunaan perantaraan adalah nilai barang dan perkhidmatan yang digunakan (sebagai input) dalam proses pengeluaran barang dan perkhidmatan tidak termasuk gaji dan upah, susut nilai daripada modal dan faedah bersih yang dibayar.

### iv. NILAI DITAMBAH

Nilai ditambah adalah perbezaan di antara output dan penggunaan perantaraan. Ia merupakan nilai ditambah barang dan perkhidmatan dalam aktiviti ekonomi. Oleh itu, ia hampir bersamaan dengan keuntungan perniagaan, gaji dan upah, susut nilai dan cukai tidak langsung; campur faedah yang dibayar dan tolak faedah yang diterima.

Aktiviti perkhidmatan kerajaan dan kediaman yang didiami oleh pemilik tidak termasuk dalam penyusunan nilai ditambah PMKS.

### ii. KONSEP DAN DEFINISI

#### Guna Tenaga

Semua orang yang bekerja sekurang-kurangnya sejam semasa minggu rujukan untuk mendapatkan upah, keuntungan atau keuntungan keluarga (sebagai majikan, pekerja, bekerja sendiri atau pekerja keluarga tanpa gaji). Mereka juga dianggap bekerja jika:

1. Tidak bekerja semasa minggu rujukan disebabkan sakit, kecederaan, tiada upaya, cuaca buruk, bercuti, pertelingkahan buruh dan sebab-sebab sosial atau keagamaan tetapi mempunyai pekerjaan, ladang, perusahaan atau perusahaan keluarga lain untuk kembali bekerja;
2. Tidak bekerja buat sementara waktu tetapi bergaji dan pasti akan dipanggil bekerja semula; atau
3. Bekerja kurang daripada 30 jam semasa minggu rujukan disebabkan bentuk kerja atau disebabkan kurang kerja dan berkeupayaan serta sanggup menerima tambahan bilangan jam bekerja. Kumpulan ini merupakan guna tenaga tidak penuh.

#### Produktiviti Buruh per Pekerja PMKS

Produktiviti buruh PMKS per pekerja diukur berdasarkan nisbah nilai ditambah PMKS (pada harga malar) kepada guna tenaga PMKS mengikut aktiviti ekonomi. Ia menunjukkan kecekapan guna tenaga dalam mengeluarkan output atau menjana nilai ditambah PMKS.

### iii. PERINCIAN JENIS AKTIVITI EKONOMI

## TECHNICAL NOTES

### A. INTRODUCTION

This publication presents the data of MSMEs by kind of economic activity for year 2015 to 2023. The MSMEs' GDP data which are expressed in current and constant 2015 prices have been realigned with the rebasing of GDP to base year 2015. The statistics are compiled based on the concepts recommended by System of National Accounts 2008.

The data of MSMEs which are presented in this publication are based on the overall MSMEs' criteria without distinguishing the detailed category of micro, small and medium.

### B. CONCEPTS AND DEFINITIONS

The definition of MSMEs used in this publication is based on the definition outlined by the National Entrepreneur Development and MSME Council (MPUPK) which focused on two criteria, namely number of full-time employees or annual sales turnover. An establishment is classified as MSMEs if it meets either one of the criteria (**Table I**). However, the definition excludes:

- Entities that are public-listed on the main board; and
- Subsidiaries of:
  - Publicly-listed companies on the main board;
  - Multinational corporations (MNCs);
  - Government-linked companies (GLCs);
  - Syarikat Menteri Kewangan Diperbadankan (MKDs); and
  - State-owned enterprises.

### C. MSMEs' GDP BY KIND OF ECONOMIC ACTIVITY

**Kind of economic activity** refers to the group of establishments engaged in similar principal activity. The principal activity of establishments are grouped into industries according to the Malaysia Standard Industrial Classification 2008 which is aligned with the International Standard Industrial Classification of All Economic Activities Rev. 4.

This publication presents MSMEs' value added for five main sectors and the breakdown for selected economic activities are depicted in **Table II**.

## MSMEs' GDP

### i. METHODOLOGY

*GDP is measured by three approaches namely Production, Expenditure and Income. Based on the availability of data, the Production Approach was the most appropriate method to estimate the contribution of MSMEs to each economic activity.*

*GDP is the total value of all goods and services produced in a certain period after deducting the cost of goods and services used up in the process of production. This value is before deducting allowances for consumption of fixed capital i.e. the sum of value added of resident producers in producers' prices plus import duties.*

**GDP can be expressed as follows:**

$$\text{GDP} \rightarrow \sum \text{Gross Value Added}$$

**where;**

- The sum of gross value added is equal to the difference between gross output of all producers less the intermediate consumption.

### ii. OUTPUT

*Output is the value of goods and services produced. This includes market production, production for own final use and non-market production (government services and NPISHs). Production of goods and services is not necessarily for sale or turnover of establishment.*

$$\text{Gross Value Added} = \text{Output} - \text{Intermediate Consumption}$$

### iii. INTERMEDIATE CONSUMPTION

*Intermediate consumption is the value of goods and services consumed (as input) in the production process of goods and services excluded salaries and wages, depreciation of capital and net interest paid.*

### iv. VALUE ADDED

*Value added is the difference between output and intermediate consumption. It represents the added value of goods and services by economic activity. Hence, it is approximately equivalent to commercial profit, salaries and wages, depreciation and indirect taxes; plus interest paid less interest received.*

*Government services and owner occupied dwellings activities are excluded from the compilation of MSMEs' value added.*

**i. SCOPE AND COVERAGE** MSMEs' exports comprises three major sectors namely Agriculture, Manufacturing and Services.

**ii. METHODOLOGY** MSMEs' exports of Agriculture sector comprises crops, livestock and fisheries commodities as follows:

- i. Crops include pineapple, banana, durian, other tropical fruits such as papaya, watermelon, guava, rambutan, starfruits, jackfruits and others<sup>1</sup>, cut flowers and vegetables (leafy vegetables<sup>2</sup> and fruit vegetables<sup>3</sup>).
- ii. Livestock include poultry.
- iii. Fisheries include fisheries and ornamental fish.

The MSMEs' exports of Manufacturing sector is derived from the external trade database which matched with the list of MSMEs' companies obtained from the Malaysia Statistical Business Register (MSBR), Department of Statistics, Malaysia based on the matching company registration number.

The exports of services recorded in the Balance of Payments statistics have been used as the base value (denominator) for the compilation of MSMEs' export of services. The sectors involved in MSMEs' exports of services are transport, travel, construction, insurance and pension, telecommunication, computer and information, financial services and personal, cultural and recreational.

**iii. SECTOR CLASSIFICATION**

The classification of MSMEs' exports of Manufacturing sector are based on commodity sections of Standard International Trade Classification (SITC) at 1-digit .

- Section 0 : Food
- Section 1 : Beverages and Tobacco
- Section 2 : Inedible Crude Materials
- Section 3 : Mineral Fuels, Lubricants, etc
- Section 4 : Animal and Vegetable Oils & Fats
- Section 5 : Chemicals
- Section 6 : Manufactured Goods
- Section 7 : Machinery & Transport Equipment
- Section 8 : Miscellaneous Manufactured Articles
- Section 9 : Miscellaneous Transactions and Commodities

**iv. MSMEs' EXPORTS DESTINATION COUNTRY**

Destination country refers to the country where it is expected that the goods will be consumed insofar as this can be ascertained at the time of exports.



## MSMEs' EMPLOYMENT

### i. SCOPE AND COVERAGE

*MSMEs' employment is compiled based on Malaysia's employment by kind of economic activity according to the Malaysia Standard Industrial Classification 2008.*

### ii. CONCEPT AND DEFINITION

#### Employment

*All persons who, at any time during the reference week worked at least one hour for pay, profit or family gain (as an employer, employee, own-account worker or unpaid family worker). They are also considered as employed if they:*

1. *Did not work during the reference week because of illness, injury, disability, bad weather, leave, labour dispute and social or religious reasons but had a job, farmer, enterprise or other family enterprise to return to;*
2. *Were temporary laid-off with pay and would definitely be called back to work; or*
3. *Were employed less than 30 hours during the reference week because of the nature of their work or due to insufficient work and are able and willing to accept additional hours of work. This group is underemployed.*

#### MSMEs' Labour Productivity per Employment

*Labour productivity per employment is measured based on the ratio of value added of MSMEs (at constant prices) to the MSMEs' employment by economic activity. It indicates the efficiency of employment in producing output or generating value added of MSMEs.*

### iii. DETAILED KIND OF ECONOMIC ACTIVITY

*Kind of economic activity are categorized into five (5) main activities namely Agriculture, Mining & Quarrying, Manufacturing, Construction and Services. Meanwhile the breakdown of Manufacturing and Services activities are as shown in Table III.*
