Laporan Statistik Upah Pekerja (Sektor Formal) Suku Tahunan diterbitkan oleh Jabatan Perangkaan Malaysia (DOSM) menggunakan sumber data pentadbiran yang diperoleh daripada agensi berkaitan seperti Kumpulan Wang Simpanan Pekerja (KWSP) dan Pertubuhan Keselamatan Sosial (PERKESO). Inisiatif menerbitkan Laporan Statistik Upah Pekerja (Sektor Formal) Suku Tahunan ini adalah bagi memenuhi permintaan yang semakin meningkat bagi statistik upah yang komprehensif dengan kekerapan yang tinggi. Laporan ini menyediakan statistik upah pekerja warganegara Malaysia mengikut ciri-ciri demografi dan sosioekonomi antaranya jantina, etnik, kumpulan umur, aktiviti ekonomi dan negeri.

Statistik upah pekerja merupakan maklumat penting yang digunakan sebagai input untuk menganalisis pasaran buruh, menggubal dasar serta merancang, melaksana dan memantau program berkaitan pembangunan sumber manusia ke arah pengukuhan pasaran buruh negara. Statistik ini juga menjadi rujukan penting kepada penyelidik, ahli ekonomi, ahli akademik, pihak swasta dan individu dalam kajian berkaitan guna tenaga, gaji & upah dan pasaran buruh.

Penerbitan ini mengandungi tiga bahagian. Bahagian pertama membentangkan ringkasan penemuan bagi bilangan pekerja aktif di sektor formal, median upah dan taburan upah. Bahagian kedua memaparkan jadual statistik. Aspek teknikal seperti kaedah pengumpulan data, skop & liputan dan konsep & definisi disediakan di bahagian terakhir bagi memudahkan pengguna memahami statistik yang diterbitkan.

The Quarterly Employee Wages Statistics (Formal Sector) Report is published by the Department of Statistics Malaysia (DOSM) using administrative data sources obtained from relevant agencies such as the Employees Provident Fund (EPF) and the Social Security Organization (SOCSO). The initiative to publish this Quarterly Employee Wages Statistics (Formal Sector) Report is to meet the escalating demand for comprehensive wage statistics with high frequency. This report provides wage statistics for Malaysian citizens according to demographic and socioeconomic characteristics encompassing sex, ethnic, age groups, economic activities and state.

Employee wages statistics serves as a crucial source of information which were used as input for labour market analysis, policy formulation as well as planning, implementing and monitoring programmes related to human resource development towards strengthening the national labour market. These statistics also serve as a vital reference for researchers, economists, academicians, private economic activity and individuals in research related to employment, wages and the labour market.

This publication contains three parts. The first part presents a summary of findings of the number of formal economic activity employees, median wage and wage distribution. In the second part, a series of statistics tables are presented. Technical aspects such as the method of data collection, scope & coverage and concept & definitions are provided in the final part to facilitate users' understanding of the published statistics.





JANTINA




Median upah bulanan bagi lelaki (**RM2,782**) adalah lebih tinggi berbanding perempuan (**RM2,700**) pada September 2024.

KUMPULAN UMUR



Kumpulan umur **45 hingga 49 tahun** mencatatkan median upah bulanan tertinggi iaitu **RM3,627** pada September 2024.

NEGERI



Median upah bulanan tertinggi pada September 2024 direkodkan bagi **W.P. Kuala Lumpur (RM3,964)** diikuti Selangor dan Pulau Pinang.

ETNIK



Pekerja formal **etnik Cina** merekodkan median upah bulanan **tertinggi** pada September 2024 (**RM4,200**).

AKTIVITI EKONOMI



Median upah bulanan paling tinggi pada September 2024 direkodkan dalam sektor **Perlombongan & pengkuarian** (**RM5,900**), diikuti Pembinaan, Perkhidmatan, Pembuatan, Pertanian, dan Perlombongan & pengkuarian.

KONSEP & DEFINISI

Upah meliputi semua ganjaran kepada pekerja dalam bentuk wang termasuk bonus, komisen dan elaun dalam tempoh rujukan.

Median merujuk kepada nilai yang terletak di tengah-tengah susunan suatu set nombor yang disusun mengikut tertib. Median upah digunakan untuk memberi gambaran "purata upah" yang lebih tepat kerana tidak terkesan kepada nilai ekstrem.


SKOP & LIPUTAN

Statistik ini bersumberkan data pentadbiran meliputi data caruman wajib simpanan pekerja sektor swasta dan pekerja tidak berpendek sektor awam serta data caruman insurans keselamatan sosial pekerja yang diperoleh daripada pelbagai agensi. Data ini hanya meliputi pekerja formal warganegara, tidak meliputi orang yang bekerja di bawah pekerjaan bukan standard, termasuk pekerja akaun sendiri dan pekerja keluarga tanpa gaji.

In September 2024, the number of Malaysian formal employees was **6.82 million persons** with median monthly wages, **RM2,745**.



BY SEX




Median monthly wages for **male (RM2,782)** was higher than female (RM2,700) in September 2024.

BY AGE GROUP



The age group of **45 to 49 years** posted the highest median monthly wages of **RM3,627** in September 2024.

BY STATES



The highest median monthly wages in September 2024 was recorded in **W.P. Kuala Lumpur (RM3,964)** followed by Selangor and Pulau Pinang.

BY ETHNIC



Chinese formal employees recorded the **highest** median monthly wages in September 2024 (**RM4,200**).

BY ECONOMIC ACTIVITY



The highest median monthly wages in September 2024 was recorded in **Mining & quarrying sector (RM5,900)**, followed by Construction, Services, Manufacturing, and Agriculture.

CONCEPT & DEFINITION

Wages refer to all remuneration paid to employees, including bonuses, commissions and allowances, during the reference period.

The **Median** refers to the middle observation in a set of data arranged in a sequence. The median wage is used to give a more accurate picture of the "average wage", as the determination of the median is not affected by extreme values.

SCOPE & COVERAGE

These statistics is based on the administrative data, including data on the mandatory contribution of retirement savings by the private and non-pensionable public sectors and data on the contribution of social security insurance from various agencies. The data focus only on the citizen formal employees and does not cover employed persons fall under non-standard employment, including own-account workers and unpaid family workers.

RINGKASAN PENEMUAN


1. PENGENALAN

Penerbitan Statistik Upah Pekerja (Sektor Formal) Suku Tahunan adalah sebahagian daripada inisiatif Jabatan Perangkaan Malaysia untuk menyediakan statistik upah yang lebih komprehensif, terperinci dan bertepatan masa bagi memenuhi permintaan pengguna yang semakin meningkat. Laporan ini adalah berdasarkan data pentadbiran dari pelbagai agensi dan memberi tumpuan kepada pekerja warganegara dalam aktiviti ekonomi formal khususnya di Malaysia. Upah yang dianggarkan dalam penerbitan ini merujuk kepada semua ganjaran kewangan meliputi bonus, komisen, dan elaun yang dibayar kepada pekerja untuk pekerjaan mereka dalam tempoh rujukan. Statistik yang dikeluarkan ini boleh digunakan sebagai input untuk menganalisis kedudukan pasaran buruh, menggubal dasar serta merancang, melaksana dan memantau program berkaitan pembangunan sumber manusia ke arah pengukuhan pasaran buruh negara.

2. KEDUDUKAN UPAH PEKERJA FORMAL MALAYSIA

Pasaran buruh Malaysia kekal stabil pada suku ketiga 2024, dipacu oleh peningkatan konsisten penawaran dan permintaan. Pada ST3 2024, bilangan penduduk bekerja meningkat 2.9 peratus (+464.6 ribu) berbanding 2.7 peratus pada suku sama tahun sebelumnya, merekodkan 16.72 juta orang. Sementara itu, bilangan penganggur menurun sebanyak 4.4 peratus (-25.2 ribu orang) berbanding suku yang sama pada tahun sebelumnya kepada 547.9 ribu orang, mendorong kadar pengangguran negara menurun 0.2 mata peratus tahun ke tahun kepada 3.2 peratus. 
Paparan 1: Kerangka Analisis Gaji & Upah Bulanan, ST3 2024

Pencapaian ini juga disokong oleh peningkatan pasaran buruh dalam sektor formal. Pada suku tahun ketiga 2024, bilangan pekerja formal di Malaysia meningkat, mencapai sejumlah 6.82 juta pada September 2024, berbanding 6.81 juta pada Ogos dan 6.80 juta pada Julai 2024. Tambahan lagi, median upah bulanan bagi pekerja formal warganegara meningkat 5.6 peratus tahun ke tahun kepada RM2,745 pada September 2024 (Julai 2024: 6.3%; Ogos 2024: 5.6%). (**Carta 1**)

3. BILANGAN PEKERJA FORMAL DAN MEDIAN UPAH BULANAN MENGIKUT JANTINA


Pekerja formal lelaki warganegara Malaysia menyumbang 55.2 peratus daripada jumlah pekerja formal warganegara Malaysia, berjumlah 3.76 juta orang pada September 2024 (Ogos 2024: 3.76 juta orang; Julai 2024: 3.76 juta orang). Pada tempoh yang sama, median upah bulanan bagi pekerja formal lelaki warganegara Malaysia meningkat kepada RM2,782, mencerminkan kenaikan 5.2 peratus tahun ke tahun daripada RM2,645 pada September 2023. Pada Ogos 2024, median upah bulanan meningkat sebanyak 5.3 peratus tahun ke tahun kepada RM2,767 (Ogos 2023: RM2,627). Begitu juga, pada Julai 2024, median upah bulanan adalah sebanyak RM2,782, mencatatkan peningkatan 5.9 peratus berbanding RM2,627 pada Julai 2023.

Pekerja formal perempuan warganegara Malaysia membentuk 44.8 peratus daripada jumlah pekerja formal warganegara Malaysia pada bulan September 2024, berjumlah 3.05 juta orang (Ogos 2024: 3.05 juta orang; Julai 2024: 3.04 juta orang). Median upah bulanan bagi pekerja formal perempuan warganegara Malaysia pada Julai, Ogos, dan September 2024 adalah masing-masing sebanyak RM2,700, RM2,682 dan RM2,700, dengan pertumbuhan tahun ke tahun masing-masing sebanyak 8.0 peratus, 7.3 peratus dan 7.2 peratus.

Analisis jurang upah mengikut jantina menunjukkan bahawa pekerja formal lelaki warganegara Malaysia secara konsisten menerima median upah bulanan yang lebih tinggi berbanding pekerja formal perempuan warganegara Malaysia. Sehingga September 2024, median upah bulanan bagi lelaki adalah 3.0 peratus lebih tinggi berbanding perempuan. (**Paparan 2**)

Paparan 2: Bilangan Pekerja Formal dan Median Upah Bulanan Mengikut Jantina, Julai - September 2024




4. BILANGAN PEKERJA FORMAL DAN MEDIAN UPAH BULANAN MENGIKUT ETNIK

Pada suku tahun ketiga 2024, semua kumpulan etnik mencatatkan kenaikan tahun ke tahun dalam median upah bulanan. Pekerja formal Bumiputera menerima median upah bulanan sebanyak RM2,300 pada September 2024, konsisten dengan angka yang direkodkan pada Ogos dan Julai 2024. Ini mencatatkan kenaikan sebanyak 4.5 peratus berbanding tempoh yang sama pada tahun sebelumnya (Ogos 2024: 4.5%; Julai 2024: 5.4%).

Pekerja formal Cina yang mewakili 28.5 peratus atau bersamaan dengan 1.95 juta orang, memperoleh median upah bulanan tertinggi sebanyak RM4,200 pada September 2024, menggambarkan pertumbuhan tahun ke tahun sebanyak 5.0 peratus berbanding September 2023 (Ogos 2024: 5.0%; Julai 2024: 5.0%).

Tambahan pula, kumpulan etnik India yang terdiri daripada 7.7 peratus atau bersamaan dengan 0.53 juta orang, mengalami pertumbuhan median upah bulanan tahun ke tahun tertinggi dalam tempoh ini, dengan upah mencecah RM2,700 pada September 2024 (Ogos 2024: RM2,682; Julai 2024: RM2,700) (**Paparan 3**)

Julai - September 2024**




5. BILANGAN PEKERJA FORMAL DAN MEDIAN UPAH BULANAN MENGIKUT KUMPULAN UMUR

Bilangan pekerja formal warganegara Malaysia meningkat pada suku ketiga 2024 untuk semua kumpulan umur, kecuali mereka yang berumur di bawah 20 dan 21 hingga 24 tahun. Komposisi kedua-dua kumpulan ini yang merangkumi 13.9 peratus daripada jumlah pekerja formal warganegara Malaysia, menurun sebanyak 3.3 peratus daripada tahun sebelumnya pada September 2024. Sementara itu, kumpulan umur 65 tahun ke atas menunjukkan peningkatan peratus tertinggi dalam bilangan pekerja formal (September 2024: 5.9%).

Semua kumpulan umur secara konsisten mencatatkan peningkatan tahunan median upah bulanan, kecuali kumpulan umur bawah 20 tahun. Kumpulan umur 45 hingga 49 tahun kekal mencatatkan median upah bulanan tertinggi pada suku tahun ketiga 2024 (September 2024: RM3,627; Ogos 2024: RM3,627; Julai 2024: RM3,627). Kumpulan umur ini merekodkan median upah bulanan tertinggi bagi 22 bulan berturut-turut sejak Disember 2022. Semua kumpulan umur merekodkan pertumbuhan positif bagi median upah bulanan pada September 2024. Walau bagaimanapun, pekerja formal yang berumur di bawah 20 tahun menerima median upah bulanan terendah iaitu RM1,500, kekal tidak berubah sejak Jun 2022. Melihat perbandingan tahun ke tahun, kumpulan umur 65 tahun dan ke atas menunjukkan pertumbuhan tahun ke tahun tertinggi pada September 2024, meningkat sebanyak 9.0 peratus kepada RM2,725. 6. BILANGAN PEKERJA FORMAL DAN MEDIAN UPAH BULANAN MENGIKUT AKTIVITI EKONOMI

Dari segi aktiviti ekonomi, semua sektor ekonomi menunjukkan peningkatan median upah bulanan yang positif. Khususnya, sektor Perlombongan dan pengkuarian merekodkan median upah bulanan tertinggi pada September 2024 kepada RM5,900 (Ogos 2024: RM5,900; Julai 2024: RM5,800). Selanjutnya, sektor ini mencatatkan pertumbuhan tahun ke tahun tertinggi sebanyak 13.5 peratus pada September 2024 (Ogos 2024: 13.5%; Julai 2024: 16.0%). Selain itu, median upah bulanan kedua tertinggi pada suku tahun ketiga 2024 dicatatkan oleh sektor Pembinaan iaitu RM2,800, diikuti oleh sektor Perkhidmatan iaitu RM2,782, sektor Pembuatan iaitu RM2,564, dan sektor Pertanian iaitu RM2,027.


Pada masa yang sama, bilangan pekerja formal terbesar pada September 2024 disumbangkan oleh sektor Perkhidmatan yang mencatatkan 67.7 peratus atau bersamaan dengan 4.61 juta orang. Pekerja dalam sektor ini merekodkan pertumbuhan tahun ke tahun sebanyak 7.0 peratus dengan peningkatan median upah bulanan kepada RM2,782 pada September 2024 (Ogos 2024: RM2,764; Julai 2024: RM2,764). Subsektor Kewangan dan insurans (RM5,900), merekodkan median upah bulanan tertinggi pada September 2024, diikuti oleh Maklumat dan komunikasi (RM5,100). Sebaliknya, subsektor Makanan & minuman dan penginapan merekodkan median upah bulanan terendah iaitu RM1,964 (Ogos 2024: RM1,927; Julai 2024: RM1,945).

Sementara itu, sektor Pembuatan menyumbang 17.9 peratus daripada keseluruhan pekerja formal atau bersamaan dengan 1.22 juta orang, mencatatkan peningkatan 5.6 peratus tahun ke tahun dalam median upah bulanan kepada RM2,564 pada September 2024 (Ogos 2024: RM2,544; Julai 2024: RM2,564).

Pada masa yang sama, sektor Pembinaan, yang merangkumi 0.43 juta tenaga kerja atau 6.3 peratus daripada keseluruhan pekerja formal, mencatatkan median upah bulanan sebanyak RM2,800 pada September 2024, dengan pertumbuhan 3.7 peratus tahun ke tahun. Khususnya, median upah bulanan bagi sektor ini adalah sebanyak RM2,845 pada Ogos 2024 dan RM2,827 pada Julai 2024.

Akhir sekali, sektor Pertanian yang meliputi 0.13 juta orang atau 1.9 peratus daripada keseluruhan pekerja formal, mencatatkan median upah bulanan terendah kepada RM2,027, merekodkan pertumbuhan 2.3 peratus tahun ke tahun pada September 2024. (**Paparan 5**)

7. BILANGAN PEKERJA FORMAL DAN MEDIAN UPAH BULANAN MENGIKUT NEGERI

Pada September 2024, tiga negeri dengan median upah bulanan tertinggi direkodkan oleh W.P. Kuala Lumpur (RM3,964), Selangor (RM3,000), dan Pulau Pinang (RM2,800), melebihi paras median upah bulanan nasional iaitu RM2,745. Sebaliknya, Kelantan, Perlis dan Sabah merekodkan median upah bulanan terendah masing-masing sebanyak RM1,682, RM1,682 dan RM1,882. Dari segi bilangan pekerja formal, Selangor mempunyai sumbangan terbesar, merekodkan 28.1 peratus, atau 1.92 juta pekerja formal. Ini diikuti oleh W.P. Kuala Lumpur, yang mempunyai 1.40 juta pekerja formal (20.5%), dan Johor, dengan 0.73 juta pekerja formal (10.7%) pada tempoh yang sama. (**Paparan 6**)



8. TABURAN UPAH BULANAN PEKERJA FORMAL

Analisis bilangan pekerja mengikut skala upah menunjukkan sebanyak 32.0 peratus pekerja formal warganegara Malaysia memperoleh kurang daripada RM2,000 pada September 2024, menyusut 2.6 mata peratus daripada 34.6 peratus pada tahun sebelumnya. Pada tempoh yang sama, 8.1 peratus pekerja formal memperoleh RM10,000 atau lebih pada setiap bulan.

Analisis lebih mendalam mengenai persentil menunjukkan pekerja formal dalam persentil ke-10 menerima RM1,500 atau kurang setiap bulan, manakala pekerja formal dalam persentil ke-90 menerima sekurang-kurangnya RM8,600 setiap bulan. Jurang upah antara kedua-dua kumpulan ini menunjukkan penerima upah tertinggi (persentil ke-90) memperoleh hampir enam kali ganda berbanding penerima upah terendah (persentil ke-10). 9. PERANTAIAN KE HADAPAN

Perantaian ke hadapan, Jabatan Perangkaan Malaysia (DOSM) beriltizam untuk terus menambah baik data-data ini dalam masa terdekat. Di samping itu, beberapa sumber data lain seperti data emolumen penjawat awam, maklumat pendapatan pembayar cukai dan set data lain yang berkaitan sedang dipertimbangkan untuk diliputi agar statistik ini menjadi lebih komprehensif dan inklusif.

Selain itu, melalui pengintegrasian dengan data pentadbiran lain, DOSM akan menghasilkan maklumat yang lebih dinamik merangkumi trend, pola, min, median dan taburan upah mengikut saiz pekerja termasuk statistik mengenai bilangan dan upah pekerja formal mengikut saiz pertubuhan, membezakan antara Perusahaan Kecil dan Sederhana (PKS) dan Perusahaan Mikro, Kecil dan Sederhana (PMKS). Data tersebut juga akan dikategorikan berdasarkan jenis intensif industri (intensif modal atau buruh), mengikut tahap kemahiran dan jenis pekerjaan pekerja, mengikut status syarikat (seperti Syarikat Multi-Nasional - MNC dan Pelaburan Langsung Asing - FDI), mengikut pemilikan pertubuhan syarikat, mengikut perniagaan berorientasikan eksport atau permintaan domestik, mengikut skala ekonomi perniagaan, mengikut usia perniagaan dan lain-lain.

Di samping itu, penambahbaikan daripada aspek metodologi penyusunan dan sumber data baharu dilaksanakan secara berterusan selaras dengan amalan terbaik Pejabat Statistik Negara (NSO) yang lain. Pada masa yang sama, DOSM menjalankan Survei Gaji & Upah yang menggunakan kaedah persampelan dan pendekatan berasaskan isi rumah. Survei ini digunakan sebagai penanda aras bagi gaji dan upah min dan median yang diterima oleh penduduk di Malaysia.


1. INTRODUCTION

The Quarterly Employee Wages Statistics (Formal Sector) Publication is part of the Department of Statistics Malaysia's initiative to provide more comprehensive, granular and frequent wages statistics to meet increasing user demand. This report is based on administrative data from various agencies and primarily focuses on citizen employees in Malaysia's formal private economic activity. The wages estimated in this publication refers to all monetary payables including bonuses, commissions, and allowances paid to employees for the work done during the reference period. The statistics released can be used as input for analysing the labour market situation, formulating policies, as well as planning, implementing and monitoring programmes related to human resource development towards strengthening Malaysia's labour market.

2. WAGES SITUATION OF FORMAL EMPLOYEES IN MALAYSIA

Malaysia's labour market remained strong in the third quarter of 2024, driven by a steady increase in both supply and demand. In Q3 2024, the number of employed persons improved 2.9 per cent (+464.6 thousand) compared to 2.7 per cent in the same quarter previous year, reaching a record of 16.72 million persons. Meanwhile, the number of unemployed persons declined 4.4 per cent (-25.2 thousand) from the same quarter in the previous year to 547.9 thousand persons, resulting in a year-on-year decrease of 0.2 percentage points in the national unemployment rate to 3.2 per cent. (**Exhibit 1**).


Exhibit 1: Monthly Salaries & Wages Analysis Framework, Q3 2024

This performance was also supported by an improving labour market in the formal sector. In the third quarter of 2024, the number of formal employees in Malaysia grew, reaching a total of 6.82 million in September 2024, compared to 6.81 million in August and 6.80 million in July 2024. Furthermore, the median monthly wages for Malaysian formal employees increased by 5.6 per cent year-on-year to RM2,745 in September 2024 (July 2024: 6.3%; August 2024: 5.6%). (**Chart 1**)

3. NUMBER OF FORMAL EMPLOYEES AND MEDIAN MONTHLY WAGES BY SEX

Malaysian male formal employees accounted for 55.2 per cent of the total Malaysian formal employees, totalling 3.76 million persons in September 2024 (August 2024: 3.76 million persons; July 2024: 3.76 million persons). During the same period, the median monthly wages for Malaysian male formal employees increased to RM2,782, reflecting a 5.2 per cent year-on-year rise from RM2,645 in September 2023. In August 2024, the median monthly wages grew by 5.3 per cent year-on-year to RM2,767 (August 2023: RM2,627). Similarly, in July 2024, the median wages stood at RM2,782, marking a 5.9 per cent increase compared to RM2,627 in July 2023.

Malaysian female formal employees made up 44.8 per cent of the employees in September 2024, totalling 3.05 million persons (August 2024: 3.05 million persons; July 2024: 3.04 million persons). The median monthly wages for Malaysian female formal employees in July, August and September 2024 were RM2,700, RM2,682 and RM2,700, respectively, with corresponding year-on-year growth of 8.0 per cent, 7.3 per cent and 7.2 per cent.

An analysis of wage disparities based on sex indicates that Malaysian male formal employees consistently receive higher median monthly wages than the Malaysian female formal employees. As of September 2024, the median monthly wages for males were 3.0 per cent higher than for female employees. (**Exhibit 2**)


4. NUMBER OF FORMAL EMPLOYEES AND MEDIAN MONTHLY WAGES BY ETHNIC

In the third quarter of 2024, all ethnic groups recorded year-on-year increases in median monthly wages. Bumiputera formal employees received a median monthly wage of RM2,300 in September 2024, consistent with the figures reported in August and July 2024. This represented a 4.5 per cent increase compared to the same period in the previous year (August 2024: 4.5%; July 2024: 5.4%).

The Chinese formal employees representing 28.5 per cent or equivalently 1.95 million persons, earned the highest median monthly wage of RM4,200 in September 2024, reflecting a year-on-year growth of 5.0 per cent compared to September 2023 (August 2024: 5.0%; July 2024: 5.0%).

Furthermore, the Indian ethnic group comprising 7.7 per cent or equivalent to 0.53 million persons, experienced the highest year-on-year growth in median monthly wages during this period, with wages reaching RM2,700 in September 2024 (August 2024: RM2,682; July 2024: RM2,700). (**Exhibit 3**)

5. NUMBER OF FORMAL EMPLOYEES AND MEDIAN MONTHLY WAGES BY AGE GROUP

The number of formal employees in Malaysia rose as of the third quarter of 2024 for all age groups, with the exception of those below 20 and 21 to 24. The proportion of these two groups, which accounted for 13.9 per cent of the total Malaysian formal employees, declined by 3.3 per cent from a year ago in September 2024. Meanwhile, the age group of 65 years and above showed the highest percentage increase in the number of formal employees (September 2024: 5.9%).

All age groups consistently experienced annual increases in median monthly wages, with the exception of employees under the age of 20. The age group of 45 to 49 years maintained recorded the highest median monthly wage during the third quarter of 2024 (September 2024: RM3,627; August 2024: RM3,627; July 2024: RM3,627). This age group has maintained the highest median monthly wage for 22 consecutive months since December 2022. All age groups recorded positive growth in the median monthly wage in September 2024. However, formal employees aged below 20 receive the lowest median monthly wage of RM1,500, which has remained unchanged since June 2022. Looking at the year-on-year comparison, the age group aged 65 years and above showed the highest year-on-year growth in September 2024, which increased by 9.0 per cent to RM2,725. (**Exhibit 4**)

6. NUMBER OF FORMAL EMPLOYEES AND MEDIAN MONTHLY WAGES BY ECONOMIC ACTIVITY

In terms of economic activity, all economic sectors show a positive increase in median monthly wages. Specifically, the Mining and quarrying sector recorded the highest median monthly wages in September 2024 to RM5,900 (August 2024: RM5,900; July 2024: RM5,800). Furthermore, this sector recorded the highest year-on-year growth of 13.5 per cent in September 2024 (August 2024: 13.5%; July 2024: 16.0%). Besides that, the second highest median monthly wages during the third quarter of 2024 were recorded in Construction sector to RM2,800, followed by Services sector to RM2,782, Manufacturing sector to RM2,564 and Agriculture sector to RM2,027.


In the meantime, the largest number of formal employees in September 2024 was contributed by the Services sector, which recorded 67.7 per cent or equivalent to 4.61 million persons. Employees in this sector marked a year-on-year wage growth of 7.0 per cent, with the median monthly wages rising to RM2,782 in September 2024 (August 2024: RM2,764; July 2024: RM2,764). The Finance and insurance sub-sector (RM5,900) recorded the highest median monthly wages in September 2024, followed by Information and communication (RM5,100). On the other hand, the Food & beverages and accommodation sub-sector recorded the lowest median monthly wages of RM1,964 (August 2024: RM1,927; July 2024: RM1,945).

Meanwhile, the Manufacturing sector accounted for 17.9 per cent of the total formal employees, which is equivalent to 1.22 million persons, recording an increase of 5.6 per cent year-on-year in the median monthly wages to RM2,564 in September 2024 (August 2024: RM2,544; July 2024: RM2,564).

Simultaneously, the Construction sector, comprising 0.43 million workforce or 6.3 per cent of the total formal employees, recorded a median monthly wages of RM2,800 in September 2024, reflecting a 3.7 per cent year-on-year growth. Notably, the median monthly wages for this sector were RM2,845 in August 2024 and RM2,827 in July 2024.

Lastly, the Agriculture sector, which accounted for 0.13 million formal employees or 1.9 per cent of the total formal employees, demonstrated the lowest median monthly wages at RM2,027, marking a 2.3 per cent year-on-year increase in September 2024. (**Exhibit 5**)

7. NUMBER OF FORMAL EMPLOYEES AND MEDIAN MONTHLY WAGES BY STATE

In September 2024, the three states with the highest median monthly wages were W.P. Kuala Lumpur (RM3,964), Selangor (RM3,000), and Pulau Pinang (RM2,800), exceeding the national median of RM2,745. In contrast, Kelantan, Perlis and Sabah recorded the lowest median monthly wages of RM1,682, RM1,682 and RM1,882, respectively. In terms of the number of formal employees, Selangor had the highest share, accounting for 28.1 per cent, or 1.92 million formal employees. This was followed by W.P. Kuala Lumpur, which had 1.40 million formal employees (20.5%), and Johor, with 0.73 million formal employees (10.7%) during the same period. (**Exhibit 6**)



8. DISTRIBUTION OF MONTHLY WAGES OF FORMAL EMPLOYEES

Analysing the numbers of employees by wage scale revealed that 32.0 per cent of Malaysian formal employees earned less than RM2,000 in September 2024, declined by 2.6 percentage points from 34.6 per cent the year before. In the same period, 8.1 per cent of formal employees earned RM10,000 or more per month.

A closer look at the percentile analysis shows that formal employees in the 10th percentile earned RM1,500 or less per month, while formal employees in the 90th percentile earned at least RM8,600 per month. The wage gap between these two groups reveals that the highest earners (90th percentile) earned nearly six times more than those in the lowest wage group (10th percentile). (**Chart 2 & Table 1**)

9. MOVING FORWARD

Looking ahead, the Department of Statistics Malaysia (DOSM) is committed to continue to improve these data in the immediate future. In addition, several types of other data sources, such as civil servant emolument data, taxpayer income information, and other relevant datasets, are being considered to be used in order for these statistics to become more comprehensive and inclusive.

Moreover, integrating data from various administrative sources, DOSM will yield dynamic information on trends, patterns, mean, median, and distribution of employees' wages by size of the employees, including statistics on the number and wages of formal employees categorized by organization size, distinguishing between Small and Medium Enterprises (SME) and Non-Small and Medium Enterprises (Non-SME). The data will also be categorized based on industry intensity (capital-intensive or labor-intensive), skill and occupation levels, company status (such as Multinational Companies - MNCs, Foreign Direct Investment - FDI), company ownership, business orientation export-oriented or domestic demand-oriented, business economic scale, company establishment period, and other relevant factors.

Besides, the continuous improvement in methodology and the inclusion of new data sources are carried out in line with the practices of other National Statistical Offices (NSOs). Simultaneously, DOSM conducts the Salaries & Wages Survey, which uses sampling methods and household-based approaches. This survey serves as a benchmark for the mean and median salaries and wages received by the population in Malaysia.

NOTA TEKNIKAL

1. PENGENALAN

Statistik Upah Pekerja disusun menggunakan data pentadbiran daripada pelbagai agensi bagi memantau prestasi gaji dan upah negara. Statistik yang dikeluarkan meliputi bilangan pekerja formal dan median upah bulanan. Nota teknikal ini menyediakan penerangan terperinci mengenai konsep, skop definisi, liputan dan metodologi yang digunakan dalam penyusunan statistik ini bagi membantu pengguna untuk lebih memahami berkaitan maklumat upah pekerja yang dikeluarkan.

2. KONSEP DAN DEFINISI

Majikan : Merujuk kepada entiti ekonomi yang bekerja sama ada melalui kontrak perkhidmatan atau latihan perantisan, dan dilaporkan melalui sistem pekerjaan yang sesuai.

Pekerja Formal : Merujuk kepada individu yang bekerja di bawah kontrak perkhidmatan atau latihan perantisan bermajikan dan menerima ganjaran untuk kerja yang diselesaikan. Pekerja formal tidak termasuk mereka yang tergolong di bawah pekerjaan bukan standard, termasuk individu bekerja sendiri, pekerja gig, pekerja akaun sendiri, pekerja keluarga tanpa gaji, dan sebagainya.

Upah : Merujuk kepada semua ganjaran dalam bentuk wang yang dibayar sepanjang tempoh rujukan kepada pekerja. Anggaran upah termasuk bonus, komisen, dan elaun mengikut definisi sumber data. Tidak termasuk caj perkhidmatan; bayaran kerja lebih masa; ganjaran; faedah persaraan; faedah pengurangan pekerja, pemberhentian atau penamatian; mana-mana elaun perjalanan atau nilai mana-mana konsesi perjalanan; atau mana-mana saraan atau bayaran lain sebagaimana yang dikecualikan oleh Menteri.

Upah tidak termasuk pendapatan dari perniagaan sendiri atau sumber lain.

Aktiviti Ekonomi : Klasifikasi aktiviti ekonomi merujuk kepada Piawaian Klasifikasi Industri Malaysia (MSIC) 2008 yang selaras dengan *International Standard Industrial Classification of All Economic Activities (ISIC) Revision 4*. Pengelasan subaktiviti ekonomi dan aktiviti ekonomi adalah seperti paparan di bawah, dengan aktiviti ekonomi Pembuatan dan Perkhidmatan dapat diperincikan kepada lapan (8) subaktiviti ekonomi:

Etnik : Klasifikasi pekerja warganegara mengikut kumpulan etnik adalah seperti berikut:

- Bumiputera;
- Cina;
- India; dan
- Lain-lain.

3. TEMPOH RUJUKAN

Statistik ini berdasarkan kaedah akruan mengikut saranan Sistem Akaun Negara 2008 (SNA), yang mengambil kira bulan ketika kerja dilakukan tanpa mengira bilakah pembayaran dibuat atau diterima.

4. SKOP DAN LIPUTAN

Pengeluaran statistik upah pekerja aktiviti ekonomi formal adalah bersumberkan data pentadbiran yang meliputi data caruman wajib simpanan pekerja aktiviti ekonomi swasta dan pekerja tidak berpencen di aktiviti ekonomi awam serta data caruman insurans keselamatan sosial pekerja yang diperoleh daripada pelbagai agensi dengan tumpuan kepada pekerja warganegara dalam aktiviti ekonomi formal di Malaysia. Data ini tidak meliputi orang yang bekerja berada di bawah pekerjaan bukan standard, termasuk pekerja akaun sendiri dan pekerja keluarga yang tanpa gaji.

5. SUMBER DATA

Sumber data utama bagi penerbitan ini adalah daripada beberapa rekod pentadbiran yang dibekalkan oleh agensi berkaitan, seperti Kumpulan Wang Simpanan Pekerja (KWSP), Pertubuhan Keselamatan Sosial (PERKESO) dan lain-lain. *Malaysia Statistical Business Register* (MBSR) merupakan kerangka kerja pertubuhan dan perusahaan yang beroperasi di Malaysia turut digunakan sebagai asas penyusunan data. MBSR merangkumi Daftar Syarikat (ROC), Daftar Perniagaan (ROB) dan Perkongsian Liabiliti Terhad (LLP) yang berdaftar dengan Suruhanjaya Syarikat Malaysia (SSM) serta pertubuhan yang berdaftar dengan pihak berkuasa tempatan dan badan profesional.

6. METODOLOGI

Anggaran upah pekerja dalam laporan ini adalah berdasarkan upah dan nilai caruman yang dilaporkan oleh majikan. Oleh kerana data dilaporkan secara tunai (semasa pembayaran dilakukan) dan bukannya asas akruan (masa pembayaran diperoleh), anggaran memerlukan penukaran data daripada asas tunai kepada asas akruan yang dilakukan melalui kaedah "*calendarisation*". Selain itu, untuk menangani sebarang jurang yang berpotensi atau ketidak lengkapan dalam data, kaedah imputasi digunakan.

Bilangan pekerja dikira secara individu, di mana pekerja dengan pelbagai pekerjaan hanya akan dikira sekaligus. Pada masa yang sama, upah bagi individu yang mempunyai pelbagai pekerjaan adalah merujuk kepada jumlah upah yang diperoleh melalui semua pekerjaan yang dilakukan pada bulan rujukan.

Median merujuk kepada nilai yang terletak di tengah-tengah susunan suatu set nombor yang disusun secara tertib. Median upah digunakan untuk memberi gambaran "purata upah" yang lebih tepat kerana penentuan median tidak dipengaruhi nilai ekstrem.

7. PEMBUNDARAN

Hasil tambah bagi sesuatu kategori mungkin berbeza dengan jumlah besar atau sub-jumlah kerana pembundaran.

8. PERINCIAN STATISTIK

Statistik dalam laporan ini diperincikan seperti berikut:

- i. Jantina;
- ii. Etnik;
- iii. Kumpulan umur;
- iv. Aktiviti ekonomi; dan
- v. Negeri.

9. SEMAKAN

Data yang mendasari anggaran ini tertakluk kepada semakan yang berkaitan dengan penerimaan data tambahan atau data yang lebih lengkap dari semasa ke semasa, terutamanya nilai caruman yang digunakan dalam menganggarkan nilai upah.

10. SULIT DAN KERAHSIAAN

TECHNICAL NOTES

1. INTRODUCTION

Employee Wages Statistics are compiled using administrative data from various agencies to monitor the performance of national wages and salaries. The statistics released cover the number of formal workers and median monthly wages. This technical note provides a detailed explanation of the concepts, definitions, scope, coverage and methodology used in the compilation of these statistics to help users better understand the wage information released.

2. CONCEPT AND DEFINITION

Employer : Refer to an economic entity with whom the employee has a contract of service or apprenticeship, and is reported through the appropriate employment system.

Formal Employee : Refer to the person who works under a contract of service or apprenticeship with the employer and receives remuneration for the work completed. Formal employees do not include those who fall under non-standard employment, including self-employed, gig-workers, own-account workers, unpaid family workers, etc.

Wages : Refers to all remuneration in money payable made throughout the reference period to employees. The wage estimated includes bonuses, commissions and allowances per the data sources' definition. It does exclude service charges; overtime payments; gratuity; retirement benefits; retrenchment, lay-off or termination benefits; any travelling allowance or the value of any travelling concession; or any other remuneration or payment as may be exempted by the Minister.

Wages do not include income from own businesses or other sources.

Economic Activity : Economic activity is classified according to Malaysian Standard Industrial Classification (MSIC) 2008 which is based on the International Standard Industrial Classification of All Economic Activities (ISIC) Revision 4. The classification of sub-economic activitys and economic activities is as in exhibit below, with the Manufacturing and Services economic activitys can be detailed into eight sub-economic activitys:

Geographical : Geographical location refers to the state where the employer is located. Employer information by state is obtained by integrating data sources with the statistical domain: Malaysia Statistical Business Register (MSBR).

Ethnic : The classification of the Malaysian formal employee's ethnic group is as follows:

- i. *Bumiputera;*
- ii. *Chinese;*
- iii. *Indian; and*
- iv. *Others.*

3. REFERENCE PERIOD

The statistics are based on the accrual basis in accordance with the 2008 System of National Accounts (SNA) recommendation, which reflects the month when the work is done regardless of when the payment is made or received.

4. SCOPE AND COVERAGE

The release of these statistics is based on administrative data, including data on the mandatory contribution of retirement savings by the private and non-pensionable public economic activitys and data on the contribution of social security insurance obtained from various agencies which focus on citizen formal employees in Malaysia. The data does not cover employed persons fall under non-standard employment, including own-account workers and unpaid family workers.

5. DATA SOURCES

The primary data sources for this publication comprise multiple administrative records provided by relevant agencies, i.e., Employees Provident Fund (EPF), Social Security Organisation (SOCSO) and others. Malaysia Statistical Business Register (MBSR), which comprises the list of establishments or enterprises operating in Malaysia gathered from the Register of Companies (ROC), Register of Businesses (ROB) and Limited Liability Partnership (LLP) registered with Companies Commission Malaysia (CCM) as well as establishment that is registered with the local authority and professional bodies also incorporated in the compilation.

6. METHODOLOGY

The estimation of employee wages in this report is based on the wages and value of contributions reported by the employers. As the data are reported on a cash basis (the time when the payment was made) rather than an accrual basis (the time when the payment was earned), the estimates require the conversion of data from a cash basis to an accrual basis done through a "calendarisation" method. Moreover, to address any potential gaps or incompleteness in the data, an imputation method is applied.

The number of employees is calculated on an individual basis, in which the employee with multiple jobs will only be calculated at once. Correspondingly, wage for individual with multiple jobs is refer to the sum of all wages that are earned through all jobs performed in the reference month.

The median refers to the middle observation in a set of data that are arranged in a sequence. The median wage is used to give a more accurate picture of the "average wage", as the determination of the median is not affected by extreme values.

7. ROUNDING

Due to rounding, the sum of component figures may not tally with the sub-total or total statistics.

8. DETAIL OF STATISTICS

The statistics in this report are presented as follows:

- i. Sex;
- ii. Ethnic;
- iii. Age group;
- iv. Economic activity; and
- v. State.

9. REVISION

Data that underlie these estimates are subjected to revision which relates to receiving additional or more complete data over time, particularly the contribution value of which used in estimating the wage values.

10. PRIVACY AND CONFIDENTIALITY

Legislative requirements stated in Statistics Act 1965 [Act 415] and Personal Data Protection Act 2010 [Act 709] to ensure the privacy and secrecy of this data have been followed. Furthermore, in accordance with the Census Act 1960 [Act 16], the results have been confidential to ensure that they are not likely to enable the identification of a particular person or organisation.
