PRESTASI PERDAGANGAN LUAR NEGERI MALAYSIA, JANUARI 2025

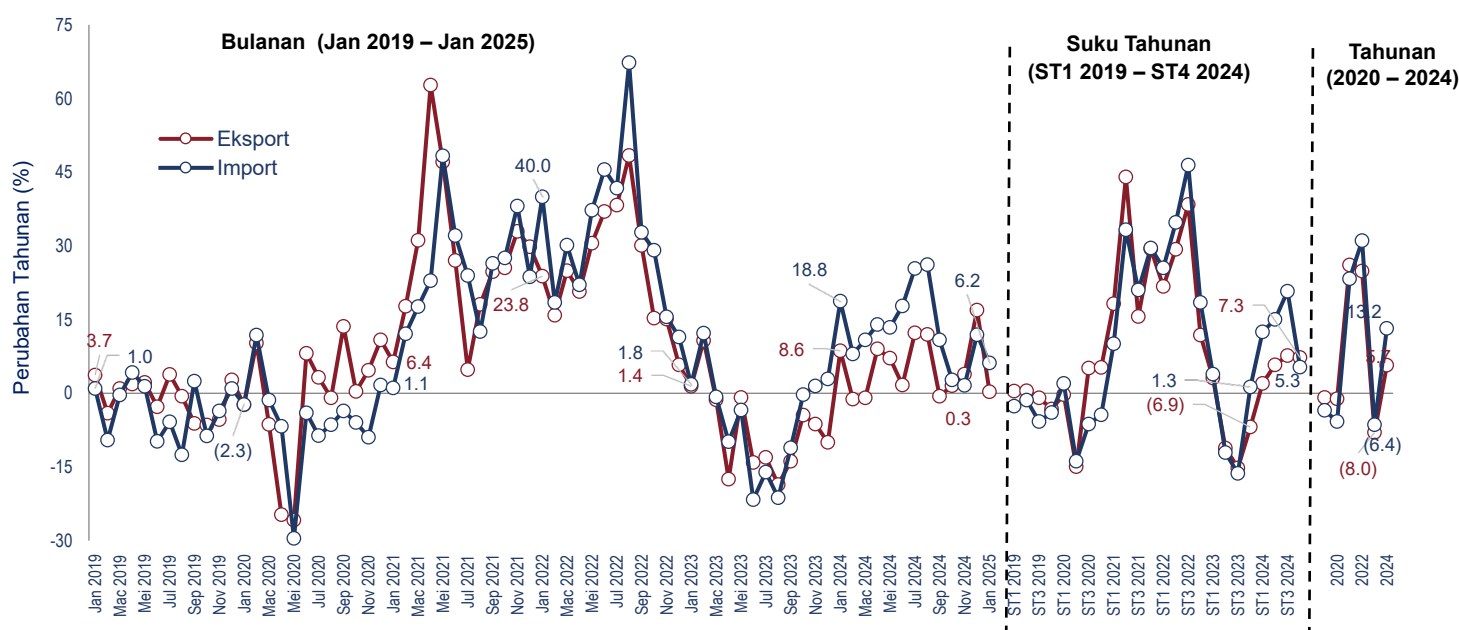
Prestasi perdagangan Malaysia memulakan trend positif pada Januari 2025 dengan jumlah perdagangan mencatatkan peningkatan 3.1 peratus atau RM7.3 bilion mencecah nilai RM241.9 bilion berbanding RM234.6 bilion pada tahun sebelumnya.

Eksport meningkat 0.3 peratus atau RM380.3 juta kepada RM122.8 bilion, manakala import mencatatkan peningkatan 6.2 peratus atau RM6.9 bilion kepada

RM119.2 bilion berbanding RM112.2 bilion pada tahun sebelumnya. Di samping itu, imbangan dagangan terus mencatatkan lebihan dengan RM3.6 bilion, turun 64.3 peratus berbanding RM10.2 bilion pada Januari 2024.

Berbanding Disember 2024, eksport, import, jumlah perdagangan dan lebihan perdagangan masing-masing menurun 11.3 peratus, 0.2 peratus, 6.2 peratus dan 81.0 peratus.

Prestasi eksport Malaysia menunjukkan trend positif pada Januari 2025, mencatatkan pertumbuhan 0.3 peratus

Prestasi Eksport

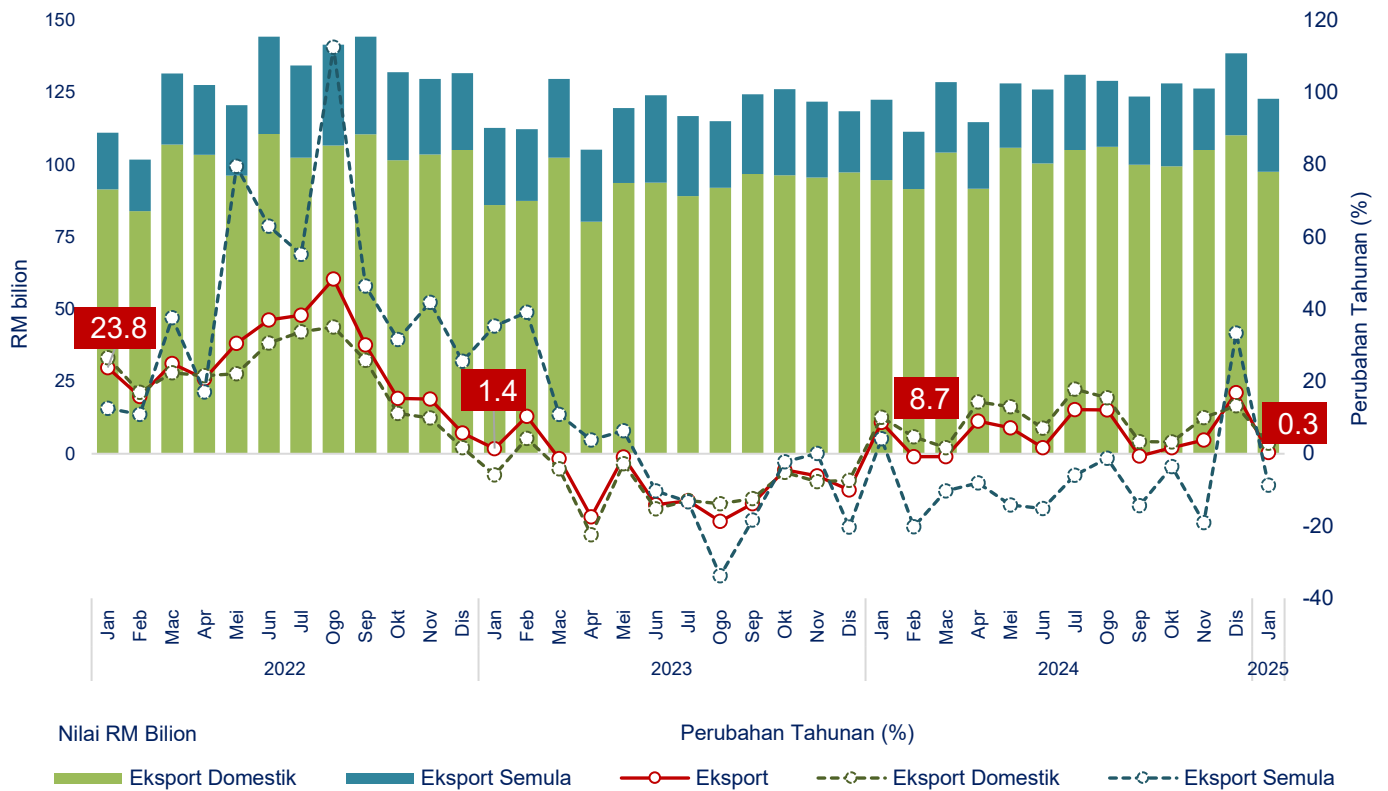
Eksport Malaysia mencatatkan kenaikan 0.3 peratus berbanding bulan yang sama pada tahun 2024, sejajar dengan peningkatan eksport domestik. Eksport domestik, yang menyumbang 79.4 peratus daripada jumlah eksport, meningkat 2.9 peratus daripada RM94.7 bilion kepada RM97.5 bilion.

Sebaliknya, eksport semula bernilai RM25.3 bilion, menyumbang 20.6 peratus

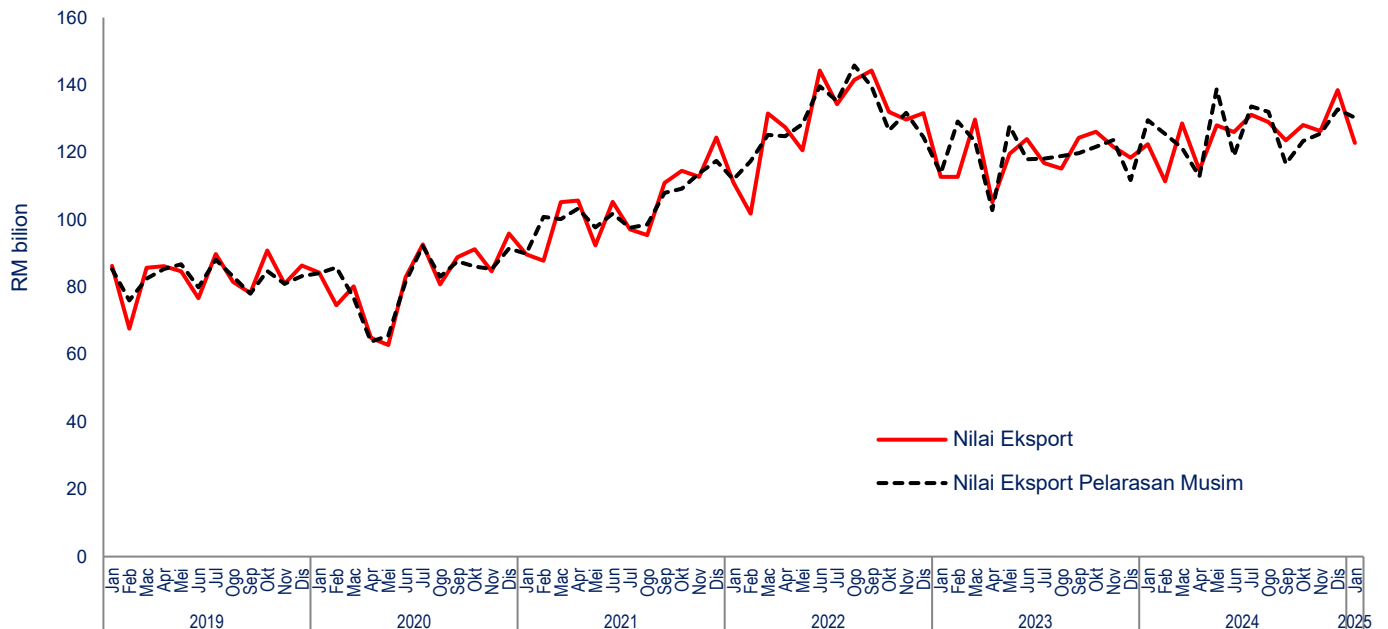
daripada jumlah eksport, menurun 8.7 peratus daripada RM27.7 bilion berbanding tahun sebelumnya.

Sementara itu, perbandingan bulanan menunjukkan eksport menurun 11.3 peratus atau RM15.7 bilion. Bagaimanapun, berdasarkan analisis terma pelarasan musim bulan ke bulan, eksport menurun 1.9 peratus kepada RM130.3 bilion.

Prestasi Eksport mengikut Negara Destinasi Utama

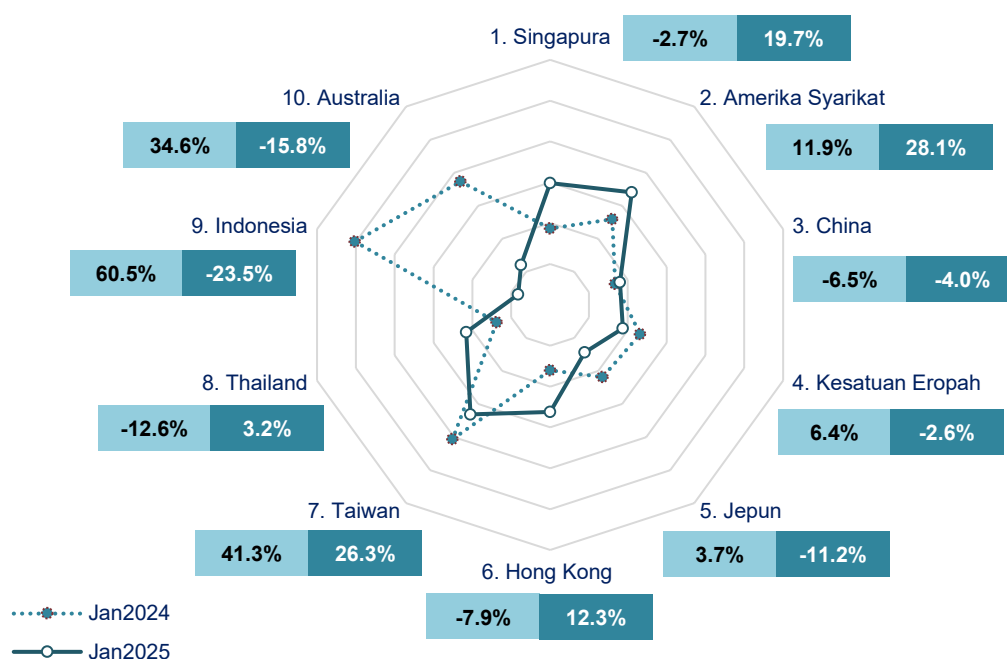
Singapura dan Amerika Syarikat merupakan negara destinasi utama dengan jumlah sumbangan 31.0 peratus kepada jumlah eksport Malaysia pada Januari 2025.

Singapura mendominasi negara destinasi utama dengan nilai RM20.9 bilion dan menyumbang 17.0 peratus kepada jumlah eksport Malaysia, meningkat 19.7 peratus atau RM3.4 bilion, tahun ke tahun. Peningkatan ini berikutan eksport yang lebih tinggi bagi barangan elektrik & elektronik (+RM3.0 bilion, +38.9%), keluaran petroleum (+RM337.6 juta, +13.0%) dan jentera, kelengkapan & alat ganti (+RM277.0 juta, +19.2%).

Nilai eksport ke Amerika Syarikat menyumbang 14.1 peratus kepada jumlah eksport bernilai RM17.3 bilion, meningkat RM3.8 bilion atau 28.1 peratus. Lonjakan tersebut didorong oleh eksport yang lebih tinggi bagi barangan elektrik & elektronik (+RM2.1 bilion, +26.5%) dan keluaran perkilangan lain (+RM470.6 juta, +50.2%).

Daripada sepuluh negara destinasi utama, eksport berkembang secara positif ke Singapura, Amerika Syarikat, Hong Kong, Taiwan dan Thailand. Sebaliknya, eksport ke Indonesia, Jepun, Australia, China dan Kesatuan Eropah mencatatkan penurunan.

Eksport ke Negara ASEAN

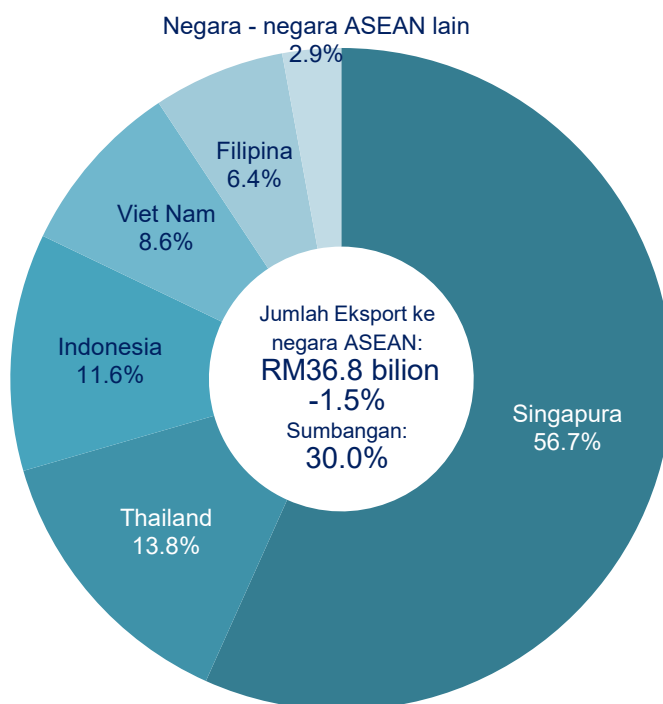
Eksport ke negara ASEAN, mewakili 30.0 peratus daripada jumlah eksport Malaysia pada Januari 2025. Ia mencatatkan nilai RM36.8 bilion dengan berkurang 1.5 peratus daripada RM37.3 bilion pada bulan yang sama tahun lepas.

Penurunan ini disumbangkan terutamanya oleh keluaran petroleum (-RM2.0 bilion, -26.5%) dan

kimia & bahan kimia (-RM449.2 million, -17.1%).

Dalam kalangan negara ASEAN, Singapura merupakan destinasi eksport utama dengan sumbangan 56.7 peratus, merekodkan peningkatan 19.6 peratus atau RM3.4 bilion berbanding Januari 2024.

Prestasi Eksport mengikut Sektor Ekonomi

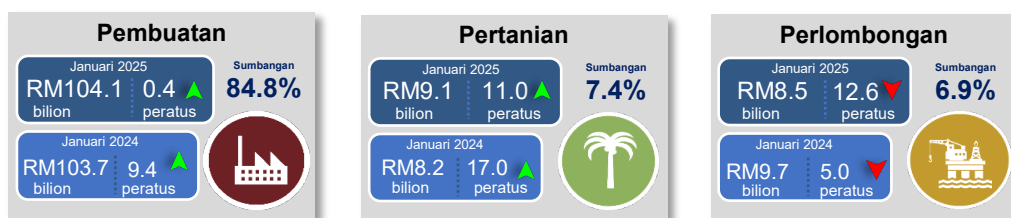
Eksport barangan perkilangan kekal sebagai komponen penting daripada jumlah eksport pada Januari 2025, menyumbang 84.8 peratus, mencatatkan peningkatan tahun ke tahun 0.4 peratus atau RM454.5 juta kepada RM104.1 bilion, tahun ke tahun. Penyumbang utama kepada peningkatan ialah produk elektrik & elektronik (+RM6.5 bilion, +14.8%), produk perkilangan lain (+665.0 juta, +17.2%) dan jentera, peralatan & alat ganti (+429.5 juta, +7.8%).

Eksport produk pertanian yang menyumbang 7.4 peratus daripada jumlah eksport turut mencatatkan pertumbuhan 11.0 peratus kepada RM9.1 bilion. Peningkatan ini

sebahagian besarnya disebabkan oleh peningkatan eksport minyak sawit & produk pertanian berasaskan minyak sawit (+RM537.8 juta, +8.7%) dan produk pertanian lain (+RM317.3 juta, +34.2%).

Sebaliknya, eksport perlombongan, yang menyumbang 6.9 peratus daripada jumlah eksport, mengalami penurunan 12.6 peratus, jatuh kepada RM8.5 bilion daripada RM9.7 bilion. Penurunan ini didorong terutamanya oleh pengurangan eksport gas asli cecair (LNG) (-RM806.1 juta, -13.3%), petroleum mentah (-RM286.1 juta, -12.3%) dan bijih logam & sekerap logam (-RM161.4 juta, -20.3%).

Eksport mengikut Produk Utama Terpilih

Prestasi eksport mencatatkan peningkatan pada Januari 2025, sejajar dengan pertumbuhan positif oleh produk berikut:

- Produk elektrik & elektronik, menyumbang 41.1 peratus daripada jumlah eksport, meningkat RM6.5 bilion atau 14.8 peratus kepada RM50.5 bilion;
- Minyak sawit & produk berasaskan minyak sawit, menyumbang 8.1 peratus daripada jumlah eksport, meningkat RM948.8 juta, mencerminkan pertumbuhan 10.5 peratus, mencecah jumlah keseluruhan RM10.0 bilion. Eksport minyak sawit, komoditi utama dalam kumpulan produk ini, mencatatkan peningkatan RM38.5 juta (+0.7%). Walaupun volum eksport merosot

24.2 peratus, nilai purata seunit meningkat 32.9 peratus. Di samping itu, harga domestik minyak sawit mentah telah meningkat 27.8 peratus, mencecah RM4,672.50 setiap tan metrik; dan

- Getah asli mewakili 0.3 peratus daripada jumlah eksport, meningkat 35.9 peratus atau RM107.0 juta kepada RM404.9 juta. Ini sejajar dengan peningkatan 2.8 peratus dalam volum eksport dan purata nilai seunit yang meningkat 32.2 peratus. Selain itu, harga getah (SMR20) mengalami peningkatan ketara 30.8 peratus.

Walau bagaimanapun, penurunan telah direkodkan untuk produk berikut:

- Keluaran petroleum ditapis, yang menyumbang 7.4 peratus daripada jumlah eksport, menurun RM4.9 bilion atau 35.0 peratus kepada RM9.0 bilion sejajar dengan penurunan volum eksport (-23.8%) dan nilai purata seunit (-14.7%);
- Petroleum mentah, menyumbang 1.7 peratus daripada jumlah eksport, menurun RM286.1 juta atau 12.3 peratus kepada RM2.0 bilion. Walaupun penurunan 18.1 peratus dalam nilai purata seunit, volum eksport mengalami pertumbuhan 7.1 peratus. Harga minyak Brent pada Januari 2025 turun

kepada RM354.4 (-5.7%) setong berbanding tahun sebelumnya;

- LNG menyumbang 4.3 peratus daripada jumlah eksport, mengalami pengurangan RM806.1 juta atau 13.3 peratus, kepada RM5.2 bilion, sejajar dengan pengurangan jumlah eksport, yang menyaksikan penurunan 7.6 peratus, serta penurunan purata nilai seunit 6.2 peratus; dan

- Kayu & keluaran berasaskan kayu susut 5.4 peratus atau RM108.9 juta kepada RM1.9 bilion, menyumbang 1.5 peratus kepada jumlah eksport.

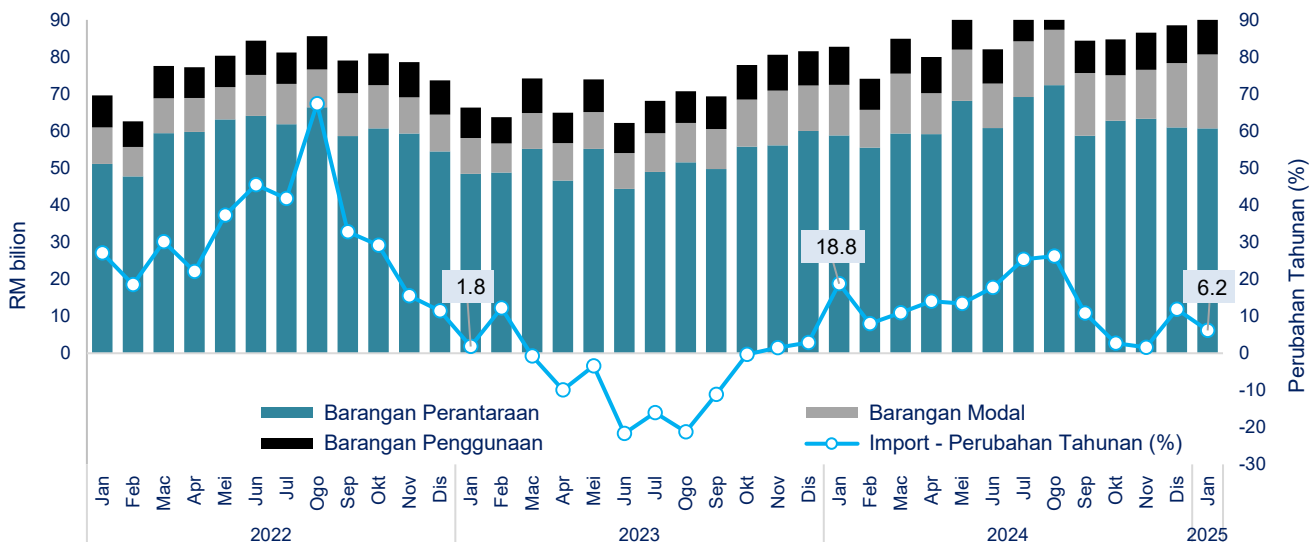
Import barangan modal mencatatkan lonjakan ketara, meningkat 45.9 peratus kepada RM20.0 bilion pada Januari 2025

Prestasi Import

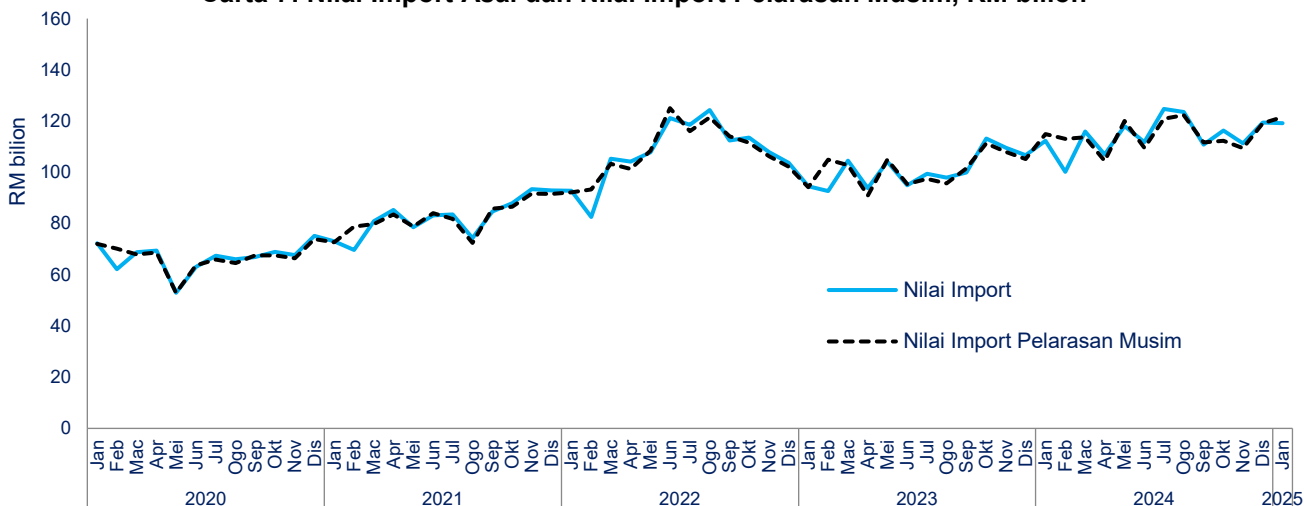
Nilai import Malaysia terus mencatatkan pertumbuhan memberangsangkan dengan peningkatan 6.2 peratus atau RM6.9 bilion pada Januari 2025. Peningkatan ini menjadikan jumlah keseluruhan import mencecah RM119.2 bilion berbanding nilai yang dicatatkan pada bulan yang sama tahun sebelumnya. Perbandingan bulanan menunjukkan import menurun secara marginal 0.2 peratus atau RM185.0 juta.

Merujuk kepada analisis terma pelarasan musim bulan ke bulan, import meningkat 2.0 peratus kepada RM121.6 bilion. Pada asas tahun ke tahun, import mengikut Penggunaan Akhir mencatatkan peningkatan bagi barangan modal dan barangan perantaraan. Import barangan modal meningkat 45.9 peratus (RM6.3 bilion) dan barangan perantaraan naik 3.3 peratus (RM1.9 bilion). Sebaliknya, barangan penggunaan menyusut 2.6 peratus atau RM272.6 juta.

Prestasi Import Mengikut Negara Asal Utama

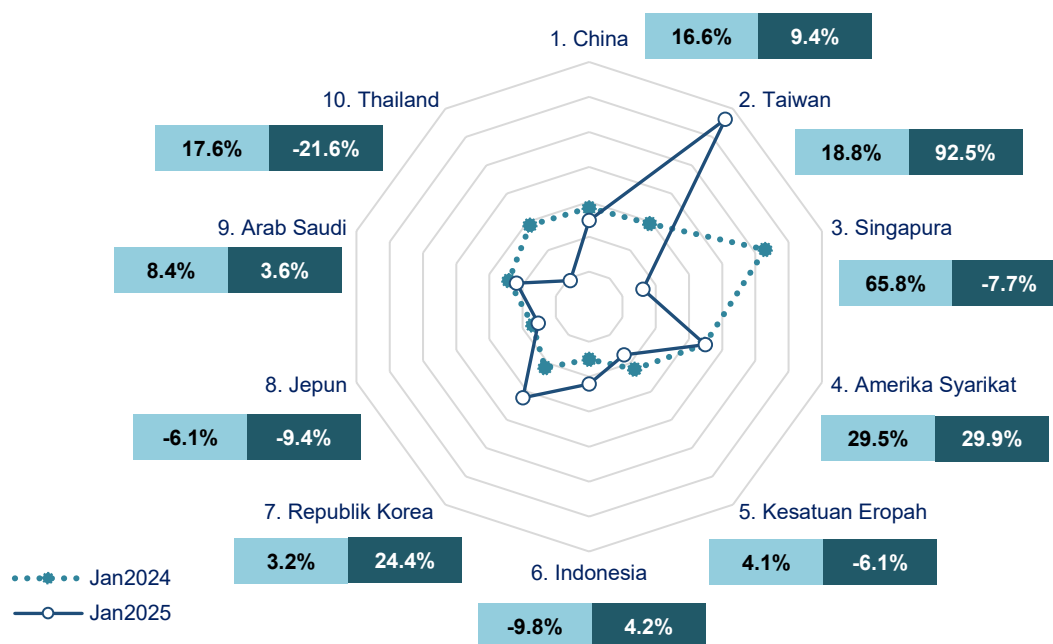
China dan Taiwan merupakan dua negara asal utama bagi import Malaysia pada Januari 2025, menyumbang 36.1 peratus kepada nilai import.

Import dari China yang mewakili 23.6 peratus daripada jumlah import Malaysia, mengembang 9.4 peratus berbanding tahun sebelum kepada RM28.1 bilion. Kenaikan import dari China dipengaruhi oleh pertambahan bagi barangan elektrik & elektronik (+RM2.1 bilion, +20.6%) dan jentera, kelengkapan & alat ganti (+RM980.6 juta, +33.5%).

Import dari Taiwan bernilai RM14.9 bilion, merangkumi 12.5 peratus kepada jumlah import, menokok 92.5 peratus atau RM7.2 bilion, tahun ke tahun. Peningkatan tersebut berikutan import yang lebih tinggi oleh barangan elektrik & elektronik (+RM8.3 bilion, +169.3%) dan barangan perkilangan lain (+RM157.6 juta, +362.2%).

Perubahan tahunan import dari empat negara asal utama mencatatkan penurunan, manakala China, Taiwan, Amerika Syarikat, Indonesia, Republik Korea dan Arab Saudi meningkat berbanding bulan yang sama tahun lepas.

Import dari Negara ASEAN

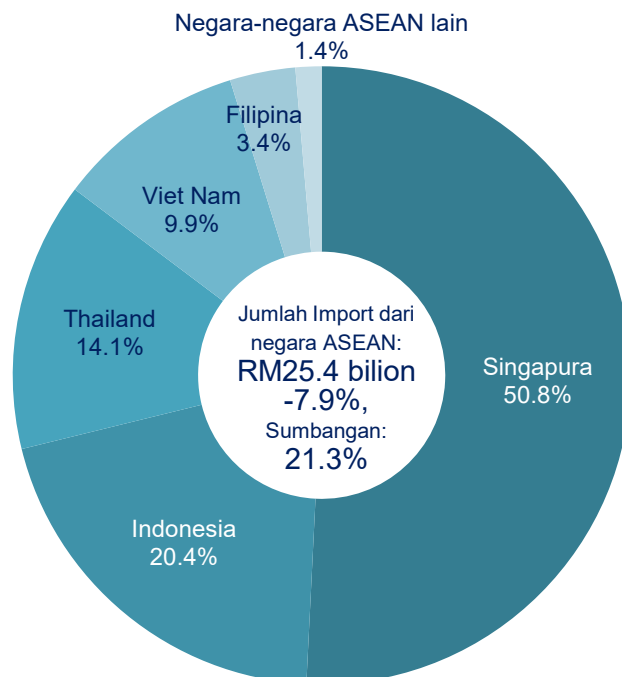
Import dari negara ASEAN meliputi 21.3 peratus daripada jumlah import, mencatatkan penurunan 7.9 peratus pada Januari 2025 kepada RM25.4 bilion berbanding RM27.5 bilion pada bulan yang sama tahun sebelumnya.

Penyusutan tersebut didorong terutamanya oleh import yang lebih rendah bagi produk kimia & bahan kimia (-RM685.4 juta, -30.3%), keluaran petroleum (-RM454.0 juta, -8.5%).

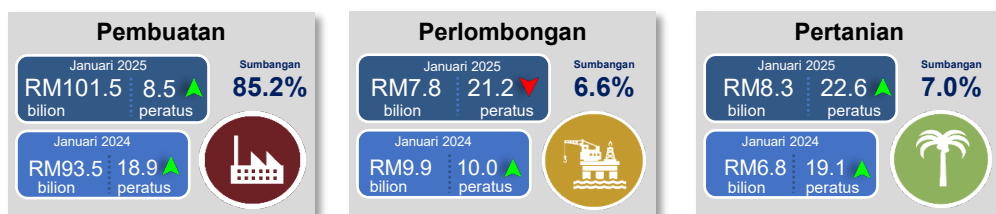
Import barangan perkilangan (85.2% daripada jumlah import), bertambah 8.5 peratus daripada RM93.5 bilion kepada RM101.5 bilion tahun ke tahun. Prestasi ini dipacu oleh import barangan elektrik & elektronik yang lebih tinggi (+RM13.4 bilion, +40.8%) dan jentera, kelengkapan & alat ganti (+RM808.3 juta, +9.1%).

Import keluaran pertanian (7.0% daripada jumlah import) bertumbuh dua angka pada 22.6 peratus kepada RM8.3 bilion, disokong terutamanya oleh import yang lebih tinggi bagi pertanian lain (+RM636.7 juta, +12.7%), minyak sawit & keluaran pertanian berasaskan minyak kelapa

sawit (+RM421.3 juta, +147.9%), minyak sayuran lain (+RM320.9 juta, +123.1%), getah asli (+RM129.6 juta, +18.0%) dan makanan laut, segar, sejuk atau beku (+RM38.0 juta, +9.2%).

Sementara itu, import hasil perlombongan (6.6% daripada jumlah import) bernilai RM7.8 bilion pada Januari 2025, merosot 21.2 peratus atau RM2.1 bilion berbanding tahun sebelumnya. 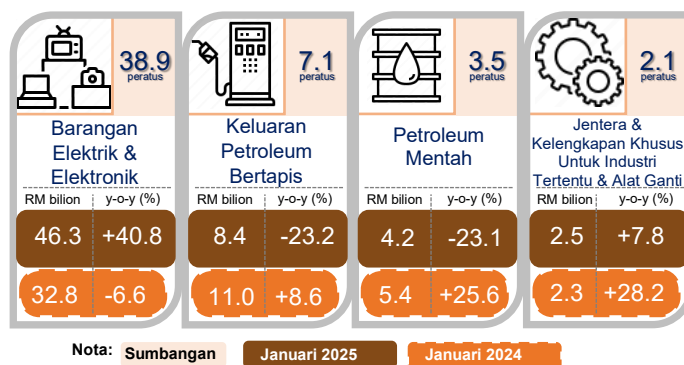

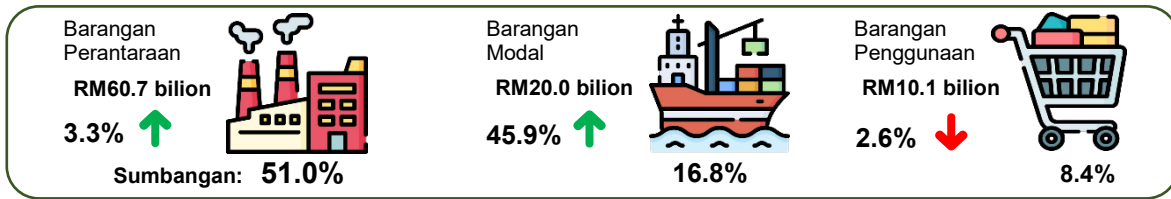

EKSPORT DAN IMPORT MENGIKUT LOKASI

Malaysia mencatatkan jumlah perdagangan bernilai RM241.9 bilion pada Januari 2025 dengan eksport dan import masing-masing bernilai RM122.8 bilion dan RM119.2 bilion.

Eksport bernilai RM122.8 bilion pada Januari 2025, meningkat sebanyak RM380.3 juta (+0.3%) berbanding bulan yang sama tahun sebelumnya. Peningkatan eksport dipengaruhi oleh eksport yang lebih tinggi di empat negeri iaitu Pulau Pinang (+RM8.3 bilion), Melaka (+RM1.4 bilion), Perak (+RM76.4 juta) dan Sabah (+RM11.0 juta). Walau bagaimanapun, nilai eksport menurun di Johor sebanyak RM4.1 bilion, Sarawak (-RM1.5 bilion), W.P. Kuala Lumpur (-RM1.0 bilion), Selangor (-RM844.6 juta), Pahang (-RM684.0 juta), Terengganu (-RM459.6 juta), Negeri Sembilan (-RM358.6 juta), Kedah (-RM225.4 juta), W.P. Labuan (-RM123.2 juta), Kelantan (-RM32.4 juta) dan Perlis (-RM10.9 juta).

Pulau Pinang kekal sebagai pengeksport utama dengan sumbangan 34.9 peratus, diikuti

oleh Johor (19.0%), Selangor (17.3%), Sarawak (7.5%) dan Kedah (4.2%).

Pada masa yang sama, import pada bulan Januari 2025 meningkat RM6.9 bilion (+6.2%) berbanding bulan yang sama pada tahun 2024. Peningkatan import disebabkan oleh import yang lebih tinggi di kebanyakan negeri iaitu Pulau Pinang (+RM7.3 bilion), Johor (+RM2.5 bilion), Perak (+RM346.2 juta), W.P. Kuala Lumpur (+RM285.2 juta), W.P. Labuan (+RM139.0 juta), Kelantan (+RM92.9 juta) dan Perlis (+RM29.0 juta). Walau bagaimanapun, nilai import jatuh di Melaka sebanyak RM2.2 bilion, Pahang (-RM633.7 juta), Terengganu (-RM479.8 juta), Negeri Sembilan (-RM377.9 juta), Kedah (-RM157.8 juta), Sabah (-RM101.4 juta), Sarawak (-RM86.9 juta) dan Selangor (-RM73.8 juta).

Selangor mendominasi import Malaysia dengan sumbangan 24.8 peratus, diikuti oleh Johor (24.3%), Pulau Pinang (24.1%), W.P. Kuala Lumpur (8.5%) dan Kedah (5.2%).

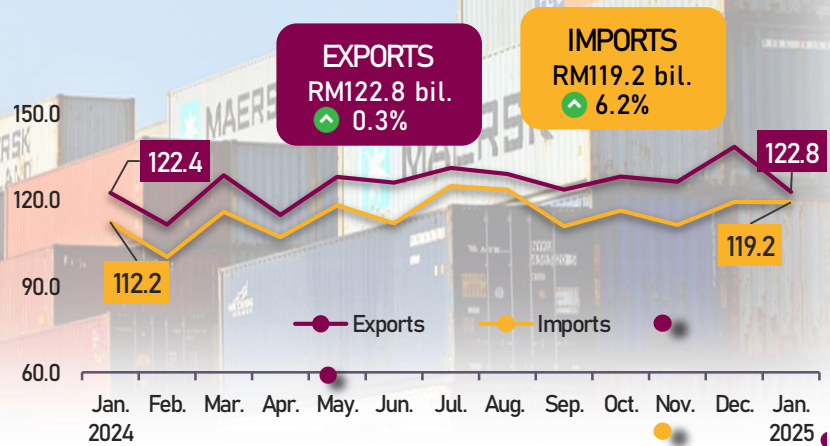

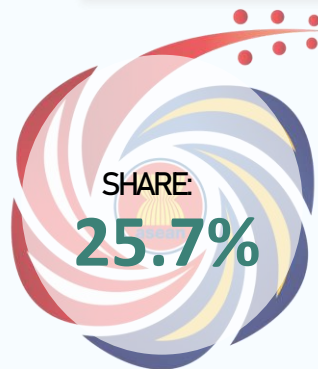

MALAYSIA'S TRADE PERFORMANCE, JANUARY 2025

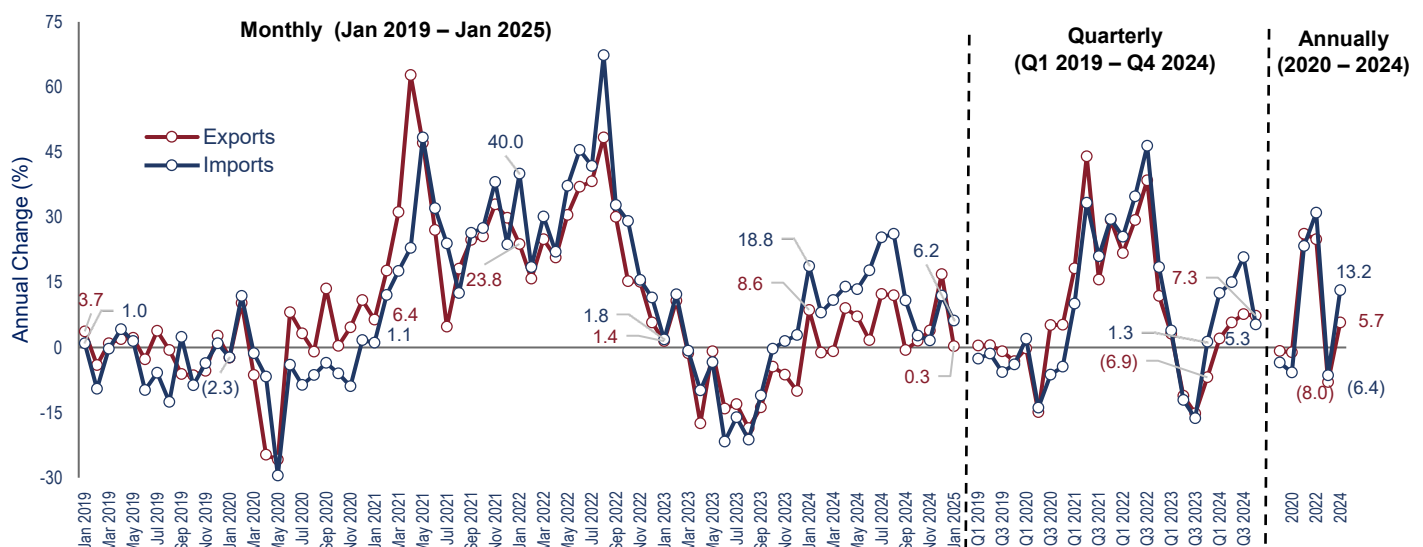
Malaysia's trade performance started a positive trend in January 2025 with the total trade recording an increase of 3.1 per cent or RM7.3 billion reaching a value of RM241.9 billion compared to RM234.6 billion in the previous year.

Exports increased by 0.3 per cent or RM380.3 million to RM122.8 billion, while imports recorded an increase of 6.2 per cent or RM6.9 billion to RM119.2 billion as compared

to RM112.2 billion in the previous year. In addition, the trade balance continuously posted a surplus with RM3.6 billion, down by 64.3 per cent as compared to RM10.2 billion in January 2024.

As compared to December 2024, exports, imports, total trade and trade surplus decreased by 11.3 per cent, 0.2 per cent, 6.2 per cent and 81.0 per cent, respectively.

EXPORTS

Malaysia's export performance showed a positive trend in January 2025, recording a growth of 0.3 per cent

Performance of Exports

Malaysia's exports recorded a growth of 0.3 per cent compared to the same month in 2024, in line with the increase in domestic exports. Domestic exports, which accounted for 79.4 per cent of total exports, increased by 2.9 per cent from RM94.7 billion to RM97.5 billion.

On the other hand, re-exports worth RM25.3 billion, accounting for 20.6 per cent of

total exports, decreased by 8.7 per cent from RM27.7 billion as compared to the previous year.

Meanwhile, the monthly comparison showed exports decreased by 11.3 per cent or RM15.7 billion. However, based on a month-on-month (m-o-m) seasonally adjusted terms analysis, exports decreased by 1.9 per cent to RM130.3 billion.

Chart 2: Domestic Exports, Re-Exports (RM billion) and Annual Change (%)

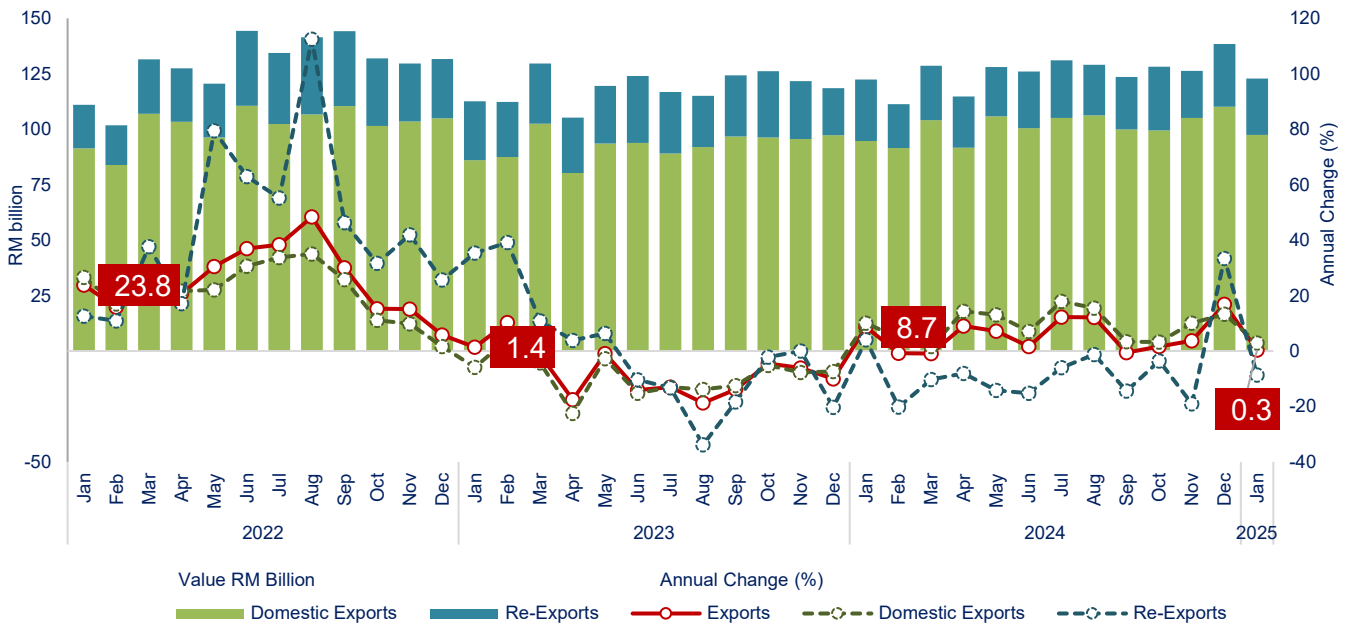
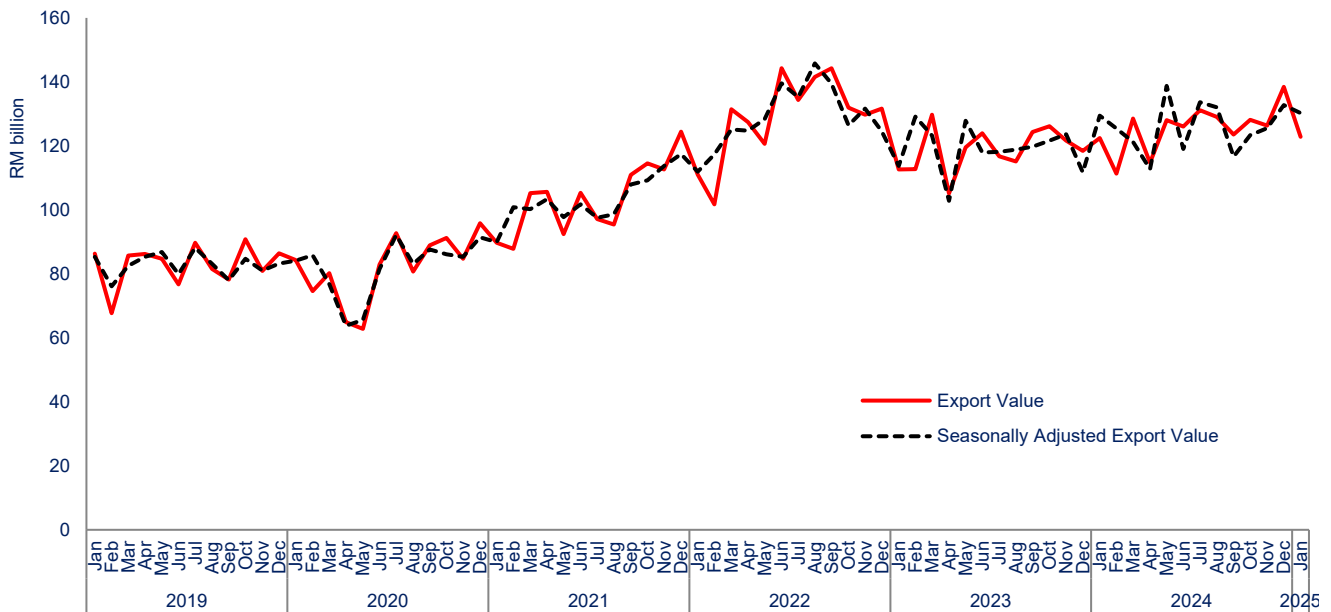


Chart 3: Actual Export Value and Seasonally Adjusted Export Value, RM billion



Export Performance for Major Country of Destination

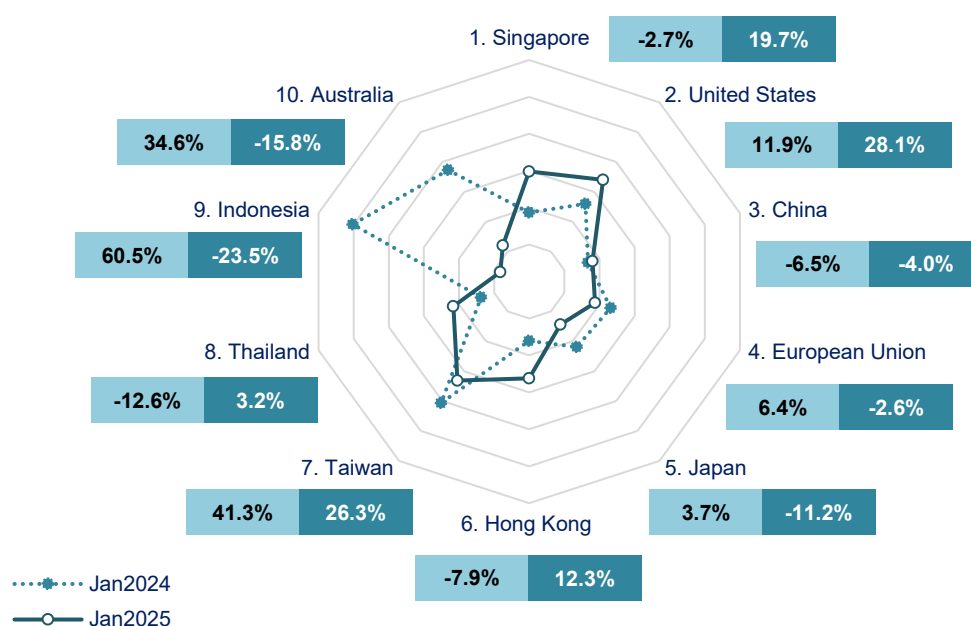
Singapore and the United States emerged as the top destination countries for Malaysia's exports, collectively contributing 31.0 per cent of the total export value in January 2025.

Singapore topped the list with exports worth RM20.9 billion, representing a 17.0 per cent share of Malaysia's total exports, reflecting a significant increase of 19.7 per cent, or RM3.4 billion, compared to the previous year. The increase was mainly driven by higher exports of electrical & electronic (E&E) products (+RM3.0 billion, +38.9%), petroleum products (+RM337.6 million, +13.0%) and machinery, equipment & parts (+RM277.0 million, +19.2%).

The United States contributed 14.1 per cent to Malaysia's total exports, valued at RM17.3 billion, marking an increase of RM3.8 billion or 28.1 per cent from the previous year. This growth was supported by higher exports of E&E products (+RM2.1 billion, +26.5%) and other manufactured products (+RM470.6 million, +50.2%).

Among the top ten destination countries, exports to Singapore, the United States, Hong Kong, Taiwan and Thailand experienced positive growth. On the other hand, exports to Indonesia, Japan, Australia, China and the European Union recorded declines.

Exports to ASEAN Countries

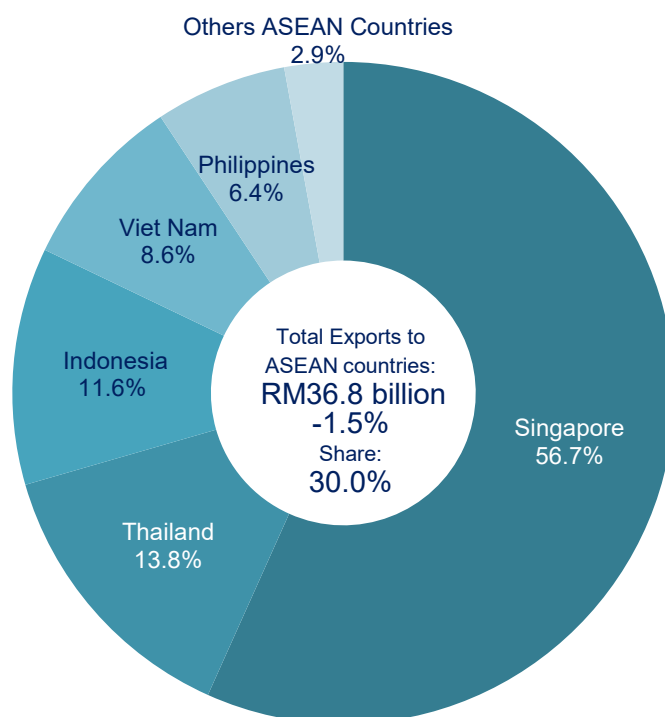
Exports to ASEAN countries, contributed 30.0 per cent of Malaysia's total exports in January 2025. It recorded a value of RM36.8 billion, a decrease of 1.5 per cent from RM37.3 billion in the same month the previous year.

The decline was mainly driven by petroleum products (-RM2.0 billion, -26.5%) and a decline

in chemical & chemical products (-RM449.2 million, -17.1%).

Among ASEAN countries, Singapore emerged as the leading export destination, contributing 56.7 per cent, with an increase of 19.6 per cent or RM3.4 billion compared to January 2024.

Export Performance for Economic Sectors

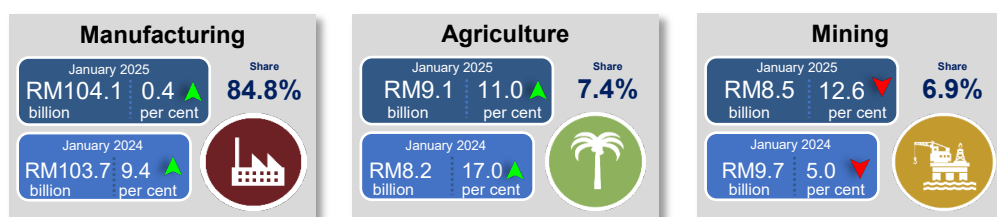
Exports of manufactured goods remained an important component of total exports in January 2025, contributing 84.8 per cent, recording a year-on-year (y-o-y) increase of 0.4 per cent or RM454.5 million to RM104.1 billion. The main contributors to the increase were E&E products (+RM6.5 billion, +14.8%), other manufactured products (+RM665.0 million, +17.2%) and machinery, equipment & parts (+RM429.5 million, +7.8%).

Exports of agricultural products which accounted for 7.4 per cent of total exports also recorded a growth of 11.0 per cent to RM9.1 billion. The

increase was largely attributed to higher exports of palm oil & palm oil-based agricultural products (+RM537.8 million, +8.7%) and other agricultural products (+RM317.3 million, +34.2%).

On the other hand, mining exports, which accounted for 6.9 per cent of total exports, experienced a decline of 12.6 per cent, falling to RM8.5 billion from RM9.7 billion. This decrease was primarily driven by reduced exports of liquefied natural gas (LNG) (-RM806.1 million, -13.3%), crude petroleum (-RM286.1 million, -12.3%) and metalliferous ores & metal scrap (-RM161.4 million, -20.3%).

Exports of Selected Major Products

Export performance recorded an increase in January 2025, in line with positive growth by the following products:

- E&E products, accounted for 41.1 per cent of total exports, increased by RM6.5 billion or 14.8 per cent to RM50.5 billion;
- Palm oil & palm oil-based products, accounting for 8.1 per cent of total exports, rose by RM948.8 million, reflecting a growth of 10.5 per cent, reaching a total of RM10.0 billion. Exports of palm oil, the leading commodity in this product group, noted an increase of RM38.5 million (+0.7%). While the export volume declined by 24.2 per cent, the average value per unit increased by 32.9 per cent. Additionally, the domestic price of crude palm oil has risen by 27.8 per cent, reaching RM4,672.50 per metric tonnes; and
- Natural rubber representing 0.3 per cent of total exports, increased 35.9 per cent or RM107.0 million to RM404.9 million. This aligns with a 2.8 per cent increase in export volume and an average unit value that has increased by 32.2 per cent. Additionally, rubber prices (SMR20) experienced a notable increase of 30.8 per cent.

However, a decrease was recorded for the following products:

- Refined petroleum products, which contributed 7.4 per cent of total exports, decreased by RM4.9 billion or 35.0 per cent to RM9.0 billion in line with the decline in export volume (-23.8%) and average value per unit (-14.7%);
- Crude petroleum, accounting for 1.7 per cent of total exports, decreased by RM286.1 million or 12.3 per cent to RM2.0 billion. Despite a decline of 18.1 per cent in the average value per unit, the export volume experienced a growth of 7.1 per cent. The price of Brent oil in January 2025 fell to RM354.4 (-5.7%) per barrel compared to the previous year;
- LNG accounted for 4.3 per cent of total exports, experiencing a reduction of RM806.1 million or 13.3 per cent, to RM5.2 billion, in line with the reduction in export volume, which saw a decline of 7.6 per cent, as well as a decrease in average unit value of 6.2 per cent; and
- Timber & timber-based products decreased by 5.4 per cent or RM108.9 million to RM1.9 billion, contributing 1.5 per cent to total exports.

IMPORTS

The import of capital goods recorded a significant surge, increasing by 45.9 per cent to RM20.0 billion in January 2025

Performance of Imports

Malaysia's import continued to record encouraging growth, increasing by 6.2 per cent or RM6.9 billion in January 2025. This increase brought the total imports to RM119.2 billion compared to the value recorded in the same month of the previous year. A m-o-m comparison showed that imports declined marginally by 0.2 per cent or RM185.0 million.

Referring to the analysis in seasonally adjusted terms m-o-m, imports increased by 2.0 per cent to RM121.6 billion. On a y-o-y basis, imports by End Use recorded an increase in capital goods and intermediate goods. Imports of capital goods rose by 45.9 per cent (RM6.3 billion), while intermediate goods increased by 3.3 per cent (RM1.9 billion). Conversely, consumption goods imports declined by 2.6 per cent or RM272.6 million.

Chart 6: Imports, Value (RM billion) and Annual Change (%)

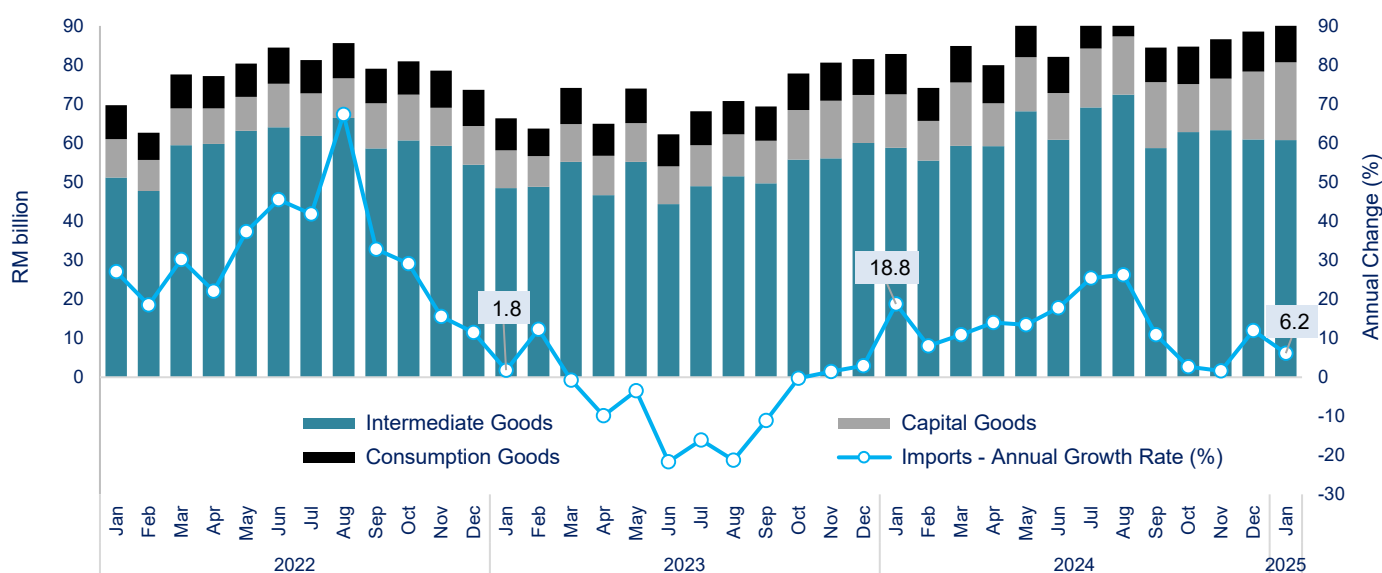
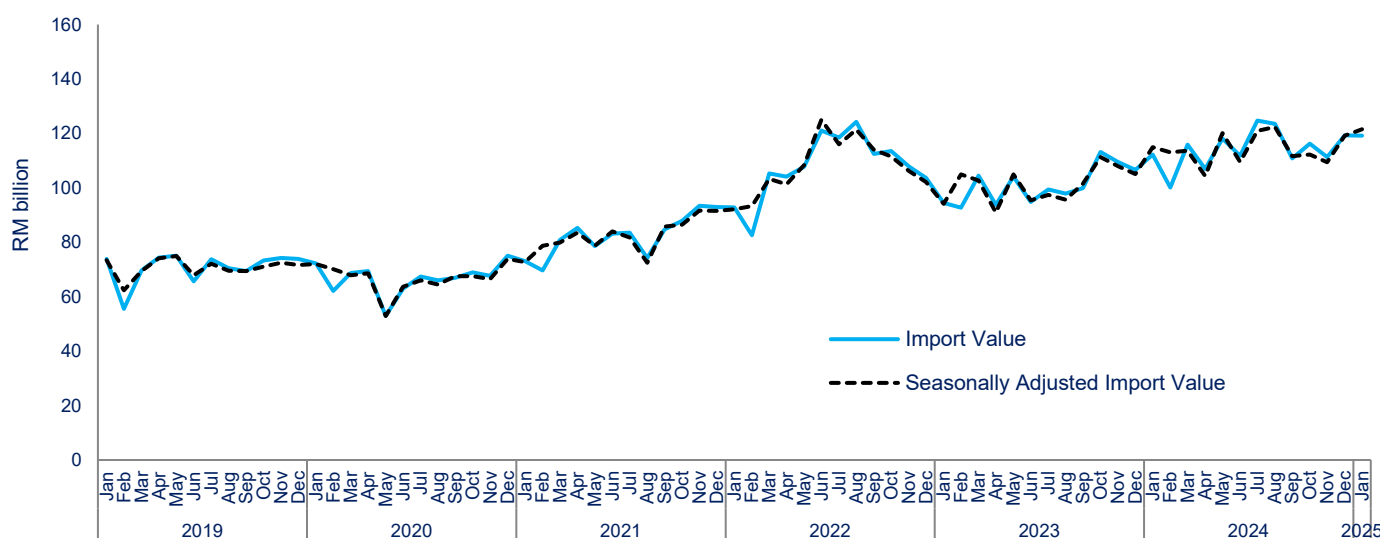


Chart 7: Actual Import Value and Seasonally Adjusted Imports Value, RM billion



Import Performance for Major Country of Origin

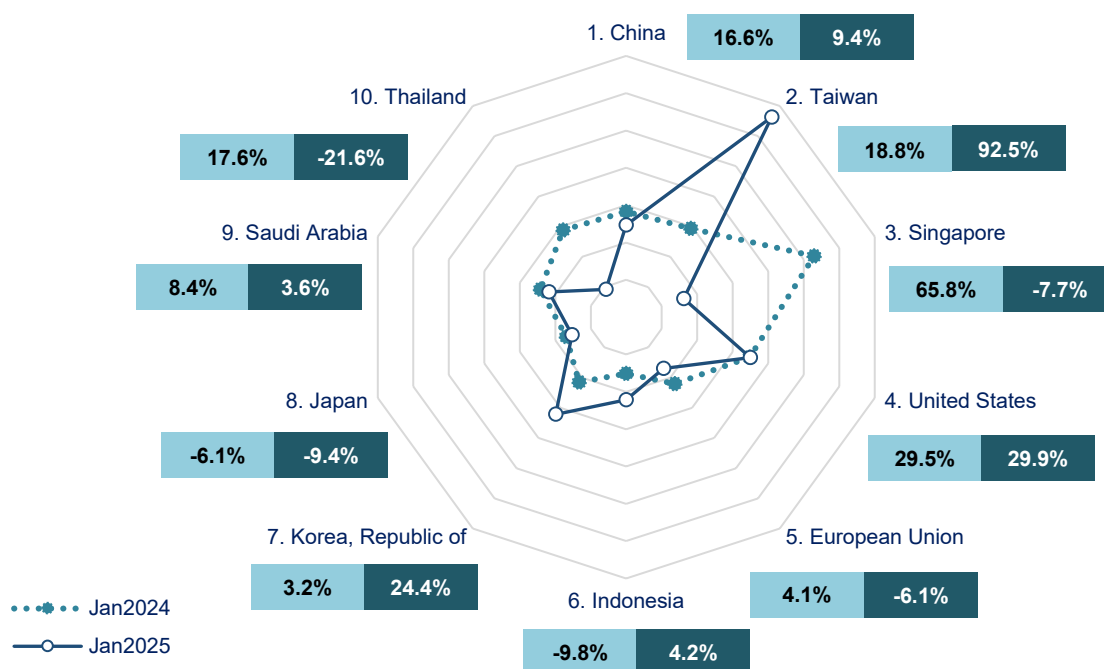
China and Taiwan were the two main countries of origin for Malaysia's imports in January 2025, contributing 36.1 per cent to the total import value.

Imports from China, which accounted for 23.6 per cent of Malaysia's total imports, expanded by 9.4 per cent to RM28.1 billion, y-o-y. The increase in imports from China was driven by higher imports of E&E products (+RM2.1 billion, +20.6%) and machinery, equipment & parts (+RM980.6 million, +33.5%).

Imports from Taiwan were valued at RM14.9 billion, making up 12.5 per cent of total imports, surging by 92.5 per cent or RM7.2 billion, y-o-y. This increase was attributed to higher imports of E&E products (+RM8.3 billion, +169.3%) and other manufactured goods (+RM157.6 million, +362.2%).

The y-o-y change in imports from four major countries recorded a decline, while imports from China, Taiwan, the United States, Indonesia, South Korea, and Saudi Arabia increased compared to the same month last year.

Imports from ASEAN Countries

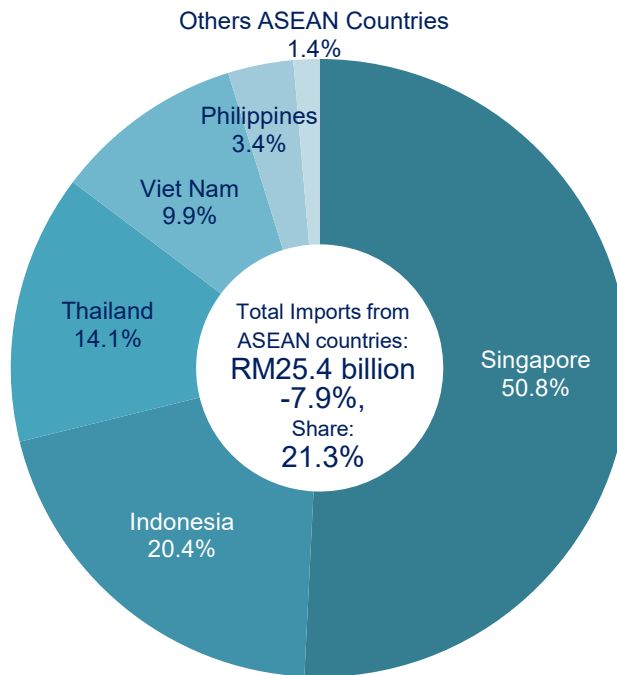
Imports from ASEAN countries accounted for 21.3 per cent of total imports, recording a decline of 7.9 per cent in January 2025 to RM25.4 billion compared to RM27.5 billion in the same month of the previous year.

This decline was mainly driven by lower imports of chemical & chemical products (-RM685.4 million, -30.3%), petroleum products (-RM454.0 million, -8.5%), other mining

(-RM365.7 million, -29.7%), transport equipment (-RM345.8 million, -32.1%), iron & steel products (-RM206.3 million, -22.9%), and E&E products (-RM205.7 million, -2.9%).

Among ASEAN countries, 50.8 per cent of imports were from Singapore, increasing by 7.7 per cent to RM12.9 billion compared to the previous year.

Import Performance for Economic Sectors

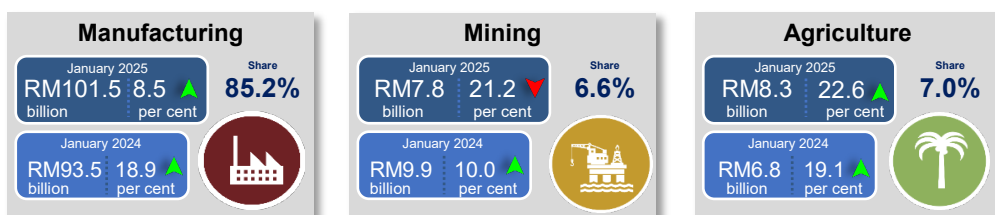
Imports of manufactured goods (85.2% of total imports) increased by 8.5 per cent from RM93.5 billion to RM101.5 billion y-o-y. This performance was driven by higher imports of E&E products (+RM13.4 billion, +40.8%) and machinery, equipment & parts (+RM808.3 million, +9.1%).

Imports of agricultural products (7.0% of total imports) grew by double digits, rising 22.6 per cent to RM8.3 billion, mainly supported by higher imports of other agricultural products (+RM636.7 million, +12.7%), palm oil & palm oil-based agricultural products (+RM421.3 million,

+147.9%), other vegetable oils (+RM320.9 million, +123.1%), natural rubber (+RM129.6 million, +18.0%), and seafood, fresh, chilled or frozen (+RM38.0 million, +9.2%).

Meanwhile, imports of mining products (6.6% of total imports) were valued at RM7.8 billion in January 2025, declining by 21.2 per cent or RM2.1 billion compared to the previous year. This was due to lower imports of crude petroleum (-RM1.3 billion, -23.1%), LNG (-RM478.9 million, -57.2%), and coal, coke & briquettes (-RM443.5 million, -22.5%).

Imports of Selected Major Products

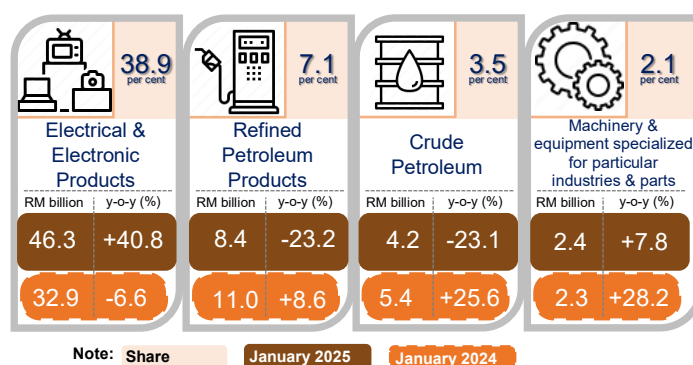
Imports continued to rise in January 2025, driven by the increase in the following products:

- E&E products (38.9% of total imports), up 40.8 per cent (+RM13.4 billion) to RM46.3 billion;
- Machinery & equipment specifically for certain industries and spare parts (2.1% of total imports), growing by 7.8 per cent (+RM178.6 million) to RM2.5 billion.

However, negative growth was recorded for the following products:

- Crude petroleum, which contributed 3.5 per cent to total imports, declined by RM1.3 billion or 23.1 per cent, in line with a decrease in import volume (-11.3%) and average unit value (-13.3%);
- Refined petroleum products, accounting for 7.1 per cent of total imports, decreased by RM2.5 billion or 23.2 per cent, consistent with a decline in average unit value (-10.7%) and import volume (-14.0%).

Imports for End Use & Broad Economic Categories (BEC) Classification

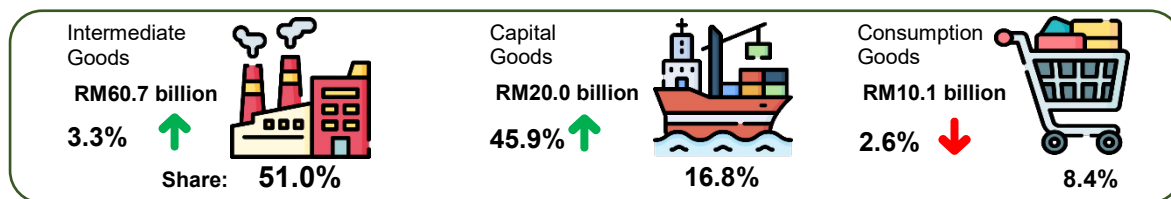
Imports increased by 6.2 per cent to RM119.2 billion, with three main import categories by End Use contributing 76.1 per cent of total imports, as follows:

Intermediate goods, valued at RM60.7 billion or 51.0 per cent of total imports, rose by 3.3 per cent, driven by a significant increase in imports of parts & accessories for capital goods (excluding transport equipment) (+RM5.6 billion, +36.1%).

Capital goods, totaling RM20.0 billion (16.8% of total imports), increased by 45.9 per cent, driven by higher imports of capital goods (excluding transport equipment), which rose by 43.9 per cent

or RM5.6 billion, and industrial transport equipment (+RM673.4 million, +73.4%).

Consumption goods, amounting to RM10.1 billion (8.4% of total imports), recorded a decline of 2.6 per cent, mainly due to lower imports of non-durable goods (-RM212.9 million, -10.4%) and semi-durable goods (-RM192.5 million, -9.3%).

EXPORTS AND IMPORTS BY LOCATION

Malaysia's total trade for January 2025 amounted to RM241.9 billion with exports and imports recorded RM122.8 billion and RM119.2 billion, respectively.

Exports was valued at RM122.8 billion in January 2025, increased RM380.3 million (+0.3%) as compared to the same month of the previous year. The increase in exports was attributed to the higher exports in four states namely Pulau Pinang (+RM8.3 billion), Melaka (+RM1.4 billion), Perak (+RM76.4 million) and Sabah (+RM11.0 million). However, exports decreased in Johor by RM4.1 billion, Sarawak (-RM1.5 billion), W.P. Kuala Lumpur (-RM1.0 billion), Selangor (-RM844.6 million), Pahang (-RM684.0 million), Terengganu (-RM459.6 million), Negeri Sembilan (-RM358.6 million), Kedah (-RM225.4 million), W.P. Labuan (-RM123.2 million), Kelantan (-RM32.4 million) and Perlis (-RM10.9 million).

Pulau Pinang remained as the top exporter with 34.9 per cent share, followed by Johor

(19.0%), Selangor (17.3%), Sarawak (7.5%) and Kedah (4.2%).

At the same time, imports in January 2025 increased RM6.9 billion (+6.2%) as compared to the same month in year 2024. The increase in imports was attributed by the higher imports in most states such as Pulau Pinang (+RM7.3 billion), Johor (+RM2.5 billion), Perak (+RM346.2 million), W.P. Kuala Lumpur (+RM285.2 million), W.P. Labuan (+RM139.0 million), Kelantan (+RM92.9 million) and Perlis (+RM29.0 million). However, imports decreased in Melaka by RM2.2 billion, Pahang (-RM633.7 million), Terengganu (-RM479.8 million), Negeri Sembilan (-RM377.9 million), Kedah (-RM157.8 million), Sabah (-RM101.4 million), Sarawak (-RM86.9 million) and Selangor (-RM73.8 million).

Selangor dominates Malaysia's imports with a share of 24.8 per cent, followed by Johor (24.3%), Pulau Pinang (24.1%), W.P. Kuala Lumpur (8.5%) and Kedah (5.2%).

Statistik ini juga meliputi Perdagangan Luar Negeri Malaysia (barangan) berkaitan import dan eksport di peringkat negeri (mengikut pintu keluar dan masuk) dengan seluruh dunia.

2. OBJEKTIF

Objektif utama penerbitan ini untuk membekalkan statistik tentang prestasi perdagangan Malaysia dengan negara-negara lain dari segi nilai dan volum barangan. Penerbitan ini menjadi input kepada penggubalan dasar, rujukan penting dalam pelaksanaan keputusan, pemantauan dan penilaian keberkesanan program pembangunan negara serta penyelidikan.

3. BIDANG DAN LIPUTAN

3.1 Malaysia menggunakan 'sistem perdagangan umum' dalam penyusunan Perangkaan Perdagangan Luar Negeri. Di bawah sistem ini, sempadan negara digunakan sebagai sempadan perangkaan. Semua barang yang dibawa masuk atau keluar dari negara (selain pengecualian yang disebutkan di para 11 di bawah) direkodkan, sama ada barangan itu tertakluk kepada kelulusan tertentu atau pun tidak. Barangan yang dibawa masuk atau keluar dari gudang-gudang simpanan kastam, Zon Bebas direkodkan di dalam perangkaan ini.

3.2 Butir-butir tentang kapal dan kapal terbang dagangan dan persendirian turut **diambil kira** jika ianya diimport atau dieksport sebagai barang yang dibeli, dijual atau disewa (kewangan) tidak kira sama ada ianya tiba atau berlepas dengan kuasanya sendiri.

3.3 Eksport mengikut lokasi adalah berdasarkan negeri asal (iaitu negeri dalam Malaysia di mana peringkat akhir pengeluaran atau pembuatan berlaku). Sebaliknya, import mengikut lokasi berdasarkan negeri destinasi terakhir (iaitu negeri di mana barangan dikeluarkan daripada kawalan Kastam, tetapi tidak semestinya di mana barangan itu akhirnya dijual atau digunakan).

Ketepatan dalam pelaporan negeri asal dan negeri destinasi akhir dalam dokumentasi oleh pihak Jabatan Kastam Diraja Malaysia (JKDM) memberi kesan kepada kualiti statistik perdagangan barangan mengikut lokasi. Dalam hal ini, lokasi pemuatan/pelepasan akan digunakan sebagai proksi bagi negeri asal/destinasi akhir yang sebenar.

3.4 Aktiviti eksport dan import yang berlaku di kawasan Supra (merangkumi aktiviti pengeluaran yang melangkaui pusat kepentingan ekonomi utama bagi mana- mana negeri) atau periklanan yang dilakukan oleh ejen penghantar tidak termasuk dalam penyusunan statistik import dan eksport mengikut lokasi. Nilai import atau eksport bagi W.P. Kuala Lumpur adalah termasuk W.P. Putrajaya.

4. SUMBER DATA

- 4.1 Pengikraran import dan eksport (*hard/soft copy*) yang diluluskan oleh Jabatan Kastam Diraja Malaysia (JKDM) dan Pihak Berkuasa Zon Bebas.
- 4.2 Keterangan mengenai pengiraman bungkusan pos/courier yang dibekalkan oleh Pos Malaysia Berhad.
- 4.3 Penyata dan pengikraran eksport mengenai *bunkers* dan *stores* yang dibekalkan kepada kapal terbang yang dikeluarkan/diluluskan oleh syarikat-syarikat petroleum.
- 4.4 Penyata penjualan barangan yang dibekalkan oleh pengusaha-pengusaha kedai bebas cukai.
- 4.5 Penyata jualan dan belian elektrik yang dikeluarkan oleh syarikat pengeluar

5. KONSEP DAN DEFINISI

- 5.1 Penyusunan statistik ini selaras dengan garis panduan dalam **International Merchandise Trade Statistics: Concepts and Definitions (IMTS) 2010** daripada Pertubuhan Bangsa-Bangsa Bersatu.

5.2 Import

Sesuatu barangan dianggap sebagai import apabila ianya dibawa **masuk** ke dalam negara, sama ada terus ataupun disimpan di gudang dalam kawasan yang dikawalselia oleh pihak Kastam tanpa mengira sama ada barangan tersebut adalah untuk kegunaan sendiri, diproses, digunakan dalam pembuatan ataupun untuk dieksport semula ke negara lain.

5.3 Eksport

Sesuatu barangan (keluaran atau buatan tempatan atau diimport untuk dieksport semula) dianggap sebagai eksport apabila ianya dibawa **keluar** dari negara.

5.4 Eksport Domestik

Sesuatu barangan (keluaran atau buatan tempatan) dianggap sebagai eksport domestik apabila ianya dibawa **keluar** dari negara.

5.5 Eksport Semula

Sesuatu barangan dianggap sebagai eksport semula apabila ianya dibawa **keluar** dari negara dalam keadaan seperti mana ianya **diimport** tanpa mengalami sebarang **perubahan**. Proses membungkus semula, menyisih atau menggred tidak dikira sebagai satu proses perubahan.

5.6 Imbangan Perdagangan

Imbangan perdagangan ialah perbezaan antara nilai eksport dan import. Apabila eksport melebihi import **lebih** direkodkan manakala **defisit** pula dicatatkan apabila import melebihi eksport.

6. ASAS PENILAIAN

- 6.1 **WTO Valuation Agreement (1994)** digunakan sebagai asas penilaian untuk semua transaksi barangan.
- 6.2 **Nilai** ditunjukkan dalam Ringgit Malaysia.
- 6.3 **Import** dinilai mengikut **cif (cost, insurance and freight – kos, insuran dan tambang)** iaitu nilai barangan di pasaran di sempadan statistik/kastam negara pengimport termasuk semua perbelanjaan insuran dan tambang semasa dalam perjalanan **tetapi** kos pemunggahan dari alat pengangkutan tidak diambil kira **kecuali** kos tersebut ditanggung sendiri oleh pengangkut.
- 6.4 **Eksport** dinilai mengikut **fob (free on board)** iaitu nilai barangan di pasaran di sempadan statistik/kastam negara pengeksport termasuk semua perbelanjaan pengangkutan ke sempadan tersebut, duti eksport dan duti lain yang perlu dibayar serta kos untuk memunggah barang ke atas alat pengangkutan **kecuali** kos terakhir itu ditanggung sendiri oleh pengangkut.

7. KLASIFIKASI BARANG DAGANGAN

- 7.1 Penyusunan Perangkaan Perdagangan Luar Negeri (barangan) bagi bulan rujukan Januari 2022 hingga Mei 2022 menggunakan Harmonised Commodity Description and Coding System (HS) 2017 yang juga dikenali sebagai Perintah Duti Kastam (PDK) 2017. Bermula bulan rujukan Jun 2022, HS2022 yang juga dikenali sebagai PDK2022 telah digunakan menggantikan HS2017. Walau bagaimanapun, pengelasan mengikut Standard International Trade Classification (S.I.T.C) Rev.4 masih digunakan dengan penyesuaian.
- 7.2 Selepas perbincangan dan perundingan dengan Lembaga Minyak Sawit Malaysia (MPOB), pilihan kod untuk minyak kelapa sawit dan hasil keluaran berasaskan minyak kelapa sawit adalah berdasarkan minyak kelapa sawit tulen dan hasil keluaran berasaskan minyak kelapa sawit serta kod-kod yang berasaskan minyak kelapa sawit dan hasil keluaran berasaskan minyak kelapa sawit (melebihi 50%).

8. VOLUM

Volum merupakan berat bersih atau ukuran lain bagi barangan itu, tidak termasuk kontena. Jika barangan itu dilaporkan dalam pelbagai unit ukuran, maka unit ukuran tersebut tidak dapat diselaraskan. Oleh itu, hanya nilai barangan sahaja dipaparkan.

9. NEGARA ASAL DAN YANG DITUJU

- 9.1 **Negara asal** merujuk kepada lokasi / negara barangan yang dibawa masuk ke dalam negara. Jika maklumat negara asalnya tidak dapat ditentukan. Sebagai contoh, bagi barangan melalui Singapura, maka import berkenaan dilaporkan dari Singapura.
- 9.2 **Negara yang dituju** merujuk kepada destinasi/negara akhir barangan itu dijangka akan digunakan. Bagi barangan yang dihantar dengan *optional bill of lading*, negara di mana pelabuhan pertama diketahui akan dilaporkan sebagai negara yang dituju. Jika maklumat negara yang dituju tidak dapat ditentukan. Sebagai contoh, bagi

barangan yang dieksport melalui Singapura, maka eksport berkenaan dilaporkan ke Singapura.

- 9.3 **Bagi bunkers dan stores yang dibekalkan kepada kapal dan kapal terbang,** negara yang dituju ditentukan mengikut lokasi/negara residen syarikat pengendali kapal atau kapal terbang tersebut.

10. TRANSAKSI BERNILAI RENDAH (TBR)

Mulai bulan rujukan Januari 2023, transaksi tunggal 'di bawah RM1,000' bagi Semenanjung Malaysia telah diliputi dalam penyusunan Perangkaan Perdagangan Luar Negeri dan transaksi bernilai 'di bawah RM5,000' telah dilaporkan mengikut kod HS yang diikrar. Manakala mulai bulan rujukan Januari 2024, transaksi tunggal 'di bawah RM2,000' untuk Sabah dan Sarawak telah dilaporkan mengikut kod HS yang diikrar.

11. PENGECEUALIAN

Barang-barang yang tidak termasuk dalam Perangkaan Perdagangan Luar Negeri adalah:

- 11.1 barangan transit, iaitu pengangkutan barangan di bawah kawalan kastam dari sebuah stesen kastam ke sebuah stesen kastam yang lain. Misalnya, pergerakan barangan dari Thailand ke Singapura melalui Semenanjung Malaysia dan pergerakan barangan dari sebuah zon bebas ke sebuah zon bebas yang lain di Malaysia. Barang dalam transit yang diliputi *through bills of lading* / *air-way bills* juga termasuk di bawah kategori ini;
- 11.2 barangan pindah kapal, iaitu pemindahan barangan di bawah kawalan pihak yang berkuasa, dari suatu pengangkutan yang digunakan untuk pengimportan kepada suatu pengangkutan lain yang digunakan untuk pengeksporan **dalam** kawasan kawalan pihak berkuasa yang sama. Stesen ini merupakan stesen pengimportan dan juga pengeksporan. Sebagai contoh, barangan dari Myanmar yang dibawa masuk ke kawasan kastam Pulau Pinang yang semata-mata bertujuan untuk dihantar ke negara ketiga (misalnya ke Hong Kong). Satu lagi contoh adalah barangan dari India yang dibawa masuk melalui Kawasan Bebas Pelabuhan Klang yang semata-mata bertujuan untuk dihantar ke Negara Ketiga (misalnya ke Sepanyol);
- 11.3 emas (kewangan) dan wang kertas serta duit syiling dalam edaran;
- 11.4 barangan yang diimport dan dieksport oleh, atau bagi pihak perkhidmatan diplomatik dan Angkatan Tentera Bukan Malaysia;
- 11.5 filem wayang untuk disewa;
- 11.6 kemasukan barangan untuk sementara waktu dan ianya tertakluk kepada pengeksporan semula dalam keadaan yang sama. Barangan ini diimport untuk tujuan tertentu dan dieksport semula dalam masa yang telah ditentukan tanpa mengalami sebarang perubahan, kecuali susut nilai yang biasa. Contohnya, binatang dan motokar bagi pertunjukan sarkas, perlumbaan, pertandingan dan pameran serta peralatan-peralatan bunyi untuk pertunjukan muzikal;
- 11.7 *barges (lash)* yang digunakan untuk mengangkut kargo dari kapal ke pantai atau sebaliknya;

- 11.8 ikan dan hasil laut lain yang dibawa oleh kapal laut berdaftar di Malaysia dan mendarat terus dari laut.
- 11.9 bekas untuk menyimpan sesuatu barang/benda, silinder, botol dan seumpamanya yang dinyatakan sebagai 'dikembalikan';
- 11.10 bekalan dan minyak yang dibekalkan kepada kapal laut dan kapal terbang yang dikendalikan oleh operator yang menetap di Malaysia;
- 11.11 semua sampel, pemberian dan bahan untuk ujian atau analisa tanpa mengira nilai transaksi yang terlibat;
- 11.12 tiket loteri & toto;
- 11.13 pergerakan barangan di antara Negeri di dalam Semenanjung Malaysia tanpa mengira cara pengangkutan serta pergerakan barangan melalui **darat** di antara Sabah dan Sarawak;
- 11.14 disket atau CD-ROM yang mengandungi perisian komputer dan / atau data, dibuat mengikut pesanan, audio dan videotapes yang mengandungi perakaman asal dan customised blueprints, dll; dan
- 11.15 barangan untuk **dibaiki**.

12. KEMASKINI TERHADAP NEGARA-NEGARA KESATUAN EROPAH (EU)

Bermula 1 Februari 2020, United Kingdom secara rasminya keluar daripada EU. Perkembangan ini telah diambil kira di dalam penerbitan mulai bulan Februari 2020 dan seterusnya.

- 13. Bermula rujukan Januari 2022, Statistik Eksport Produk Halal mengikut Pengelasan Barangan disusun daripada hasil gabungan pangkalan data Perdagangan Luar Negeri dengan senarai syarikat berstatus halal yang diperoleh daripada Jabatan Kemajuan Islam Malaysia (JAKIM).

14. PELARASAN MUSIM

Data siri masa adalah amat berguna untuk ahli ekonomi, pembuat dasar dan polisi serta penganalisis siri masa untuk mengenal pasti ciri-ciri penting siri ekonomi seperti arah, *turning point* dan konsistensi antara penunjuk ekonomi yang lain. Kadang-kadang ciri ini sukar untuk diperhatikan kerana pergerakan bermusim. Oleh itu, sekiranya kesan bermusim boleh disingkirkan, perilaku data siri ini dapat dilihat dengan lebih baik. Anggaran dan penyingkiran kesan bermusim dipanggil pelarasan bermusim.

Pelarasan bermusim adalah satu proses untuk mengenal pasti dan menyingkirkan bentuk pola bermusim yang biasa berlaku dalam tempoh satu tahun, yang mungkin juga merangkumi pengaruh dari kesan cuti yang bergerak dan hari bekerja/ berdagang bagi suatu tempoh. Objektif utama proses ini adalah untuk menyerlahkan dasar arah aliran dan pergerakan-pergerakan jangka pendek dalam siri ini.

Di Malaysia, kebanyakan data siri masa terjejas oleh kesan bermusim. Oleh itu, untuk menghapuskan kesan bermusim dan juga melaraskan musim data siri masa ekonomi Malaysia, pakej pelarasan bermusim standard, X-12 ARIMA telah digunakan oleh Jabatan Perangkaan, Malaysia.

Data siri masa ekonomi Malaysia kerap dipengaruhi oleh perayaan agama utama seperti Aidilfitri bagi umat Islam, Tahun Baru Cina untuk kaum Cina dan Deepavali untuk kaum India. Tarikh perayaan-perayaan ini tetap mengikut tahun lunar tetapi berbeza-beza mengikut kalendar Gregorian. Oleh itu, untuk menganggar dan menyingkirkan kesan cuti yang bergerak dari data siri masa, satu prosedur telah dibangunkan iaitu *Seasonal Adjustment for Malaysia* (SEAM).

Kaedah SEAM digunakan untuk membuang kesan bermusim bagi data Perdagangan Luar Negeri Malaysia. Pelarasan musim dibuat ke atas data bulanan bagi jumlah eksport dan import. Data siri pelarasan bermusim untuk tiga tahun sebelumnya akan disemak setiap tahun apabila data untuk 12 bulan lengkap.

15. KLASIFIKASI MENGIKUT KATEGORI EKONOMI UMUM (BEC)

- 15.1 Klasifikasi mengikut Kategori Ekonomi Umum (BEC) diwujudkan adalah untuk meringkaskan Perangkaan Perdagangan Luar Negeri (PPLN) mengikut kelas komoditi ekonomi yang luas. Di samping itu, ia dibentuk sebagai pengantara untuk menukarkan data PPLN yang disusun berdasarkan HS kepada kategori penggunaan akhir yang lebih bermakna dalam konteks Sistem Akaun Negara (SNA) iaitu barang modal, barang pengantara dan barang penggunaan. Penyusunan ini membolehkan data PPLN dihubungkan dengan perangkaan ekonomi umum seperti perangkaan akaun negara dan perangkaan perindustrian bagi tujuan penganalisan ekonomi di peringkat negara, kawasan dan dunia.
- 15.2 BEC termasuk sembilan belas kategori asas. Setiap kategori BEC didefinisikan dari segi bahagian, kumpulan, sub-kumpulan dan tajuk HS. Setiap tajuk asas HS ditetapkan secara khusus kepada satu kategori BEC. Penetapan ini dibuat berasaskan penggunaan akhir yang utama bagi sesuatu komoditi dalam setiap tajuk HS, walaupun erdapat banyak komoditi yang didagangkan di peringkat antarabangsa boleh dikelaskan kepada pelbagai kegunaan.
- 15.3 Statistik dalam Jadual 16: Import Barangan Mengikut Klasifikasi Kategori Ekonomi Umum dijana berdasarkan import tertangguh iaitu import tolak eksport semula. Angka tersebut boleh menjadi negatif bagi bulan rujukan tertentu jika eksport semula melebihi daripada import.

16. KERAHSIAAN DATA

Data perdagangan telah disusun di bawah peruntukan ***Statistics Act 1965 (Revised-1989)***. Akta ini mensyaratkan bahawa kandungan penyata individu adalah sulit. Selaras dengan peruntukan tersebut, hanya angka agregat diterbitkan.

17. DASAR PINDAAN

Data pada bulan semasa adalah sementara (provisional) dan tertakluk kepada pindaan sehingga ia dimuktamadkan. Pindaan dibuat sekiranya wujud maklumat tambahan. Bermula tahun 2021, data muktamad akan dikeluarkan 7 (tujuh) bulan selepas tahun rujukan. Perangkaan muktamad perdagangan luar negeri bagi tahun rujukan 2021 telah digunakan mulai bulan rujukan Jun 2022.

18. **PEMBUNDARAN**

Jumlah-jumlah kecil, apabila dicampurkan, **mungkin** tidak bersamaan dengan jumlah besar disebabkan oleh pembundaran.

TECHNICAL NOTES

1. INTRODUCTION

This publication contains statistics of Malaysia's External trade (merchandise) pertaining to imports and exports (including re-exports) by sections, divisions and groups of commodity, country of origin and destination, selected/major commodities, Broad Economic Category (BEC) classification and end-use as well as seasonally adjusted data.

This publication also contains statistics of Malaysia's External Trade (merchandise) on imports and exports at the state level (based on exit and entry points) with the rest of the world.

2. OBJECTIVE

The main objective of compiling Malaysia's external trade statistics is to provide information on Malaysia's trade performance vis-a-vis the rest of the world in terms of volume and value of merchandise goods. The trade statistics, therefore, serve as a tool in assisting the government in formulating policies and monitoring economic performance as well as for development planning. The data can also be used by the private sector and individuals for specific purposes such as for economic projection and analysis.

3. SCOPE AND COVERAGE

3.1 *The 'general trade system' of recording is adopted in compiling Malaysian external trade statistics. Under this system, the national boundary of the country is used as the statistical frontier. All goods entering or leaving the country (except specific exclusions mentioned in paragraph 11 below) are recorded, whether or not such goods are subject to clearance. Accordingly, goods entering or leaving customs bonded warehouses, Free Zones are recorded in the statistics.*

3.2 *Details of commercial and private ships and aircraft are also **included** in these statistics if they were imported or exported as goods purchased, sold or leased (financial) whether or not they arrived or departed under their own power.*

3.3 *Exports by location based on the state of origin (i.e. state of Malaysia where the final stage of production or manufacturing occurs). On the other hand, imports by location based on the state of final destination (i.e. the state of Malaysia in which goods are released from Customs controls, but not necessarily where they are ultimately sold or consumed).*

The accuracy in reporting the actual State of origin and State of final destination on Royal Malaysian Customs Department documentation affects the quality of State merchandise trade statistics. In this case, the location of loading/discharge may be used as a proxy for the actual state of origin/final destination.

3.4 *Export and import activities that are taking place in the Supra area (including production activities beyond the centre of predominant economic interest for any state) or declarations made by the agent are not included in the compilation of imports and exports statistics by location. Imports or exports value for the W.P. Kuala Lumpur includes the W.P. Putrajaya.*

4. SOURCE OF DATA

- 4.1 *Import and export declarations (hard/soft copy) approved by the Royal Malaysian Customs Department (RMCD) and Free Zone Authorities.*
- 4.2 *Particulars on postal/courier packages are provided by Pos Malaysia Berhad.*
- 4.3 *Statements and export declarations on bunkers and stores supplied to aircraft issued/approved by the petroleum companies.*
- 4.4 *Statements on goods sold are supplied by the operators of duty-free shops.*
- 4.5 *Statements on the sale and purchase of electricity issued by 'power producer company'.*

5. CONCEPTS AND DEFINITIONS

- 5.1 *The compilation of these statistics is in accordance with the guidelines of the **International Merchandise Trade Statistics: Concepts and Definitions (IMTS) 2010** from the **United Nations**.*

5.2 **Imports**

*Goods are regarded as imports when they are brought **into** the country either directly or into bonded warehouses, irrespective of whether such goods are for consumption, to be processed, use in manufacturing or subsequent re-exports to other countries.*

5.3 **Exports**

*Goods (locally produced or manufactured or imported for subsequent re-exports) are regarded as exports when they are taken **out** of the country.*

5.4 **Domestic Exports**

*Goods (locally produced or manufactured) are regarded as domestic exports when they are taken **out** of the country.*

5.5 **Re-exports**

*Goods are regarded as re-exports when they are taken **out** of the country in the same form as they were **imported** without any **transformation**. Re-packing, sorting or grading processes are not considered as part of the transformation process.*

5.6 **Balance of Trade**

*The balance of trade is the difference between the value of exports and imports. When exports exceed imports it is recorded as a **surplus** while a **deficit** is registered when imports exceed exports.*

6. BASIS OF VALUATION

- 6.1 *The **WTO Valuation Agreement (1994)** is used as the basis of valuation for all transactions of goods.*
- 6.2 ***Values** are shown in Malaysian Ringgit.*

- 6.3 **Imports** are valued on a **c.i.f. (cost, insurance and freight)** basis, that is, the value of the goods in the market at the statistical / customs frontier of the importing country, including all charges for transport and insurance whilst in transit **but** excluding the cost of unloading from the carrier **unless** it is borne by the carrier.
- 6.4 **Exports** are valued on a **f.o.b. (free on board)** basis, that is, the value of the goods in the market at the statistical / customs frontier of the exporting country, including all costs of transporting the goods to the statistical / customs frontier, export and other duties payable as well as the cost of loading the goods onto the carrier **unless** the latter cost is borne by the carrier.

7. CLASSIFICATION OF COMMODITIES

- 7.1 The compilation of External Trade Statistics (merchandise) for the reference month of January 2022 to May 2022 used the Harmonised Commodity description and Coding system (HS) 2017, also known as Customs Duties Order (PDK) 2017. Commencing from the reference month of June 2022, HS2022 also known as PDK2022 has been used to replace HS2017. However, Standard International Trade Classification (S.I.T.C) Rev.4 is still in use with appropriate updates.
- 7.2 After discussion and consultation with Malaysian Palm Oil Board (MPOB), the selection of codes for palm oil and palm oil-based products is based on pure palm oil and palm oil-based products as well as those codes which are predominantly palm oil and palm oil-based products (more than 50%).

8. VOLUME

Volume, where shown, represent the nett weight or other measurement of the goods exclusive of packing containers. Where a commodity item comprises different kinds of commodities for which a common unit of measurement cannot be used, only values are shown.

9. COUNTRY OF ORIGIN AND DESTINATION

- 9.1 **Country of origin** refers to the location/country of goods brought into the country. If the country of origin information cannot be determined, for example, for goods via Singapore, then the import is reported from Singapore.
- 9.2 **Country of destination** refers to the final destination/country where the goods are expected to be used. For goods sent with a country where the first port is known will be reported as the country of destination. if the destination country information cannot be determined, for example, for goods exported through Singapore, then the exports is reported to Singapore.
- 9.3 **For bunkers and stores supplied to ships and aircraft**, the country of destination is determined according to the country of residence of the operator of the ship or aircraft.

10. LOW VALUE TRANSACTIONS (LVT)

With effect from reference month of January 2023, single transactions with a value 'below RM1,000' for Peninsular Malaysia have been covered in the compilation of External Trade Statistics and transactions worth 'below RM5,000' have been reported according to the pledged HS code. Meanwhile with effect from reference month of January 2024, single transactions with a value 'below RM2,000' for Sabah and Sarawak have been reported according to the pledged HS code.

11. EXCLUSIONS

Classes of goods excluded from external trade statistics are: -

- 11.1 transit cargo, that is goods transported under customs control from one Customs office to another. Examples are the movement of goods from Thailand bound for Singapore through Peninsular Malaysia and the movement of goods within Malaysia from one free trade zone to another. All goods in transit covered through bills of lading/air-way bills are also included in this category;*
- 11.2 transshipment cargo, that is goods transferred under the control of the relevant authorities from the importing means of transport to the exporting means of transport **within** the area of control of the same authorities, which is the office of both importation and exportation. For example, goods from Myanmar brought into the Pulau Pinang Customs area for the sole purpose of transport to a third country (e.g. to Hong Kong). Another example is goods from India brought into the Port Klang Free Zone for the sole purpose of transport to a third country (e.g. to Spain);*
- 11.3 gold bullion (monetary) and issued currency notes and coins;*
- 11.4 goods imported and exported by, or on behalf of, diplomatic services and non-Malaysian Armed Forces;*
- 11.5 exposed cinematographic films on a rental basis;*
- 11.6 temporary admission of goods subject to re-exportation in the same state. Such goods must be imported for a specific purpose and must be intended for re-exportation within a specified period without having undergone any change except normal depreciation. Examples are animals and cars for circuses, races, competitions and exhibitions and instruments/sound equipment for musical performances;*
- 11.7 barges (lash) used for the transportation of cargo from vessel to shore or vice-versa;*
- 11.8 fish and other marine produce landed by Malaysian registered vessels direct from the sea;*
- 11.9 containers, cylinders, bottles, crates and the like specified as returnable;*
- 11.10 stores and fuel supplied to ships and aircraft handled by operators of Malaysian residence;*
- 11.11 samples, gifts and specimens for test or analysis, irrespective of value;*
- 11.12 toto & lottery tickets;*

11.13 movement of goods by any mode of transportation between states within Peninsular Malaysia and movement of goods by **land** between Sabah and Sarawak;

11.14 diskettes or CD-ROMs with stored computer software and/or data, developed to order, audio and videotapes containing original recordings and customised blueprints, etc; and

11.15 goods for **repair**.

12. **UPDATE TO EUROPEAN UNION (EU) COUNTRIES**

From 1st July 2013, Croatia has joined EU. This development has been incorporated in the publication from July 2013 onwards.

13. *Commencing from January 2022, statistics on Exports of Halal Products by Commodity Classification is compiled from an integrated external trade database with list of Halal certified companies which obtained from the Department of Islamic Development Malaysia (JAKIM).*

14. **SEASONAL ADJUSTMENT**

Time-series data are very useful for economists, policy & decision makers and time-series analysts to identify the important features of economic series such as direction, turning point and consistency between other economic indicators. Sometimes this feature is difficult to observe because of seasonal movements. Thus, if the seasonal effect can be removed, the behaviour of the series would be better viewed. The estimation and removal of the seasonal effects is called seasonal adjustment.

Seasonal adjustment is a process to identify and to remove the regular within-a-year seasonal pattern, which may also include the influences of moving holidays and working / trading days effect in each period. The ultimate objective of the process is to highlight the underlying trends and short-term movements in the series.

In Malaysia, most of the time series data are affected by seasonal effects. Hence, to eliminate the seasonal effect as well as to seasonally adjust the Malaysian economic time series data, a standard seasonal adjustment package, X-12 ARIMA was used by Department of Statistics, Malaysia.

Malaysian economic time series data are often affected by major religious festivals such as Eid-ul Fitr of the Muslims, Chinese New Year of the Chinese and Deepavali of the Indians. These festivals' dates are fixed according to the lunar year but vary according to the Gregorian calendar. Therefore, to estimate and remove moving holiday effect from time-series data, a procedure was developed, namely Seasonal Adjustment for Malaysia (SEAM).

The SEAM method is used to remove seasonal effect for Malaysia's merchandise external trade data. The seasonal adjustment is carried out on monthly total exports and total imports. The seasonally adjusted series data for the preceding three years are revised each year when the figures for complete 12 months become available.

15. CLASSIFICATION BY BROAD ECONOMIC CATEGORIES (BEC)

- 15.1 The BEC was originally devised mainly for the summarization of data on international trade by large economic classes of commodities. In addition, it was designed to serve as a means for converting external trade data compiled on the HS into end use categories that are meaningful within the framework of the System of National Accounts (SNA) namely capital goods, intermediate goods, and consumption goods. This aggregation permits external trade statistics to be considered jointly with other sets of general economic statistics such as national accounts and industrial statistics for national, regional or world level economic analysis.
- 15.2 The BEC includes nineteen basic categories. Each category of the BEC is defined in terms of divisions, groups, sub-groups and basic headings of HS. Each HS basic heading is allocated entirely to one BEC category. The allocation is done on the basis of the main end use of the commodities in each HS basic heading, although it is recognised that many commodities that are traded internationally may be put to a variety of uses.
- 15.3 The statistics in Table 16: Imports of Commodities by Broad Economic Categories Classifications are generated based on retained imports i.e. imports minus re-exports. The figure could be negative for a reference month if re-exports are higher than imports.

16. CONFIDENTIALITY REQUIREMENTS

The trade data statistics have been compiled under the provisions of the **Statistics Act 1965 (Revised-1989)**. The Act stipulates that the contents of individual returns are **confidential**. In conformity with the said stipulation, only aggregated figures are published.

17. REVISION POLICY

Data for the current month is provisional and subject to revision until it is finalised. Revisions are made if there are additional information. Starting 2021, final data will be released by 7 (seven) months after reference year. Final external trade statistics for reference year 2021 was used from reference month June 2022.

18. ROUNDING

Sub-totals **may** not add up exactly to totals due to rounding.
