Penerbitan Keluaran Dalam Negeri Kasar (KDNK), Malaysia adalah penerbitan tahunan yang membentangkan Akaun pengeluaran dan perbelanjaan negara mengikut aktiviti ekonomi dan jenis perbelanjaan pada harga semasa dan harga malar tahun asas 2015. Siri data tahunan dari 2015 dan seterusnya turut disertakan dalam laporan ini.

Anggaran KDNK pada tahun 2021 telah dimuktamadkan berdasarkan data terkini daripada penyiasatan tahunan dan pelbagai sumber data. PREFACE

The publication of Gross Domestic Product (GDP), Malaysia is an annual publication which presents the National production and expenditure accounts by economic activity and type of expenditure in both current and constant prices at the base year 2015. Annual data series from 2015 onwards are also included in this report.

GDP estimates for 2021 were finalised based on the latest annual surveys and various data sources. Revisions of data were incorporated into the 2022 GDP estimates, while the 2023 GDP estimates were based on preliminary data. The compilation for the GDP is based on recommendations of the System of National Accounts 2008.

The summary of the findings of Malaysia's economy for the year 2023 is presented in the first section of this publication, followed by a series of GDP data and technical notes for the user's reference. Meanwhile, the methodology, data sources and glossary are accessible from the Department's portal.

The Department of Statistics Malaysia (DOSM) acknowledges the cooperation of all parties that have provided the required data and contributed to the success of this publication. Any feedback and suggestions towards improving the future publication are highly appreciated.





PERTUMBUHAN EKONOMI


Ekonomi Malaysia menyederhana kepada 3.6 peratus pada tahun 2023 daripada 8.9 peratus pada tahun sebelumnya (Carta 1). Prestasi ini dipacu oleh sektor Perkhidmatan dan Pembuatan yang menyumbang 82.6 peratus daripada jumlah Keluaran Dalam Negeri Kasar (KDNK). Dari segi permintaan, Perbelanjaan penggunaan akhir swasta kekal sebagai komponen terbesar dengan sumbangan sebanyak 60.7 peratus kepada KDNK pada tahun 2023 (Carta 2).

KDNK Malaysia pada harga semasa berjumlah RM1.82 trilion pada tahun 2023 dan RM1.57 trilion pada harga malar. Berdasarkan prestasi keseluruhan semasa, Pendapatan Negara Kasar per kapita mencatatkan RM53,026 berbanding RM53,121 pada tahun 2022.

Carta 2 KDNK - Sumbangan Peratusan pada Harga Malar 2023




RINGKASAN PENEMUAN 2023

PERKHIDMATAN

Sektor **Perkhidmatan** berkembang sebanyak 5.1 peratus pada tahun 2023 daripada 11.0 peratus pada tahun sebelumnya, seperti ditunjukkan di Carta 3. Prestasi ini disokong oleh pertumbuhan kukuh dalam subsektor utama seperti Perdagangan borong & runcit pada 5.9 peratus (2022: 13.7%), Pengangkutan & penyimpanan pada 13.8 peratus (2022: 29.4%) dan Makanan & minuman dan penginapan pada 7.7 peratus (2022: 34.7%).



PEMBUATAN

Sektor **Pembuatan** bertumbuh pada kadar yang lebih perlahan pada 0.7 peratus (2022: 8.1%) pada tahun 2023, seperti di Carta 4. Pertumbuhan sederhana ini dipengaruhi oleh produk berorientasikan domestik seperti Kenderaan bermotor dan peralatan pengangkutan pada 3.6 peratus (2022: 15.2%), Pemprosesan makanan pada 5.5 peratus (2022: 7.9%) dan Produk logam yang direka pada 7.0 peratus (2022: 7.0%). Walau bagaimanapun, produk berorientasikan eksport seperti Komponen & papan elektronik, peralatan komunikasi dan elektronik pengguna dan Produk petroleum bertapis masing-masing menyusut 3.0 peratus (2022: 16.7%) dan 2.3 peratus (2022: 5.4%), telah mengurangkan pertumbuhan keseluruhan sektor ini.



PERTANIAN

Sektor **Pertanian** meningkat 0.7 peratus pada tahun 2023 berbanding 1.3 peratus pada tahun 2022 (Carta 5). Peningkatan marginal ini didorong terutamanya oleh subsektor Kelapa sawit dan Ternakan yang masing-masing meningkat 0.2 peratus (2022: 3.8%) dan 0.7 peratus (2022: 0.5%). Walau bagaimanapun, subsektor Getah dan Perhutanan dan pembalakan menyusut, masing-masing sebanyak 6.6 peratus (2022: -19.7%) dan 9.0 peratus (2022: 0.6%).



PERLOMBONGAN DAN PENGKUARIAN

Sektor **Perlombongan dan pengkuarian** meningkat 0.5 peratus daripada 3.5 peratus pada tahun 2022, seperti di Carta 6. Peningkatan ini disumbangkan oleh subsektor Gas asli yang berkembang 0.6 peratus (2022: 5.3%) dan Perlombongan lain & pengkuarian dan perkhidmatan sokongan yang meningkat 3.6 peratus (2022: 10.2%). Sementara itu, Minyak mentah & kondensat menurun sebanyak 0.4 peratus (2022: -0.3%) pada tahun 2023.




RINGKASAN PENEMUAN 2023

PEMBINAAN

Sektor **Pembinaan** meningkat 6.1 peratus berbanding 5.1 peratus pada tahun sebelumnya (Carta 7). Prestasi ini diterajui oleh Kejuruteraan awam, Aktiviti pembinaan pertukangan khas dan Bangunan kediaman, dengan masing-masing mencatatkan peningkatan 14.5 peratus (2022: -0.9%), 6.5 peratus (2022: 6.5%) dan 2.4 peratus (2022: -1.2%). 


PERBELANJAAN PENGGUNAAN AKHIR SWASTA

Perbelanjaan penggunaan akhir swasta menyederhana kepada 4.7 peratus berbanding 11.3 peratus pada tahun sebelumnya, seperti di Carta 8. Pertumbuhan sederhana ini dipengaruhi oleh perbelanjaan penggunaan ke atas Pengangkutan, Makanan & minuman bukan alkohol dan Perumahan, air, elektrik, gas & bahan api lain.

Sumbangan perbelanjaan bagi barang meningkat kepada 60.1 peratus (2022: 58.7%), disumbangkan oleh barang tidak tahan lama (72.4%) dan barang tahan lama (17.4%). Sementara itu, sumbangan perbelanjaan ke atas perkhidmatan kepada jumlah perbelanjaan penggunaan swasta berkurang daripada 41.3 peratus kepada 39.9 peratus pada tahun 2023.






PEMBENTUKAN MODAL TETAP KASAR

Pembentukan modal tetap kasar (PMTK) mencatatkan pertumbuhan 5.5 peratus (2022: 6.8%), seperti yang digambarkan dalam Carta 10. Momentum yang lebih perlana dalam PMTK adalah disebabkan oleh segmen Jentera & peralatan yang menyederhana 5.2 peratus (2022: 10.2%). Selain itu, Struktur dan Aset lain yang masing-masing berkembang 6.1 peratus (2022: 4.8%) dan 2.8 peratus (2022: 2.4%) telah mengimbangi perlana bagi sektor ini.

Dari segi sektor, prestasi PMTK sebahagian besarnya adalah disokong oleh sektor Swasta (sumbangan: 77.2%), dengan pertumbuhan 4.6 peratus berbanding 7.2 peratus pada tahun 2022. Selain itu, sektor Awam meningkat kepada 8.6 peratus daripada 5.3 peratus pada tahun sebelumnya.

Carta 10 PMTK - Nilai, Perubahan Peratusan Tahunan dan Sumbangan Peratusan pada Harga Malar 2015




EKSPORT DAN IMPORT


Eksport menyusut 8.1 peratus daripada pertumbuhan kukuh 14.5 peratus pada tahun sebelumnya (Carta 11). Kejatuhan ini dipengaruhi oleh Eksport barang dengan penyusutan 12.7 peratus (2022: 11.0%) yang menyumbang 85.3 peratus daripada jumlah Eksport. Sementara itu, Eksport perkhidmatan bertumbuh 33.0 peratus daripada 58.3 peratus pada tahun 2022.

Import menurun 7.4 peratus daripada 16.0 peratus pada tahun 2022 (Carta 12). Penguncupan ini disebabkan oleh penyusutan dalam Import barang yang merekodkan penurunan 11.7 peratus (2022: 14.4%). Import barang menyumbang 80.7 peratus daripada keseluruhan Import.

ECONOMIC GROWTH

Malaysia's economy moderated to 3.6 per cent in 2023 from 8.9 per cent in the preceding year (Chart 1). The performance was driven by the Services and Manufacturing sectors, which accounted for 82.6 per cent of the total Gross Domestic Product (GDP). In terms of demand, Private final consumption expenditure remained the largest component with a share of 60.7 per cent to GDP in 2023 (Chart 2).

Malaysia's GDP at current prices amounted to RM1.82 trillion in 2023 and RM1.57 trillion at constant prices. Based on the current overall performance, the Gross National Income per capita registered to RM53,026 as compared RM53,121 in 2022.

Chart 1 GDP - Annual Percentage Change at Constant Prices






Chart 2 GDP - Percentage Share at Constant 2015 Prices



SERVICES

The **Services** sector expanded by 5.1 per cent in 2023 from 11.0 per cent in the previous year, as shown in Chart 3. The performance was supported by steady growth in the main sub-sectors, namely Wholesale & retail trade at 5.9 per cent (2022: 13.7%), Transportation & storage at 13.8 per cent (2022: 29.4%) and Food & beverage and accommodation at 7.7 per cent (2022: 34.7%).


Chart 3 Services - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



MANUFACTURING

The **Manufacturing** sector grew at a slower pace of 0.7 per cent (2022: 8.1%) in 2023, as in Chart 4. The moderate growth was influenced by domestic oriented products such as Motor vehicles and transport equipment at 3.6 per cent (2022: 15.2%), Food processing at 5.5 per cent (2022: 7.9%) and Fabricated metal products at 7.0 per cent (2022: 7.0%). Nevertheless, export oriented products, namely Electronic components & boards, communication equipment & consumer electronics products and Refined petroleum products shrank by 3.0 per cent (2022: 16.7%) and 2.3 per cent (2022: 5.4%), respectively, which weighed down the overall growth of this sector.


Chart 4 Manufacturing - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



AGRICULTURE

The **Agriculture** sector grew at 0.7 per cent in 2023 as compared to 1.3 per cent in 2022 (Chart 5). The marginal increased was backed by Oil palm and Livestock sub-sectors, which rose by 0.2 per cent (2022: 3.8%) and 0.7 per cent (2022: 0.5%), respectively. However, Rubber and Forestry & logging sub-sectors, shrank by 6.6 per cent (2022: -19.7%) and 9.0 per cent (2022: 0.6%), respectively.


Chart 5 Agriculture - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



MINING AND QUARRYING

The **Mining and quarrying** sector grew at 0.5 per cent as against 3.5 per cent in 2022, as shown in Chart 6. The growth was contributed by the Natural gas sub-sector, which grew at 0.6 per cent (2022: 5.3%) and Other mining & quarrying and support services, which increased by 3.6 per cent (2022: 10.2%). Meanwhile, Crude oil & condensate decreased by 0.4 per cent (2022: -0.3%) in 2023.


Chart 6 Mining and Quarrying - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



CONSTRUCTION

The **Construction** sector surged by 6.1 per cent as compared to 5.1 per cent in the previous year (Chart 7). The attainment was led by Civil engineering, Specialised construction activities and Residential building which increased 14.5 per cent (2022: -0.9%), 6.5 per cent (2022: 6.5%) and 2.4 per cent (2022: -1.2%), respectively. In contrast, Non-residential buildings declined by 0.5 per cent (2022: 17.0%).

Chart 7 Construction - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices




PRIVATE FINAL CONSUMPTION EXPENDITURE

Private final consumption expenditure eased 4.7 per cent against 11.3 per cent in the preceding year, as in Chart 8. The moderation was influenced by the consumption expenditures of Transport, Food & non-alcoholic beverages and Housing, water, electricity, gas & other fuels.

The share of goods expenditure expanded to 60.1 per cent (2022: 58.7%), contributed by non-durable goods (72.4%) and durable goods (17.4%). Meanwhile, the share of expenditure on services to total private consumption expenditure reduced from 41.3 per cent to 39.9 per cent in 2023.


Chart 8 Private Final Consumption Expenditure - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices



GOVERNMENT FINAL CONSUMPTION EXPENDITURE

Government final consumption expenditure moderated to 3.3 per cent as compared to 5.1 per cent in the previous year (Chart 9). The expenditure on education and defence has driven the growth for government expenditure in 2023. However, the slower growth in spending on general public services has influenced the overall performance of government expenditure.

Chart 9 **Government Final Consumption Expenditure - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices**




GROSS FIXED CAPITAL FORMATION

Gross fixed capital formation (GFCF) posted a growth of 5.5 per cent (2022: 6.8%), as illustrated in Chart 10. The slower momentum in GFCF was due to the Machinery & equipment segment, which eased at 5.2 per cent (2022: 10.2%). Furthermore, Structure and Other assets expanded to 6.1 per cent (2022: 4.8%) and 2.8 per cent (2022: 2.4%), respectively, which has mitigated the slowdown in this sector.

In terms of sector, the performance of GFCF was largely underpinned by the Private sector (share: 77.2%) with a growth of 4.6 per cent as compared to 7.2 per cent in 2022. In addition, the Public sector accelerated to 8.6 per cent from 5.3 per cent in the preceding year.

EXPORTS AND IMPORTS

Exports contracted 8.1 per cent from a robust growth of 14.5 per cent in the previous year (Chart 11). The decline was influenced by *Exports of goods*, with a decreased of 12.7 per cent (2022: 11.0%) which contributed 85.3 per cent of total *Exports*. Meanwhile, *Exports of services* grew at 33.0 per cent from 58.3 per cent in 2022.

Imports descended 7.4 per cent from 16.0 per cent in 2022 (Chart 12). The contraction was attributed to the decline in *Imports of goods*, which recorded a decrease of 11.7 per cent (2022: 14.4%). *Imports of goods* accounted for 80.7 per cent of total *Imports*.

Chart 11 Exports - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices





Chart 12 Imports - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices

KONSEP DAN DEFINISI

PENGENALAN

Penyusunan data akaun negara yang ditunjukkan dalam jadual penerbitan ini adalah item terpilih daripada keseluruhan sistem perakaunan negara yang merekodkan semua aktiviti ekonomi. Sistem perakaunan negara meliputi pengeluaran, perbelanjaan, penjanaan dan pengagihan pendapatan, pembiayaan, tabungan dan pelaburan bagi keseluruhan ekonomi.

Sistem perakaunan ini ditakrifkan oleh Pertubuhan Bangsa-Bangsa Bersatu dan transaksi yang diberikan adalah mengikut panduan *Systems of National Accounts 2008 (SNA 2008)*.

KELUARAN DALAM NEGERI KASAR (KDNK)

Keluaran Dalam Negeri Kasar (KDNK) adalah jumlah nilai barang dan perkhidmatan yang dikeluarkan dalam tempoh tertentu selepas ditolak kos barang dan perkhidmatan yang digunakan dalam proses pengeluaran. Nilai ini merupakan nilai sebelum ditolak nilai peruntukan bagi modal tetap; iaitu jumlah nilai ditambah pada harga pengeluar bagi pengeluar residen ditambah dengan duti import. KDNK ini juga bersamaan dengan perbelanjaan ke atas KDNK (pada harga pembeli) iaitu jumlah bagi semua komponen perbelanjaan akhir ke atas barang dan perkhidmatan tolak dengan import barang dan perkhidmatan.


KDNK boleh diukur dengan menggunakan tiga kaedah iaitu Kaedah Pengeluaran, Perbelanjaan dan Pendapatan. Namun begitu, penerbitan ini hanya menggunakan Kaedah Pengeluaran dan Perbelanjaan sahaja.

KAEDAH PENGETAHUAN

KDNK berdasarkan Kaedah Pengeluaran boleh didefinisikan sebagai jumlah nilai barang dan perkhidmatan yang dikeluarkan di Malaysia setelah ditolak dengan nilai penggunaan perantaraan. Kaedah ini turut dikenali sebagai kaedah nilai ditambah yang mana ia menunjukkan sumbangan setiap aktiviti ekonomi terhadap keseluruhan KDNK.

KDNK merupakan sistem perakaunan catatan bergu dan dalam penerbitan ini, iaanya ditunjukkan seperti berikut:

- (a) Jumlah nilai ditambah kasar bagi semua pengeluar yang terlibat dalam ekonomi; atau
- (b) Perbezaan antara output kasar bagi semua pengeluar tolak penggunaan perantaraan (sebagai input).



OUTPUT

Output adalah nilai barang dan perkhidmatan yang dikeluarkan. Ini termasuk pengeluaran untuk pasaran, pengeluaran untuk kegunaan sendiri dan pengeluaran bukan pasaran (perkhidmatan kerajaan dan NPISHs). Pengeluaran barang dan perkhidmatan tidak semestinya untuk dijual atau perolehan oleh pertubuhan.

NOTA TEKNIKAL

PENGGUNAAN PERANTARAAN

Penggunaan perantaraan adalah nilai barang dan perkhidmatan yang digunakan (sebagai input) dalam proses pengeluaran barang dan perkhidmatan tidak termasuk gaji dan upah, susut nilai daripada modal dan faedah bersih yang dibayar.

NILAI DITAMBAH

Nilai ditambah adalah perbezaan di antara output dan penggunaan perantaraan. Ia merupakan nilai ditambah barang dan perkhidmatan dalam aktiviti ekonomi. Oleh itu, ia hampir menyamai dengan keuntungan perniagaan, gaji dan upah, susut nilai dan cukai tidak langsung; campur faedah yang dibayar dan tolak faedah yang diterima.

CUKAI

Di dalam perakaunan negara, cukai dinyatakan dalam dua bentuk iaitu:

(a) CUKAI TIDAK LANGSUNG

Cukai tidak langsung dianggap sebagai kos pengeluaran, di mana ia adalah sebahagian daripada komponen nilai ditambah. Oleh itu, cukai tidak langsung perlu ditambah pada nilai barang dan perkhidmatan. Cukai tidak langsung termasuk cukai jalan, cukai nilai ditambah, duti eksais, cukai pintu dan lain-lain.

(b) CUKAI LANGSUNG

Cukai langsung adalah cukai ke atas keuntungan dan pendapatan, di mana ia merupakan pengagihan semula pendapatan dari sektor swasta kepada sektor awam dan bukan dalam bentuk kos pengeluaran. Dalam konteks Malaysia, cukai pendapatan merupakan cukai langsung yang paling utama.

KAEDAH PERBELANJAAN

KDNK berasaskan Kaedah Perbelanjaan adalah penjumlahan Penggunaan Akhir Swasta, Penggunaan Akhir Kerajaan, Pembentukan Modal Tetap Kasar, Perubahan Inventori dan Barang Berharga, Eksport barang dan perkhidmatan dan ditolak dengan Import barang dan perkhidmatan. Semua komponen ini dikategorikan sebagai 'permintaan akhir' atau 'perbelanjaan akhir'. Kaedah ini mengira nilai barang dan perkhidmatan yang digunakan oleh pengguna akhir terhadap barang dan perkhidmatan yang dikeluarkan oleh residen.

PENGIMBANGAN ANTARA ANGGARAN PENGELOUARAN DAN PERBELANJAAN

Secara teori, anggaran KDNK bagi kedua-dua kaedah harus menghasilkan nilai yang sama. Walau bagaimanapun, secara praktikal, anggaran nilai bagi kedua-dua kaedah ini tidak akan sama kerana penggunaan sumber data yang berlainan. Perbezaan ini dikenali sebagai "Perbezaan Statistik" dalam *System of National Accounts*.



PENILAIAN TRANSAKSI

Anggaran dinyatakan dalam dua jenis harga iaitu harga semasa dan harga malar (tahun asas 2015). Pelbagai teknik digunakan dalam membuat nilai anggaran pada harga semasa dan malar.

KDNK PADA HARGA MALAR

KDNK pada harga malar adalah nilai KDNK tanpa kesan harga. KDNK pada harga malar ini penting bagi membolehkan perbandingan sebenar perubahan tingkat pengeluaran/ kuantiti barang dan perkhidmatan yang berlaku dalam aktiviti ekonomi.

PENDEFLEASI HARGA TERSIRAT

Bagi mendapatkan siri harga malar, kaedah deflasi langsung yang terdiri daripada deflasi tunggal dan deflasi berganda digunakan. Kaedah deflasi tunggal menghapuskan pengaruh harga daripada output atau input yang telah dianggarkan manakala deflasi berganda pula menghapuskan pengaruh harga daripada output dan input. Oleh itu, nilai ditambah diperoleh sebagai perbezaan hasil tolak input daripada output.

Indeks harga utama yang digunakan adalah Indeks Harga Pengeluar, Indeks Harga Pengguna dan Indeks Harga Pengeluar Perkhidmatan. Sementara itu, bagi barang dan perkhidmatan yang tidak terdapat dalam kedua-dua indeks ini, maklumat harga diperoleh dari pertubuhan yang terlibat. Maklumat ini kemudiannya dijadikan indeks harga terbitan khususnya bagi barang dan perkhidmatan tersebut.

HUBUNGAN ANTARA ANGGARAN KDNK DAN IMBANGAN PEMBAYARAN

Siri akaun negara yang dikeluarkan dalam penerbitan ini adalah konsisten dengan anggaran tahun imbalan pembayaran yang dikeluarkan oleh Jabatan Perangkaan Malaysia. Kedua-dua anggaran ini menunjukkan penyata yang lengkap mengenai transaksi antara Malaysia dengan negara-negara lain pada harga semasa.

Penerbitan ini memberikan semakan anggaran KDNK tahunan bagi tahun 2021 hingga 2023. Semakan adalah berdasarkan data terkini banci/ survei tahunan/ dwi-tahunan dan akaun syarikat/ perusahaan individu bagi tahun 2021 dan 2022. Bagi tahun terkini 2023, anggaran adalah berdasarkan kepada sumber data suku tahunan.

Siri masa tahunan ini akan dikemaskini setiap tahun.

CONCEPTS AND DEFINITIONS

INTRODUCTION

The national accounts data presented in the tables are selected items from a full national accounting system, which records all economic activities. The national accounting system covers production, expenditure, income generation and distribution, financing, savings and investment of the whole economy.

This accounting system is defined by the United Nations and the transactions which are presented follow the recommendations of the Systems of National Accounts 2008 (2008 SNA).

GROSS DOMESTIC PRODUCT (GDP)

Gross Domestic Product (GDP) is the total value of all goods and services produced in a certain period after deducting the cost of goods and services used up in the process of production. This value is before deducting the allowances for consumption of fixed capital i.e. the sum of value added of resident producer in producer's price plus import duties. GDP is equivalent to expenditure on the GDP (in purchaser's price) i.e. the sum of all components of final expenditure on goods and services less imports of goods and services.


GDP can be measured by using three approaches namely Production, Expenditure and Income Approach. However, this publication only presents Production and Expenditure Approach.

PRODUCTION APPROACH

GDP based on Production Approach is defined as value of total production of goods and services produced in Malaysia after deducting value of intermediate consumption. This approach is also known as value added approach which will be able to show the contribution of each economic activity on overall GDP.

GDP is an item in a double entry accounting system and in this publication, it is presented in the following ways:

- (a) The sum of gross value added of all producers engaged in production in the economy; or
- (b) The difference between gross output of all producers less the intermediate consumption (as input)



OUTPUT

Output is the value of goods and services produced. This includes market production, production for own final use, and non-market production (government services and NPISHs). Production of goods and services is not necessarily for sale or turnover of establishment.

TECHNICAL NOTES

INTERMEDIATE CONSUMPTION

Intermediate consumption is the value of goods and services consumed (as input) in the production process of goods and services excluded salaries and wages, depreciation of capital and net interest paid.

VALUE ADDED

Value added is the difference between output and intermediate consumption. It represents the added value of goods and services by economic activity. Hence, it is approximately equivalent to commercial profit, salaries and wages, depreciation and indirect taxes; plus interest paid less interest received.

TAXES

In national accounts, taxes are expressed in two forms:

(a) *INDIRECT TAXES*


Indirect taxes are regarded as a cost of production, which are part of value added component. Hence, indirect taxes must be added to the value of goods and services. Indirect taxes include sales tax, value added taxes, excise duties, quit rent and etc.

(b) *DIRECT TAXES*

Direct taxes are taxes on profits or incomes, which constitute of a redistribution of income from the private sector to the government and it is not in the form of production cost. In Malaysia's context, income tax is the most significant direct tax.

EXPENDITURE APPROACH

GDP based on Expenditure Approach is the summation of Private Final Consumption, Government Final Consumption, Gross Fixed Capital Formation, Changes in Inventories and Valuables, Exports of goods and services minus Imports of goods and services. All these components are categorised as 'final demand' or 'final expenditure'. This approach measures value of goods and services used by final users on goods and services produced by resident.



BALANCING BETWEEN THE PRODUCTION AND EXPENDITURE ESTIMATES

Theoretically, the estimates GDP for both approaches should arrive at the same value. However, in practice, the estimated value by both approaches will not be equal due to the usage of different data sources. These differences are known as "Statistical Discrepancy" in System of National Accounts.



VALUATION OF TRANSACTIONS

Estimation is expressed in two types of prices namely current prices and constant prices (base year 2015). Various techniques have been used to estimate value at current and constant prices.

GDP AT CONSTANT PRICES

GDP at constant prices is the value of GDP without price effect. GDP at constant prices enables actual comparison to be made for changes in level of production/ volume of goods and services occurred in economic activity.

IMPLICIT PRICE DEFULATOR

In deriving the constant prices series, direct deflation method which consists of single deflation and double deflation is used. The single deflation method removes the price effect from the estimated output or input, while double deflation method eliminates the price effect from both the output and input. Hence, value added is obtained as residual by subtracting input from output.

Main price indices that are being used are Producer Price Index, Consumer Price Index and Services Producer Price Index. Meanwhile, for goods and services which are not in both indices, information on prices are obtained from establishment involved. The information is then transformed into derived price indices specially for those goods and services.

RELATION BETWEEN GDP ESTIMATES AND BALANCE OF PAYMENT

The national accounts series published in this publication is consistent with the annual estimates of balance of payments published by DOSM. These two estimates show a complete statement of Malaysia transaction with other countries at current prices.

This publication presents the revision of the annual GDP estimates for the year 2021 to 2023. The revisions were based on the latest data of census/ annual surveys/ biennial and account of company/ individual enterprise for the year 2021 and 2022. For the latest year 2023, estimation was based on the quarterly data sources.

The annual time series will be updated every year.
