ADVANCE GROSS DOMESTIC PRODUCT ESTIMATES
SECOND QUARTER OF 2024

***Malaysia's GDP is estimated to expand by 5.8 per cent
in the second quarter of 2024***

PUTRAJAYA, 19 July 2024 – Today, the Department of Statistics Malaysia (DOSM) released the advance Gross Domestic Product (GDP) estimates¹ for the second quarter of 2024. Based on advance estimates, Malaysia's economy expanded 5.8 per cent in the second quarter of 2024, up from 4.2 per cent in the previous quarter. This growth is the highest since the fourth quarter of 2022 (7.4%). For the first half of 2024, GDP increased by 5.0 per cent as compared to 4.1 per cent in the same period last year.

Malaysia's economy is expected to continue its growth momentum, supported by domestic and export-driven factors, with a positive outlook for the remainder of the year. The increase in household consumption expenditures was spurred by the festive and school holidays as well as the payment of Sumbangan Tunai Rahmah (STR) Phase 2 in April 2024. Furthermore, a total of RM6.98 billion was withdrawn from the Account 3 (Flexible Account) of the Employees Provident Fund (EPF) as of June 2024 to support short-term financial needs.

According to the Chief Statistician of Malaysia, Dato' Sri Dr. Mohd Uzir Mahidin, "The estimated growth for this second quarter was in line with the latest indicators such as the Industrial Production Index, which rose 6.1 per cent and 2.4 per cent, respectively in April and May 2024 as compared to the previous year. Meanwhile, the sales value of wholesale and retail increased 6.6 per cent in April and 7.1 per cent in May based on year-on-year basis. In the external sector, the total trade, exports and imports experienced an increase as compared to the same period last year. Other factors include the increase of tourist arrivals as well as oil palm production and the progress development of mega projects."

Dato' Sri Dr Mohd Uzir further explained, "The economic performance in this quarter was driven by the Services sector, with most key sectors showing better growth

compared to the previous quarter. The **Services** sector further increased to 5.6 per cent (Q1 2024: 4.7%), bolstered by Wholesale & retail trade, Transportation & storage and Finance & insurance sub-sectors.”

The **Manufacturing** sector grew to 4.7 per cent from 1.9 per cent in the last quarter, supported by growth in all sub-sectors, mainly Non-metallic mineral products, basic metal & fabricated metal products and Petroleum, chemical, rubber & plastic products. Furthermore, the **Construction** sector remained with a double-digit growth of 17.2 per cent (Q1 2024: 11.9%), which was driven by strong performance across all sub-sectors, notably in Civil engineering and Specialised construction activities.

He added, “The **Agriculture** sector rose 7.1 per cent (Q1 2024: 1.6%) in this quarter, contributed by remarkable growth in the Oil palm sub-sector. Meanwhile, the **Mining and quarrying** sector eased to 3.3 per cent as against 5.7 per cent in the previous quarter, attributed to a moderation in the Natural gas sub-sector.”

DOSM is committed to compiling and disseminating statistics that serve the needs of statistical users. The preliminary GDP estimates, providing a detailed and comprehensive analysis for the second quarter of 2024 will be released on 16 August 2024.

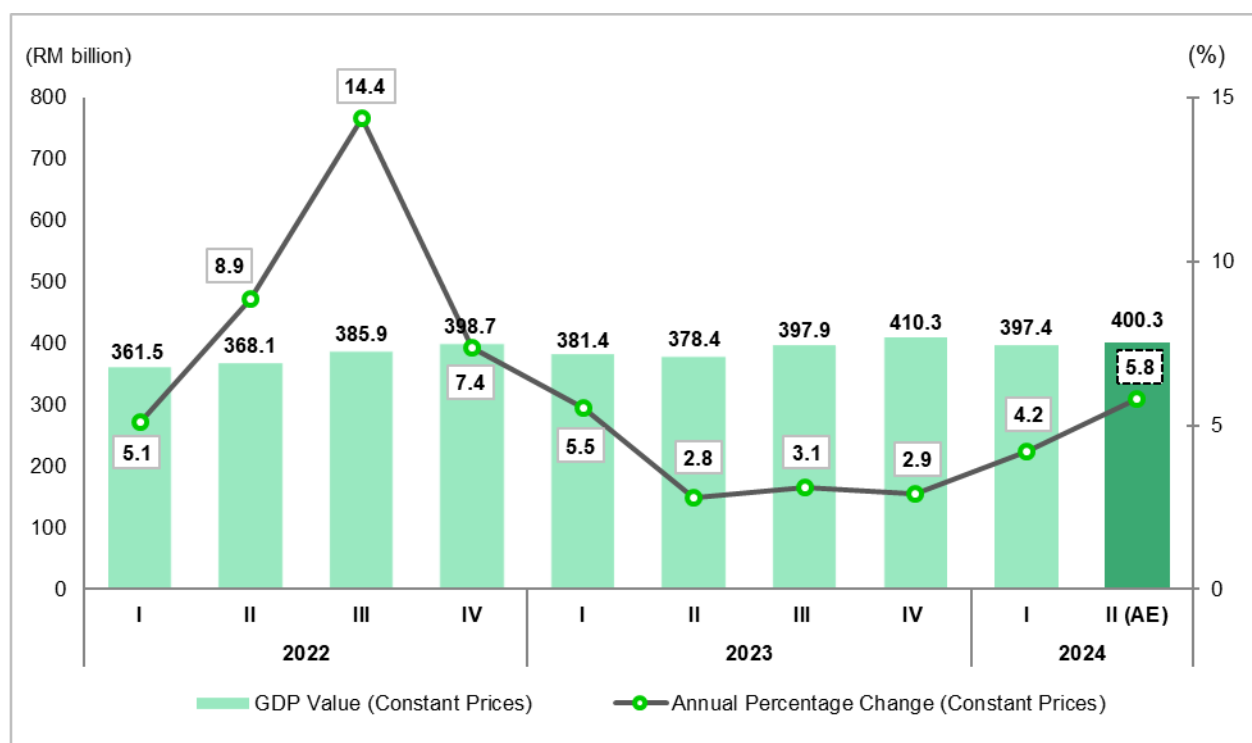
