PRODUCER PRICE INDEX

A) INDEKS HARGA PENGELUAR

Nota Keterangan

1. Indeks Harga Pengeluar (IHPR) bagi pengeluaran tempatan mengukur purata perubahan harga yang dikenakan oleh pengeluar barangan dalam sesuatu industri pada bulan rujukan berbanding tempoh asas. Oleh itu, ia merupakan penunjuk ekonomi makro yang digunakan bagi memantau pergerakan harga output tempatan dan sering dilihat sebagai penunjuk awal kepada Indeks Harga Pengguna.
2. IHPR yang pertama telah disusun bagi Semenanjung Malaysia untuk tahun rujukan 1973 menggunakan tahun asas 1972. Sejak itu, ia telah melalui beberapa siri pembangunan yang bukan sahaja telah memperbaiki metodologi yang digunakan tetapi juga telah menjadikannya sebagai salah satu daripada penunjuk ekonomi utama negara. Selepas tahun asas 1972, IHPR telah dikira bagi tahun asas 1978, 1989, 2000, 2005 dan kini disusun menggunakan 2010 sebagai tahun asas.
3. Indeks Harga Ekonomi Domestik ialah indeks komposit berdasarkan data harga yang diperoleh daripada indeks harga pengeluaran tempatan dan import. Indeks ekonomi domestik diwakili oleh 66.7 peratus wajaran dari pengeluaran tempatan dan 33.3 peratus wajaran dari import.
4. IHPR meliputi lima sektor ekonomi, iaitu Pertanian, Perhutanan & Perikanan, Perlombongan, Pembuatan, Bekalan elektrik & gas dan Bekalan air.

A) PRODUCER PRICE INDEX

Explanatory Notes

1. *The Producer Price Index (PPI) for local production measures the average change in the prices charged by producers of goods of an industry in a reference month compared with the base period. Thus, it is an important macroeconomic indicator used for monitoring the price movements of local outputs and is often viewed as a leading indicator of Consumer Price Index.*
2. *The first PPI was compiled for Peninsular Malaysia for the reference year 1973 with 1972 as its base year. Since then, it has undergone a series of development which has not only improved the methodology but also placed itself as one of the leading economic indicators in the country. Subsequent to 1972 base year, the PPI was constructed for base years 1978, 1989, 2000, 2005 and is currently compiled using 2010 as the base year.*
3. *The Domestic Economy Price Index is a composite index which is based on the price data derived from that of the local production and import price indices. The domestic economy index is represented by 66.7 per cent weights from local production and 33.3 per cent weights from imports.*
4. *PPI covers the following five sectors of the economy, namely Agriculture, Forestry & Fishing, Mining, Manufacturing, Electricity & gas and Water supply.*

5. Harga pengeluar bagi pengeluaran tempatan untuk tahun asas 2005 dan 2010 adalah harga di kilang sahaja, tidak termasuk duti eksais dan cukai jualan. Walau bagaimanapun, bagi tahun asas 1972, 1978, 1989 dan 2000, duti eksais dan cukai jualan dimasukkan sebagai komponen dalam harga pengeluar.

6. Pemilihan pertubuhan adalah berdasarkan sumbangan pertubuhan tersebut kepada jumlah output bagi industri yang telah terpilih. Pertubuhan yang terpilih mewakili produk masing-masing. Pertubuhan ini secara kolektif menyumbang sekurang-kurangnya 85 peratus daripada jumlah output produk yang terpilih. Senarai pertubuhan yang terlibat dalam pengeluaran tempatan diambil daripada Banci Ekonomi 2010 dan sumber-sumber tambahan. Sampel tersebut meliputi 1,165 pertubuhan yang dipilih secara 'cut-off' daripada rangka penyiasatan pembuatan bulanan dan tahunan.

5. *The producer price for local production for the base years 2005 and 2010 refers to the ex-factory price only, excludes excise duty and sales tax. However, for base years 1972, 1978, 1989 and 2000, excise duties and sales tax were included as components of the producer price.*

6. *The selection of establishments is based on their contributions to the total output of the selected industry. The selected establishments are representative of their products. These establishments collectively accounted for at least 85 per cent of the total output of the products selected. The lists of establishments are drawn from the Economic Census, 2010 as well as from other supplementary sources. The sample covers 1,165 establishments selected on a cut-off basis from the monthly and annual manufacturing frames.*

B) INDEKS HARGA IMPORT & EKSPORT

Nota Keterangan

1. Indeks harga import mengukur perubahan harga yang dibayar oleh pengimport bagi barangan yang diimport ke Malaysia bagi sesuatu tempoh masa. Ia adalah indeks berasaskan input yang mengukur perubahan harga bahan mentah dan barangan perantaraan yang diimport oleh pengeluaran tempatan bagi produk siap.
2. Indeks harga eksport mengukur perubahan harga yang diterima oleh pengeksport bagi barangan yang dieksport ke luar Malaysia.
3. Indeks Harga Import dan Eksport meliputi komoditi yang dikelas berdasarkan *Standard International Trade Classification, Revision 4 (SITC 4)* oleh Pertubuhan Bangsa-Bangsa Bersatu merangkumi seksyen komoditi berikut:
 - 0 - Makanan
 - 1 - Minuman dan tembakau
 - 2 - Bahan-bahan mentah tidak boleh dimakan
 - 3 - Bahan api galian, pelincir, dll
 - 4 - Minyak dan lemak binatang dan sayur-sayuran
 - 5 - Bahan kimia
 - 6 - Barang-barang keluaran kilang
 - 7 - Jentera dan kelengkapan pengangkutan
 - 8 - Pelbagai barang keluaran kilang
 - 9 - Pelbagai urus niaga dan barangan

B) IMPORT & EXPORT PRICE INDICES

Explanatory Notes

1. *The import price index measures the changes over time in the price paid by importers for goods imported into Malaysia. It is an input-based index which measures the change in the price of raw materials and intermediate goods imported by local producers for the production of their final products.*
2. *The export price index measures the changes over time in the prices of goods received by exporters for goods exported outside Malaysia.*
3. *The Import and Export Price Indices cover commodities which are classified based on the Standard International Trade Classification, Revision 4 (SITC 4) by United Nations comprising the following commodity sections:*
 - 0 - Food
 - 1 - Beverages and tobacco
 - 2 - Crude materials, inedible
 - 3 - Mineral fuels, lubricants, etc.
 - 4 - Animal and vegetable oils and fats
 - 5 - Chemicals
 - 6 - Manufactured goods
 - 7 - Machinery and transport equipment
 - 8 - Miscellaneous manufactured articles
 - 9 - Miscellaneous transactions and commodities

4. Sejumlah 3,274 spesifikasi item telah dipilih untuk mewakili 1,107 item komoditi (SITC 9 digit) dalam penyusunan indeks harga import manakala 2,467 spesifikasi item telah dipilih digunakan untuk penyusunan indeks harga eksport yang mewakili 725 item komoditi (SITC 9 digit).

4. A total of 3,274 item specifications are selected to represent 1,107 commodity items (9 digit SITC) in the compilation of the import price index while 2,467 item specifications are used in the compilation of the export price index which represent 725 commodity items (9 digit SITC).
